SEPTEMBER 19

The SPEAKER. Members, I am going to invite our colleagues to speak on three of the resolutions that we just passed, so I am asking everybody to please take their seats. Representative Kate Harper will be speaking on HR 969, Representative Fred Keller will be speaking on HR 967, and Representative Benninghoff will be speaking on HR 973. So, members, please take your seats.

STATEMENT BY MS. HARPER

The SPEAKER. Representative Harper, you are recognized. Ms. HARPER. Thank you, Mr. Speaker.

Thank you, members of the House, for your unanimous support for my resolution designating this week, September 17 through September 23, as "Civic Education Awareness Week" in Pennsylvania.

The Rendell Center for Civics and Civic Engagement, started by former First Lady and Federal judge Marjorie Rendell, is dedicated to promoting civic learning, defined as civic knowledge, public action, and democratic – as in democracy, not the party – deliberation. The center stresses the importance of civic learning in schools and helps with lesson plans, age-appropriate civics learning games, and professional education. It is important work, both for the students and for our democracy. The center also promotes Constitution Day, which occurs every year on the birthday of the United States Constitution, September 17. So Civics Awareness Week in Pennsylvania is timed to coincide with that.

Now, Pennsylvania does require civics education in the form of social studies in schools, but many of us believe that we need to do more to ensure that today's students grow up to be participating, contributing members of the government "of the people, by the people, and for the people," as President Abraham Lincoln put it just a few miles from here at Gettysburg. Our colleagues, Representative Boback and Representative Kortz, have introduced HB 1858 that would require that a student demonstrate a knowledge of civics to obtain a diploma or GED (general equivalency diploma), and that is certainly something this House should consider.

But the inspiration for this resolution actually came from a constituent of mine, Richard R. Buttacavoli of North Wales, who is with us today on the House floor. If I might ask, Mr. Speaker, for Mr. Buttacavoli to stand.

The SPEAKER. Yes, please.

Welcome. Thank you so much for being here.

Ms. HARPER. Thank you.

And it was adults, not children, who caught the attention of this citizen in stressing the need for civic education. Here is what he wrote to me: "As an elected committee person, one of my responsibilities is to make sure the residents in my precinct vote on Election Day. I was dismayed to hear that...turnout throughout Pennsylvania was..." only 38 percent for the recent gubernatorial election "and I began to research why people don't vote, and through speaking with individuals and groups..., I realized they don't vote because they do not understand" particularly "local government and how it works." They do not know what a row officer is. They do not know what a prothonotary is. But I actually think that goes for State and federal offices as well. There are many people who think this year that they know too much about the election. But in general, citizens need to know more.

Anyway, Richard Buttacavoli proposed that we shed some light on the need for educating adults about civics, and that is why I introduced, and you just passed unanimously, Civics Education Awareness Week in Pennsylvania.

As Supreme Court Justice Anthony Kennedy has noted, we all have an "obligation to preserve, protect and defend the Constitution, but you cannot preserve what you do not revere. You cannot protect what you do not comprehend. You cannot defend what you do not know."

Civic education matters, not just in our public schools where it is supposed to be taught and learned, but for adults as well.

Please join me and Richard Buttacavoli of North Wales, Pennsylvania, in encouraging our schools, families, and civic organizations to understand civics and our form of government and to encourage every citizen to exercise not just their rights but also their responsibilities as citizens. Thank you.

Thank you, Mr. Speaker.

The SPEAKER. Thank you, Madam Chair.

STATEMENT BY MR. KELLER

The SPEAKER. Representative Fred Keller is recognized to speak on HR 967. I would ask that all members please take their seats.

Representative Keller, the floor is yours, sir.

Mr. F. KELLER. Thank you, Mr. Speaker.

I would like to thank all my colleagues for the unanimous passage of HR 967, which designates this month of September as "Chiari Malformation Awareness Month" in Pennsylvania.

I suspect were it not for this resolution, many of us would never have heard of Chiari malformation. It is a neurological disorder characterized by herniation of the cerebellum and may produce a variety of symptoms, including severe headache, dizziness, vertigo, disequilibrium, visual disturbances, difficulty swallowing, heart palpitations, sleep apnea, impaired fine motor skills, chronic fatigue, and painful tingling of the feet and hands. While the condition is generally thought to be rare, perhaps just 1 in 1,000 individuals have it, there are no definitive statistics to indicate just how many people are affected by Chiari malformation. The uncertainty is complicated by questions of how one defines Chiari and the fact that people may have some abnormalities indicative of Chiari but do not and may never suffer any symptoms.

There is no question that facing any type of long-term, chronic disease is, at best, challenging, but I suspect the challenge is greater for people suffering from rare conditions like Chiari because they are not well known or well understood and do not get the same level of research attention as more common diseases.

I am standing here today because a constituent of mine, Nena Bilger, who suffers with Chiari, has made a commitment to raise awareness, not only on her own behalf but on behalf of others afflicted with this disease. I commend her for speaking out about her condition and working toward a better understanding of Chiari and how to effectively treat and ultimately prevent it. I would like to thank Nena for her courage, not only through her life to deal with this disease but also to try and make life better for others. And if I may, Mr. Speaker, introduce Nena Bilger to the chamber. If you would please rise, Nena. We would like to thank you for your work.

The SPEAKER. Great to have you here today, Nena. Thank you.

Mr. F. KELLER. Thank you, Mr. Speaker.

STATEMENT BY MR. BENNINGHOFF

The SPEAKER. Representative Kerry Benninghoff is recognized to speak on HR 973.

Mr. BENNINGHOFF. Thank you, Mr. Speaker.

I, too, want to thank the members for their unanimous vote on HR 973. I will keep my comments brief, but I thought it was only appropriate that we take a moment to recognize September 2016 as "Childhood Cancer Awareness Month." Many of our lives have been touched with that, as well as some of the members in this chamber, and I just want to take a moment to recognize these families and the young children who have to deal with this issue. We also want to express our thanks and appreciation to the physicians and the nurses that help deal with these children on a day-to-day basis.

Just real quick, childhood cancer, as you may know, is the second leading cause of childhood death in children under the age of 15, which is exceeded only by accidents, to the tune of about 1,250 children are expected to die in 2016. As we know, the American Cancer Society estimates that about 10,380 children in the United States under the age of 15 will be diagnosed alone with cancer in 2016, over 600 of those here in the State of Pennsylvania. Mr. Speaker, that is one and a half children every day. The potential years of life lost to childhood cancer and the potential years of life saved by treatment is exceeded only by cancers such as breast cancer.

Most children cannot be treated in their local hospitals, so the family has the additional challenges of the disruption of their families and having to be traveling across the State and sometimes into other States to regional cancer centers.

Fortunately, I do want to acknowledge that there have been major treatment advancements here in the State of Pennsylvania as well as across the globe. We have had some great successes and want to continue to build on that, and that is why I raise this as an issue of awareness. There is significant progress that still needs to be made in relationship to childhood cancer treatment, because there are so many types of childhood cancer and so many varieties with very low survival rates and are still very difficult to treat. But Pennsylvania is one of the leaders, and I would be remiss to not acknowledge that we have six Children's Oncology Group hospitals, like St. Christopher's Hospital, Children's Hospital of Philadelphia, Geisinger Medical Center, Lehigh Valley Hospital-Muhlenberg, Hershey Medical Center, and Children's Hospital of Pittsburgh.

To the members, I just want to say thank you for giving me a moment to make this acknowledgement, to thank those physicians and nurses for their great work, and God bless the families, and we are very thankful for the successes we have seen.

Thank you, Mr. Speaker. The SPEAKER. Thank you.

A few minutes ago I had the opportunity to visit with Leonard DeLong, a living legend who embodies HR 1002. This resolution recognizes those individuals who not only served in World War II—

The SPEAKER. Representative Gillen, please suspend for just a moment.

Members, please take your seats.

As the clerk indicated, this resolution is honoring more than 171,000 veterans who served in World War II, the Korean Conflict or Korean war, and the Vietnam war, and I believe he has some very special guests with us today as well, correct?

Mr. GILLEN. Yes, Mr. Speaker.

The SPEAKER. So please let us give them the honor that they deserve and the attention that they deserve.

GUESTS INTRODUCED

The SPEAKER. Representative Gillen, you may proceed. Mr. GILLEN. Thank you, Mr. Speaker.

In the back of the auditorium we have members of the DeLong family. We also have individuals from Col. Jacob Morgan Post 537 at Caernarvon Township, Berks County, that I want to recognize, as well as Mr. Leonard DeLong and his stepson, Charles Johnson. I would like us to acknowledge them and give them a welcome to the hall of the House, and I will say more about Mr. DeLong in a moment. Please rise.

Thank you. You may be seated.

During the Pledge of Allegiance and the prayer earlier, I noticed that Leonard DeLong was probably one of the first to his feet, though maybe a little bit less capable than some others in the hall of the House. He would have had every good reason physically to remain seated, but Mr. DeLong is all about duty.

In 1969 he received orders to go to Vietnam for the second time with the 1st Marine Air Wing near Da Nang, the Air Force base. And I said to him, "Was there any hesitancy?" And I will explain why we could conceive that there may be some pause. But he said, "No. It was my duty to go to Vietnam for a second tour of duty."

Back in 1950 Mr. DeLong was called to Korea to the Inchon landing, that legendary movement led by Gen. Douglas MacArthur that saved the Korean people and the peninsula. Later in that conflict Leonard DeLong was at the Chosin Reservoir, which only could be described as brutal, savage, where tens of thousands of combatants on both sides lost their lives, some to mortar rounds, others to bullets, still others because of the elements in the Chosin Reservoir.

In 1943 Leonard DeLong received his call to duty as a United States Marine, and in 1944 – perhaps the better known D-day landing was occurring – Leonard DeLong was running out of a landing craft with another 18-year-old alongside of him and said, "This looks like the end for us." Saipan was heavily fortified, heavily guarded, and was the site of the greatest, the largest banzai charge in the South Pacific during World War II.

There was somebody else on Saipan that was a target of the United States Marines, United States Armed Forces. Chuichi Nagumo was the admiral that led the carrier attack on the United States at Pearl Harbor. In that Battle for Saipan there were a number of notable naval vessels, but let me note two of them, the battleship *California* and the battleship *Tennessee*. The battleship *California* was sunk at Pearl Harbor and the battleship *Tennessee* was damaged, both with loss of life. The United States refloated the *California*, rebuilt her, and the *Tennessee* was repaired, and both saw action at Saipan.

In World War II, Leonard DeLong was at Saipan, he was at Okinawa, he was at Tinian, and received three Bronze Stars for heroic conduct, for valor, for achievement, for bravery, and literally, for a love of country, and we thank you for that.

His unwavering response to the call to duty continued into the Korean Conflict. Three Bronze Stars in the South Pacific and some years later in Korea five Bronze Stars for Leonard DeLong. He is a man who at 91 years young – just celebrated a birthday in August – still loves that flag enough to stand up when it is difficult to do it. In fact, he has been very sick recently, but he much wanted to be here to greet you.

Unwavering and relentless in the face of the heat of battle, tenacious in conflict because he loves that flag, he responded in World War II, in Korea, in Vietnam to the call and the cry of duty, honor, and country. Leonard, we love you. God bless you.

STATEMENT BY MS. PICKETT

The SPEAKER. At this time Representative Pickett is recognized.

Ms. PICKETT. Thank you, Mr. Speaker.

I would like to thank you for giving me the opportunity to thank my colleagues for their support for HR 982. This resolution specifically designates this very week as "Youth 2 Youth: Partners 4 Peace Week" in Pennsylvania. It comes as no surprise to us that our Commonwealth is full of bright, engaging, and inspiring young men and women who want to make their communities and Pennsylvania an even better place to live, to work, and to raise their families someday. Sadly, though, newspaper headlines, TV stories, and social media tend to focus on the negative, especially with regard to youth committing violence. The Youth 2 Youth: Partners 4 Peace has four main goals: number one, talk openly about violence, aggression, and bullying; number two, learn how peers have been affected by youth violence; number three, empower one another to make a difference; and number four, explore solutions for the future.

Job Corps students are using this program to expand the conversations about violence and talk about how this violence is impacting their peers and their communities, all with the hope of getting people their ages to put down the guns, talk about their differences, and improve their communities.

For the past several years that I have been in touch with this program, I have been very impressed by its graduates – young men and women who are taking this opportunity and bettering themselves and their families, and with that, of course, their very own communities. I believe this new initiative is one way in which our youth can make a positive difference in our communities, and I am proud to sponsor this resolution designating this week in honor of this terrific program.

Mr. Speaker, I would like to take a moment to mention the four Job Corps centers in our State – the Keystone Job Corps Center in Drums; Philadelphia; Pittsburgh; and Red Rock in Lopez – and to personally thank the staff and the faculty of these centers for giving the bright young men and women their opportunity to succeed.

All this is, is a government mandate without even an answer of, how do you fix the property so that it can be sold?

This bill did not go through a public hearing, and for that reason I think the amendment is premature, and I am voting against this and I am going to vote against the bill.

(5) In the case of an appeal or request for variance or extension of time involving the construction of a one-family or two-family residential building, the board of appeals shall convene a hearing within 30 days of the appeal.
