# **GUESTS INTRODUCED**

The SPEAKER. Located in the well of the House, we welcome guest page Kevin Bonarzone. Please stand. He is the guest of Representative Tom Murt. Thanks for being with us, Kevin.

To the left of the rostrum, we welcome Jenna Harnish. This is Pennsylvania's Future Farmers of America State president. Please stand. Oh, there, right there. Thank you so much. It is great to have you. She is over there with the chair, Marty Causer, and she is the guest of Chair Tina Pickett and Chair Marty Causer.

In the rear of the House, we welcome Grace Mussoline, and she is a senior at Marian Catholic High School. She is shadowing Representative Tarah Toohil. Will you please stand, and she is with her grandmother, I believe, Elaine. Elaine, if you will stand as well. Thanks so much for being with us today.

In the rear of the House, we welcome a guest of Representative Carolyn Comitta, Anne-Cerise Nilsson. She is from Stockholm, Sweden. There she is, right there. If everybody could wave. She is the deputy director of the Division of Chemicals at the Swedish Ministry for the Environment and Energy, and she works at the United Nations on the Commission for Sustainable Development.

### STATEMENT BY MR. ROTHMAN

The SPEAKER. In the rear of the House—Folks, if you could please take your seats. We are going to recognize Representative Greg Rothman on unanimous consent. This is quite a celebration, and I am going to ask the Sergeants at Arms to close the doors of the House briefly, and, members, if you could take your seats, we would appreciate it. Please take your seats. Representative Rothman, why do you not come up front, to the microphone up front in the well of the House. Representative Rothman, you may proceed.

Mr. ROTHMAN. Mr. Speaker, this summer I read a book by a Harvard professor, Steven Pinker, called "Enlightenment Now" where he looked at the last 100 years and looked at metrics involved with life, health, prosperity, safety, peace, knowledge, happiness. In 1918 the life expectancy was 50 years. Today we are here to honor William DeGrove Carter, who was born on September 27, 1918. He was born in Jacksonville, Florida; enrolled in the University of Florida at age 17. After graduating, he got married and joined the United States Navy.

In 1942 he was selected to attend naval flight school and became a naval aviator in 1943 where he was assigned to Naval Air Station Whiting Field in Milton, Florida, where he trained Navy students in basic navigation and combat maneuvers until the completion of World War II. He would then spend 20 years overseas working in government positions, including postings in Madrid, Spain, and London, England, working as a liaison to the Naval Attaché Office in both U.S. Embassies. During this time he also earned a doctorate degree in Spanish from the University of Madrid. He retired from the Naval Reserve in 1967 as a commander, and from government service in 1973. He returned to Delray Beach, Florida, where he would remain until 2017 when he moved to Mechanicsburg, Pennsylvania, to be closer to his family in my district.

In retirement Bill was an English instructor in Florida for Spanish-speaking immigrants for many years, specializing in working with Cuban and Haitian refugees, and he and his wife, prior to her death, were also avid world travelers. He has visited over 125 countries, from Antarctica to the Galápagos Islands to the Great Wall of China, and continues to travel to this day. His most recent trip at the age of 99 was a 4-week cruise to the Caribbean.

## MISS PENNSYLVANIA PRESENTED

Mr. MOUL. Thank you, Mr. Speaker.

Kayla Repasky, a 22-year-old native of Gettysburg, is a senior at the University of Alabama studying to obtain a bachelor's of science degree in nursing. Her career ambition is to ultimately become a nurse anesthetist. She is a member of the Phi Sigma Theta Honor Society and the Order of Omega. An accomplished dancer, she received her formative years of training at the Hanover Children's Ballet Theatre and Company. She has danced in various places around the country, including on the Beauty and the Beast Stage in Disney World.

Kayla Repasky was Miss Greater Carlisle before becoming Miss Pennsylvania. Kayla's personal platform is Think First America, a 501(c)(3) nonprofit that she founded. She has created education programs to promote antibullying and to educate K-through-12 students on how to use technology responsibly and to fight against cyberbullying.

She published a children's book, "Buddy and the Bully," to help parents and educators teach kindness and discuss bullying to young children. Kayla has been awarded the Daily Point of Light Award, President's Volunteer Service Award, and has been designated a champion organization with Pacer's National Bullying Prevention Center. As Miss Pennsylvania, she will serve as the goodwill ambassador for all five of Pennsylvania's Children's Miracle Network Hospitals. She is also an advocate for STEM (Science, Technology, Engineering, and Mathematics) education.

Please give a warm welcome to Kayla Repasky, Miss Pennsylvania.

The SPEAKER. Kayla, welcome to the House of Representatives. We are very honored to have you. It is not often that people get to speak to the House in and of itself, but we are honored to have you here as Miss Pennsylvania 2018. Please proceed.

Miss REPASKY. Thank you.

On February 3, 2018, Bryan Doll, an eighth grader in my community, took his own life because he was bullied. This story is all too familiar. One in every four students are bullied in our school systems. I started a nonprofit organization Think First America that seeks to educate students to combat bullying, promote Internet positivity, and the importance of choosing kindness.

A few of my initiatives that I am proud of are having established the Bryan Doll, Jr. Memorial Fund, publishing a children's book entitled "Buddy and the Bully," and creating the THINK Before You Post Girl Scout Patch Program. To date I have raised \$20,000 to support Think First America and antibullying initiatives in my community. But my advocacy through education programs can only go so far.

I am calling on Pennsylvanians to take action to combat this bullying epidemic. Our State needs stricter antibullying laws and a more streamlined process to report bullying. Every student who reports being bullied should be taken seriously. The actions taken by the administrators that process bullying cases need to be more closely monitored with consequences for those who do not adhere to the policies of properly investigating claims of bullying.

It is time for action because we are not doing enough. We need to also educate parents on the warning signs to notice if a child is being bullied and how to advocate for their children that are being bullied. If we can take action together, we can help Pennsylvania's children combat bullying and choose kindness. Thank you.

Thank you for being with us.

So we are going to close the doors of the House. I am going to ask all members to please take their seats. All members, please take your seats. The courtesy of listening to our fellow retiring members give their final remarks. So I am asking everybody to please take your seats.

# FAREWELL ADDRESS BY MR. TALLMAN

The SPEAKER. We are very honored to recognize Representative Will Tallman, who has served the residents of the 193d Legislative District since 2008. As many of you know, he and his wife, Suzanne, live in New Oxford, parents of four children, three of whom are missionaries and a fourth serving in the United States Army.

Representative Tallman, I will have additional remarks. We are going to have you come up here.

Members, please take your seats.

Mr. TALLMAN. Thank you, Mr. Speaker.

Speaker Turzai, did I say it right? Pretty close. I used to want to call him Turzai, but I found out it is Turzai, and Dave Reddecliff is timing me so my microphone is going to turn off.

I am going to start off serious and then I am going to get a little funny and then I am going to end serious.

So the first serious part is John Dickinson, who was one of the Pennsylvania signers of the Declaration of Independence. So I am going to read a quote from him: "Kings or parliaments could not give the rights essential to happiness.... We claim them from a higher source – from the King of kings, and Lord..." of lords. "They are not annexed to us by parchments and seals. They are created in us by the decrees of Providence, which establish the laws of our nature. They are born with us...." They "cannot be taken from us by any human power...." And that is John Dickinson, one of the signers of the Declaration of Independence, from Pennsylvania.

So I would like to introduce – Mother, if I get this wrong – 93-year-old, my mom. Ninety-three, she soon turns 94 in January. So my mother is here. My wife, Suzanne, coming up on 48 years – if I have that right – so my wife; my son, Rob; his wife, Coco; and two of my grandchildren, Brooke and Jewel, are here.

Just one thing and most of you know this, but I could not have done this job if it was not for my wife. She would correct my speeches, she is a good speech writer, and just all kinds of things that we have to put up with and we take home, and being away, and some of you who live even farther away than I do, that is even more of a challenge than it is for me.

So as the Speaker has said, my family is a family of service. So two of my children are missionaries. Rob, he goes over and puts out fires. So he has been to Venezuela and Papua New Guinea, and currently he is not at any of those places; and then my youngest, Joel, has 17 years, all active duty, in the United States Army. I have 14 grandchildren and so we are a well-blessed family.

And we hold most of you, if not all of you, from time to time up in our prayers at home. So just this morning, Suzanne and I, we prayed for the Speaker, we prayed for Majority Leader Reed. We do that. I do not see Sid. Sid Kavulich, you are out there and we prayed with you when you had your medical situations. We are now praying for Representative Pyle and Representative O'Brien with their current medical issues. So we pray for you folks here often.

So in the back – I do not see Carol, who was with me a long time – Elizabeth is here, I think. Is she here? Elizabeth is back there. Jared is there. Yvonne, who has been with me from the very beginning in my district office, is not here. Scott Little is not here either, I do not think. He is my PR guy, almost from the very beginning, and I have always told Scott that there was a certain member that I tried to achieve, and then a couple weeks ago when I achieved international or national fame, he said, "I think you finally got close."

The York delegation, which is a tremendous organization. So in December of 2008– Seth, I think you were there at that very first meeting – I showed up in a brand-new suit coat. You have to buy suit coats and suits in this job. I showed up. I thought it was going to be a very serious operation. Keith, you are laughing already. It was not. So Stan Saylor, Ron Miller – I do not know if any of you remember Ron Miller – right away they start picking on each other and it was not a serious organization at all. But we did accomplish things. So the York delegation was really, really great.

Dan Moul. I have been to a lot of things – I have multiple cards – Dan Moul can talk 2 hours off of one 3-by-5 card, by the way – but Dan Moul I have gotten to know really, really well. I now consider him a friend. We got chicken grease all over us this past weekend from cooking chickens with Dan Moul.

Mike Reese. He does not know anything about U.S. history, but Mike Reese I consider a friend. Also, he has been to my house, all the way from Westmoreland County, and just to share a little bit, Mike, so my mother's maiden name is Quiggle, and Mike Hanna has a Quiggle. So Mike Hanna, I think I am third cousins or third cousins, twice removed, or something like that. You can talk to my mother, Mike. She will give you the dates and who they were. So Mike Hanna and I are related somehow, like I said third cousins, twice removed. But the Quiggles, Quiggle was a signer of the Declaration of Independence, signed at the Tiadaghton Elm. I do not know if you knew that, Mike, but it was a Quiggle that signed that. What is that in Pennsylvania history? Then the Tallman side of the family, we were Connecticut Yankees, and many people do not know what that is either. But I got a history book, the history of Montour County and it talks about the Connecticut Yankees.

Jerry Stern is here. I did not know you were going to be here, Jerry. My first term I laid on your couch and got psychological counseling. That did not happen too well. Then Mark Keller – I do not know if he is back there – I used to go into his office, his is right across the aisle from mine and I used to go in for him and he used to always offer me some hard stuff to get over my angst with how the House operated.

So Aaron Kaufer is back there, and we would have very, very interesting conversations, typically about Israel and about the politics and Jewish life, and so very, very interesting conversations with Aaron, very insightful conversations, because one of our goals when we retire is to go visit Israel and Aaron has set me up with all kinds of things to do and people to talk to. I am not sure that is wise, but that is another thing.

Tim Hennessey. My very first day on this House floor – some of you remember, Seth you remember – we spent hours in debate. We got to miss – I think most of you guys that came in with me, Mike and Carl, and some of you others – we did not get to do our dinner that we typically have. We spent our time in caucus and debating here on the House floor, and Tim Hennessey, when I came down, he said, "How's it going to feel to lose your first

vote?" Which I did. I lost my very first vote here on the House floor. But sitting next to Tim was entertainment. Tim always kept me entertained. You could not do anything when you are sitting next to Tim Hennessey.

So now I am going to get just a little bit serious. Two things I would have liked to get accomplished and I was not able to do it – property tax, we need property tax relief. Hopefully, we can do it next session. And I told Tom Creighton – you guys probably forgot Tom Creighton, too – but I told Tom Creighton, I said, "State government is broken and I have proven to myself that it is broken," not so much here but the agencies that we deal with. Customer service, we need to have that as an aspect of our customer service.

Now, I am going to get just a little bit serious. So on the ceiling of the Capitol we have John 8:32, "Ye shall know the truth and the truth shall make you free." John 14:6, just a little bit later down, Jesus said, "I am the way, the truth, and the life. No one comes to the Father but by me." And so that truth that it speaks about up there, it is actually speaking about Jesus. So we need to be that.

So finally, I do not know where I am at, Dave, on your timer, but finally, retirement frees us — that is Suzanne and I — to volunteer more thoughtfully and effectively, due to our life experiences, and to devote more time to such endeavors. It is now possible to do now that we are not going to be working. So what lies ahead for me? There are some mission projects, you know, some of them I shared with — my wife and I would probably like to do a long-term mission project over to Papua New Guinea, and she is considering teaching. I am just going to go over to cause trouble, and most of you know that we can do and we are also going to get involved in some local projects. So my wife and I are going to be involved in volunteer activities.

It has been a joy to be with you. Some of you I have gotten to know very much. I know Leader Reed and Speaker Turzai are not going to miss me. They are going to be thankful that I am leaving. But anyways, it has been a joy to get to know even Mike and Dave, and Dave and I have had some serious conversations over the years, and I do appreciate some of those, you know, straightforward conversations.

Thank you very much, Mr. Speaker.

The SPEAKER. Representative Tallman, you would be mistaken. I certainly will miss you, and I consider you a very, very good friend. I also think of you and your lovely wife as two of the most thoughtful, prayerful individuals that I have been able to come across in a lifetime of being involved in, you know, the public sector just as you have. You are one of the most earnest persons, thoughtful about legislation, in addition to what should inspire us, and you have served your district and the Commonwealth really humbly and yet with great leadership.

Amongst other things that I know you have worked on, the work you did two budgets ago, you were one of the leaders in trying to find a way out of a tough fiscal situation that particular year and you wanted to do it without increasing taxes and you came up with creative approaches and I think your leadership meant a lot to the direction of the Commonwealth of Pennsylvania, in just that endeavor, not to mention all the other fine issues you have worked on. You have also reminded us regularly, because you oftentimes say the prayer for us, of the importance of, you know, looking to guidance and providence from the Lord in moving forward, as you did today, and I will tell you that I think that that humility and that sense of purpose and that mission has just stood so well for you and your service here.

Many, many of us will miss you. I do know that you and Suzanne will be great missionaries wherever you go, if that is where the life journey takes you next, and probably your greatest testament is your family, and it is so wonderful to have so many of them here. I did not know you had 14 grandchildren though. So, Will, thank you so much and we have a gift for you. Thank you for your service.

# FAREWELL ADDRESS BY MRS. WARD

The SPEAKER. Representative Judy Ward became the first female State Representative in Blair County's history when she was elected to serve the people of the 80th Legislative District in 2014. As I indicated, she is presently a candidate for the State Senate. Judy, as you may know, is a registered nurse, a small business owner, development professional, wellness coordinator, and I am sure from her perspective, in addition to her service to her constituents in the 80th District, also very proud of her husband, Bill, and her two grown sons, Bill, Jr., and Adam.

At this time I present to you Representative Judy Ward.

Mrs. WARD. Thank you, Mr. Speaker.

Good morning. As many previous to me have gotten here and have been here to give their farewell addresses, it is very different when you are standing up here than when you are sitting back there. So it is a bit overwhelming. But it is hard to believe that I am standing here to say goodbye, because it seems like I just got here. Four years go by very quickly. Being a House member was never my ambition, but I am so blessed to be here, and as I look out, I see so many wonderful friends and it is impossible to mention everybody who has really touched my heart and been a great friend these 4 years. It is very difficult.

But I want to begin by thanking my predecessor, Representative Jerry Stern; our mutual friend, Bruce Erb; and my son, Bill, Jr. They saw something in me that I did not see in myself, and I will be forever grateful. Representative Stern and his wife, Susan, are here with us today, under some trying circumstances this morning, but they are here today and I am so grateful. Thank you so much for being here.

A special thank you to Speaker Turzai and Leader Reed for your support and assistance along the way. I really appreciate it. Thank you so much.

I want you all to know that I came here very uncertain and possibly skeptical, but I leave with great hope and optimism. This chamber is filled with leaders who want to serve their constituents and make Pennsylvania a better place to live, work, and grow. This is truly the people's House. All walks of life are represented in this chamber.

It is certainly bittersweet to leave. I have so many great friends. How can you ever replicate sitting in front of Mindy Fee, who made me laugh every single day? How do you talk sitting next to Marty Causer? Marty is a true gentleman who helped me learn the ropes, and I consider him a dear friend. Marty, as a parting gift to you, I am going to stock our cabinet full of Snickers bars, okay? Also, I will miss sitting next to Mark Gillen and Representative Barry Jozwiak. I pulled a joke on Barry Jozwiak a few weeks ago with the F.O.P. (Fraternal Order of Police), and I do not know if he has still forgiven me.

I remember telling Dave Reddecliff when we were brought in 4 years ago that I did not care whom I shared an office with, it would be okay, I can get along with anybody, and he was kind enough to allow me to share an office with Craig Staats. It could not have been a better choice. And by the way, Craig, I still think there is something wrong with the person who has not one piece of paper on their desk, okay? Craig and I were fortunate to get one of the best legislative assistants in the Capitol, Eileen Krick. Yep. That was her fan club starting the applause. I want to take a moment and thank Eileen for her excellent work, her professionalism, and her great sense of humor. We have had a lot of fun

Some of the moments that I will never forget here in this chamber— Actually before, when I first got here in the Irvis Office Building, I had a morning where I was taking – I had a card, it was Representative McGinnis' birthday, and I slipped a birthday card under his door and I am fussing around and I came to find out that the zipper in my skirt that zipped bottom to top was up in the back and nobody told me about it, because they said they did not know what to say to me. I said, "Come on," you know.

But I will always remember a photo that we took as freshmen with Kate Klunk and Kristin Phillips-Hill. The three of us posed on the rotunda steps in a "Charlie's Angels" pose, and when things got dark during the budget of our first year, we had the photo printed, autographed, and framed for Speaker Turzai, and it made our day and I hope it made his day as well.

How about Tommy Sankey? Tommy Sankey gets up on the House floor and he says, "I rarely get up to speak on the House floor, but when I do, it's usually pretty awesome." That gets a round of applause.

How about Jesse Topper? Representative Topper started his floor remarks once with "I'm just a home-schooled boy from the country...," and everybody – he got a "boo" on that one.

And who can forget Representative McGinnis, his mother's jokes that he would tell from time to time? She is very funny and quite clever.

They say that politics is very divided these days and it certainly is, but I have been very blessed to have friends on the other side of the aisle. Early in my tenure, Dan Miller came to me and talked about collaborating on a bill that would provide a mental health checkup for children in grades 6 and 11, along with their other mandated physical and dental exams. Dan, this is a great bill and I hope to be able to work on this in the future. It has

been such a pleasure to work with you, and I believe that you are a true champion for folks with disabilities.

Bryan Barbin has been a wonderful friend to me, and who could not get along with Rob Matzie? Anytime I am out with Rob at a dinner I always have a good time. Representative Donna Bullock even came to visit me in my district and at my home, and I will never forget that. And who would not want a hug from Joanna McClinton?

But probably my most favorite story here is from dear, sweet Eddie Day Pashinski. Eddie, you know what I am going to say. One day he came up to me and he said, "I heard great news about you." I said, "Yea?" He said, "I heard you're expecting." I thought for a moment and I said, "You have me mixed up with Kate Klunk, don't you?" Poor Eddie, he looked mortified. He did not know what to say. I said, "Oh, Eddie, everybody mixes us up. It's great for me, but it really stinks for her." But I will tell you, he has called me Judy every day since then.

Many days here have been fun and many days were not that much fun, but I have always been lifted and inspired by my colleagues who are here for the right reasons. They are here to serve the people. John McCain once said, "Our shared values define us more than our differences. And acknowledging those shared values can see us through our challenges today if we have the wisdom to trust in them...."

In closing, I want to especially thank my husband, Bill. We have been married for 34 years and he is here with me today. Will you please stand, Bill. I would like to also introduce our sons, Bill, Jr., and Adam. They are my rocks and my true north and they have been here every day for me no matter what and I do not know what I would have done without them. I am so grateful for their love and support, and it means the world to me.

In closing, it has been fun, but it has been a true honor and privilege to serve the people of the 80th District in this esteemed body. I thank them for the opportunity to serve them. It has been an opportunity of a lifetime and one of the greatest blessings of my life. Thank you all.

The SPEAKER. She's a dynamic, dynamic lady and you're just all going to love her," and of course, Jerry was right. Judy, you and your wonderful family have become friends to so many of us. I got to spend time with Representative Ward and her son, Bill, Jr., at the convention, and we had such a great time with so many people, and you bring a seriousness but a levity to this important business that we do and, Judy, your talent for that, I think, allows you to work with everybody and to move things forward.

I must tell you amongst a wide variety of important legislation you have worked on already in the 4 years and I know, you know, God willing for you, that you will continue the service to the citizens of Pennsylvania back home, but your work with respect to the, you know, Down syndrome children and the Down Syndrome Protection Act, I still think your opening remarks were some of the most powerful I have ever heard on the House floor. God bless.

I just want to thank you for all the work on behalf of this chamber and wish you the very, very best, and to your family, Bill, and your boys, you know, always we all feel like we know your whole family because you are so open and engaging about them with each and every one of us.

Judy, I have a little gift for you, a gavel. Please feel free to use it any time across the Capitol, and God bless. Thank you very much.

(Commemorative gavel was presented.)

# FAREWELL ADDRESS BY MR. LEWIS

The SPEAKER. Representative Harry Lewis was elected in 2014 to serve the 74th Legislative District of Chester County. This good gentleman, this fine gentleman had a career of public service before the Republicans recruited him to run for this office, and I have to tell you, no matter when I am in Chester County or much of the surrounding area or see guests up here, how many times people have had Representative Lewis as a coach, a teacher, an administrator, and how many times each and every one of them said, "You were the person that changed my life."

He is here today, I believe, with his wife, Regina. They have three daughters. I am so honored, again, but saddened to see such a fine member give his or her final remarks.

But at this time I call up Representative Lewis.

Mr. LEWIS. Thank you, Mr. Speaker.

This is kind of an emotional time for me. I do not have a lot of jokes and this kind of thing, but some remembrances. When I decided to make this move, I could not imagine the Chief Clerk sitting in my office waiting for me to come in, and he had some information for me and he sort of chuckled. I chuckled back. He said, "Representative, do you know that you are the second oldest member in this entire House?" So that kind of really helped me make up my mind. I do not mind being second to Representative Godshall.

It is with great humility that I come before you today. As you know, I had a long and rich career in education and as a track coach, and I had established a record of volunteering many hours in my community, and that was long before I even thought about running for office. I was probably the most unlikely candidate with a remote chance that I would actually even consider running for office, but I am glad I did. And though I was not your typical freshman, each of you graciously welcomed me, and I really, truly thank you for that. Sometimes you made me feel uncomfortable, like I was a star or something, taking care of me, but that really resonated with me, and though I was not – I am grateful for the opportunity afforded me by the members and the constituents of the 74th Legislative District. Along with you and with the hardworking and committed staff here in Harrisburg – and that means all of you - because I do observe and I watch what you do on both sides, and our constituents have no idea, because you really, really make this place work.

I guess the next phase of my life – because I think I did make a difference in my community and to my constituents, I am proud of that – when I retire, it will not mean sitting back and doing nothing. Rather, I feel a lot better prepared to give back to my community because I served here with all of you. I have gained valuable insight and established strong relationships, and much to my surprise, I know my community even better than I thought I did before I got here. After nearly 50 years of service, it can only get better from here for me in particular.

The complex challenges we face today, ladies and gentlemen, need all of us. Wherever we are, we cannot afford to be negative, we cannot afford to turn on each other. We are here for business. We represent an awful lot of people in this Commonwealth. We can address the needs of our citizens, our State, and our nation by working together with all of our communities. I am not deterred by the challenges ahead. At the end of the day, we will come together to make our communities better for everyone. That is all of our communities. People from all persuasions, backgrounds, and political and religious affiliations show up at our door. They pour their hearts out and they rely on all of us to help. They come from every direction, approaching us in the street. How many have approached you at the store, at events, and some have even come to our homes. But when they call on us to help, we all know we have a responsibility to give our best, to do all we can to help our constituents. So I promise you that even in retirement I will stay the course. Doing nothing has never, ever been a part of my game. I know you will all stay the course, whether actually working or not. Collectively, we will continue to make a difference along with the new wave of legislators and citizens to come, both citizens that care. The reality is that our paths may cross again, but only if we intentionally stay in touch. That is always the intent, but let us make it happen. And even if our paths do not cross, we will know that there are others out there, based on our shared experiences and who we are, we are all doing all we can to make it better for all of us and our citizens.

It has been my pleasure, ladies and gentlemen, to serve with you, and I mean that from the bottom of my heart. I thank you and I thank all of my staff members: Joni Mitchell, my right hand here in Harrisburg, and Reggie Ward, my district office executive. Mitch and Andrea Keenan. I have even had superior help from the mace, Jim Fata. I have another young lady here that started this process with me and she was there at the beginning and she started my campaign and she even became known as my second wife at times, Trish Milanese, and she is in the rear. All of you have gone above and beyond to help me.

Finally, some of my guests that are here, especially my wife, my daughters, my granddaughters, and I thank those who helped and supported me. I have one young gentleman with me, my brother, Larry Lewis. Some of you may remember him. He served as executive guard for Governor Casey all the way through to Governor Rendell. Larry Lewis. Stand, Larry.

I would like to introduce my guests: my daughter, Bridgette Boyer, stand please; her daughter and my granddaughter, Amari Boyer; my eldest daughter, Stephanie Montgomery.

In the rear I have Reggie Ward, I mentioned. Alison Evans. Alison is the publicist for me, and let me tell you, she made me look good back in my district, and I really appreciate you, Alison. Thank you. Ann-Marie Franciscus, a guest, please stand; I have Frank and Kathy Costigan-DeHaut, please stand; and another friend, Sherry Keene; Mr. and Mrs. George Carlino; and last but not least, a very, very close friend of the family and mine, Earl Johnson.

Once again, thank you for this privilege and thanks for giving me this opportunity.

The SPEAKER. As we indicated, you know Representative Lewis distinguished himself as an outstanding educator for more than 40 years prior to coming to serve in the House of Representatives. He served at the Coatesville Area Senior High School as principal, assistant principal, special education teacher, physical education teacher, and of course, track coach. A graduate of Winston-Salem University, this good gentleman received two master's degrees, one from West Chester and one from Cheyney. He and his wife, Regina, we got to meet two of the three daughters, and one of the granddaughters, but have a great and large family, including as many of you may remember, the Representative's nephew, Kenric Lewis, a pastor who gave our invocation on swearing-in day for this session. So it is bittersweet, as we had begun that session with one of his close family members, to be seeing us come toward the end of it in your retirement.

Representative Lewis, you are a person of great dignity, great mentorship, someone who has really been a great colleague and helped move legislation forward, with member upon member upon member, because of your lining up behind it. Thank you so much for your service.

### STATEMENT BY MR. JAMES

The SPEAKER pro tempore. On this occasion, under unanimous consent, Representative James is recognized for brief remarks.

Mr. JAMES. Thank you, Mr. Speaker.

Thank you all for the nice round of applause for my constituents from back in Venango County. I just want to say that 40 years ago, previous House member, Ron Black, conceived of an idea based on the first oil well being drilled at Drake Well in northern Venango County, and he said, "Boy, we ought to celebrate this and maybe have 3 or 4 days once a year where we recognize the importance of that." Included in that, we have elected a couple of ladies, an Oil Heritage Queen and a runner-up, every year, and I just wanted to compliment them primarily. These ladies are top of their classes, they are going to go places when it is all over, and they very kindly agreed to represent the chamber of commerce and their high school for an entire year in this capacity. So God bless them all, and again, thank you for the round of applause.

The SPEAKER pro tempore. The Chair thanks the gentleman. At this time we are going to invite members who have expressed an interest in speaking on bills that are on the supplemental uncontested calendar to offer their remarks at this time, beginning with Representative Matzie, who is recognized under unanimous consent to speak on HR 1127, Pancreatic Cancer Awareness Month.

### STATEMENT BY MR. MATZIE

The SPEAKER pro tempore. Representative Matzie.

Mr. MATZIE. Thank you, Mr. Speaker.

As many of you know, I introduce this resolution each year designating the month of November as "Pancreatic Cancer Awareness Month" in Pennsylvania and every year I list statistics about the number of lives claimed by this devastating disease. I wish I could stand here and tell you that the statistics are improving, that more people are surviving. Sadly, that is not the case. The statistics this year are no better than last year and possibly worse. The facts surrounding pancreatic cancer are sobering. This disease is currently the third leading cause of cancer-related deaths in our country. By the year 2020, it is expected to become the second leading cause. According to the Pancreatic Cancer Action Network, more than 55,000 people are expected to be diagnosed in 2018 and more than 44,000 are expected to die.

I have always said that this fight is personal to me because my mother, fortunately, is a pancreatic cancer survivor, 4 years strong for Mom. She just celebrated a birthday yesterday and it is amazing. When we celebrate her actual birth date, I tell her every time that we celebrate your birthday really twice a year: on the day that she was born and on June 16, the day of her surgery that eradicated this disease.

Earlier this year the fight became personal for all of us, when it claimed the life of our beloved colleague, Flo Fabrizio. I know the guys in the back all talk about Flo still, and we still remember him and, of course, had the memorial for him a couple of weeks ago. Flo and I talked quite a bit when he was first diagnosed about the symptoms, about the possibility of survival, and how long that would take. He fought valiantly until his death this summer at the age of 73. As most of us knew, Flo was not a quitter and he was never afraid of that fight, but the odds were against him. That is because we have made no new advances in treating pancreatic cancer for more than 25 years.

The reason pancreatic cancer is so lethal is because it is such an insidious disease. There are typically no symptoms during the initial stages, and those that do arise are often vague. At the same time, the disease spreads quickly, so by the time a patient experiences symptoms such as jaundice, digestive problems, and weight loss, it is often too late. In many cases, surgery is not possible, like my mother was fortunate to have, leaving chemotherapy and radiation as the only treatment options, as Flo had to undergo. Sadly, the survival rate is just 9 percent.

But like Flo, we are not ones to give up in the face of adversity. There are things we can do to fight back. A critical part of the fight is continuing to raise public awareness like this resolution. Through our efforts we need to make people understand the importance of being proactive and not ignoring symptoms, even vague ones. Early detection can mean the difference between life and death. My mother is a living testament to that fact, that you can survive pancreatic cancer with early enough detection. That

is why it is so important that we do all we can do to keep this deadly disease in the forefront of public health consciousness.

Equally critical, we can fight for greater funding for medical research, which can one day lead to the development of a cure. The Pancreatic Cancer Action Network reports that clinical trials, when a patient is eligible, may offer the best opportunity for a positive outcome. This tells us that funding for research is absolutely critical. I vow to continue advocating on behalf of greater public awareness and greater funding for research until a cure is found.

And I would say to all of you, please join me in memory of Flo and all the other victims of pancreatic cancer. With continued public awareness and increased funding for research, I hope to be able to stand up here one year and report that things are actually getting better.

## STATEMENT BY MR. DeLUCA

The SPEAKER pro tempore. Under unanimous consent, the Chair recognizes the gentleman from Allegheny County, Representative DeLuca, also to speak on HR 1127.

Mr. DeLUCA. Thank you, Mr. Speaker.

I want to commend the gentleman for introducing that resolution, but the reason I am up here for unanimous consent is because this month is Breast Cancer Awareness Month and the fact that my wife is a breast cancer survivor and myself as a cancer survivor, I congratulate all the members here who introduce these resolutions for awareness. But, ladies and gentlemen, nothing happens unless we can increase the money for research and development. We have been making so much progress on the fight against cancer that it is a shame that we have organizations under the guise of cancer – the victims – who are raising money and doing little for research and development.

I would like to point out this one group my wife just got a solicitation for. A couple times she gave to it until I told her—

The SPEAKER pro tempore. Will the gentleman suspend.

I just would like to remind the gentleman we are on the uncontroversial calendar. So please, I understand it is important information. Just please remember, this is supposed to be noncontroversial's time.

Mr. DeLUCA. If you think this is controversial, Mr. Speaker, it is not controversial, because the fact is, this organization collected \$6 million – million – and let me give you this organization – Breast Cancer Institute of America, Mr. Speaker. Out of the \$6 million, they gave 6.7 percent to research and development; 86 percent to fundraising. That money could be used for research and development, Mr. Speaker. We let them get away with it. The Federal government should be cracking down on these organizations.

But I am a little upset, Mr. Speaker, because of the fact there is a bill in this House, 462, that would say 65 percent of the charity's money must go to the mission, but unfortunately it is tied up. We cannot wait another 40 years—

The SPEAKER pro tempore. The Chair thanks the gentleman. Mr. DeLUCA. —for our kids to be cured of cancer. And next session, Mr. Speaker, I would hope that we move on this legislation to do something good, not just on resolutions. Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman. For the information of the members, my brief time at the rostrum today does not constitute my valedictory remarks. I do fully intend to offer you all a piece of my mind in the morning.

## STATEMENT BY MR. NELSON

The SPEAKER pro tempore. Under unanimous consent for noncontroversial remarks, on HR 1143, concerning Domestic Violence Awareness Day, the Chair recognizes Representative Nelson.

Mr. NELSON. Thank you, Mr. Speaker.

Today I rise and thank my colleagues for their unanimous support in recognizing "Domestic Violence Awareness Month" in Pennsylvania. Specifically, I spoke a number of times on the floor stressing the element of teenage violence. Unfortunately, 2018 has been a year of threes. Thirteen percent increase in domestic violence over this past year, and unfortunately, Mr. Speaker, the number of teen deaths has flatlined. One in three adolescents are victims of physical, sexual, emotional, or verbal abuse from their partner, and one-third of those never report to anyone else. A teenager is three times higher, if she is a female, of being a victim of domestic violence.

So, Mr. Speaker, I rise today in recognition that 16 years ago, a day after her 16th birthday, Demi Brae Cuccia was killed in the kitchen of her home from a teenager following a breakup. Incidents like these can be prevented, and, Mr. Speaker, it is important for parents to realize when we focus on teen violence, parents need to be aware of warning signs. Again, the number three. Thirty texts or messages within an hour of controlling behavior from a relationship is an enormous warning sign. Controlling what a teenager might wear, where they may attend or whom they may attend events with is also a significant warning sign. Our parents need to know that if their children are experiencing these, one, it is safe to mention, and two, they need to take action, because the parents of Demi Brae Cuccia took action and started the Demi Brae Cuccia Foundation and since then, over these 16 years, have touched the lives of thousands of Pennsylvania teenagers, helping them to be aware of both the problem and of the potential for solution.

So, Mr. Speaker, I thank my colleagues for their continued support for awareness and efforts to prevent domestic violence, in particular, within our teenage population.

My amendment, A09273, inserts language requiring a Governor's declaration for a disaster emergency to include a statement expressly stating whether the Price Gouging Act is applicable to the declaration that is being made so that there will be no ambiguity related to the requirement of the statute.

I would ask the members for a "yes" vote on this amendment. Thank you.

As we begin the debate on this issue, I just wanted to submit some things that would be worthwhile to take a look at the legislative history of this bill. The Senate Veterans Affairs and Emergency Preparedness Committee reported this bill by a vote of 12 to 0; on the Senate floor this bill received a fast roll call of 48 to 0 with no debate; and finally, Mr. Speaker, the House Veterans Affairs and Emergency Preparedness Committee reported the bill to the floor by a vote of 27 to 0.

Now, with the Barrar amendment we have the opportunity to address two concerns that were raised by the Governor's Office regarding the bill to make it even better. Mr. Speaker, those of us who have looked at this issue have come to realize that what we have here is a law with unintended consequences. What I mean by that is we learned that the Governor's declaration regarding a health emergency triggered price controls on all consumer goods in the Commonwealth. We recognize that a declaration of a health emergency that, for example, triggered price controls on hotel rooms is an unintended consequence and needs to be addressed by changing the law.

Mr. Speaker, we recognize the vital importance of ensuring consumer protections, especially in times of emergencies. We also recognize the need for predictability and consistency in our economy and business operations. Therefore, I would respectfully ask my colleagues to vote "yes" on amendment A09273 and strengthen the Price Gouging Act for consumers and business alike.

Thank you, Mr. Speaker.

Mr. BARRAR. Thank you, Mr. Speaker.

I want to thank the Representative for his very positive comments.

I do want the members to realize that this amendment is a result of some conversations we have had with the Governor's Office trying to work out a compromise. Mr. SONNEY. Thank you, Mr. Speaker.

Mr. Speaker, we have all heard the arguments coming from our magisterial district justices this is about safety, and quite frankly, I would argue that we face those exact same issues when we go out to get signatures to run for office. And we not only face those exact same constituents, we face them three times as often and we have to get three times as many signatures. So if this is really and truly about safety, I believe that our safety is just as important.

So I would encourage a positive vote on amendment 09528. Thank you, Mr. Speaker.

The SPEAKER. Thank you, sir.

Representative Diamond, on the amendment? Okay. No.

Representative Barrar, on the amendment.

Mr. BARRAR. Thank you, Mr. Speaker.

I would ask the members to vote against this. I think it is probably not a bad idea what the Representative is proposing, but I really think it should be a separate bill so we can debate the merits of that bill individually. I have looked at this amendment. It really adds nothing to this bill that helps get it across the finish line.

I would ask the members to vote "no."

The SPEAKER. Representative DeLuca, on the amendment, sir

Mr. DeLUCA. Thank you, Mr. Speaker.

I, too, rise to oppose this amendment. We are in a different situation than some of these district judges, because the fact is we are not every day or once a week or twice a week making decisions on criminals, and the fact that these individuals have to go door-to-door and when you knock on a door, who knows what is going to happen. I think it is a good – this SB 299 is a good bill, and I certainly would appreciate everybody voting against the Sonney amendment. Thank you.

The SPEAKER. Representative Pyle.

Mr. PYLE. Thank you, Mr. Speaker.

Mr. Speaker, I would also encourage membership to look very hard at Representative Sonney's amendment. What it asks is that seated members of this House file a certificate of reelection expressing their desire. I have gotten the same phone calls from my magistrates back home. It is dangerous out there. I said, "Buddy, try standing next to a gas pump when somebody fills up and they look at you and know you ran the transportation bill." I do not want to hear, I do not want to hear how dangerous it is. Mr. Speaker, no disrespect toward our MDJs at all, I happen to know that as a substation of our police departments, they are worried about their safety; we do not have cops in our offices.

The gentleman's amendment is correct. Please vote in favor. Thank you.

The SPEAKER. Representative Bill Kortz, on the amendment, sir.

Mr. KORTZ. Thank you, Mr. Speaker.

Mr. Speaker, I rise to oppose this amendment. Several of the other chairmen have already voiced concerns about safety, and that is exactly right. Let us face it, Mr. Speaker, we are not putting people in jail. These magistrates are putting some of these folks into jail, and there is retribution. It is a different day and age out there now. It is very different out there. Can you imagine being a district justice, going into a home, and maybe it was not that person but maybe it was a brother or maybe it was a cousin, you do not know what can happen.

So it is about safety. Let us do the right thing. Let us vote this amendment down, and let us move this bill because it will kill the bill if we amend it the way it is. It is time to move the bill. I would ask everybody to oppose the amendment.

Thank you, Mr. Speaker.

The SPEAKER. Representative Bryan Barbin.

Mr. BARBIN. Thank you, Mr. Speaker.

I oppose the amendment for a slightly different reason. When you are a magistrate, you are dealing with 10,000 or less people. When you are a magistrate, you are running every 6 years, but we are trying to take politics out of the judiciary. This is the minor judiciary, but they do send people to jail. And even the people they do not send to jail, the drug epidemic is being played out for the most part in the magistrate's office. Do you really want a judge who is not supposed to be in politics to be going into somebody's house whose brother just happens to be addicted and owns a weapon? I do not.

I think we should vote this amendment down. We should run the bill because there is a need, and I ask for everyone to oppose the amendment.

The SPEAKER. Representative John Maher.

Mr. MAHER. Sometimes we offer amendments to improve legislation. Other times amendments are offered to illustrate what a bad idea the underlying legislation is. I think the purpose of this amendment is to illustrate what a bad idea the underlying bill is. And I do think it would be a bad idea for legislators just to file a certificate just because they are incumbents.

Then to those who are concerned about the politics in a judicial race, well, maybe we ought to prohibit them from using signs or advertising. No politics. I do not know. I do not get it. I think it is a terrible idea. I think it is an unequal approach to electing. And I actually hope the maker of the amendment, having made his point so well, may consider withdrawing this amendment and we can carry on.

Thank you, Mr. Speaker.

The SPEAKER. Representative Pashinski, on the amendment. Mr. PASHINSKI. Thank you very much, Mr. Speaker.

I rise in opposition to this amendment. There are a lot of great points that are being made here today, and let us offer a few more.

First of all, when we have discussed the possibility of having our city employees live within their city in order to help with the tax structure, it has been time and time again where we have said firemen are considered heroes within the territory they cover and living within that city would be appropriate. Those public service officials that live within the city that take care of our garbage and clean our streets and so on would be appropriate because they do their work. The policeman has been given the pass to say, you know what, we want to make sure you have the opportunity to protect yourself, your family because of the fact that you administer punishment, you are law enforcement, and all the good that you may do can be misinterpreted by so many people that are the result of that punishment.

A district justice faces the same kind of issue. When they first run, it is appropriate for them to gather their name just like we do, but after they have been there for 6 years and they have administered punishment time and time again, they are in jeopardy and many of them fear for their family as well as themselves.

I would hope that this body reconsiders it and votes "no" on this amendment.
