#### CONDOLENCE RESOLUTION

WHEREAS, The House of Representatives of Pennsylvania wishes to honor the memory of Karen S. Coates, Esq., who passed away at the age of fifty-five on January 17, 2019; and

WHEREAS, Born in Philadelphia, Ms. Coates was the daughter of Carmella Breen and the late Richard Smith. Salutatorian of Bloomsburg High School, she graduated Cum Laude from Bloomsburg University and Cum Laude from the Dickinson School of Law, where she was notes editor of the Law Review. Ms. Coates was admitted to the Pennsylvania Bar Association in 1988 and, in March 2007, began her tenure as Chief Legal Counsel to the Judiciary Committee of the House of Representatives of Pennsylvania. In December 2010, she became Director of Legislative Affairs for the office of the Majority Leader of the House of Representatives, a position she held until January 2015, when she assumed the position of Chief of Staff and Chief Counsel to the Speaker of the House of Representatives, Mike Turzai. ; and authorizing the transfer of title for certain Project 70 lands owned by Lehigh County to Whitehall Township, Lehigh County. Amend Bill, page 5, by inserting between lines 13 and 14 Section 2. Lands to be transferred to Whitehall Township, Lehigh

County.

- (a) Authorization.—Under the requirements of section 20(b) of the act of June 22, 1964 (Sp.Sess., P.L.131, No.8), known as the Project 70 Land Acquisition and Borrowing Act, the General Assembly hereby authorizes the transfer of the title for a portion of the Project 70 lands owned by Lehigh County, known as the Jordan Creek Parkway, which are more particularly described in subsection (c), to Whitehall Township, Lehigh County.
- (b) Project 70 restrictions.—The lands described in subsection (c) shall be transferred with all existing restrictions currently imposed by the Project 70 Land Acquisition and Borrowing Act upon conveyance of the lands to Whitehall Township, Lehigh County.
- (c) Property description.—The parcels of land to be transferred with existing Project 70 restrictions are located in Whitehall Township, Lehigh County, and are more particularly bounded and described as follows:

#### (1) Parcel 45.

All that certain tract of land located along Jordan Creek North of Pennsylvania State Highway (U.S. Route 22, L.R. 771) in the second ward of the Township of Whitehall, County of Lehigh and Commonwealth of Pennsylvania, being bounded and described as follows:

BEGINNING at a point in the line dividing lands now or late of Michael Puchyr and Mary Puchyr, husband and wife, and D.S. Sausman Enterprises, Inc., and in the northern right-of-way line of Pennsylvania State Highway (U.S. Route 22, L.R. 771), thence along said right-of-way line south 72 degrees 02 minutes 55 seconds West, 261.96 feet, crossing Jordan Creek to a point, thence along land now or late of the Township of Whitehall, North 0 degrees 21 minutes 45 seconds West, 96.77 feet to a point, thence along lands now or late of Horace E. McCready and Ruth A. McCready, husband and wife, and in and along Jordan Creek the three (3) following courses and distances:

- 1. North 12 degrees 40 minutes 45 seconds West, 455.00 feet to a point,
- 2. North 5 degrees 34 minutes 15 seconds East, 220.00 feet to a point, and
- 3. North 22 degrees 39 minutes 20 seconds East, 1270.69 feet to a point,

#### STATEMENT BY MS. McCLINTON

The SPEAKER. Representative Joanna McClinton is recognized to speak on HR 55.

Wait. I am going to ask all members to please take their seats.

Ms. McCLINTON. Thank you, Mr. Speaker.

And thank you, colleagues, for unanimously supporting HR 55.

You have nothing to fear but fear itself; you have nothing to fear but fear itself; you have nothing to fear but fear itself unless you are an African-American during the civil rights movement riding public transportation. Can you imagine being an American with no rights, not even rights to occupy the bus you paid a ticket for? Can you imagine knowing that your simple everyday routine of just riding public transportation has the potential to end your life?

Well, the truth is there is no reason to imagine any of this anymore because that was an everyday reality on December 1, 1955. You see, on that day one brave woman decided that despite the fact that she was a woman – no; excuse me – an African-American woman, she would not give up her bus seat. That woman was Rosa Parks.

I wonder what it must have been like for her on that day sitting on the bus staring life or death in the face, trying to maintain her composure and dignity, and getting disrespected from not only other passengers but even the bus driver. Imagine knowing how little your life mattered, knowing that there would be no one, a man or a woman, who would be able to protect or support you and that you would have to stand alone, even though there were people on the bus you knew; that you had no inalienable right that would be honored or protected; knowing you would face fear, be degraded, humiliated, possibly raped, beaten, physically assaulted, unable to defend yourself; no true right to the freedom of speech; no right to deny your seat to a fellow passenger.

I wonder what kind of bravery it takes to be able to do that, and do I have that type of bravery in me? I wonder if you have that type of bravery in you. Or is it in all of us? Do we have what it is to do what is right when we are faced with these types of defining moments?

Mrs. Parks would later say, "God has always given me the strength to do what is right. I have learned over the years that when one's mind is made up, this diminishes fear; knowing what must be done does away with fear." This is where she found her strength and her bravery.

Today and every day I am thankful that Rosa Parks had it in her to do what was right despite having to face fear, humiliation, and vulnerability. She said, "No, I will not move." And in doing so, she sparked what would be known as the Montgomery Bus Boycott, a yearlong protest from December 5, 1955, until December 20, 1956, in which African-Americans refused to ride city buses in protest of segregated seating. The boycott galvanized the city of Montgomery, the State of Alabama, and this United States of America, along with rocking the world. Her act of bravery would lead to the Supreme Court's decision that declared segregation on buses unconstitutional and would become the seminal event that would spark the civil rights movement.

The beauty of the story and this defining moment of history and this master class on bravery is that Rosa Parks is not that much different from you or me. She possessed no superhero powers, no advanced degrees, was not wealthy, no one was standing behind her to support her in that moment. She was just an African-American woman who had been pushed as far as she could be pushed, and she was not going to take it anymore. So on that day she took a stand not only for African-Americans but people from around the world who deserve rights to live in a

society that honors the fact that we are all in fact people. Rosa Parks was one of those rare people who could identify a vision and take action on it.

It is for this reason that I am asking all of you to join me in celebrating the life and the legacy, the bravery of the mother of the civil rights movement, Mrs. Rosa Parks. Let us not forget that there is still work for us to be done right here in the Commonwealth of Pennsylvania. Women who are here working hard in the House of Representatives, women who are home taking care of their households, women who are on the workforce, women who are currently in school, women across the globe, we must not be afraid to fight – fight for equality in education, fight for equal access to the ballot, fight for equal pay, and fight for equal rights. We must fight discrimination in every form so that no one has to be discriminated against based on the color of their skin, the country they are from, how they identify, or whom they love.

Thank you all for being brave and honoring Rosa Parks with me on today.

The SPEAKER. Representative McClinton, thank you.

HR 55 was passed unanimously, and I would say that each and every one of us stands strong with you in remembering this great American, Rosa Parks. Thank you.

#### STATEMENT BY MR. NELSON

I am hopeful this resolution will raise awareness across the State for those families who have a child suffering from CHD.
