Mr. CRUZ called up HR 449, PN 2454, entitled:

Mr. CRUZ. Thank you, Mr. Speaker.

Mr. Speaker, to your left, for the folks that do not know, my Senator from the 2d Senatorial District in Philadelphia, Senator Christine Tartaglione, is here accompanying us today. Thank you, Senator.

Margaret Tartaglione, the mother of Senator Christine Tartaglione and Renee Tartaglione, was a lifelong public servant until her passing on July 9, 2019.

Known affectionately as Marge, Tartaglione was ahead of her time. A woman with strength and a political matriarch in the Philadelphia old school called the old boys' club, she was a force to be reckoned with, exuding power and she broke down barriers, ultimately opening doors for other women in politics. In her more than four decades in politics, she was a true example of a public servant and worked tirelessly for her constituents, ensuring that they had a fair avenue to vote.

Tartaglione won her first Philadelphia citywide race as commissioner in 1975. Overseeing the city's election for nearly four decades, Tartaglione served the longest tenure of any commissioner since the office was formed in the 1850s. In addition, Tartaglione served as the Democratic ward leader for the 62d Ward until her passing.

It is my honor to introduce this resolution, because with its passage, the memory of Marge Tartaglione and her contributions will always be etched in the Commonwealth's legislative record. And I ask my colleagues for an affirmative vote on this resolution.

She is today surrounded by her many family members who have come here to wish her well on her retirement. It is so well deserved. Cuppy, if you do not mind standing again because I want to – I think I am going to have all of your guests. I hope I do. And if I do not, I am going to ask you to just tell us so that we can make sure everybody knows who is here.

JoAnne, your roommate. Where is JoAnne? JoAnne, thank you so much, dear, for being with us on this special day. Daughter, Amanda. Where is Amanda? Amanda, holding that the beautiful baby. Is that Jayla that you are holding? Granddaughter, Jayla. Your son, Matthew. Where is Matthew? Matthew, thank you, my good friend. Daughter-in-law, Katelyn. Katelyn. And they have with them today Liam and Lilly. Thank you so much for being here. Cuppy's brother, Mark. Where is Mark? Mark, thank you for being here. Sister, Candy. Candy, thank you. You can remain standing if you want. Brother-in-law, Steve; sister, Jennifer; and good friend, Bill. And we especially welcome Cuppy's father, sitting right next to her there, Raymond Shugars, who, as many of you know, is a retired and well-known district justice who has served Susquehanna Township and Penbrook. Thank you, Judge, for being with us today.

We want to take a moment to honor the memory of Cuppy's late mother, Alverta, who was instrumental to Cuppy making a career in the House of Representatives. There is no doubt she would be so proud of you and the service that you have provided the Commonwealth of Pennsylvania and this great body.

Thank you for your tireless and highly reliable source of support for members and staff for over three decades; always so gracious to me in my role as Speaker or majority leader or as member. I know each and every one of you have had the same experience.

I watched Aaron Angelo, here today, pitch 10 out of the 18 innings in those 3 games, and watched the team play and not give up to make Cumberland County and this community proud. Cumberland County is incredibly proud of these boys and their outstanding coaching staff.

- (e) Report.—On or before the second March 30 of the effective date of this section, and every subsequent March 30 thereafter, the department shall submit a report to the chairperson and minority chairperson of the Community, Economic and Recreational Development Committee of the Senate, the chairperson and minority chairperson of the Commerce Committee of the House of Representatives to include, but not be limited to:
 - (1) the number of properties, by county, on the registry during the previous year;
 - (2) the number of times the registry has been accessed in the previous year;
 - (3) any perceived achievements during the prior year;
 - (4) the plans for the upcoming year to improve processes and procedures; and

RECONSIDERATION CALENDAR

The SPEAKER. Members, please turn to your reconsideration calendar. Please turn to the reconsideration calendar. HB 1055 was defeated on April 30 of 2019, and on May 1, 2019, Representatives Cutler and Benninghoff, the leader and whip, the majority leader and majority whip, moved that the vote by which HB 1055 was defeated on April 30 be reconsidered. It is on the reconsideration calendar. It is HB 1055, PN 1407. The clerk will read a summary of the bill, and then I will bring up the motion. I just want everybody to know what the bill is about.

HB 1055 RECONSIDERED

The SPEAKER. So we have the motion to reconsider in front of us. I believe it is only the leaders, but let me just make sure about this.

At this time I am going to call upon the two leaders.

On the question,

Will the House agree to the motion?

The SPEAKER. The majority leader, I will start with you first. Bryan Cutler on the motion to reconsider, sir.

Mr. CUTLER. Thank you, Mr. Speaker.

Mr. Speaker, very briefly. Upon original consideration of this bill, I believe that there were several key components that were not necessarily explained in a way that all of the members fully understood the advisory nature of this bill. There was a lot of discussion regarding the office, and the office has created both, one, sunset – so it is not permanent and we can evaluate the job that it does – and two, and more importantly, it would simply make recommendations to us as a legislative body to look at regulations and laws that might need repealed.

Given that new information, I would like the opportunity to debate that underlying bill in the hopes of advancing it to the other chamber.

Additionally, Mr. Speaker, I would also point out that we, ourselves, as a body have already undertaken a large amount of repealer bills repealing outdated laws. We had nearly two dozen that have already passed this chamber, and this proposal would simply enhance our ability to do that – very similar to the two dozen that we already have preloaded again for the fall session.

I would urge support of the motion to reconsider so that we can debate the underlying bill.

Thank you, Mr. Speaker.

The SPEAKER. Thank you, sir.

I am going to call on the Democratic leader.

Representative Samuelson, typically on the motion to reconsider, we use the leaders, but do you want to speak on this? If you do, I will call you right now before the leader. Okay. He waives off.

Democratic leader, Frank Dermody, on the motion to reconsider.

Mr. DERMODY. Thank you, Mr. Speaker.

As you may recall when we voted this bill originally, what this bill does is create a whole new, unnecessary bureaucracy that will do damage and kill our regulations to protect our environment, protect our health care, protect the people of Pennsylvania. I urge a "no" vote on the motion to reconsider.

BILL ON FINAL PASSAGE

The House proceeded to consideration on final passage of **HB 1055, PN 1407**, entitled:

An Act amending the act of June 25, 1982 (P.L.633, No.181), known as the Regulatory Review Act, further providing for definitions and for existing regulations; and establishing the Independent Office of the Repealer and providing for its power and duties.

On the question recurring, Shall the bill pass finally?

The SPEAKER. On the bill, Representative Steve Samuelson. Mr. SAMUELSON. Thank you, Mr. Speaker.

I rise in opposition to this bill, as I did back in April. I direct your attention to the fiscal note for this legislation. It is right on your computer screen. You can call it up. It is only a couple of pages long. Just look at the cost of this bill. I know the majority leader said that this is the kind of bill that could sunset at any time. My concern is when you read that year 1 is going to be about \$650,000, and then year 2 is going to be \$783,000 – that is not sunsetting; that is an escalating cost that goes up every year, unless it is one of those sunsets at the North Pole where the sun never goes down. My goodness, look at those numbers; look at those numbers.

You will find that this is an office – I think we were told by the prime sponsor back in April that this is about 2 1/2 people. There is going to be an executive director, a deputy director, maybe a professional support staff – 2, 2 1/2, 3 positions. How in the world do three positions in Pennsylvania State government cost 650,000?

Now, I know sometimes members of the majority party portray themselves as fiscal conservatives, but then read the next sentence. This fiscal note, which, by the way, was written by the majority party's Appropriations staff. So yes, your own staffer wrote this fiscal note, "...\$105,000 for furniture, equipment, and a...website...."

First of all, if it is only three people, why do three people need \$105,000 worth of furniture? Your constituents would say that is obscene. Your constituents would also ask why could they not use some used furniture that is available within the Pennsylvania State government? Why do they need the top of the line? Why do they need to outfit their office as the Taj Mahal? I thought this

office was supposed to be about repealing and reducing State government, but instead, this office is a built-in growth to State government.

Do not take my word for it; take the word of the Republican staffer who wrote that fiscal note. Six hundred – let me get the right number – \$695,000 for the first 9 months, and that includes \$105,000 for furniture, equipment, and a Web site, and then the second year, \$783,000. I have a prediction to make, if you pass this bill, if this bill becomes law, it is going to grow to \$1 million in year 4 and it is going to be here forever. We do not need this additional bureaucracy.

By the way, the work of this repealer, the Office of the Repealer, is also described as completely advisory. So if the power to repeal laws remains with the General Assembly, why do you need to spend almost \$1 million on an adviser – \$695,000 year 1, \$783,000 year 2? We do not need this kind of spending in State government. Vote "no" on HB 1055.

The SPEAKER. Does anybody else wish to speak on HB 1055? I have the majority leader.

The majority leader, Representative Bryan Cutler.

Mr. CUTLER. Thank you, Mr. Speaker.

I certainly appreciate the good gentleman's passion regarding the issue, but I would encourage him to read a little further into the bill. In fact, the bill does specifically sunset. On line 18, it says that "This act shall expire June 30, 2025." So we can have an opportunity to see the value add that we can have regarding many of our duplicative efforts regarding regulations and laws. I believe we owe it to our constituents to evaluate that because that is what they expect us to do.

I would urge a "yes" vote for the underlying bill because it will streamline government and make Pennsylvania more appealing to individuals who want to locate here and raise their families here and have family-sustaining jobs here.

Mr. Speaker, there are a whole host of regulations that are constantly in conflict. I saw it myself with a young couple who came to speak to me at our local fair. They are trying to build a home and a garage and an oversized workshop. They are \$80,000 into planning for storm water management and a whole host of other overlapping regulations in all very important issues; however, we can never have a real discussion about affordable housing when we are spending \$80,000 in governmental compliance.

Mr. Speaker, this position will help us cut through that red tape. I believe our constituents deserve it. I would urge a "yes" vote.

The SPEAKER. The minority chair, Representative Matt Bradford, has requested to speak, and the majority Appropriations chair. Representative Saylor, is that okay? Okay. So at this time I call upon Representative Matt Bradford, who is the Democratic Appropriations chair, to be followed by the majority Appropriations chair, Representative Stan Saylor.

Representative Bradford, please proceed.

Mr. BRADFORD. Thank you, Speaker Turzai.

I appreciate the will of this body to reconsider HB 1055, but I do not appreciate their understanding of the appropriateness of spending \$105,000 on furniture, equipment, and the development of a Web site. In April of this past year, this body spoke clearly and defeated this bill for one simple reason: it was wasteful. We can only talk about being fiscal conservatives if we act in such a way. I do not know about you, but I am not going to go to Restoration Hardware to buy \$105,000 of office furniture.

Now, if this good body thinks it is appropriate in its wisdom to go to, I do not know, the King of Prussia mall and go check out what \$105,000 in furniture for three employees looks like, I would like to see us put this vote up. I would like people to switch and decide that the wisdom they had in April is not the wisdom they have in September. Ethan Allen will be happy to see the Republican majority show up, but the people of Pennsylvania would be happy to know that in this bill, those who would talk about defending the environment will find that there is a requirement that those people sitting at that Queen Anne Furniture, that fancy \$105,000 worth of office furniture, their job, their charge is to rescind two regulations for every one that is promulgated in the future.

Now, let us say there is an epidemic with an issue like PFAS (polyfluoroalkyl substances). Maybe we are going to need some regulation, maybe we are going to need to have some environmental controls, maybe we are going to need regulation because the Office of Repealer is spending \$105,000 on office furniture. I think there is an appropriate role for good regulation in Pennsylvania.

I think HB 1055 is a bad idea. I think spending \$105,000 on office furniture is insane, and I think reconsidering HB 1055 and reversing the will of this body is foolishness.

Thank you, Mr. Speaker.

The SPEAKER. The majority Appropriations Chair, Representative Stan Saylor.

Mr. SAYLOR. Thank you, Mr. Speaker.

I have heard a lot of exaggerations here today on this bill. First of all, Queen Anne Furniture? I do not know that any of us have Queen Anne Furniture in our offices here. First of all, we have a lot of unused furniture that the Governor has, the House has, the Senate has. There are any number of ways to cut costs in this program. The figures we used, by the way, were the rate that the Governor pays his employees, not the rate that the House of Representatives pays its employees.

So it depends how the Governor decides to structure this office, but we have laid out the fact that this repealer would save the Commonwealth of Pennsylvania millions of dollars by getting rid of laws that are on the books that cost us dollars every day in our law books and everywhere else.

Mr. Speaker, this is a commonsense bill that the people of Pennsylvania expect the legislature and the Governor to look at antiquated things in this Commonwealth and clean it up, so that the laws of this Commonwealth are not so confusing to our prosecutors, to the people who everyday use our regulations.

We sit here every day, Mr. Speaker, and talk about cost. If you are going to get cost under control, we need the help of somebody who can spend full time looking at things that need to change. We talk about transparency. This bill brings transparency to the taxpayers of Pennsylvania. I realize here in State government sometimes the words "common sense" are lost on all of us, but this bill is a commonsense approach to cleaning up the things that over the years have been duplicative, that are outdated, and cost many of our taxpayers millions of dollars because we have not changed the way we have done business in 50 years.

So I ask you to do the commonsense thing and help save the taxpayers of Pennsylvania millions of dollars by passing this piece of legislation. This is a small price to pay to save millions and millions of dollars.

Thank you, Mr. Speaker.

The SPEAKER. And for the second time, the Democratic Appropriations chair, Matt Bradford.

Mr. BRADFORD. Thank you, Mr. Speaker.

I am still not convinced on HB 1055. Chairman Saylor says that we need this bill to, quote, "bring costs under control," and there have been a lot of misstatements about HB 1055. So I am going to read from the fiscal note prepared from the Republican majority's office. "FISCAL IMPACT" — this is a direct quote — "The enactment of this legislation will have estimated total first year costs of approximately \$695,000, including one-time costs of \$105,000 for furniture, equipment, and the development of the required website and tracking system...." That is plain English. And that is the exact quote from the fiscal note that was prepared from the Republican majority.

I would question whether we should in any way – and I know and like the chairman very much, but the plain English is so clear. It is so compelling. It is so obvious that I think we do ourselves a disservice to say it says anything else than it is going to cost \$105,000 for furniture and a Web site. And I think if we are being honest, that this is not a good bill, and I think if we read the bill, we would find that on September 1, we were supposed to hire an ED (executive director) under this bill. Well, obviously, September 1 has come and gone. This bill is out of date.

Now, I know that there are those that want to push it through, and when the majority does not get its way it is great to do a motion to reconsider, but this is embarrassing to the Commonwealth. If we say we are going to cut costs, how can we do a 180 on an Office of Repealer bill that we know is going to waste \$105,000 as its first act? How can we vote for a bill that is major's charge, its charge in statute is to repeal two regulations for any one and future promulgates.

This was a bad idea in April. It is a bad idea in September. The fiscal note said what it said in April when it was defeated, and it says the same thing now. I would encourage us to, again, in a bipartisan and resounding way, defeat HB 1055.

Thank you, Mr. Speaker.

The SPEAKER. And the majority Appropriations chair, Representative Stan Saylor, for the second time.

Mr. SAYLOR. Thank you, Mr. Speaker.

Again I want to reiterate, our fiscal note says what it says, but our fiscal notes do not go into projecting how many millions of dollars are saved by spending and doing a bill like this because it is tough to estimate dollars on how much we would save, but all of us know in this General Assembly, all of us know in this General Assembly about the antiquated laws. Democrats and Republicans have stood on this floor and talked about the antiquated laws in any number of any of our agencies and departments. We have talked about antiquated regulations. Those things cost businesses and taxpayers money.

This is an investment made to save taxpayers' dollars. We did tax forgiveness, by the way. If you remember how much money this Commonwealth brought in from that. This is a similar bill that will bring in more money to the Commonwealth by the dollars it saves our taxpayers, and it saves our business community as well. This, again, is a commonsense approach to assisting the General Assembly and this Governor and every Governor after him to make sure that we are more transparent, our legislation is up to date, and we get the job done right.

Thank you, Mr. Speaker.

The SPEAKER. I have the two leaders that I am going to be calling upon. Okay, not the majority leader. The minority leader, Representative Frank Dermody, wishes to be recognized. Does anybody else? Okay.

Leader Dermody, please.

Mr. DERMODY. Thank you, Mr. Speaker.

Mr. Speaker, as I have already stated, this bill creates a totally new, unnecessary bureaucracy that will spend hundreds of thousands of dollars, as we have heard, doing away with all sorts of regulations. There is language in the bill that creates a committee to select the executive director who picks what regulations to get rid of, spends all the money. The leaders in the Republican Caucus have an appointment to that committee, the Governor has an appointment to that committee; the minority party does not have an appointment to that committee.

So you know, Mr. Speaker, you may not always be in the majority. So look, this bill is the last thing we need right now, the last thing we need to be doing is destroying our environment, destroying the regulations that help protect us. We need to vote "no."

Thank you, Mr. Speaker.

On the question recurring,

Shall the bill pass finally?

The SPEAKER. Agreeable to the provisions of the Constitution, the yeas and nays will now be taken.

BILL ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 1106**, **PN 1599**, entitled:

An Act amending the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, providing for environmental permits and plan approvals; making related repeals; and abrogating regulations.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

I am just going to go down the list right now of names. So I have the main sponsor, Representative Puskaric, then I have Representative Krueger. Okay. And we will start off with the prime sponsor, Representative Puskaric. Is that Representative Ullman? Yes, Representative Ullman and Representative Otten. Representative Boyle, sorry about that. I did not see you. I apologize. And Representative Vitali. If I am missing anybody, just tell one of the – you know either on the Democratic side or the Republican side that you want to speak and I will make sure to get it listed.

Representative Mike Puskaric is recognized on HB 1106, PN 1599.

Mr. PUSKARIC. Thank you, Mr. Speaker.

This legislation aims to give predictability to our business climate here in Pennsylvania by streamlining our Department of Environmental Protection permitting process. It also helps to strengthen our environmental protection and enforcement here in the Commonwealth by moving our labor force from the Department of Environmental Protection from simply just accepting paperwork to actually enforcing our laws and codes that are on the book. I respectfully ask for a "yes" vote. Thank you.

The SPEAKER. Representative Krueger, on HB 1106, PN 1599.

Ms. KRUEGER. Mr. Speaker, I rise in opposition to HB 1106. Today is a bad day for the environment in this chamber, and today is a bad day for workers. A few minutes ago, in a sneak attack, we were forced to revote a vote that died on this House floor in April by a vote of 100 to 97.

POINT OF ORDER

Mr. CUTLER. Point of order, Mr. Speaker.

The SPEAKER. Yes; yes.

Mr. CUTLER. I appreciate the gentlelady's passion, but I would encourage her to read the rules and actually understand the procedure that we did. I believe she is far afield of the underlying issue of the bill and should stay focused on that.

The SPEAKER. Representative Krueger, we did pass 1055. It was in adherence to the rules passed by this chamber at the beginning of the session consistent with past rules. And at this time, if you could speak on HB 1106, we would ask you to please do so.

POINT OF ORDER

The SPEAKER. And the leader; Leader, do you have a point? You may proceed. Point of order, sir.

Mr. DERMODY. Yeah, Mr. Speaker.

The gentlelady is speaking on the same issue and for the same reasons on the environment that we just went through, and they are all related and it is a part of an argument on the floor that is proper, and I believe, you know, the gentlelady voted on the rules and I am sure she read them.

The SPEAKER. Hey, what I would like is if everybody could please take their seats. Please take your seats. Everybody is entitled to be heard. Please take your seats.

And to the Democratic leader, my only point as Speaker is just this point: the majority leader raises that if there are any concerns with the rules with respect to any prior bills, they would have to be raised at that time, and that could have been done. In fact, we had significant debate on both the motion to reconsider and the vote of 1055 itself. We do have in front of us 1106.

Representative Krueger is entitled to be heard. She has a perspective. She is entitled to be heard, and I am asking members to please take your seats, and I do have a number of members that wish to speak on this.

Representative Krueger, you may proceed.

Ms. KRUEGER. Thank you, Mr. Speaker.

The decisions that we make on this floor have the potential to roll back environmental regulations that keep our air clean, our water safe to drink, and our children safe. And now before us, after that last vote that somehow went from a vote of 100 to 97

to 103 voting for it, Mr. Speaker, we have HB 1106, which will ram through weak and deficient permit applications because the Department of Environmental Protection does not have enough staff to get through every permit application in 30 days.

Mr. Speaker, in my district in Delaware County, we have seen firsthand what happens when a permit is approved before it is ready, Mr. Speaker. We have seen pipeline accident after pipeline accident. In nearby Chester County, we have seen private wells destroyed, and I believe that the DEP needs to take their time so when an environmental permit is approved, we know that people will be safe in the surrounding neighborhoods.

Mr. Speaker, HB 1106 is opposed by environmental groups, but it is also opposed by our brothers and sisters in organized labor. This is taking away an important decision from a regulatory body that needs the time to do its homework. Mr. Speaker, I hope that we can stand up and for once make a good decision for the environment on this House floor and not a bad one. I will be voting against HB 1106.

Thank you, Mr. Speaker.

The SPEAKER. Representative Cris Dush.

Mr. DUSH. Thank you, Mr. Speaker.

A couple points I want to bring up about this bill. First of all, the "deemed approved" language; currently in the States of Vermont, California, and New York, this is actually law. California, one of the most progressive States with environmental regulations and rules, it is deemed approved. And I will read the language from California. The California Permit Streamlining Act requires local governments to approve or disapprove a variety of permit applications within specific time periods. Failure to approve or disapprove results in a permit being deemed approved.

Now, if New York and California, in particular, and Vermont are receiving good results as a result of this, then— It just astounds me that people are against this, especially when the people who are against this also have folks back in their district whose homes are suffering when they are trying to build a home, their schools are suffering when the schools are trying to get built or additions done to them, when their townships and their boroughs and their cities are trying to get things done for the municipal governments. And let me tell you how pervasive it is. We knew that it was this bad, and in fact this was referred, an examination of it was referred to the bicameral Legislative Budget and Finance Committee's team of auditors, and this is what they found: "Total staff resources for DEP and the..." County Conservation Districts "for both Chapter 102 and Chapter 105 averaged 303..." Full Time Equivalents "and the number of FTEs increased by 3 percent during the review period. Staffing levels for DEP averaged 109 FTEs and increased by 3.6 percent while staffing for CCDs averaged 194 FTEs increased by 2.6 percent. Total expenditures for DEP and the CCDs averaged \$14.8 million per year, increasing by 12.4 percent over the review period...."

Now, let me tell you what we got for that. While the DEP had a 3.6-percent increase in staff, we got a thousand fewer permits done. Conversely, with the County Conservation Districts, with only a 2.6-percent increase, they had an increase in the number of permits that were approved. DEP has been failing.

One of the things that was brought up during the committee hearings was that, well, let us give it 30 or 90 or 180 days, give the DEP a chance to fix this. Well, several years ago when we were trying to merge five different departments together, there was not a single Secretary that understood what Lean or Six Sigma was. They were trying to create what in effect would have been a Fortune 100 company with no idea how industry does that or even the Federal government. That put a brake to it. The Governor rightly said, okay, we are going to institute a Lean program. DEP has not done that. Well, they say they have started the process, but that was 3 1/2 years ago. So if the department has not started down this road towards fixing this problem for 3 1/2 years, and in fact their e-permitting program to make this stuff streamlined and better efficient still has not been rolled out yet - 3 1/2 years; 90 or 180 days - this department is not going to do it. We have to do something important and significant.

The previous speaker said about rolling back regulations. Those regulations have the force of law – the force of law. It has been since Woodrow Wilson's time that we started delegating that authority to these bureaucrats, but it is time we started taking that authority back to this body and started promulgating the things that have the force of law that do protect the environment. That was another thing that came out of this report – again, bicameral, bipartisan; Democrats, Republicans; House, Senate were both lambasting the Secretary on this – they cannot even prove, according to their mission statement, they have nothing to prove that what they are doing protects the environment, or the health, safety, and welfare of the people of the Commonwealth of Pennsylvania.

It is high time we started holding these folks accountable, and this bill is the first step in grabbing that power back to the legislature where it belongs and starting to hold our bureaucrats accountable. Thank you.

So I am going to begin with the majority whip, Representative Kerry Benninghoff, and Representative Sainato has one as well.

Representative Benninghoff and Representative O'Mara will be first.

STATEMENT BY MR. BENNINGHOFF

The SPEAKER. I am going to begin with the majority whip, Representative Kerry Benninghoff.

Mr. BENNINGHOFF. Thank you, Mr. Speaker.

I thank the members for their attention. There is a lot going on in the month of September, but we also want to take a moment – I am joined by Representative O'Mara – as we recognize not only September 10 as Suicide Prevention Day, but Suicide Prevention Month is for the month of September. It is not always an easy topic to talk about, but it is an important one, especially for those families that consider themselves survivors and for those individuals who had ideology about it and maybe even made an attempt. It is something we need to remove the stigma about and be willing to talk about, because it is one of the most preventable causes of premature deaths, not only here in Pennsylvania, but in the United States in general. And then we know it can be influenced by many things - cultural, environmental, psychological, marital changes, job losses, or whatever else – but sadly, we lose about 129 people by suicide daily, and over 47,000 Americans. To me, that is unacceptable.

Because this is preventable, it is worth it to – like what we do in other types of illnesses and afflictions – be preventive. How are you preventive? You have got to talk about it and be willing to bring that up; henceforth, why we have Suicide Awareness Prevention Month, and again, so we can raise that awareness, reduce the stigma, and keep people informed that there is help available, and if they have concerns, to seek out counseling and help find brighter days ahead.

I will now turn the microphone over to Representative O'Mara. Thank you very much for joining us.

STATEMENT BY MS. O'MARA

The SPEAKER. Representative O'Mara.

Ms. O'MARA. Thank you, Mr. Speaker.

And thank you, Representative, for allowing me to stand up here with you today.

Many of you may have heard me talk about this, but in 2003 I lost my father to suicide. My dad was a firefighter in the Philadelphia Fire Department, and what we now know is that we lose more first responders to suicide than we do in the line of duty.

When I got elected, I realized, after researching, that we are losing more and more people to suicide every year. Since 1999 the rate in Pennsylvania has increased 34 percent, and in 2017 we lost over 2,000 Pennsylvanians to suicide. So I have decided to share my dad's story – even though for many years I was unable to – because I think having conversations like this is so important, and for the Pennsylvania Legislature to send a message to survivors and to people struggling with mental health that they stand with us for Suicide Prevention Day and suicide prevention awareness is a huge step, and I am very grateful for my colleagues for recognizing this important day and this important month.

Thank you, Mr. Speaker, and thank you, Representative Benninghoff.

STATEMENT BY MS. BOBACK

The SPEAKER. Representative Karen Boback is recognized to speak on a resolution.

Ms. BOBACK Thank you, Mr. Speaker.

Today I would like to bring awareness to the month of September as "Baby Safety Month" in Pennsylvania. In 1983 the Juvenile Products Manufacturers Association founded Expectant Mother's Day, but in 1991 it became designated that every September would be Baby Safety Month. According to this organization, injuries are the leading cause of death in children. The organization recommends securing furniture and televisions so they do not tip over and getting rid of small objects that could pose a choking hazard. In addition, it is extremely important to conduct a safety check of all toys to ensure that there are not any loose threads, strings, or missing hardware. Lastly, please make sure all baby gear is being used properly and is appropriate for the recommended age of your child.

I hope that my remarks today, as a mother and as a grandmother, will be a reminder that we must keep our babies safe and to take the necessary steps to make this happen.

As a proud veteran of the United States Navy, I have introduced a concurrent resolution to proclaim October 13 as the United States Navy's birthday in Pennsylvania. The U.S. Navy has a long and proud history. On October 13, 1775, the Continental Congress established a naval force, hoping that a small fleet would be able to offset the uncontested exercise of British sea power. Although the Continental Navy was later dismantled, October 13, 1775, remains the U.S. Navy's official birthday.

From those humble beginnings, the world's most powerful naval force was born. Over the course of its 244-year history, and with thousands of ships, subs, and aircraft manned by the most talented and dedicated sailors deployed worldwide, the U.S. Navy is second to none – and yes, Army, Air Force, and Marines, I am talking to you.

One of the best decisions I have ever made was enlisting in the Navy in 1997. Through my time serving, I learned the core values of honor, courage, and commitment, and I still live by those values today. I would not be where I am today without the Navy, and I am so proud to introduce this resolution and give the Navy the recognition it deserves.

I would ask my colleagues to please join me in supporting HR 470. Thank you.
