## STATEMENT BY MR. MOUL

The SPEAKER. On that point, the Chair recognizes the gentleman from Adams County, Representative Dan Moul.

Mr. MOUL. Thank you, Mr. Speaker.

Today I am sponsoring HR 951. I sponsored a very similar resolution last year that makes September as the official month of "Hirschsprung's Disease Awareness Month," this year, 2020. Hirschsprung's disease is a life-threatening congenital condition affecting 1 in 5,000 births, and in short, a child is born without the nerve endings in their colon, sometimes their ileum, and that does not permit the intestines to function properly which then causes all kinds of trouble.

I will not go too far in depth, but I do have to do a shout-out. Our friend and colleague, Aaron Bernstine, has a very young lady who is a constituent in his district by the name of Kyree Beachem. She was born with Hirschsprung's disease and received a small bowel replacement in 2010 and then a four-organ transplant in 2015. After a 5-year wait, her donor angel was also a Pennsylvania resident. Kyree is one of our Hirschsprung surviving heroes. You go, girl.

## STATEMENT BY MS. SAPPEY

The SPEAKER. The Chair recognizes the gentlewoman, Representative Sappey, to speak on HR 980.

Ms. SAPPEY. Thank you, Mr. Speaker.

I bring forward this resolution today in order to recognize the importance Pennsylvania and Chester County played in the fight to abolish slavery. It is vitally important that we acknowledge the sacrifice and courage of those involved in the Underground Railroad and our Commonwealth's historic role as a haven for those seeking freedom from slavery. This resolution would designate September 2020 as "International Underground Railroad Month."

Pennsylvania, particularly the southeast and the 158th Legislative District, was critical to the Underground Railroad due to its proximity to Maryland and Delaware, the relatively large former slave community, the larger local Quaker community, and the number of organized abolitionist societies here. Included among these abolitionist societies is the nation's first, the American Anti-slavery Society, founded in Philadelphia in 1833.

Thousands of free persons across the State risked their own freedom to ensure the safety and freedom of others. The efforts of these Pennsylvanians illustrate the Commonwealth's historic dedication to human rights and antislavery roots. It is estimated that a total of 100,000 slaves escaped to the North through the Underground Railroad between 1810 and 1850. In Chester County alone, approximately 132 agents operated the Underground Railroad in the early to mid-1800s, and at least 20 families in and around the 158th District and Kennett Square assisted. Chester County had a relatively large free African-American population of about 6,000 people, and the largest Quaker population in Pennsylvania.

Notable figures and leaders of the Underground Railroad include Harriet Tubman and Frederick Douglass. Harriet Tubman traveled through much of Pennsylvania during her work in the Underground Railroad, multiple times through the Kennett Square area specifically. Frederick Douglass, the former slave, distinguished author, and statesman, helped free over 400 slaves through the Underground Railroad. He gave his last speech on the grounds of West Chester University. Today Pennsylvania has 14 Frederick Douglass Institutes throughout the Pennsylvania State System of Higher Education, dedicated as educational and cultural resources for advancing multicultural studies across the curriculum and for deepening the intellectual heritage of Frederick Douglass. I have been honored to work with my friend, Dr. James Trotman, of West Chester University and the founder of the Frederick Douglass Institute at West Chester, to help bring this resolution to fruition.

Today throughout Pennsylvania, the National Park Service recognizes 51 sites and centers as part of the National Underground Railroad Network to Freedom. In Chester County, the Kennett Underground Railroad Center was founded in 1988 to preserve the heritage and engage the public about the historic abolitionists and the freedom-seekers in our area.

It is my hope that this chamber takes inspiration from the great history of our Commonwealth and from those who risked so much in the name of freedom. It is also my hope that we continue these efforts to address the human rights needs that remain here today.

Thank you for joining me in recognizing September 2020 as "International Underground Railroad Month."

## STATEMENT BY MR. HERSHEY

The SPEAKER. The Chair recognizes the gentleman, Representative Hershey, to speak on HR 958.

Mr. HERSHEY. Thank you, Mr. Speaker.

And thank you, colleagues, for unanimously supporting HR 958, which recognizes September 19-25 – that is next week – as our State "Thank a Local Farmer Week." My colleagues, you might be wondering why I chose to recognize next week in the middle of a pandemic as Thank a Local Farmer Week, but during this pandemic, due to logistical hurdles, global agriculture and food prices have risen while on-farm incomes, according to the USDA (United States Department of Agriculture), have remained stagnant here in Pennsylvania. As incomes remain stagnant even

as global food prices rise, farmers are still expected to supply our nation and our world with nutritious and abundant food.

Farmers are so vital to Pennsylvania's history and current economy. Our agriculture industry, right here in our own State, exports more than \$1 billion a year. Pennsylvania is known as a leading producer of dairy products, lumber, mushrooms, eggs, and even cattle that serve as prime breeding stock in several countries throughout the world.

The 82d District – Juniata, Mifflin, and Franklin Counties – and indeed this whole Commonwealth, boasts both small family farms and enormous agribusinesses that are critical to our State's economy. They have served us in good times and in times like right now of market disruption and economic volatility.

The 82d District itself has a number of extraordinary producers whom I am proud to call my friends. I want to thank Hannah from Village Acres for suggesting this resolution to me. But the 82d District also has a number of extraordinary producers, including the National Pig Farmer of the Year, as named by the National Pork Board; a national EPA (Environmental Protection Agency) adviser; and a number of other producers that I am proud to call my friends. These people work tirelessly to produce our nation's food supply, and I am encouraging you all to thank your local farmers — urban, suburban, rural — this week.

I hope that we can all use this coming week to take a moment to thank our farmers who work so hard 365 days a year to support the agricultural industry. I know that since this resolution has unanimous support that you are all willing to join me in doing that, and I want to thank you for supporting this resolution here today.

#### STATEMENT BY MR. WENTLING

The SPEAKER. Moving to House resolutions and comments. The Chair recognizes the gentleman, Representative Wentling, to speak on HR 976.

Mr. WENTLING. Thank you, Mr. Speaker.

Good morning, everyone. I am pleased to introduce legislation with the gentleman from Allegheny and Westmoreland Counties in support of Danny Murtaugh's 2020 election to the Baseball Hall of Fame through the Golden Days Era Committee ballot.

Murtaugh started in the major leagues in 1941, playing with the Philadelphia Phillies. When offered the chance to play for the Army baseball team, he turned it down, as he did not think it would help the war effort. He instead joined the combat infantry and spent time fighting in Europe before helping with the rebuilding efforts in Japan. After serving, he joined the Pittsburgh Pirates, but he could only play for so long until his war service ailments caught up with him. Then he transitioned into a managerial role. In his time with the Pirates, he had 1,115 managerial wins and won 2 World Series championships. Both managers Murtaugh defeated in his World Series appearances, Casey Stengel and Earl Weaver, are in the Hall of Fame.

In 1971 Murtaugh broke a barrier when he fielded an all-minority starting lineup for the first time in Major League Baseball history. Asked about it later, Murtaugh said, "When it comes to making out the lineup, I'm colorblind and my athletes know it."

Based on stats, Murtaugh certainly deserves being in the Hall of Fame. His winning percentages, World Series victories, and league pennants are equal to or better than many managers currently in the Hall. He was only 59 years old when he died on December 2, 1976. The Pirates retired Murtaugh's number, 40, on opening day the following year.

This year – the 60th anniversary of the 1960 World Series – the Baseball Hall of Fame's Golden Days Era Committee will consider candidates who made their mark in the game from 1950 to 1969. If elected, Murtaugh would be introduced into the Hall as Pirates fans celebrate the 50th anniversary of the 1971 World Series. With Danny Murtaugh's career stretching from Philly to Pittsburgh, this would be a great occasion for all Pennsylvanians, including Murtaugh's granddaughter, Colleen, who has taken such pride in her grandfather's life, she has written a biography appropriately named "The Whistling Irishman."

## STATEMENT BY MRS. BULLOCK

The SPEAKER. The Chair recognizes the gentlewoman, Representative Bullock, under unanimous consent.

Mrs. BULLOCK. Thank you, Mr. Speaker.

Last night, 55 bullets rang through my district at a local playground; 55 bullets across a basketball court. Four young people were shot, between the ages of 18 and 21, and two of them lost their lives. By some standards, we would call this a mass shooting, but it is not the first to happen in my district in just a few months.

On August 9 six people were shot at another playground just feet away from the Philadelphia Zoo: two 18-year-olds, a 17-year-old, another 18-year-old woman, a 24-year-old woman, and a 59-year-old woman. And then on August 18, a warm Tuesday afternoon at 4 p.m., five people were shot just feet away from my mother's home in the Strawberry Mansion community. In a span of a month, my community has seen three mass shootings.

I pray for my community, and I ask for the prayers of this legislative body for my community and for our city and for the families who have lost loved ones.

My boys, whom many of you have met, said to me casually this summer, "You know, Mom, we heard gunshots last night, but we didn't even bother to wake you up because we are used to it now." That is not something a mother wants to hear from her 9- and 12-year-old sons, that they are used to hearing gunshots at night. My boys walk down the street and they see candles and balloons at the corner of our block. They see candles and balloons at the recreation center. They see candles and balloons on the way to Grandmom's house, and they know that means that somebody lost their life. It is not a birthday. Candles and balloons need to mean something else to them.

I pray for my sons, I pray for every citizen of Philadelphia, and I pray for our communities as we grapple with more than 300 deaths in the city of Philadelphia, most of them due to gun violence, and I ask, I ask for your prayers, but I ask for action. I look forward to working with my colleagues so that we can do something to address gun violence, not just in the city of Philadelphia, but across this Commonwealth.

Thank you, Mr. Speaker, for allowing me this moment.

## REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. The Chair is in receipt of comments on HR 838 by Representative Maloney that have been officially submitted for the record. They will be entered in today's Journal.

Mr. MALONEY submitted the following remarks for the Legislative Journal:

Thank you, Mr. Speaker.

I rise to ask support for HR 838, legislation sponsored by myself and Representative Parke Wentling designating the month of May 2020 as "Bike Month," the week of May 11 through 17, 2020, as "Bike to Work Week," and May 15, 2020, as "Bike to Work Day" in Pennsylvania.

For me, bicycling is fun, a way to get exercise and get away from the stress of everyday life. The great thing about living in Pennsylvania is that we have so many opportunities to cycle – on a trail, a windy back road, and most of our cities have bike lane systems designed to allow folks to use bicycles as transportation.

Maybe using a bicycle as a primary mode of transportation might not be for everybody. Indeed, there are challenges in most anything we choose to do. One of the most common misconceptions about biking to work is that it is inconvenient. But what is more inconvenient than circling city blocks looking for parking, getting stuck in traffic jams, or fitting public transportation's schedule into your schedule?

Cycling is also cost-effective. In 2019 the average American household spent \$1,962 on gasoline and motor oil and \$4,394 on vehicle purchases. Add on vehicle maintenance, occasional repairs, insurance, and the skyrocketing cost of parking, and you are in the neighborhood of \$10,000 per year just to own a regular four-door sedan.

We spend a lot of time in this legislative body discussing ways to improve air quality and the environment. The transportation sector – including mass transit – accounts for nearly 30 percent of all U.S. greenhouse gas emissions, with cars and trucks delivering nearly one-fifth of those emissions. While a solo driver in an average vehicle releases about 1.2 pounds of CO2 per mile, the average cyclist releases only 0.7 grams through respiration.

There are also the benefits of staying active. A study on the health effects of cycling as mode of transportation in the United Kingdom showed that commuters who cycled to work had a 41-percent lower risk of dying from all causes than people who drove or took public transport. They also had a 46 percent lower risk of developing and a 52 percent lower risk of dying from cardiovascular disease.

But above all, we all need to be safe. Cycling, just like driving a car or riding a motorcycle, presents risks. We need to wear protective gear, and we need to be aware of our surroundings. A few years back, I got a law put in place to create a "Share the Road" license plate. The proceeds of the purchase of those plates went to help fund the office of Bicycle and Pedestrian Coordinator and promote motorist/cyclist safety.

Pedestrians crossing the street have the right of way. Motorists and bicyclists have the right to use the roads in Pennsylvania and should work to maintain a 4-foot barrier between each other when passing.

I ask my colleagues for their support of HR 838.

# FAREWELL ADDRESS BY MR. DUSH

The SPEAKER. At this time the Chair will invite Representative Dush to the rostrum. As we draw to a conclusion here and start to look towards the end of session, as is customary, we will be giving some retirement speeches. Representative Dush was kind enough to agree to go today.

He is currently serving in his third term as the Representative for the 66th Legislative District. He was first elected in 2014. He serves on the Environmental Resources and Energy Committee, Labor and Industry, State Government, and Urban Affairs Committees.

He attended Clarion State University before enlisting in the United States Air Force. In 2012, after 16 years, he retired as a corrections officer at the Pennsylvania Department of Corrections. Cris enlisted with the 193d Special Operations Wing of the Pennsylvania Air National Guard as a Security Forces member. He was deployed in Operation Iraqi Freedom, Operation Noble Eagle, and on the American border in New Mexico. He also served on the staff with the Air Force Special Operations Command. He recently served as the Chief of Information Protection at the Pennsylvania Air National Guard headquarters and units throughout the Commonwealth.

Cris resides in Pine Creek Township with his wife, Traci.

I will ask members to please come to order and please take your seats.

And I invite Representative Dush to the rostrum.

Mr. DUSH. Thank you, Mr. Speaker.

And I want to thank the members for allowing me this opportunity to offer my parting remarks, as well as my thanks to everyone who has been so gracious and kind with your suggestions and your mentorships. So many of you over the years have been a great blessing to my time here.

I really want to start out by expressing my gratefulness to two of the strongest women that I know. Traci has stuck with me through deployments and military activations that have taken me across the world from her, from Asia to the Near East, through civilian jobs that have taken me away for extended periods and made it impossible at times to schedule things for our family. Through it all, she has been a faithful partner and my very best friend.

Traci is responsible for much of the success that I can see in both of my sons. She gave everything for our sons, ensuring that she took jobs that allowed her to be there when the boys went to school and that she would be there when they came home. She was their steady rock, especially when my commitments could not afford that opportunity. Baby, I know you are not here with me today and I know you will be watching this later, and I want the world to know how blessed I am with you.

My mother is an amazing woman. When my dad broke his back working the oil rigs, she took on a job to make sure that we were cared for, that we did not grow up in want. She was there, she was my dad's rock as he was going to Clarion. He went and earned his teaching degree, and Mom continued and made sure that we were there and we had food and we just never felt like we were in want – grilled cheese and tomato soup seemed like a pretty good staple. But she worked her way up. Her dedication and work ethic helped her move quickly up through Penn Separator Corporation. She ended up as the office manager. And she always found ways to not only make things stretch, but also to make sure that we had a good time as a family.

She has a fierce, though quiet, independence, coupled with an eloquence when she speaks that I have always respected. That all showed through whenever she showed up when Lieutenant Governor Fetterman showed up in Jefferson County on his listening tour. Unbeknownst to me, she decided to show up. She got up and spoke, spoke out against what he was proposing, but he made the comment to one of the county commissioners about how well-spoken she was. And he, of course, piped up and said, that's Representative Dush's mother. Of course, I heard about it from a reporter the next day. And the Lieutenant Governor said that I had dragged her along, and I responded, "If you knew my mother, you'd know I couldn't drag her to anything or prevent her from getting to it." Mom, you have been a blessing to all four of us and our families. Thank you for who you are.

My dad was another strong character. We lost him a few days before my first primary. He used workers' comp to earn his teaching credentials in 3 years. The folks at Voc Rehab had never seen that happen before. They were so impressed. They said, "You have got to come work for us. We have more people who need to see what you are going through." From 1963 on he never knew a day without pain. He also never stopped working. He was a great role model for all of us.

Dad was also a fighter for his clients and he was a fighter against corruption. In the 1970s, there were things going on in AFSCME (American Federation of State, County, and Municipal Employees) that the social services employees were disgusted with. Dad was one of seven people who organized a decertification drive that removed AFSCME from representing the State's social services employees and created the Pennsylvania Social Services Union. He also had stories of standing up to legislators and government officials that I am not going to go into today.

I want to thank my sons, Ryan and Garrett. They have had to give me a lot of support over the years – they did not have to, they chose to. Through the military, through my civilian jobs, they suffered a lot. I mean, it was almost on the border of neglect. And yet by the grace of God, the strength of my wife and my family, they are good Christian men who have gone through college, are very gainfully employed, doing very well for themselves. One of them is in the Air Force as a pararescueman; the other one is working for Schwan's – doing very well for themselves. But they are also excellent fathers. I could not ask for a better legacy.

When it comes to achievements, I learned early on in both my civilian and military careers that nothing - and in fact, even before that when I was a member of a swimming team - nothing of significance can be achieved without a good team. In this position, I have been blessed with the best. Dianne Welsh, she was stuck in a little office in Brookville, and she had been working for the House but she was pretty much alone all day except for all the constituents who constantly poured in there. She had a reputation for being able to pick up the phone and be on a first-name basis with people around the State who knew how to solve problems for her constituents, for our constituents. Before I was even elected I told her, "If I get this office and if I'm blessed to have it, you don't have to worry about your job." In fact, my first official act was to make her the district manager, a decision I will never regret. She helped me to find the young man who became her successor when she retired. Zach, God bless you, and I thank you. You have been a steady hand and you are also very adept at coordinating things. I am grateful for what you have done.

Joanna was already there at the Punxsy office when I came in. Representative Pyle, you did a great job of getting her trained, and then she went to work for Speaker Smith and then I have been blessed with her. She is a remarkable woman who cares very much about the constituents. And so does Penny Pifer, the last we brought on for the district team. Dianne helped me find her as well. In fact, one of her former bosses told me, "If I could have had a position and I could afford her, there's no way we'd be having this conversation." Penny, you have proved it over and over again.

All of my team, they have prayed with people, they have cried with people, especially of late. I get so many compliments about how my team cares. It is so obvious. Like I said, one thing I love about my people is they are not afraid to pray, and we have never had a single person, when the need has been felt and they have asked, not a single person has said no.

One other person that deals with the district office, as I know many of you also have dealings with, is Chad Horner. Chad works for district ops, but he is also my constituent. Chad, I have no idea how he manages to take care of all our offices and keep things going the way he does. He is remarkable. He has got a huge part of western Pennsylvania that he takes care of and makes sure that everything flows well. He is, like I said, I just do not know how he manages to do it. He finds fill-ins when they are needed, and he has just been a great blessing.

I want to thank Representative Sonney for inviting me to work alongside of him in the office suite that we had in the East Wing for my first two sessions. Curt, you have been a great blessing, and you blessed me with Christine as well. Christine Crone is sitting over here. She was my first legislative assistant. District ops can tell you, I have got one of the busiest House districts

when it comes to PennDOT work and unemployment stuff and that kind of thing. I do not know how she managed Curt's caseload and mine together and taking care of coordinating all this stuff, but she has been remarkable. Thank you.

When Curt took her away with him to the Education Committee, I was worried – that is until I found out I got Carol Henry. Carol fit right in with my team and it has been a blessing, and she has been a steady influence as we have dealt with the issues, especially over the past 6 months. Thank you, Carol. I value both of your friendships, and you guys have taken care of me in a way that I just cannot say thank you enough.

Ty McCauslin is not able to be here today, but he has been with me from the beginning as my PRC. He knows my style of writing and my stance on the issues and has helped me to get my message out through news releases and newsletters, as well as on Facebook. He has helped me coordinate and publicize events and came up with some ideas for me that I had not thought of. He has been a fantastic blessing on that front.

You know, there have been in this building countless – and I do mean countless – of our committee team members who have been such a blessing to me, and if I started trying to name them, I would miss some and I do not want to do that. Just know that all of you – I miss Karen Coates, as we all knew, and Greg. We really are blessed in here with the team that we have. I do not call folks staff; I call them my team, and we have got a huge one here.

Members, Seth Grove, from my first year in office when we teamed up for the report on the Governor's spending during the impasse, the report that broke the deadlock, you have been a great mentor. Much of this body, and certainly most of the Commonwealth, have no idea how much you have saved them. You are one of those people who tries to stay in the background, digging into things that need improved and then passing the legislation and the credit on to others. I am not letting the opportunity pass to recognize that.

The members of the Common Sense Caucus - wow, what a ride. When Chairman Moul made the statement that I am going back to the Capitol and I am not going home until I find this money that we need to pay for this, there were a bunch of us that came together and really dug into the seat cushions -\$12.6 billion in 118 hidden special funds. Boy, did that have an impact. Dawn Keefer on that caucus, her nose for inconsistency and the keen ability to keep things sorted and keep us on track more than anybody, she is the one that did that – had an immense impact on our effectiveness. Seth Grove and Frank's abilities to grasp the financial intricacies, and Seth's abilities to translate Frank's technological language allowed us to take in the significance of what we were learning and to get the message out. For the sake of time, I cannot go into the whole team, but I remember each of you, and I will, and I will never forget the days.

Some people measure success in this building by the number of pieces of legislation they have had signed into law. That can be a good thing if the laws are just and serve the people. I am grateful for the members who have been so successful on a number of fronts with that. I am happy to have a stood with them and to help them pass. That is one way to fix the things that are broken.

Defensor Fortis. It is the motto of the Air Force Security Forces. It is Latin for strong defender. God has implanted in me a calling to defend. During my first two sessions in this body, it seemed that that was all I was doing. From the beginning of this

session, at least through March of this year, it has been a welcome difference.

Speaker Cutler, I want to thank you for your leadership this session, first as majority leader and now as Speaker. The very first piece of legislation I put in, having been in law enforcement and security and understanding some of the fraud, waste, and abuse that we have going on, I know that we have to provide protection for our whistleblowers if we are going to call them down here for a hearing. And I have wanted the subpoena power given to each of the standing committee chairmen. We ended up in the last session with all but three of the committee chairs on as cosponsors. And then Leader Cutler approached me and talked to me about creating an oversight committee that would have that power, and I am grateful for it, and I see us starting to make some progress there. And I see it is going to be effective, given the broad spectrum of everything that we are experiencing now. It might be worthy of expanding or at least granting to some committee chairs that authority as well so that we can dig into the things that we are seeing as a result of the court case, the things that were brought out during that court case.

Clancy, you are an institution within an institution. Your leadership up here and steadfastness and the ability to come up with some of the things that you have come up with have been just astounding. But he also has the responsibility of keeping us in line as well. I will never, I will never forget, it was during that budget impasse in 2015, I literally left the woods because I had to go out and drive on the first day of buck season – I promised my family I would drive for them – hauled my butt down here and I decided to keep the orange vest on underneath my suit and an orange tie. And I had occasion to talk on the floor, and I said that I was down here hunting for a vote. You know, Clancy, in his way, came back and just gently reminded me of the proper decorum on the floor. He has got a tremendous job, and this institution has an institution in you that you just cannot describe accurately. I will leave it at that.

We all miss Karen Coates, as I said.

Mark Rozzi, you know, we have had some back and forths over the years, but we have also had things that we have embraced in each other, both literally and figuratively. Your trip to Rome and the way you came to Christ and the way your life has been just – you are a remarkable person to have stood up in the face of evil that you experienced. And the way that once you had Christ come into you the way that He did, the change is remarkable and I think God has got some plans for you, so please stay true to him.

Bill Kortz and Harry Readshaw, God bless you. This place is going to be lacking without you as well. Thank you. You guys have been good colleagues.

The Roxy's Caucus – what a group. Sometimes called the Raucous Caucus. Right now we have got the leader, the whip, Policy chairman, and hopefully here next year we will double the Senate contingent. You guys have been great mentors, all of you, the whole caucus, the whole Roxy's Caucus. The stories have given me a perspective about this institution that I do not think anybody could have done just one on one. Listening to the discussions and the things that you guys have experienced, it did put a lot of things in context for me and I am grateful.

One of things that, a piece of advice for me is I have learned, I was told early on, "Sit down, shut up. You don't know what you're talking about," and it was in response to a question. And my response was, "I have got 64,000 bosses; there's not one of

them in this room." Now, some of you I know have some of your constituents' bosses here in the room, but for most of us, that is not the case. If I am not, if you are not asking questions, you are not serving them. If you are not digging for answers, you are not serving them. We need to make sure that we are digging and demanding answers. We cannot let people continue to say, "I will get back with you on that." We have to follow up.

In 1776 we were a unicameral legislature whose members served 1-year terms. Because of the dire situation with Britain and the fact that our leaders were putting their lives on the line, the weight of the oaths of office were especially heavy. They knew the oaths had to give those who would be entrusting their lives, who the people would be entrusting their lives to were operating government in a way that it was worthy of trust.

Chapter 2, section 10, of the Constitution of 1776 reads thus: "A quorum of the house of representatives shall consist of two-thirds of the whole number of members elected; and having met and chosen their speaker, shall each of them before they proceed to business take and subscribe, as well the oath or affirmation of fidelity and allegiance hereinafter directed...I" – and then your name - "do swear (or affirm) that as a member of this assembly, I will not propose or assent to any bill, vote, or resolution, which shall appear to me injurious to the people; nor do or consent to any act or thing whatever, that shall have a tendency to lessen or abridge their rights and privileges, as declared in the constitution of this state; but will in all things conduct myself as a faithful honest representative and guardian of the people, according to the best of my judgment and abilities." I am working on a piece of legislation to change the Constitution to reinstate that. Our current oath of office is not weighty enough on us as we are taking these seats, and I would like to see that reinstated.

There is another oath that was to be – the article continues, "And each member, before he takes his seat, shall make and subscribe the following declaration...I do believe in one God, the creator and governor of the universe, the rewarder of the good and the punisher of the wicked. And I do acknowledge the Scriptures of the Old and New Testament to be given by Divine inspiration. And no further or other religious test shall ever hereafter be required of any civil officer or magistrate in this State."

I take both of those oaths of offices. I have done it every time we have come in, in addition to the one that we have taken here on the floor. We have to remember, as the Constitution says, "WE, the people of the Commonwealth of Pennsylvania, grateful to Almighty God for the blessings of civil and religious liberty, and humbly invoking His guidance, do ordain and establish this Constitution." He is first in the Constitution. He is not unconstitutional. We have to remember the one who is the author of all civil and religious liberties.

When the Pharisees and the keepers of the law made their final challenge to Jesus, they asked Him, "Which is the greatest Commandment?" His reply is telling in that He did not just stop with that one. He said, "Love the Lord your God with all your heart and with all your soul and with all your mind. This is the first and greatest commandment. And the second is like it: Love your neighbors as yourself." Then he continued, "All the law and the Prophets hang on these two commandments." All the law. We would do well to remember those two, because with those two, I know, our State and our nation would be so much better off.

That is first principles, for those of you who do not understand. In covenant law, constitutional law, the things that come first have precedence over the things that follow. That is why our Constitution is constructed the way it is. To remember that it is the people and God at first. If we would structure the law in this Commonwealth and this nation on these two, if we were seen to live our lives as living testimonies to these two, if the people of this Commonwealth lived our lives as living testimonies to these two, the whole world would be a better place.

It has been an honor to serve this body. I thank the people of the 66th Legislative District in Jefferson and Indiana Counties for the very distinct honor they have bestowed on me to be able to serve them in this office.

I pray that this body, the legislature as a whole, the executive and judicial branches, and the people of Pennsylvania will come together loving Almighty God, whom we acknowledge in our Constitution, and loving each other. The blessings that will flow if we choose that path will allow our children to live happier, healthier, safer, and more fulfilling lives than any of us can truly imagine. I pray God bless each of you and your families, the people of the Commonwealth of Pennsylvania, and the United States of America with such blessings.
