The Sergeants at Arms will clear the conversations. Members, please take your seats. Take the conversations off the House floor.

The gentleman from Juniata, Representative Hershey, is recognized to speak on HB 664.

Mr. HERSHEY. Thank you, Mr. Interim Speaker, for the opportunity to talk about HB 664.

When I was first elected to office, I was shocked to read an article about a Washington, DC, family that was fined \$500 by their local municipality for allowing their child to operate a lemonade stand. I was more shocked to find out later that this actually happens here in the Commonwealth and that some of our municipalities have cracked down on these minor-run businesses as well.

This bill is limited in scope in it allows minor-run businesses to operate without fear of retribution from their local municipality. This bill is limited in scope; it does not affect any licensure- or health- or agriculture-related issues, but it only affects children making less than \$5,000 in income, and it is limited to mainly summer jobs or seasonal employment. But the short-term jobs that these kids have and the businesses that they start benefit them for a lifetime. It teaches marketing skills, it teaches bookkeeping skills, and allows our young entrepreneurs the freedom to operate.

So I am very excited to have been given the opportunity to run this bill, and I encourage my colleagues to support HB 664. I have called this the free-the-lemonade-stand bill, but this also supports our young lawn mowers, and our young snow shovelers as well. But I have been saying that when our municipalities hand our kids lemons, this is a good opportunity to allow them to not only make lemonade, but to sell their lemonade too.

So I thank my colleagues for supporting this bill and for supporting our young entrepreneurs.

The SPEAKER pro tempore. The Speaker thanks the gentleman.

The gentleman from Berks, Representative Maloney, is recognized.

Mr. MALONEY. Thank you, Mr. Speaker.

I want to thank my colleague for this tremendous bill, which I think we are mostly shocked at why we are here today even talking about lemonade. Some people have asked me some of the history, back home, as to why we are even passing such a bill. So I call this the protect Alex and Susie's lemonade stand. So in most of your municipalities, boroughs, and such, we have some elected officials who contracted third-party agencies to go out like the gestapo and to figure out who they can stop from having yard sales, garage sales, and lemonade stands. I find it hard to believe, in encouraging young entrepreneurs and having part of the American dream, that we would even be having this discussion.

So some people asked me, how did we get here? Well, Mr. Speaker, I believe our House rules require us to adjourn at 11 p.m. tonight. Is that not correct? So I am not able to go over the laws that this body has passed in the hundreds of pages in the consolidated statutes in townships, counties, boroughs. Imagine this. The Boroughs Association wants your kids to get a merchant permit to squeeze lemons. Now, you might want to drink that Kool-Aid, but I think lemons are a whole lot healthier. As a matter of fact, lemons help to treat the liver and the toxins in the liver they help to flush, and I think most of us know that there are many people who need their liver flushed. I find it unbelievable that Alex and Susie will put out a stand to help their mom with medical bills and we are going to stop that.

We have an opportunity here in this House to address property taxes. I have Alex and Susie putting a stand out to help their parents pay their property tax bill and the local gestapo drives around and stops them. I think it is high time—

The SPEAKER pro tempore. The gentleman will suspend. The Speaker would encourage the gentleman to stay on the topic of the bill, HB 664, as it relates to amending Title 53 and Title 68 to exempt small businesses run by minors from requirements to get a business license by a municipality or planned community.

The gentleman may continue.

Mr. MALONEY. So, Mr. Speaker, I will keep to supporting Alex and Susie and their squeezing of lemons to help their parents in this tough time and/or themselves to buy a bike or whatever they might feel fit as an entrepreneur to start their own business.

Please, I would hope that this bill goes through unanimously. I would actually want to tell you of my disappointment that the bill was amended to actually limit the amount of money that Alex and Susie can take in. I find that troubling. But at least this is a start to protect them in their entrepreneur spirit. I think I got my point across. Thank you. I appreciate that.

Thank you, Mr. Speaker. I would encourage an affirmative vote.

The SPEAKER pro tempore. The Speaker thanks the gentleman.
