A CONCURRENT RESOLUTION

Disapproving the Environmental Quality Board regulations on a CO2 Budget Trading Program.

WHEREAS, The Environmental Quality Board proposed at 50 Pa.B. 6212 (November 7, 2020) regulations on a CO2 Budget Trading Program in accordance with sections 5 (a) (1) and (8) and 6.3 of the act of January 8, 1960 (1959 P.L.2119, No.787), known as the Air Pollution Control Act; and

WHEREAS, On January 13, 2021, the Environmental Quality Board approved "CO2 Budget Trading Program" Regulations (Environmental Quality Board Regulation #7-559 and Independent Regulatory Review Commission #3274) (regulations); and

WHEREAS, On July 28, 2021, the Environmental Resources and Energy Committee of the House of Representatives, in accordance with section 5.1(j.2) of the act of June 25, 1982 (P.L.633, No.181), known as the Regulatory Review Act, voted to disapprove the Regulations; and

WHEREAS, On September 1, 2021, notwithstanding the disapproval of the House of Representatives Oversight Committee, the Independent Regulatory Review Commission (IRRC) voted to approve the regulations; and

WHEREAS, In a letter dated September 1, 2021, the IRRC notified the Environmental Resources and Energy Committee of the House of Representatives that the IRRC adopted an order approving the regulations; and

WHEREAS, The Environmental Resources and Energy Committee of the House of Representatives has determined that the submitted regulations should be disapproved by the General Assembly; and

WHEREAS, The Environmental Resources and Energy Committee of the House of Representatives is reporting this resolution under section 7(d) of the Regulatory Review Act for action by the House of Representatives, which shall have 30 calendar days or 10 legislative days, whichever is longer, from the date on which the concurrent resolution has been reported to adopt the concurrent resolution; and

WHEREAS, The Senate shall have 30 calendar days or 10 legislative days, whichever is longer, from the date on which the concurrent resolution has been adopted by the House of Representatives to adopt the concurrent resolution; therefore be it

RESOLVED (the Senate concurring), That the General Assembly disapprove the Environmental Quality Board regulations on a CO2 Budget Trading Program; and be it further

RESOLVED, That, in accordance with section 7(d) of the Regulatory Review Act, this resolution constitute a bar to promulgation of the regulations.
