Each advisory council shall consist of 15 members and the Adjutant General, who shall serve ex officio. Twelve of the members shall be appointed by the Governor from a list of nominations submitted to the Adjutant General by the Pennsylvania War Veterans' Council. The Speaker of the House of Representatives and the President pro tempore of the Senate shall each appoint one member from their respective bodies to serve on each council. The remaining member on the advisory council shall be selected by the residents of the veterans' homes.
- (b) Term of office and officers.—Each member of the councils appointed from the General Assembly shall serve for the duration of that General Assembly. The eight members appointed by the Governor shall serve a term of three years, provided that the initial eight members selected by the Governor shall serve as follows: three members for one year, three members for two years and two members for three years as designated by the Governor. Each council shall organize as soon as possible and shall annually elect a president, vice president and secretary.
- (c) Removal for cause.—The members appointed by the Governor may be removed by the Governor for cause.
- (d) Quorum and time of meetings.—Six members of a council shall constitute a quorum for the purpose of conducting the business of the council. Each advisory council shall meet at least quarterly and at other times at the call of the president.
- (e) Expenses.—Members of each advisory council shall receive no compensation for their services but shall receive reimbursement for their necessary and proper expenses for attendance at meetings.
- (f) Power and duty of advisory councils.—Each veterans' home advisory council shall advise the Adjutant General as to the management, operation and the adequacy of facilities and services at their respective homes.]

Section 2. Section 1701 of Title 51 is amended to read: \S 1701. Definitions.

The following words and phrases when used in this chapter shall have the meanings given to them in this section unless the context clearly indicates otherwise:

"Adult day health care." The term shall have the same meaning as the term "adult day care" in section 1001 of the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, which is provided to an individual eligible for Federal reimbursement through the United States Department of Veterans Affairs.

"Commandant." The administrator of a veterans' home.

"Commission." The State Veterans' Commission established by this chapter.

"Éligible veteran." A veteran who meets the admissions criteria required under this chapter as established by the department.

"Nursing home." A nursing home as defined in section 1001 of the Human Services Code.

"Personal care home." A personal care home as defined in

section 1001 of the Human Services Code.

<u>"Spouse."</u> The spouse of an eligible veteran or the surviving spouse of an eligible veteran.

"Veteran." An individual who meets all of the following:

(1) Served in the Armed Forces of the United States, including a reserve component, National Guard or the Pennsylvania military forces.

(2) Was discharged or released from service under conditions other than dishonorable.

"Veterans' home" or "home." A nursing home or personal care home operated by the department for the provision of care to eligible veterans and their spouses.

Section 3. Section 1705 of Title 51 is repealed:

[§ 1705. Veterans' home hall of fame.

- (a) General rule.—Each veterans' home operated by the Commonwealth shall establish and dedicate a hall of fame to recognize and honor the military achievements of outstanding veterans who have completed honorable, active duty military service and who reside or resided in the geographic region served by the veterans' home. The area or space in the veterans' home dedicated to the hall of fame may be used for other purposes.
- (b) Selection of inductees.—The advisory council for each veterans' home shall, consistent with the guidelines established by the commission in subsection (c), nominate eligible veterans for induction into the hall of fame by the commission and perform such other duties relating to the hall of fame as approved by the commission. Any Medal of Honor recipient shall be automatically inducted into the hall of fame.

 - (2) Procedures for nomination of candidates and selection of inductees.

 - (5) Maintenance of the halls of fame.
 - (6) Duties of the advisory councils of the veterans' homes relating to the halls of fame.
- (d) Documentation.—Each eligible veteran or his or her representative shall be responsible for obtaining the documentation necessary to establish his or her eligibility from the National Archives in Washington, D.C., or the National Personnel Record Center in St. Louis, Missouri.
- (e) Centralized list.—The State Veterans' Commission shall keep a centralized list of all hall of fame inductees from all regional veterans' homes.]

The General Assembly finds that community-based and congregate residential services that may assist veterans and their spouses may include adult day health care, assisted living, home health

care, hospice care, independent living, memory care, palliative care, respite care and telemedicine.

HB 2255 addresses the practice of scholarship displacement at our Commonwealth's public institutions of higher education. Scholarship displacement occurs when a college or university reduces the amount of financial aid awarded by the institution to a student if they receive a scholarship from a private entity such as a business or a nonprofit. For example, if a student receives \$10,000 financial aid from a university and then is awarded \$5,000 from a private scholarship, the university could reduce the

student's financial aid by \$5,000. Now instead of \$15,000, the student is only going to get \$10,000 to put towards their education costs.

With the increase in costs of higher education, scholarship displacement punishes students by eliminating the financial incentive of earning a private scholarship and it discourages them from seeking them out. Scholarship displacement creates a system where private scholarships provide more of a financial benefit to the college or university instead of providing that benefit to the student who earned that scholarship. That is not right. So please join me in supporting this legislation for the future of our students.

The House proceeded to third consideration of **HB 398**, **PN 372**, entitled:

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Human Services Code, in public assistance, further providing for verification of eligibility.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On that question, the Chair recognizes the gentlewoman, Representative Krueger.

Ms. KRUEGER. Thank you, Mr. Speaker.

I rise today in opposition to HB 398. I oppose this bill because of the trauma it will cause to survivors of domestic violence and their children. This bill changes current law to make a child's access to health insurance through the Medical Assistance Program dependent on the custodial parent pursuing the noncustodial parent to provide private health insurance. The custodial parent is the parent who has legal and physical custody of the children, and the noncustodial parent is the parent who the child does not live with. If this bill passes and the custodial parent is unable or unwilling to pursue the noncustodial parent, those children would lose their lifesaving health insurance.

Being a survivor of domestic violence is hard enough; this bill would make the lives of survivors harder. Pursuing a noncustodial parent means expensive legal bills. Very few domestic violence organizations are able to provide legal support for survivors in custody cases. Their legal resources are often restricted just to protection from abuse orders. So the survivor may need to hire a lawyer, and those bills add up quickly. Passing this bill means courtroom hearings where the survivor would have to be in close proximity to their abuser. Every time a survivor has to sit in the same room with their abuser, there is potential for trauma. Every time they are forced to have contact with their abuser, there is potential for trauma. Abusers are manipulative and controlling.

This requirement could easily be used as one more abusive tactic by an abusive partner who drags out their response to the custodial parent or flat out refuses to provide access to health insurance for that shared child. Yes, the maker of the bill included language that intends to exempt survivors in situations where the noncustodial parent was an abusive perpetrator, yet the problem is, this language does not go far enough. The experts on these issues, the Pennsylvania Coalition Against Domestic Violence oppose this bill because the exemption language may not provide the protection that it intends to all survivors of domestic violence. They oppose this bill, and I ask my colleagues to vote "no" today in solidarity with survivors.

Thank you, Mr. Speaker.

Mr. OWLETT. Thank you, Mr. Speaker.

I appreciate the opportunity to speak on this and to set the record straight. We adopted an amendment last time when we worked on this bill. We have done this bill several times. It actually, back in – I think it was 2017, it passed unanimously in this House without the amendment that the other side had for us to put in there. And we appreciate the amendment. We added it into the bill. We take care of the issues, and we actually had I think a great product again this time. I wish we could get unanimous support like we did back in 2017. Hopefully, we can do that today. We have taken care of a lot of the issues.

This is very basic. The State should be the payer of last resort. That is the goal of this bill, and we try to make sure the exemptions are there so that we do not interrupt service, that we take care of domestic violence issues, and that we make sure that we protect the kids that are involved in those all across the board.

So to make it very clear, you know, this bill has been run through this House several times. I would appreciate unanimous support of HB 398 so that we can make sure that we have the funds necessary in the future to help as many kids as possible here in the State of Pennsylvania.

Mr. FRANKEL. Thank you, Mr. Speaker.

I will note, Mr. Speaker, that there has been a change in this legislation which had the department – in the previous version – you know, "must" take into consideration the child's protection and "may" at this point. So it is kind of voluntary.

But you know, when my kids were little and got caught breaking the rules, they might get grounded or miss out on dessert. We dole out consequences to children sometimes to help them learn to make better choices – with mixed results. While

punishing children may or may not be an effective way to change their behavior, I think we can all agree that it is an unacceptable way to force their parents to follow the rules.

What is absolutely unthinkable is withholding a child's access to health care to try to make adults take action. This legislation does that by denying children Medicaid to punish a noncustodial parent who may be required to place children on their health insurance. To be clear, Pennsylvania's existing law already requires parents to provide coverage if it is available. Parents who seek State services are already required to seek child support. In the vast majority of cases, the noncustodial parent does not have access to quality insurance at a reasonable cost, if they have it at all. And if they do, there may be a very good reason the child is not on it. The primary parent may be fearful of relying on the other parent to pay premiums. The parent may be fearful of their child losing access to a needed health-care provider. The primary parent may be fearful of the other parent, period, as was described by my colleague from Delaware County.

With this legislation, children's access to health care is put right in the middle of a fight between adults, and that is dangerous. And that is why Community Legal Services, Pennsylvania Health Access Network, and InVision Services all agree that while the intent may be good to ensure that children are cared for, the policy itself does not work. I appreciate the intent to provide protections under the bill for some children and parents who might be harmed by the policy, but the Department of Human Services has told us that, in practice, ensuring that children are not harmed by this legislation would be expensive and difficult, costing millions and undermining any hope of savings this bill seeks to recover. Because the truth is, in most cases, these children may well be best served by Medicaid and harmed by the efforts to force them onto other plans.

Pennsylvania law already requires that parents provide health insurance for their children when they can. I cannot support legislation that uses children's health care as a way to put the screws to their parents, particularly when it is unlikely to even save the Commonwealth money. I ask you for a "no" vote.

Thank you, Mr. Speaker.

The House proceeded to third consideration of **HB 2441**, **PN 2857**, entitled:

An Act amending the act of June 29, 1953 (P.L.304, No.66), known as the Vital Statistics Law of 1953, in general provisions, further providing for definitions; and, in records, further providing for disclosure to governmental agencies.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

The gentleman, Representative Frankel, is recognized on final passage.

Mr. FRANKEL. Thank you, Mr. Speaker.

At the heart of this piece of legislation is the idea that the Department of Health is overzealous about protecting vital records, that it treats them like precious secrets and it is going to take the brunt force of legislation to pry these documents out of the department's hands. Well, if the department does jealously protect vital records, all I can say is thank goodness for that, because vital records are not just the birth and death certificates you use to get a passport; they contain full information about how Pennsylvanians are born and how they die. They hold Pennsylvanians' very private stories.

This bill originated as part of an investigation of COVID-19 deaths, but death records do not just contain COVID-19 information. They describe deaths from sexually transmitted infections, alcohol poisoning, violence, drug overdose, and even suicide – manners of death that people might very well want to keep secret. They have stories of births, including whether or not parents were married, and even information children might not have about who their parents were. Vital records include marriage records and fetal death records. It makes perfect sense that the Department of Health believes it must honor the trust of Pennsylvanians by keeping these documents private as much as possible.

When the IRS (Internal Revenue Service) or your local township supervisor comes calling, the Department of Health does not just hand them over; now they would have to. And while I believe that our government entities — whether local, State, or Federal — do generally have the privacy of residents at heart, we just saw that even the most closely guarded information out of the Supreme Court can be leaked. And once private information is publicly available, it never becomes private again — just ask the Chief Justice of the United States Supreme Court.

That is why organizations dedicated to protecting victims' information, like the Pennsylvania Coalition Against Domestic Violence, do not want to see a bill of this broad scope move forward. I understand the prime sponsor's dedication to conducting a thorough investigation of COVID-19 deaths. I want that too. With more than 1 million dead from COVID-19 in the United States, I want to know what happened in Pennsylvania and how we can prevent it from happening again, if possible. But I believe we can do so without risking the privacy of millions of Pennsylvanians.

The prime sponsor's previous language, and amendment to HB 2033, would have simply provided COVID-19 death data to the Legislative Budget and Finance Committee. I propose that we could even do one better and work with researchers who understand medical coding to get a strong sense of what actually happened. I would be delighted to work with the sponsor on legislation that would set up such a study, but I cannot vote to abandon all protections for highly sensitive Pennsylvania data now and forever in an effort to get incomplete information about COVID-19 deaths.

This legislation creates more problems than it solves, and we can do better. So I am asking for a "no" vote, Mr. Speaker. Thank you.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentlewoman, Representative Klunk, on final passage.

And I wish that I did not have to introduce this bill, but alas, we are here today because the Department of Health has refused to provide the Legislative Budget and Finance Committee, or LBFC, with certain redacted death certificate information as part of an audit they were performing of the Department of Health's COVID-19 data collection, based on a resolution that we unanimously passed here in November of 2020.

Mr. Speaker, I ask for an affirmative vote.

REMARKS SUBMITTED FOR THE RECORD

Ms. KLUNK. And I will submit the remainder of my remarks for the record.

Ms. KLUNK submitted the following remarks for the Legislative Journal:

Thank you, Mr. Speaker.

Today I rise in support of HB 2441. I wish I did not have to introduce HB 2441, but alas, we are here.

HB 2441 is the result of the Department of Health refusing to provide the Legislative Budget and Finance Committee, or LBFC, with certain redacted death certificate information as part of an audit they were performing of the Department of Health's COVID-19 data collection.

The House tasked the LBFC with the audit under HR 1087 of 2020. I would like to note that HR 1087 passed the House Health Committee and the full House unanimously in the fall of 2020.

Throughout the pandemic, there were numerous occasions where the information published by the Department of Health has turned out to be inaccurate or incomplete. This includes thousands of COVID-19 positive cases being removed from the daily totals, days where there

were significant statistical anomalies in the data, and finally, the comingling of data according to the CDC (Centers for Disease Control and Prevention).

The purpose of the audit request was to gain a better understanding of the data collection process of COVID-19 data that would be vital in helping us to gain a clearer picture of what occurred during the pandemic, and to help us determine how we as government could do better in future situations where disease mitigation is necessary.

Since this resolution passed, the LBFC has worked diligently to compile a preliminary report based on the information and data made available to them. As part of their work, the LBFC requested the Department of Health provide 100 death certificates selected by the LBFC for persons whose deaths are attributable to COVID-19, with redactions made to protect certain personally identifiable information. The DOH's chief counsel responded to this request with a lengthy letter denying this request, citing conflict with sections 805 and 806 of the Vital Statistics Law of 1953.

The department's reasoning was that the Legislative Budget and Finance Committee somehow did not qualify by law for access as an exempted purpose including either "disclosure for research" or "disclosure to federal, state, or municipal agencies of government conducting an official duty." Additionally, the department claimed that the LBFC was not an "agency of government."

Because the Vital Statistics Law does not define what qualifies as an "agency of government," the DOH chose to withhold the information requested for adequate completion of the audit report. The LBFC is clearly an agency of government – a legislative service agency.

The LBFC clearly is and was performing research like it has been for over 60 years. And finally, the LBFC was asking for the data to perform an official duty.

Since the Department of Health dug in its heels and the LBFC cannot complete the research we requested to be performed, I introduced HB 2441 to make minor technical changes to our Vital Statistics Law to help define four terms, including "conduct of official duty," "legislative service agency," "research," and "State agencies of government."

The bill also changes the wording from "may" to "shall" to require the Department of Health to disclose vital statistics information or data to Federal, State, or municipal agencies of government for official duties or for research purposes.

This bill will help to ensure that legislative service agencies tasked by the General Assembly to perform research will be able to review vital statistics records for research purposes. Additionally, this does not change other provisions of the Vital Statistics Law that allow for redactions and protections of certain private and personally identifiable information from being disclosed.

I ask my colleagues to join me in voting "yes" on HB 2441. These minor changes to our Vital Statistics Law will expressly include the Legislative Budget and Finance Committee as a government agency to ensure that they are able to continue conducting the important research work as they have for the last 60 years and so that they can complete the COVID-19 data audit that this body unanimously requested over a year and a half ago.

Thank you, Mr. Speaker.
