On the question,

Will the House adopt the resolution?

The SPEAKER. On the resolution, the Chair recognizes the maker of the resolution, Representative Stambaugh.

Mr. STAMBAUGH. Thank you, Madam Speaker.

Madam Speaker, unimaginable tragedy struck Juniata County and the Commonwealth on Saturday, June 17, when Pennsylvania State Trooper Jacques F. Rougeau, Jr., was killed, and Lt. James A. Wagner wounded, in separate encounters with the same shooter.

Trooper Rougeau was a 3-year State Police veteran who had been assigned since March to the Troop G Lewistown Station, which is located in Arch Rock, Juniata County. He was the 104th member of the Keystone State's rural and small-town constabulary to give his life since the agency was founded in 1905.

Representative Jozwiak discussed the details of the incident that took Trooper Rougeau's life last week, so I will not go over that ground today, but I want to talk briefly about the effect that this tragedy has had on the local community.

On Sunday evening, June 18, the day after the shooting took place, the local community leaders and faith leaders held a prayer vigil on the grounds of the Juniata County Courthouse in Mifflintown. Included in the ceremonies was a special intercession for the Juniata County first responders, who magnificently performed their always-vital role as the day's tragic and terrible events unfolded. This Saturday another community comfort day is taking place in Mifflintown, and yard signs thanking the Pennsylvania State Police are popping up everywhere in Juniata County.

I am proud that, as has been the case historically across Pennsylvania, rural areas and small towns in the 86th Legislative District are drawing on their collective strength to provide each other with understanding and support.

The events of June 17 demonstrate once again the dedication that law enforcement officers bring to work every day to protect us all – all of us, everyone – from wrongdoers.

I urge everyone to continue to pray for the troopers, their families, our State Police contingent, and everyone affected.

WHEREAS, Born in San Diego, California, on September 7, 1993, Trooper Jacques F. Rougeau Jr., was the son of Angela Hunt Gervasio and her husband, Carlo; and

WHEREAS, A 2012 graduate of Corry Area High School, Trooper Rougeau attended Penn State Behrend before earning a bachelor's degree in criminology from The Pennsylvania State University in 2015; and

WHEREAS, After working for Weis Markets in loss prevention for several years, Trooper Rougeau graduated from the Pennsylvania State Police Academy in 2021; and

WHEREAS, Originally stationed with Troop J in York, Trooper Rougeau joined Troop G in Lewistown in 2023; and

WHEREAS, On June 17, 2023, Trooper Rougeau was tragically shot and killed by a suspect during an incident involving Pennsylvania State Police Troop G, Lewistown Station; and

WHEREAS, Active in his community, Trooper Rougeau was a member of the Fraternal Order of Police, and he was an avid fan of the Penn State Nittany Lions football team; and

WHEREAS, Trooper Rougeau also enjoyed playing golf and basketball, aviation and flying drones; and

WHEREAS, Trooper Rougeau faithfully endeavored to preserve and protect the health, safety, and welfare of his fellow citizens and gave the ultimate sacrifice in the furtherance of these goals; and

WHEREAS, Trooper Rougeau demonstrated exemplary knowledge, integrity, and courage in carrying out his many responsibilities and earned deep respect and gratitude for his tireless devotion to duty; therefore be it

RESOLVED, That the House of Representatives celebrate the life and honor the memory of Trooper Jacques F. Rougeau Jr., who gave his life in the line of duty on June 17, 2023; and be it further

RESOLVED, That the House of Representatives express heartfelt condolences to his wife of five years, Chloe Miller Rougeau; mother, Angela Hunt Gervasio; siblings, Christina Rougeau-Bailey and Justin Hunt; grandparents, Kenneth and Cheryl Hunt and Emily Hunt; and many other family members and friends.

RESOLUTION REPORTED FROM COMMITTEE

SR 136, PN 984

By Rep. NEILSON

A Concurrent Resolution extending in whole the disaster emergency declared on June 12, 2023, in response to the collapse of the northbound bridge and severe compromise of the southbound bridge on Interstate 95 in the City of Philadelphia, Philadelphia County.

TRANSPORTATION.

RULES SUSPENDED

The SPEAKER. For what purpose does the gentleman, Representative Bradford, rise?

Mr. BRADFORD. I rise to make a motion to suspend the rules for the immediate consideration of SR 136.

The SPEAKER. Representative Bradford moves to suspend the rules for the purpose of immediate consideration of SR 136.

On the question, Will the House agree to the motion?

The SPEAKER. Members are reminded that pursuant to rule 77, the motion to suspend is only debatable by the leaders, the maker of the motion, and the maker of the bill under consideration.

On that question, the Chair recognizes the maker of the motion.

Mr. BRADFORD. Thank you, Madam Speaker.

SR 136 extends the Governor's emergency declaration until November 1, 2023. The current declaration will expire on July 3, 2023, and without an extension, all work on I-95 will stop.

This House passed HR 154 on June 26, 2023, which would have extended this declaration until June 2024.

Thank you, Madam Speaker.

The SPEAKER. The Chair thanks the gentleman.

On that question, the Chair recognizes Representative Cutler. Mr. CUTLER. Thank you, Madam Speaker.

Madam Speaker, in the interest of just garnering a little bit more information for our members so they can make an informed choice, I was wondering if I could interrogate the maker of the motion regarding our upcoming schedule.

The SPEAKER. The gentleman indicates that he will stand for interrogation on the upcoming schedule.

Mr. CUTLER. Thank you, Madam Speaker.

Madam Speaker, in terms of the timing of this resolution, what are your intentions regarding any other business or our return to session? In other words, would we potentially be here tomorrow that this could be considered, or is it at some point further in the future?

Mr. BRADFORD. Well, tomorrow will be sunshined. It is the intent to go on to a 6-hour call of the Chair.

Mr. CUTLER. Thank you, Madam Speaker.

Further interrogation, if I may?

The SPEAKER. The gentleman is in order and may proceed. Mr. CUTLER. Thank you, Madam Speaker.

Madam Speaker, do you have an intended time of renewal, understanding that a 6-hour call could be at any time, but in terms of the breadth of work yet to be undertaken with the Senate, of course, what is your anticipation in terms of notification for the members?

Mr. BRADFORD. It would have been our hope, obviously, having passed the bill several weeks ago that the Senate might have passed something before now. Obviously, we are waiting for a GA (general appropriations) bill from them at this minute. We are going to need some time. It is going to be at least several days to get a review to give our members a fully informed idea of what the Senate has passed.

Mr. CUTLER. Thank you, Madam Speaker.

On the motion, if I may?

The SPEAKER. The gentleman is in order and may proceed. Mr. CUTLER. Thank you, Madam Speaker.

Madam Speaker, I agree that there are probably several days of work yet to be done regarding the budget and here we are on the last day of the fiscal year.

One of my concerns, simply by looking out across the chamber here, it would certainly appear, given the attendance, that some members were notified of the upcoming schedule while others were not. I would simply ask, as a courtesy going forward, to the extent practicable, that we could have timely updates regarding an expectation of returning to the floor, understanding that it is highly unlikely to be tomorrow, given the current dynamics.

I think that the easiest way through this current situation would be to increase communications regarding schedules and having regular updates as to when to expect a return to the floor. And the good leader, you extended me the courtesy of being able to speak a second time in Rules while we were doing that, and in the interest of getting to the bottom of this schedule issue, and in a show of good faith, I would urge the members to support the suspension in order to consider the resolution before us, in the hopes that we can return to some level of normalcy regarding the upcoming – unfortunately, probably protracted – budget impasse that we see ourselves heading to.

I think that with some better planning and some better communication, it is certainly my hope that we can find a solution that would be satisfactory to the citizens of the Commonwealth, and I certainly wish that we were not in a position, on the last day of the fiscal year, to be doing this, but do understand the gravity of the situation regarding I-95 and what that impact means, not just economically, but on day-to-day life for those around there, and urge the members to support not just the suspension of the rules for the immediate consideration, but also the underlying resolution so that the emergency can be properly addressed.

And I want to thank the good minority leader. I will tell you, I will extend every personal courtesy and make sure we are in communication to make sure that your members get timely notification, and I apologize if intracaucus communication was not what it could have been.

I would just note, sometimes it is the chambers that lack the ability to communicate that drive some of this, and I know they kept us here last night waiting for a bill that did not arrive until this afternoon, and so we are in that same situation again - not knowing when we will get a bill today. But again, I will give you my word that every courtesy will be extended possible.

REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. For what purpose does the gentleman, Representative Neilson, rise?

Mr. NEILSON. Thank you, Madam Speaker.

I would just like to thank the members for their affirmative vote and submit my comments for the record on the resolution. The SPEAKER. The Chair thanks the gentleman.

Mr. NEILSON submitted the following remarks for the Legislative Journal:

Today I stand in front of you with a plea to extend the Governor's declaration on the I-95 collapse in Philadelphia. The intent set forth under HR 154 was to expand the declaration for a year due to the multiple agencies involved to be certain that the full impact of the project can move forward. While we have seen the temporary structure be put in place at a record pace, in just 12 days, there are numerous other aspects of the project that will likely continue well past the completion of a permanent replacement - we all know that.

For example, earlier today Governor Shapiro announced that the U.S. Small Business Association has granted a disaster declaration to provide the much-needed assistance for the local business community who have been and will continue to sustain substantial economic injury due to the collapse - businesses like Curran's Irish pub, Sweet Lucy's BBQ, City Distilling, along with numerous auto repair shops and other businesses that are directly impacted and may not have the ability to recover well beyond the full replacement of I-95 and the opening of the exit ramps and when traffic patterns are restored to normal.

Since passing HR 154 in the House, the Senate has not taken any action and places the project in immediate danger of coming to a complete halt. While the PA House has passed a budget, it seems that the Senate has yet to come to a consensus, so we need to take action immediately. Pennsylvania cannot afford the Governor's declaration to expire on Monday, July 3, 2023.

Today I ask for your support of SR 136, introduced by my colleague in the Senate, Senator Dillon. SR 136 was amended in the Senate to expire on November 1, 2023, which will at least get us beyond the budget and summer months, where we will be able to take it up once again in the fall to make certain that I-95 and the businesses around the affected area can be rebuilt and recover from this disaster.
