PRAYER

Representative Hill-Evans, who serves York, brought constituents from her district. They are seated in the gallery. We are so glad this morning to have Joanne Lasky, Lee Baldwin, and Kim Williamson visiting the Capitol today. York County guests of Representative Hill-Evans, please stand. Thank you for coming.

Representative Munroe, who serves Bucks County, has brought Susan Dorfman, Francine and Lou Sanutti, Steve and Joyce Pagano. They are members of the Congregation Tiferes B'nai Israel. They are in Warrington, Pennsylvania. Susan Dorfman is the copresident, Steve Pagano is the immediate past president of the congregation, and we are so grateful that they are seated in the gallery and they have come from Bucks County. Representative Smith-Wade-El, who serves Lancaster County, has brought the Legislative Working Group on Homelessness from Lancaster. Ms. OBERLANDER. Thank you, Madam Speaker.

I rise to speak on amendment A04011, which will restore the fair venue rules for medical malpractice claims that had been effective in addressing the doctor shortage facing the Commonwealth 20 years ago.

In 2002 and in 2003, the Commonwealth was facing a crisis. Medical providers were fleeing the State due to the skyrocketing costs of malpractice insurance. That crisis was only mitigated when the General Assembly passed Act 127 of 2002, which prevented venue shopping for medical malpractice cases, and the Pennsylvania Supreme Court adopted that rule in the Rules of Civil Procedure. The Supreme Court, through a rulemaking procedure, has unilaterally now decided to undo that process and return to the days of venue shopping for medical malpractice cases.

My amendment would restore the venue rules that were enacted by the legislature in Act 127 of 2002. We cannot go back to a time where doctors were fleeing the State because of out-of-control malpractice insurance costs, when renewal premiums were well into the double digits. And I just recently heard of several orthopedic surgeons who, through no fault of their own, their increases were going to be 30 percent. Thirty percent of their insurance premium was going to be an increase specifically because of this change in Pennsylvania. I also know that since the rule change, cases in the Judicial District 1 have doubled by the counties surrounding Philadelphia – excuse me, they have doubled; however, the counties surrounding Philadelphia have seen a significant decrease in the number of cases. I do not believe that is a coincidence.

AMENDMENT WITHDRAWN

Ms. OBERLANDER. I do, however, know how the vote for this amendment will go and I do not want to jeopardize the underlying bill. So for that reason I will withdraw this amendment.

Thank you, Madam Speaker.

The SPEAKER. The Chair thanks the gentlelady.

Mr. **FRANKEL** offered the following amendment No. **A03902**:

Amend Bill, page 3, lines 3 and 4, by striking out "work independently or for a competing employer" and inserting

practice independently or in the employment of a competing employer after the term of employment

Amend Bill, page 5, lines 7 through 10, by striking out all of said lines and inserting

- (1) Section 5 shall take effect in 30 days.
- (2) The remainder of this act shall take effect immediately.

On the question,

Will the House agree to the amendment?

The SPEAKER. On that question, the Chair recognizes the maker of the amendment and the bill, Representative Frankel.

Mr. FRANKEL. Thank you, Madam Speaker.

I am offering amendment A03902, which I consider a technical amendment. The amendment refines the definition of "restrictive covenant" to make it clear that the prohibition on restrictive covenants is specific to the provision of health care. Many business executives may also happen to have a health-care license covered under the language of the bill. The intent of the legislation is not to impact noncompete clauses related to business dealings, only to health-care practice.

Similarly, the intent of the bill is not to prohibit noncompete clauses as they relate to health-care practitioners working for two different employers at the same time. This language clarifies that the restrictive covenant is specific to after a health-care practitioner ends employment with one health-care system or employer. As amended, after a provider leaves one employer, that health system or employer cannot stop them from seeking employment with a different hospital, health system, or provider group.

Thank you, Madam Speaker. I ask for an affirmative vote. The SPEAKER. The Chair thanks the gentleman.

PARLIAMENTARY INQUIRY

The SPEAKER. For what purpose does the gentleman from Allegheny County, Representative Venkat, rise?

Mr. VENKAT. Conflict of interest request, Madam Speaker. As a licensed health practitioner, I ask for a judgment from the Chair as to whether I can participate in this debate.

The SPEAKER. The Chair finds that you are a member of a class, and you may participate in this vote. The Chair thanks the gentleman.

PARLIAMENTARY INQUIRY

The SPEAKER. The Chair recognizes the gentleman from Lancaster, the floor leader, Representative Cutler.

Mr. CUTLER. Thank you, Madam Speaker.

Madam Speaker, similarly, I have a family member who is in such an arrangement currently and was wondering if that in fact also precludes me from voting on the underlying amendment or the bill? And I would just ask for a ruling from the Chair.

The reasoning behind my request for a "no" vote on this is that the bill states that any provider-owned group can utilize noncompetes, but due to the Pennsylvania Corporate Practice of Medicine Doctrine in Pennsylvania, only providers can own these types of groups, and so as written, this would apply to every provider group from small practices of 2 to 5 doctors to practices of 1,000 doctors or more. It states that they cannot be affiliated with any other provider group, but of course they would be, by nature, affiliated with other providers.

Ultimately, this bill undermines the ability to regulate huge corporate medical groups that are also working to gain market share advantage. So I would ask for a "no" vote on this amendment.

An Act authorizing the Department of Environmental Protection, in consultation with the Department of General Services to lease certain submerged lands within Erie County and associated wind, water and solar resources for the assessment, development, construction and operation of utility scale offshore wind, solar or kinetic energy generation facilities; providing for collection of certain lease and royalty payments; establishing the Lake Erie Large-Scale Energy System Development Fund; and providing for distributions and transfers from the fund.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On that question, the Chair recognizes the maker of the bill, the gentleman from Erie, Representative Merski.

Mr. MERSKI. Thank you, Madam Speaker.

HB 254 is an important piece of legislation that would help us diversify our energy portfolio and be another source of clean energy in Pennsylvania. It would also be a great source of family-sustaining jobs for the Erie region and help us in our quest

to make America energy-independent. The legislation would allow certain areas of the bed of Lake Erie to be leased by the Commonwealth to an entity or entities for renewable energy projects. DGS (Department of General Services), DCNR (Department of Conservation and Natural Resources), the Fish and Boat Commission, and the Game Commission would all have to be consulted by DEP in developing the maps for the areas of Lake Erie that could be used for this purpose.

Further, the area that would be used would be concentrated in the central and western portions of Lake Erie and avoiding developing near shore areas, avoiding shipping lanes, and avoiding the areas of Lake Erie where pathways of migratory birds and species are concentrated. This legislation would empower DEP to make and execute leases where they determine that it is in the best interest of the Commonwealth. Prior to entering any long-term lease, the lessee would be required to conduct a feasibility study to assess the viability of the project and to assess the environmental, navigational, public safety, and structural, and any other impacts that the project may have.

With this legislation, we have an opportunity to grow our energy portfolio and invest in our workforce. Please join me in voting in favor of HB 254.

The SPEAKER. The Chair thanks the gentleman.

On that question, the Chair recognizes the gentleman from Erie, Representative Banta.

Mr. BANTA. Thank you, Madam Speaker.

I rise today to oppose HB 254. My constituents include anglers and charter captains who are concerned for the environmental hazards windmills will pose when installed in Lake Erie. Their concerns include oil leakage, contamination, toxic sediment on the bottom that will be stirred up from the installation, and the threat to birds and the fish industry as a whole. Research shows that these windmills have been struck by lightning, can wear out or leak, and sometimes come apart in high winds. If this bill was proposed for environmental stewardship, it is anything but.

We should also consider the negative impact of vibrations of these windmills to the lake, bedrock, and aquatic life. Homeowners who enjoy the sunset on the lake are also opposed to replacing their views with wind turbines and noise pollution that comes with it.

Madam Speaker, I stand with my Erie County constituents that want to preserve their peaceful way of life. Madam Speaker, the risks of these windmills on the lake are not worth the reward. I rise today to ask for a "no" vote on HB 254.

Thank you, Madam Speaker.

The SPEAKER. The Chair thanks the gentleman.

On that question, the Chair recognizes the gentleman from Indiana, Representative Struzzi.

Mr. STRUZZI. Thank you, Madam Speaker.

The bill before us will allow for the construction of utility level windmills and solar panels in Lake Erie; in Lake Erie. I have nothing against solar, I have nothing against wind, and I mean no disrespect to the maker of this bill, but this is wrong on so many levels.

Have you been to Lake Erie? Have you seen Presque Isle State Park? Four million visitors a year come to Pennsylvania for the Erie shoreline. Vineyards across the coast, all the way up to New York. It is pristine. It is beautiful. The property values in Erie are there because of the view of the lake. And I am not from Erie. I am from Indiana County – right? – about a 2-hour drive to Erie. But I have spent my entire life vacationing in Erie. As a child, my family went there. You know, we swam on Presque Isle, sat on

the beaches, fished in the lake. I continue that same tradition with my family today, and I cannot sit back and think what it would look like when we are there vacationing and we see windmills across the horizon. And we do not even know where they are going to be. We are asking the DEP to create a map showing us where these windmills are going to be.

I do not know how anyone who supports the environment, who supports our outdoor spaces, who supports tourism, who supports fishing, who supports wildlife and all the great assets we have in this State – particularly in Erie County and in Presque Isle State Park and in Lake Erie – could support this bill. I ask you to please vote "no" on this. This is not ready, this is not a good idea, and it will destroy one of our greatest assets in this Commonwealth. Thank you.

On that question, the Chair recognizes the gentleman from McKean, Representative Causer.

Mr. CAUSER. Thank you, Madam Speaker.

Madam Speaker, I rise to express a number of concerns with this particular legislation. And I am not opposed to wind or solar, but what about other energy sources? I think we have to be looking at all of our energy sources rather than just a very narrow view.

In the Environmental Resources and Energy Committee, an amendment was adopted that was quite expansive. It removed the Department of General Services from this process and designated sole authority to the Department of Environmental Protection to negotiate these leases. It further said that the Department of Environmental Protection could waive the competitive bidding process. It further granted the Department of Environmental Protection the power and ability and authority to negotiate the terms of the leases which are in the best interest of the Commonwealth. Those are frightening words for an agency that many of us feel has way too much power right now — way, way too much power.

This bill is not well thought through, and I would request a negative vote.

Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On that question, the Chair recognizes the maker of the bill, the chair of Local Government, Representative Freeman, from Northampton.

Mr. FREEMAN. Thank you, Madam Speaker.

HB 1220 would amend the campaign finance law to require all candidates for State office to file not only the second-Fridaybefore-the-election report, but the 6-weeks-before-the-election report as well. Under current law, only statewide candidates file the 6-weeks-before-election report. The aim of this legislation is to create greater transparency, and in some respects, provide for a structure of reporting that will, in a way, be more user-friendly to candidates. By having candidates file both the 6-weeks and the second-Friday reports, it will create reports that are much more compact in size, easier to comply with, and be much more usable in terms of complying with the law.

The key of this legislation is transparency. Too often in the course of a campaign, the information from the second-Fridaybefore-the-election report gets lost in the last week of campaigning, the hurly and burly of the campaign process. By having an earlier look at what candidates are raising, where they are raising money from, that enables the voters and the campaign process to more clearly indicate where people are gaining their support. Earlier understanding of where candidates receive their contributions is an important part of voters' ability to make a decision on candidates.

And I urge the House to adopt this bill as a way to provide for, again, greater transparency and a reform of the campaign finance law process that will be much more beneficial to voters' knowledge of who is backing whom and how voters would wish

I urge a "yes" vote.

The House proceeded to third consideration of **HB 1472**, **PN 2941**, entitled:

An Act amending the act of June 3, 1937 (P.L.1333, No.320), known as the Pennsylvania Election Code, in primary and election expenses, further providing for reporting by candidate and political committees and other persons and for late contributions and independent expenditures.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

(Bill analysis was read.)

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On that question, the Chair recognizes the gentleman from Philadelphia, Representative Kenyatta.

Mr. KENYATTA. Thank you, Madam Speaker.

HB 1472 is a part of a package of bills introduced by myself and the gentleman from Philadelphia, Chairman Solomon, to try to make our system what it should be: fair, open, transparent.

Every 6 months Pennsylvanians have an opportunity to weigh in about who is going to represent them here in this body and at multiple levels of government, and also every 6 months, Madam Speaker, dark money groups, special interest groups spend thousands, tens of thousands, in some instances, millions of dollars trying to impact the outcome of those elections without having a lot of the simple safeguards in terms of allowing voters to understand who is paying for the ads, who is paying for certain communication, and what their interests may be.

This bill is very simple. Yesterday in this body, in a bipartisan way, we made this bill even better, included even more groups to ensure that anybody who wants to influence our elections, that voters get to understand who those people are, what donations they are making, and then can make a decision based off of that information.

And so I want to thank the majority leader for calling this bill up and for us doing everything we can in this body to move from the Wild, Wild West of no rules as it relates to campaign finance, to a better, fairer system where voters understand who is trying to impact their vote and influence their decision.

Thank you, Madam Speaker.

The SPEAKER. The Chair thanks the gentleman.

On that question, the Chair recognizes the gentleman from Mercer, Representative Bonner.

Mr. BONNER. Thank you, Madam Speaker.

HB 1472 requires any person, including 501(c) organizations, who make a political contribution to any entity which is independent and separate from the candidate, to report such contribution to the Department of State. This has been the law for decades in Pennsylvania. The only substantive change we are making in the law is to eliminate the threshold of \$100 that had to have been met before the report was due. Now a report will be due from any contribution starting at dollar one that must be reported to the Department of State. This bill, then, is a de minimis change in the law, simply reducing the \$100 threshold each year to no dollars.

The amendment to the bill does include a definition that the word "person" will now include all 501(c) corporations, but they were already included under the act. The act says that any person shall report such a contribution. Pennsylvania law defines "any person" as an individual or a corporation. This provision now being added to the bill only reinforces the requirement that all 501(c) corporations must report such contributions.

This bill does not require the names of the initial donors to the nonprofit corporation to be disclosed, nor could it require such a disclosure because the United States Supreme Court ruled in 2021, in the case of *Americans for Prosperity Foundation* v. *Bonta*, that the names of the initial donors to the nonprofit corporations cannot be released to the public, as it would violate

the donors' right of freedom of speech and freedom of association. Every statute passed in the United States must be read in conjunction with Supreme Court constitutional decisions, and so must this act, and that prohibits the release and disclosure of names of donors.

Dark money, then – where the names of the initial donors seeking to influence our elections – very much remains with us. Although this legislation is more optics than substance, the message it sends is still very important: that the Pennsylvania House of Representatives is very concerned with the power and influence of dark money in our elections.

It is very clear, then, that American citizens strongly object to dark money deciding our elections. In a recent poll, 75 percent of all Americans oppose corporations and unions making unlimited contributions to independent PACs (political action committees). Eighty-five percent of all Democrats oppose such contributions. Sixty-six percent of all Republicans oppose such contributions. In 2006 we had \$5 million going to these independent PACs. Now we have over \$1 billion annually going to these independent PACs as dark money.

Frankly, this bill does nothing to stop the flow and use of dark money, but it will signal where we stand on this issue as the Pennsylvania House of Representatives. This bill sends a greater long-term message that this body, the Pennsylvania House of Representatives, wants to regulate dark money in our political process; that the Pennsylvania House of Representatives wants the public to know who is funding our election process and why; and that the Pennsylvania House of Representatives not only wants transparency and light in our governing process, but also in the process by which we elect our leaders to public office.

I would ask for your support for this legislation. Thank you.

Mrs. CERRATO. Thank you, Mr. Speaker.

I rise today to ask for your support for HB 1903. Private lateral water and sewer lines connect a house or property to the main lines of the water and sewer system. These lines play a crucial role in ensuring the efficient functioning of our infrastructure. However, when they deteriorate and develop leaks, experience root intrusions, or allow rainwater infiltration, they can have a detrimental impact on the entire system. While making these repairs is essential, they are extremely costly, creating unnecessary burdens on Pennsylvania homeowners.

By passing this bill, we can achieve several important objectives. First, we can enhance the effectiveness of maintenance efforts, leading to a more robust and reliable water and sewer system. Second, we will reduce long-term costs associated with infrastructure repair and replacement, ultimately saving taxpayers dollars. Third, we will improve public health outcomes by addressing issues such as leaks and sewer backage more promptly and efficiently.

By enabling access to public funds and workers for lateral line maintenance, we can alleviate the financial burden placed on individual residents and promote a healthier, more sustainable community. Thank you for your support.

The SPEAKER pro tempore. The Chair thanks the gentlelady and recognizes the gentlelady from Fayette, Representative Krupa.

Mrs. KRUPA. Thank you, Mr. Speaker.

I rise in opposition to HB 1903. I want to thank the maker of the bill, as I believe that the underlying intent is good. I absolutely support the idea that municipalities should have the authority to repair, replace, and maintain private lateral lines to municipal water lines when there is a public health and safety issue. But I do have serious reservations about this bill because of the potential for it to be abused at the taxpayer's expense. Let me be clear: I would not hesitate to support this bill if it included provisions that the property, the privately owned property would ultimately have a lien against it or the property owner would bear the financial responsibility of the maintenance work.

Pennsylvania taxpayers are already living under the burden of inflation and rising taxes. It is our responsibility here in Harrisburg to ensure that those tax dollars are used wisely. I will be a "no" vote on HB 1903 as written because taxpayers should not have to bear the ultimate financial burden of maintaining privately owned water and sewage lines.

As I was contemplating the pros and cons of this bill, I was reminded of a particular incident in my district. During the winter months, there was a mobile home park, and because of the dilapidated condition of those privately owned lateral lines, it resulted in multiple residents being without water for days and days. In this particular situation, I believe that there is a serious health and safety issue and that the municipalities should be able to step in and repair those. However, as the bill is currently written, there is neither a lien against the property or a judgment against the property owner who reaps the rewards of those

improvements. How would you feel if you have to write a check to do repairs to your privately owned line only to find out that your neighbor, who is in an equal or possibly better financial situation, had his paid by the municipality?

Until HB 1903 is amended to require a lien against the property if it is being improved, I will be a "no" vote, and I urge my colleagues to do the same. Thank you.
