SENATE

TUESDAY, August 1, 1967.

The Senate met at 1:30 p.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Raymond J. Broderick) in the Chair.

PRAYER

The Chaplain, Rev. ELMER J. DAVIS, Pastor of the First Presbyterian Church, Pottsville, offered the following prayer:

Members of the Senate, staff and guests, we will pause in a moment of reverential silence to honor the men of the USS Forrestal, those who have died, those who have suffered injury, those who have survived and those of such heroic service that the cost of life has been kept as low as it was. Let us think on them.

O God, Thou Who art the source of every good thing, help us to know the facts of life. Help us to see life clearly, with both short and long-term purposes. Teach us, again, that Thy will has created all things, that man was born to do Thy will and that Thy love of all that Thou hast created is the source of all values. Teach us to know that we destroy life when we waste the material gifts of life, when we regard with indifference any man, regardless of his color, creed or national origin, and when we begin to play "fast and loose" with values that are meant to give the true worth of each man as Thy child.

Enable the men of this Body, with its vested responsibilities and privileges, to so elevate the life of all within the Commonwealth that this State may fulfill the dream of its founders and that she may point the Nation toward the necessary quality of civil life, based upon personal honesty, interpersonal concern and love, and the social well-being and peace.

May Thy rich blessing of trust rest upon the young men and women of this land who seek to protect the rights of free people throughout the world. May the gift of Thy Holy Spirit and an outgoing sense of concern on the part of this Legislature and every similar body be the assurance of every soldier prodding the jungles of Viet Nam, facing the wall of hostility at "Checkpoint Charlie", peering the lonely hills and crags of Korea and standing for us wherever the "cold war" breathes with destructive heat. As they labor for world peace abroad, may we seek the grounds of peace, understanding the opportunity for all here at home.

Now, by the power that only Thou canst provide, may our prayer, our endeavors and Thy will become one in the service of Thy Kingdom. We would ask this in the Name of Christ, Thy Son, our Pioneer, our Counselor and our Lord. Amen.

SENATE RESOLUTION

EXPRESSING GRATITUDE TO PATROLMAN EDWARD CRAWFORD FOR HIS DISTINGUISHED SERVICE

Messrs. DENGLER, COUGHLIN and BELL offered the following resolution which was read, considered and adopted:

In the Senate, August 1, 1967.

Patrolman Edward Crawford has dedicated his life to the service of his country and his community. After grad-

uating from the Upper Darby High School in 1944, Edward Crawford, at the age of seventeen, enlisted in the United States Marine Corps in May, 1945. Upon completing boot training, he joined the First Marine Division, and was sent to Okinawa where he encountered fighting which he was to see later in Korea and Vietnam. Patrolman Crawford served for fourteen months in China after the war, and was discharged in December, 1948.

Patrolman Crawford married Miss Joan Lee in August, 1950 while he was still in the Reserves. The Marine Corps recalled Patrolman Crawford to active duty one month after his wedding, in September, 1950. For one year Edward Crawford was on reserve duty, then he reenlisted in the Corps for three years so that he could serve during the Korean War.

In November, 1952, Patrolman Crawford was sent to Korea, and in April, 1953, he was wounded in the leg by mortar fire during an attack. On July 25, 1953, he was shot in the arm, and the very next day was hit in the legs and hip by the blast of a grenade. For his heroism, Patrolman Crawford won the Bronze Star. He was discharged in 1955, and again enlisted in the Reserves.

He voluntarily returned to active duty with the Marine Corps in February, 1967, and requested and got duty in Vietnam. On April 30, 1967, Edward Crawford was shot while his unit, the Second Battalion, Third Marines, was fighting the now famous battle for Hill 881.

After two weeks of hospitalization, he returned to his unit. While the unit was fighting in the Demilitarized Zone, on May 20, 1967, he was hit by mortar fire while carrying a wounded Marine.

After serving his Nation in World War II and the Korean War, Edward Crawford joined the Upper Darby Township Police Department on March 1, 1957 and began a long and distinguished career of service to his community. Upon his return from Vietnam, Patrolman Crawford rejoined the Upper Darby Township Police Department, and is currently enlisted until February, 1969.

Patrolman Crawford's family consists of his wife and three children: David L., age ten, Kathy M., age eleven and Eddie F., age fifteen. Patrolman Crawford is a sports enthusiast, and is an amateur boxer.

The many long and difficult years of service to country and community which Patrolman Crawford has dedicated merit our attention, our thanks, and our pride; therefore be it

RESOLVED, That the Senate of the Commonwealth of Pennsylvania express its gratitude to Patrolman Edward Crawford for his many years of distinguished service and selfless sacrifice to his country and community; and be it further

RESOLVED, That a copy of this resolution be prepared for presentation to Patrolman Crawford.

PATROLMAN EDWARD CRAWFORD AND FAMILY PRESENTED TO SENATE

Mr. DENGLER. Mr. President and Members of the Senate, Sergeant Edward Crawford is in our midst, today, as a visitor to the Senate. Sergeant Crawford went to Upper Darby High School and graduated in 1944. He served in the Armed Forces in Korea and was wounded twice. About a year ago, he enlisted and was sent to Viet Nam and as late as May 20, 1967, he was wounded while carrying a Marine back from the firing line.

I deem it a great privilege to have Sergeant Crawford as one of my constituents. I am sure, Mr. President, that the Chair will deem it a pleasure to welcome Sergeant Crawford, his family and his friends to the floor of this Senate.

The PRESIDENT. Thank you, Senator Dengler.

Sergeant Crawford, the Chair would appreciate it if you would stand, in order that the Members of the Senate may give you a round of applause, one which you deserve.

If Sergeant Crawford's family would please stand, we

also would like to welcome them.

Thank you; it is good having you with us and we are proud of you.

Mr. BELL. Mr. President, Sergeant Crawford has been wounded five times. He has served in World War II, in the Korean emergency and in Viet Nam. Between the various conflicts, he served as a member of the United States Marine Corps Reserve.

I think, Mr. President, that Sergeant Crawford is here today as a symbol of all of Pennsylvania's citizens who are serving in the Marine Corps, on active duty and in the Reserve components. I think that Sergeant Crawford's conduct on the field of battle, as exemplified by five Purple Hearts, reflects great credit to the Commonwealth of Pennsylvania.

SENATE CONCURRENT RESOLUTION

**IN MEMORIAM
S. EDWARD HANNESTAD**

Messrs. STROUP and LANE, on behalf of the entire Membership of the Senate, offered the following resolution (Serial No. 138), which was read, considered and adopted:

In the Senate, August 1, 1967.

S. Edward Hannestad, the retired director of the Legislative Reference Bureau, died Saturday, July 29, at the Harrisburg Hospital.

Born in Kailili, on the Island of Mani, Hawaiian Islands, he was the son of Waldemar and Laura Bucholz Hannestad.

He was a graduate of Punahon Academy in Honolulu and received his doctor of law and master of law degrees at Yale University Law School.

During World War I, he served with a tank corps in France.

Ed Hannestad served the General Assembly with brilliance and dedication. He was employed as a member of the staff of the Legislative Reference Bureau from 1915 to 1925 and from 1931 to 1957, the year of his retirement. He became Assistant Director in 1939 and Director in 1947, a post he held until his retirement.

During the years 1925 to 1931, he practiced privately in Chester and was a member of the Borough Council of Glenolden from 1929 to 1931.

During his days as Director of the Reference Bureau, he not only trained many of the present staff of the Bureau but attorneys, who not remaining with that governmental agency, went on to serve the Bench and Bar and their communities, the better for having known him.

His knowledge of Pennsylvania statute law was encyclopedic. In particular, he was an expert on the school laws and local taxation, drafting the Public School Code of 1949 and an article on the latter, which is a commentary in Volume 72 of Purdon's Pennsylvania Statutes Annotated. For the Commonwealth, he wrote the bill drafter's "bible", a "Manual of Legislative Drafting" (1954) and "Court Decisions Affecting Legislative Drafting" (1957). His reputation as a legislative draftsman was nationwide.

Personally, he was a shy, unobtrusive, kindly man with a sharp sense of humor. Of his courage, there is little doubt: he fought cancer for many, many years.

Mr. Hannestad was a member of the American Legion and the Dauphin County, Pennsylvania and American Bar Associations. He served as counsel for the Pennsylvania Commission on Constitutional Revision at its creation in 1957.

Since 1959, he had studied and traveled in the United States, Europe, the Middle East and Hawaii.

He is survived by a son, John Eric Hannestad of Stuttgart, Germany; a sister, Mrs. Katherine Allen of Honolulu, and four grandchildren; therefore be it

MEMORIALIZING CONGRESS TO ENACT LEGISLATION BANNING THE SALE OF WEAPONS BY MAIL

Messrs. McCREESH, HILL, MURRAY and CIANFRANI offered the following resolution (**Serial No. 49**), which was read and referred to the Committee on Rules:

In the Senate, August 1, 1967.

The recent outbreak of riots and acts of vandalism throughout the country has made it evident that some Federal control over the interstate shipment of guns by mail is necessary.

It has been four years since the assassination of President Kennedy by a mail order rifle stirred an outcry against such sales across the Nation. But to this day, nothing has been done in Congress to plug up the mail order rat race that makes firearms available to misfits and worse.

Both the House and the Senate in Washington have proposals to ban mail order sales, but none of the bills have come out of committee; therefore be it

RESOLVED, That the Senate of the Commonwealth of Pennsylvania memorializes Congress to enact legislation that would ban the sale of weapons by mail; and be it further

RESOLVED, That a copy of this resolution be forwarded to Senators Clark and Scott and to each member of the House of Representatives from Pennsylvania.
