An Act amending the act of April 9, 1929 (P. L. 343, No. 176), known as "The Fiscal Code," further providing for the payment of interest on overpaid tax.

Senator FISHER. Mr. President, I would like to take this opportunity to introduce three friends and constituents from my district, two of whom are borough councilmen from the Borough of Whitehall. They are in Harrisburg as part of the Pennsylvania State Boroughs' Association Convention. Here from Whitehall Borough are Councilman Ray Miller and Councilman George Sites, together with Maxine Horner.

The PRESIDENT pro tempore. Would Senator Fisher's guests please rise so we may give you a warm welcome. (Applause.)

**PRESENTATION OF COMMONWEALTH
OF PENNSYLVANIA FLAG FOR USE
DURING THE 100TH ANNIVERSARY
OF STATUE OF LIBERTY**

The PRESIDENT pro tempore. We have several other guests here and at this time I would ask if Senator Fumo would come forward and not only introduce our special guests, but I think he also has a presentation to make as well.

Senator FUMO. Mr. President, the eyes of this nation and much of the world will be focused on New York Harbor this July 4th. On that day, the 100th anniversary of the Statue of Liberty will take place, a spectacular celebration of freedom, of patriotism, of caring, that has not seen its parallel in our lifetimes. There will be the world's largest fireworks display, an unveiling of Lady Liberty's new torch and a parade of tall ships, among other dramatic events.

It is only fitting on this historic occasion that the Commonwealth of Pennsylvania and the City of Philadelphia, both of which have played so great a part in this nation's struggle for freedom and independence, be appropriately represented. And so they will be.

Sailing prominently and proudly among the more than 100 tall ships on the 4th of July will be the historic Gazela Philadelphia, herself 103 years old and now the oldest wooden barkentine still sailing in the world. Flying atop her mast will be the flag of the Commonwealth of Pennsylvania, the flag that we are proudly presenting today to Mr. Jack Brown, Chairman of the Ship Preservation Guild.

The Gazela is more than just another tall ship. Owned by the City of Philadelphia and supported and operated by volunteers of the nonprofit Philadelphia Ship Preservation Guild, she is a goodwill ambassador for both her city and her state. In addition, the Philadelphia Port Corporation has continually contributed financial support to the ship. She frequently visits other ports and has served as a floating classroom to perpetuate the maritime skills learned by generations of hardy sailors. Since 1975, she has made trips with volunteer crews between Philadelphia and Portland, Maine; Bermuda, the Chesapeake, and most recently to Quebec, Halifax, Portsmouth, Boston and New York.

Most fittingly, the Gazela was chosen by a film production company to portray the Isere, the French ship that brought the Statue of Liberty to America in 1885, because the Gazela is the one ship in the world that most resembles the Isere. NBC-TV will show this documentary on June 30th.

By way of history, the Gazela was built in Portugal in 1883 from pine cut in forests planted in the 14th Century by Prince Henry, the Navigator. She was first used as a coastal trader in Europe and later as a Grand Banks dory fisherman. The Gazela is 177 feet long with a 27 foot beam. She has a mast height of 94 feet and a sail area of 11,000 square feet.

The Gazela will begin her trip to New York Harbor and the July 4th celebration in fine fashion. An estimated 20,000 spectators will be on hand to send her off from Penn's Landing on June 29th. She will arrive in New York on July 1st to take several children from Brooklyn to the historic South Street

Seaport for the grand opening of the Children's Museum. The Gazela will cruise around the port on July 3rd, readying herself for the Parade of Sail the following day. On July 5th and 6th, this historic vessel will be open to the public for touring and the following day she will depart New York Harbor enroute to Philadelphia, followed by a contingent of tall ships which will accompany her and participate in Philadelphia's Freedom Festival, July 9th to July 11th, an event to which you all are invited.

Therefore, I call upon my colleagues to extend congratulations to Mr. Brown and the captain and crew of the historic Gazela. May they fly the flag of the Commonwealth of Pennsylvania with the pride and dignity befitting this grand occasion.

Mr. President, at this time I would like Mr. Brown and the Chief Engineer, H. J. Talardy, Sr., of the Gazela to come forward and accept the flag. We hope you fly it proudly for us on July 4th.

(Applause.)

(Whereupon, the presentation of the Commonwealth of Pennsylvania flag was made to the Gazela representatives.)

Senator FUMO. At this time, Mr. President, I would appreciate the Senate giving its usual warm welcome to three other people who are with us this afternoon, two of whom have a presentation for you. They are Mr. Dominic Sabatini, the Managing Director of Penn's Landing Corporation, and Karen and Anthony Biddle, members of Philadelphia's prominent Biddle family and valued supporters of the Ship Preservation Guild. Mr. and Mrs. Biddle and Dominic, will you come forward.

The PRESIDENT pro tempore. We certainly welcome you here today.

(Applause.)

Mr. BIDDLE. Mr. President and Members of this Body, we are very grateful to have had the honor bestowed upon us to carry the flag in New York Harbor on July 4th. We would offer this as a token of our appreciation and we hope we see you all there.

(Applause.)

The PRESIDENT pro tempore. Somebody said that there has to be a reason why every once in a while the Lieutenant Governor does not preside. I think I have found mine today. Thank you very much.

Senator STAUFFER. Mr. President, I would like to join with the gentleman from Philadelphia, Senator Fumo, and the Members of the Senate in welcoming our guests here today. As some of you know, one of the great pleasures in life that I have is to travel wherever I can to photograph tall ships. Many times I have had the privilege of seeing and photographing the Gazela Primeiro. On July 4th, 1976, my wife and I had probably one of the great days of our life to spend that entire day at the end of the longest pier on the Hudson River during Operation Sail when all of the tall ships, including the Gazela, came into New York on that great, wonderful day that I shall never forget. I think all of us should recognize the dedication of those who have participated in the restoration

and the maintenance of the ship and those who dedicate a great deal of their time and ability and resources toward this ship. Back on July 4th, 1976, or just prior to that, many of the ships which were going to sail into New York Harbor made a visit to Bermuda. As a matter of fact, I guess there was a race to Bermuda and in the great hubbub which surrounds a race out of a harbor such as Bermuda's, the main mast of the Gazela was broken in an unfortunate accident. But not to be outdone and not to miss the great opportunity to sail into New York on that great day of July 4, 1976, there were temporary repairs made. There was a piece lashed on in order that the main mast would be usable, and the Gazela performed well in sailing up the Hudson that day. It was a great feeling of satisfaction to me to know that we in Pennsylvania and in the southeastern region do have one of the few great majestic tall ships that remains in this world representing our Commonwealth and carrying the flag of the Commonwealth.

I thank the folks for their dedication and all they do and wish them a great success, not only on July 4th, but for many, many years to come.

(Applause.)

The PRESIDENT pro tempore. I am sure Senator Stauffer and Senator Fumo speak for all of the Members of the Pennsylvania Senate in congratulating you and welcoming you. We know you are going to have an extraordinarily successful event, not only on July 4th but prior thereto, and many, many days, weeks, months and years thereafter. We welcome you and we are delighted that you could be here today to share these things with us.

SB 1113 (Pr. No. 2244) — The Senate proceeded to consideration of the bill, entitled:

An Act amending the act of April 9, 1929 (P. L. 177, No. 175), entitled "The Administrative Code of 1929," providing for the reporting of insurance claims; providing for budget preparation;

providing that fees be adopted by regulation; further providing for granting of easements by the Department of Environmental Resources; further providing for Administrative Boards and Commissions; adding and changing definitions relating to Crime Victims' Compensation; further providing for eligibility for Crime Victims' Compensation and for awards; providing for the responsibilities of providers of service to crime victims; further providing for the allocation of certain funds; extending the limitations period for the filing of claims for Crime Victims' Compensation by child victims; authorizing a program for the provision of assistance and counseling to women with crisis pregnancies who have chosen childbirth as an alternative to abortion; making an appropriation; making repeals; and making editorial changes.

The PRESIDENT pro tempore. Will the gentleman from Chester, Senator Stauffer, permit himself to be interrogated?

Senator STAUFFER. I will, Mr. President.

Senator ROCKS. Mr. President, I am attempting with other Members on this side of the aisle to understand the precedent of rereferring a bill that is here on a concurrence vote to a committee of the Senate. Could the Majority Leader, Mr. President, explain his understanding of that as per our Rules?

Senator STAUFFER. Mr. President, it is my belief that it is well within the right of the Senate Rules to send a bill on concurrence to committee. It has been done many times. In the particular instance before us, we have a bill that has a number of very large expenditures in it, and it is for the purpose of getting the fiscal impact of all of those various expenditures that the motion is made to rerefer the bill to the Committee on Appropriations.

Senator ROCKS. Mr. President, rather than a point of parliamentary inquiry or a question of a Rule challenge, because I understand our Rule very clearly and specifically to say bills on third consideration, we now take note in the Minority that this is the second time recently that a bill that has come to us from the House on concurrence is being rereferred to a committee here in the Senate. Mr. President, I would ask the Majority Leader, especially as we have some very significant votes coming up on the budget itself, and I do not think we

will find any larger expenditure than the budget bill and I doubt very much if we are going to see that bill at the point that it comes here on concurrence rereferred to the Committee on Appropriations or any other committee of the Senate, if it is his intent that this bill is going to the Committee on Appropriations for the review as he has described it, and is it coming back to the floor of this Senate, and could he possibly give us some indication of what time line that plan might be on?

Senator STAUFFER. Mr. President, there are a couple of issues embodied in the gentleman's question and I will respond as best I can. It was the view of Members of our caucus who made the suggestion that they desired a fiscal note on this bill and that it be sent to the Committee on Appropriations for that purpose. It was agreed that we should do this. It would be my expectation that the committee chairman would take the bill and would carry forth with that request and would deal further with the legislation. Obviously, in all fairness I cannot speak for the committee chairman. This is not something I have engineered or anything like that. It is a request of our caucus, and it would be the committee chairman's responsibility to deal with the issue as he sees fit.

Senator ROCKS. Mr. President, I thank the Majority Leader and appreciate very much his candor and accept by way of his motion which is before us now that this bill on concurrence vote is going for, hopefully, a speedy fiscal review in our Committee on Appropriations.

I will speak individually, Mr. President, on the point that there is some unorthodoxy for a bill on concurrence, as our Rules are written, to be rereferred to any committee of this Senate, and maybe at another point in time we can more thoroughly address that.

CHAPTER 1 GENERAL PROVISIONS

Section 101. Short title.

This act shall be known and may be cited as the Veterans' Act of 1986.

Section 102. Legislative findings.

(a) Recognition of contributions.—The General Assembly recognizes the great contributions and unselfish sacrifices made by Pennsylvania service people during armed conflicts in which the United States was a participant.

(b) Absence of memorial.—The General Assembly further recognizes that no adequate, appropriate and permanent memorial has ever been erected in appreciation of and in tribute to those Pennsylvania service people who gave devoted and dedicated service to their country and the Commonwealth.

(c) Erection of memorial.—The General Assembly believes that, in consideration of the foregoing, a positive, permanent and patriotic memorial should be erected on the grounds of the Indiantown Gap National Cemetery in appreciation of the full measure of devotion given by Pennsylvania's veterans.

(d) PTSD.—The General Assembly further recognizes the debilitating effects of Post Traumatic Stress Disorder upon our veterans and their families and by this act establishes a pilot program of residential and outpatient care and counseling. Section 103. Definitions.

The following words and phrases when used in this act shall have the meanings given to them in this section unless the context clearly indicates otherwise:

"Commission." The Pennsylvania Veterans' Memorial Commission created by this act.

"Department." The Department of Military Affairs of the Commonwealth.

"Fund." The Pennsylvania Veterans' Memorial Trust Fund established by this act.

"PTSD." Post Traumatic Stress Disorder.

CHAPTER 3

PENNSYLVANIA VETERANS' MEMORIAL COMMISSION

Section 301. Establishment of commission.

(a) Establishment.—There is hereby established the Pennsylvania Veterans' Memorial Commission to erect on the grounds of the Indiantown Gap Memorial Cemetery an appropriately patriotic and positive physical monument or memorial as a testament of appreciation from the Commonwealth to those Pennsylvania service persons who served in armed conflicts in which the United States was a participant.

(b) Composition of commission.—The commission shall be composed of the following:

(1) Two members of the Senate to be appointed by the President pro tempore of the Senate, one from the majority party and one from the minority party. Preference shall be given to honorably discharged veterans.

(2) Two members of the House of Representatives to be appointed by the Speaker of the House of Representatives, one from the majority party and one from the minority party. Preference shall be given to honorably discharged veterans.

(3) The Secretary of the Department of General Services, or his designee.

(4) The Executive Director of the Pennsylvania Historical and Museum Commission, or his designee.

(5) One member, appointed by the Governor, who shall be an architect.

(6) Five members, appointed by the Governor, who shall be Pennsylvania veterans. At least one of these members shall be a woman.

(7) The Commander of the Pennsylvania War Veteran's Council, or his designee.

(8) The State Adjutant of the Pennsylvania Veterans of Foreign Wars, or his designee.

(9) The Pennsylvania State Commander of the Disabled American Veterans, or his designee.

(10) The State Adjutant of the Pennsylvania American Legion, or his designee.

(11) The Adjutant General of the Department of Military Affairs, or his designee.

(12) The Director of the Bureau of Veterans Affairs in the Department of Military Affairs.

(13) One member, appointed by the Governor, who shall be a certified public accountant.

(c) Terms.—All members shall serve for a period of three years from the date of their appointment except that no member appointed under paragraph (1), (2), (3), (4), (7), (8), (9), (10), (11) or (12) shall serve past the date of expiration of his or her respective office.

(d) Vacancies.—Vacancies in the membership of the commission shall be filled in the same manner as the original appointment.

(e) Organization and procedure.—

(1) The commission shall meet initially within 90 days after enactment of this act and shall elect, by a majority of all its members, a chairman, vice-chairman and a secretary from among its members, each to serve for a term of three years.

(2) A majority of all members of the commission shall constitute a quorum for the transaction of business.

(3) The commission may adopt rules for its government, organization and procedures, not inconsistent with the provisions of this act.

(f) Expenses.—Commission members shall receive no compensation for their services but shall be reimbursed as hereinafter provided for all necessary travel and other reasonable expenses incurred in connection with the performance of their duties as members of the commission.

Section 302. Duties of the commission.

In addition to other powers conferred by this chapter, the commission shall have the power:

(1) To erect a physical monument to be located on the grounds of the Indiantown Gap National Cemetery honoring Pennsylvania veterans.

(2) To receive for and on behalf of the Commonwealth, monetary gifts or bequests which shall be deposited in the fund.

(3) To accept grants and subsidies from and enter into agreements or other transactions with any Federal agency or agency of the Commonwealth or other entity.

(4) To enter into contracts and to execute all instruments necessary or convenient for carrying on its operations.

(5) To issue appropriate regulations for the implementation of this chapter.

(6) To do all other things necessary or convenient to carry out the powers granted to it by this chapter.

Section 303. Pennsylvania Veterans' Memorial Trust Fund.

(a) Establishment and administration.—There is hereby established a separate fund in the State Treasury to be known as the Pennsylvania Veterans' Memorial Trust Fund. The fund shall be administered by the commission and all moneys in the fund are hereby appropriated to the commission on a continuing basis.

(b) Purpose.—The moneys in the fund shall be used:

(1) For the design and selection of an appropriate physical monument on the grounds of the Indiantown Gap Memorial Cemetery and other costs incidental thereto.

(2) For the payment of the necessary travel and other reasonable expenses incurred by members of the commission. No more than 0.5% of the fund shall be set aside for this purpose, with the remaining balance at the end of each fiscal year returned to the corpus of the fund.

(c) Contributions and solicitation of funds.—

(1) The commission is hereby authorized:

(i) To accept on behalf of the Commonwealth, gifts, donations, legacies and usages of money from individuals, organizations, public or private corporations and other similar entities.

(ii) To solicit and raise moneys from public and private sources.

(2) All moneys received or raised under this subsection shall be paid into the State Treasury and credited to the fund.

CHAPTER 5

POST TRAUMATIC STRESS DISORDER

Section 501. Pilot program.

The department shall develop and establish a pilot program of residential and outpatient care and counseling for veterans who are victims of PTSD.

Section 502. Facility.

(a) Location.—The program shall consist of one facility, as described in this section.

(b) Characteristics.—The characteristics of the facility shall include a homelike setting, centrally located, providing easy access by public and private transportation. Parking spaces shall be available for clients who will need to drive to and from work. The house shall be designed to serve up to ten clients in residence, plus a professional staff member. There shall be common rooms for dining, recreation and meetings. There shall be a private office for counseling and administrative work. This facility shall be located in a community with a suitable number of potential clients. Complete kitchen and laundry facilities shall be available. The facility shall be accessible to handicapped (wheelchair bound) clients.

Section 503. Staffing.

(a) General rule.—The program shall include two core personnel, the program director and administrator, and a complement of staff. A minimal staff-to-client ratio of one to eight will be maintained at all times in the residential unit.

(b) Director and administrator.—

(1) There shall be a program director who shall be responsible for all program development, policy, staffing, coordination with other agencies and funding.

(2) The administrator shall hold the chief administrative position in the program and shall direct all program operations. He shall oversee the development and implementation of all counseling services and reporting procedures. He shall make final determinations on acceptance, progress and discharge of all clients, supervise all professional and nonprofessional staff and maintain liaison with Veterans' Administration hospitals and other human service facilities used by the program. This shall be a full-time position, held by a master's or doctoral level professional with a background in management and experience with PTSD.

(c) Staffing of facilities.—The following describes the staff positions of the program:

(1) Mental health counselors shall have the responsibility for day-to-day implementation of specific intake, treatment planning and counseling activities with the clients. They shall provide individual and group therapy for clients residing in the house. The position shall be filled by two full-time mental health professionals who will rotate shifts. The requirements are for a doctorate level, licensed psychologist and/or certified M.S.W., experienced with veterans and PTSD problems. One counselor shall bear senior administrative responsibilities in the house and shall report to the administrator.

(2) An assistant director for house affairs shall oversee all day-to-day operations of the house, including procurement and maintenance of the facility and equipment and supplies; supervision of the cook/housekeeper; scheduling of daytime, overnight and weekend staff; and spot checks of client rooms. This shall be a part-time position.

(3) A cook shall be responsible for menu planning and preparation of evening meals, and cleaning of the kitchen and dining area of the house. This shall be a part-time job.

(4) Day counselors shall carry primary responsibility for the clients and house, shall assure that residents follow expected schedules and shall obtain on-call therapeutic assistance as necessary.

(5) Overnight counselors shall have responsibilities similar to the day counselors.

(6) A relief counselor shall be obtained as needed, day to day, to provide relief coverage for counselors during vacation and sick leave.

(7) Volunteers shall be used to supplement the staffing pattern at various times, in a manner that augments, rather than replaces, professional presence.

(8) An advisory board, composed of voluntary members, shall be used to offer guidance on program policy, fundraising, community relations and other aspects of operation.

(9) An office manager shall perform typing, communications, file management and related services. This shall be a part-time clerical worker.

Section 504. Contracts.

The department may enter into contracts with public or private medical or social welfare agencies to provide any services required under this chapter.

Section 505. Rules and regulations.

The department shall, in the manner provided by law, promulgate the rules and regulations necessary to carry out this chapter.

Section 506. Report to General Assembly.

The department shall make a report of the operation of the PTSD pilot program to the General Assembly not later than April 30, 1987. This report shall be transmitted to the chairmen and minority chairmen of the Military and Veterans Affairs Committees of the Senate and the House of Representatives.

CHAPTER 21

MISCELLANEOUS PROVISIONS

Section 2101. Repeal.

All acts and parts of acts are repealed insofar as they are inconsistent with this act.

Section 2102. Appropriation.

The sum of \$300,000, or as much thereof as may be necessary, is hereby appropriated to the Department of Military Affairs for operation of the program under Chapter 5 for the fiscal year July 1, 1986, to June 30, 1987.

Section 2103. Initial appointments.

Initial appointments to the commission established in Chapter 3 shall be made within 30 days of the effective date of this act.

Section 2104. Expiration of act.

(a) Chapter 3.—Chapter 3 of this act shall expire three years from the date of final enactment.

(b) Chapter 5.—Chapter 5 of this act shall expire two years from the date of final enactment.

(c) Remainder.—The remainder of this act shall expire upon the expiration of the last expiring chapter.

Section 2105. Effective date.

This act shall take effect as follows:

(1) Chapter 5 of this act shall take effect July 1, 1986, or immediately, whichever is later.

(2) The remainder of this act shall take effect immediately.

On the question,

Will the Senate agree to the amendment?

Senator LEWIS. Mr. President, very briefly, this amendment would provide the opportunity for a pilot program for veterans for the use of a halfway house in the hopes of attempting to provide medical and psychological services which they have been certified to need. All too frequently we find now that the facilities that provide these services are not conveniently available and, therefore, it is impractical and oftentimes impossible for needed services to be rendered. The

result of the failure of that in some instances has ended up in further societal difficulties and oftentimes infractions of the law. We think these veterans certainly deserve this kind of an interest and an opportunity, and with this type of a pilot program we think we can show that it will have a direct and meaningful benefit to the community.

And the question recurring,

Will the Senate agree to the amendment?

Senator CORMAN. Mr. President, what this does is divide the issue and divides the point of law so if a young person is guilty of consuming alcoholic beverages, he is guilty of that and would pay that penalty on its own. If he is guilty of a violation of the Motor Vehicle Code, then he is guilty of that and will face that violation alone. It does not combine the violation so, if an individual is sitting on his front porch and improperly consuming a beer, he cannot then lose his driver's license when he was not involved with a motor vehicle.

Senator SHUMAKER. Mr. President, I rise to oppose this amendment for two reasons. First, this guts the very heart of the bill by taking out the one deterrent that all young people understand and that is the value of their driver's license, and the effect of this is to take out entirely Section 6310.4, which has to do with the restriction of operating privileges. In the hearings we held and in the meetings we have had with all the groups who support this, and in the conversations with young people and appearances in high schools and elsewhere, the one thing they said they value and the one thing that would keep them from drinking more than anything else is to lose for one day or any period of time their motor vehicle operating privileges. I also might point out that in this bill on a first offense it is never counted as a record and there is no fine, but there is a restriction. If this is taken out, there will be no restriction, the driver's license can be maintained. But the point is that on a second offense there is a fine. On a third offense there is a greater fine, and so on down the line. If this amendment goes through, there is no way we can ever determine when a first offense occurs because there is no reporting. It can only be handled in a district justice's office as a first offense every time, and they can be put on a program where they can get training or they can get work that should be done in community service and things like this. Not only does it take away the deterrent, but it leaves the total system setup in shambles, and I would ask for a "no" vote on this amendment.

Senator EARLY. Mr. President, I, too, rise in opposition to this particular amendment. What I have found in dealing with teenagers when visiting high schools, the thing they value the most are their wheels, and when they are informed there will be a possibility that they no longer will be able to drive, that is when they take note. To take that particular provision out of this legislation—I agree with the gentleman from Dauphin, Senator Shumaker—you are taking out the guts, you are taking the purpose out of the legislation.

**MEMORIALIZING THE PRESIDENT AND THE
CONGRESS OF THE UNITED STATES TO
MAINTAIN THE HIGH PRIORITY OF THE
ISSUE OF AMERICA'S PRISONERS OF WAR
AND MISSING IN ACTION**

Senators RHOADES, BELL, WILT, LEMMOND, JUBELIRER, HELFRICK, SALVATORE, WENGER, HOPPER, MADIGAN, SHUMAKER, ARMSTRONG, PETERSON, MELLOW, LINCOLN, STAPLETON, STOUT, BODACK and SHAFFER offered the following resolution (**Senate Resolution No. 180**), which was read, considered and adopted:

In the Senate, June 24, 1986.

A RESOLUTION

Memorializing the President and the Congress of the United States to maintain the high priority of the issue of America's prisoners of war and missing in action.

WHEREAS, The 12 years after the Vietnam War have witnessed the triumphant return of 566 military and 25 civilian prisoners of war from Southeast Asia; there currently remain more than 2,436 Americans still missing or otherwise unaccounted for in Indochina; and

WHEREAS, The families of servicemen and civilians missing in Indochina still suffer untold grief and uncertainty due to lack of an adequate accounting; and

WHEREAS, The President has declared the issue of America's missing or otherwise unaccounted for in Indochina a matter of high national priority and has high level dialogue with the governments of the Lao Peoples' Democratic Republic and the Socialist Republic Vietnam on this issue; and

WHEREAS, The Socialist Republic of Vietnam, in February 1984, promised to accelerate the resolution of this humanitarian issue and, in February 1985, indicated it was interested in normal relations with the United States; and

WHEREAS, There is a growing body of evidence that Americans continue to be held captive in Indochina; therefore be it

RESOLVED, That the Senate support the President's pledge of high national priority to resolve the status of more than 2,436 Americans still missing and unaccounted for in Indochina; and be it further

RESOLVED, That the strongest signal that can be sent to the governments of Vietnam and Laos is the united voice of the American people, demanding that the United States Government and Congress take more decisive and aggressive action to secure the freedom of our POW's; and be it further

RESOLVED, That the Senate urge the President and the Congress of the United States to ensure that this issue remains one of highest national priority and to accelerate efforts in every possible way to obtain the immediate release of Americans who are still being held captive in Indochina; and be it further

RESOLVED, That copies of this resolution be transmitted to the Honorable Ronald Reagan, President of the United States, to the presiding officers of each house of Congress and to each

member of Congress from Pennsylvania, and to the legislatures of the 50 states.
