WHEREAS, Overcrowding of the inmate populations at correctional institutions maintained by both the Commonwealth and the City of Philadelphia continues to worsen, and much of this overcrowding is due to the increasing number of drug offenses and the imposition of mandatory sentences for drug-related crimes; and

WHEREAS, A Federal Court has issued an order placing a moratorium on the number of prisoners that can be incarcerated in the City of Philadelphia's correctional facilities; and

WHEREAS, More effective treatment can be provided by housing together those individuals with a shared problem, making it sound public policy for the Commonwealth to construct a new correctional institution in the City of Philadelphia to house and provide needed rehabilitative treatment for drug offenders; and

WHEREAS, The creation of a correctional institution reserved for drug offenders is a new initiative in the Commonwealth which recognizes current inadequacies in our overcrowd-

ing correctional system, based in great part on the continuing need to effectively address drug-related crime and to provide the necessary resources and space to responsibly treat drug offenders; and

WHEREAS, The General Assembly recognized the importance of this initiative when it appropriated the \$50 million included in Act 1988-113 for the construction of a 700-cell correctional facility in the City of Philadelphia; therefore be it

RESOLVED, That the Senate urge the Governor to immediately release this needed appropriation.

WHEREAS, A majority of the citizens of this Commonwealth depend on broadcast media as a major source of information; and

WHEREAS, The television and radio broadcasting of the proceedings of the Senate will give the citizens of this Commonwealth maximum direct public access to such proceedings and thereby assist them in achieving a better understanding of the public issues and of the practices and procedures of the Senate as a representative and legislative body; and

WHEREAS, It is the purpose of this resolution to provide a means, in conformity with acceptable standards of dignity, propriety and decorum, by which the proceedings of the Senate may be covered by television and radio broadcasts; and

WHEREAS, These broadcasts will be made for the information, education and enlightenment of the general public on the basis of providing accurate and impartial news coverage concerning the operations, practices and procedures of the Senate as a representative and legislative body; and

WHEREAS, These broadcasts will provide for the development of a perspective of understanding by the general public concerning the role and function of the Senate under the Constitution of Pennsylvania; and

WHEREAS, It is the intent of this resolution that the general conduct of the proceedings covered and personal behavior of the members of the Senate and of the television and radio personnel involved shall be in strict conformity with and in observance of acceptable standards of dignity, propriety, courtesy and decorum that is traditionally associated with and observed by the Senate; and

WHEREAS, The television and radio broadcasting of the sessions of the Senate shall in no way distort the objects and purposes of the proceedings or activities of the members of the Senate involved in said proceedings, or in connection with the general work of the Senate; and

WHEREAS, Television and radio coverage of the proceedings of the Senate shall in no way cast discredit or dishonor on the members of the Senate, or bring the Senate or any members thereof into disrepute; and

WHEREAS, The television and radio coverage of the Senate is a privilege granted by the Senate and shall be permitted and conducted only in strict conformity with the purposes, provisions and requirements of this resolution; therefore be it

RESOLVED, That the Rules of the Senate be amended by adding a rule to read:

**RULE XL
TELEVISION AND RADIO
COVERAGE OF SESSIONS
OF THE SENATE**

Coverage in General

1. Television and radio coverage of the proceedings in the Chamber of the Senate of Pennsylvania shall be authorized on a continuing basis, from gavel to gavel, except for caucuses and off-the-floor committee meetings.

Televised gavel-to-gavel coverage shall commence with a test period to last at least six months dating from the adoption of this rule. During this test period, no television or radio broadcast signal will be sent outside the capitol building for public or private use.

Type of Coverage

2. Coverage shall provide a complete, unedited record of what is said on the floor of the Senate and is intended to be an informative documentary, and not a staged performance, and is to be free from editorial analysis.

Only the presiding officer and the persons actually speaking shall be covered by the cameras during the proceedings and debate. Cameras shall not pan the entire Senate Chamber.

During roll call votes, and other votes, the cameras will be focused on the presiding officer and the appropriate clerks.

During recesses of the Senate, cameras shall be turned off.

The name of the Senator who is speaking shall be superimposed on the bottom of the screen.

Still photographs of the proceedings are prohibited.

The Committee on Rules may decide other minor issues which may develop.

Administration and Procurement

3. A lighting and camera consultant shall be hired by the Chief Clerk of the Senate to assist in the implementation of broadcast equipment.

The Office of the Chief Clerk shall be responsible for the installation of equipment and for the operation of the television broadcast, including the hiring of the necessary technical personnel.

All equipment shall be owned and operated by the Senate so that the Senate can more effectively supervise the broadcasts and prevent disruption of the normal proceedings.

Access

4. The continuous broadcast of the Senate shall be provided free of charge to any licensed radio or television station; the Rules Committee may, however, authorize other entities, such as government agencies and universities, to receive broadcasts.

Further Provisions

5. The State Museum and Archives shall store the historical copies which may be reviewed free of charge at the Museum. Copies may be made for the cost of the copy.

No coverage shall be used or made available for use as partisan political campaign material to promote or oppose the candidacy of any person for elective office, whether in paid political broadcasts or otherwise; and use of the coverage so provided shall be subject to all State and Federal laws relating to elections and campaign practices.

No part of such coverage or any recording thereof shall be used in any commercial advertisement.

Any live coverage shall be without and presented without any commercial sponsorship, except when it is part of a bona fide news program or public affairs documentary.

Nothing in any contract entered into by the Office of the Chief Clerk regarding installations of equipment shall permit any control over microphones in the Senate Chamber to be exercised by anyone but the appropriate Senate officers and employees.

Any television or radio network or station may or may not, at its discretion, broadcast any or all such coverage, either live or through the use of edited portions, in news broadcasts and other appropriate programs.

Offices of Senators and their staff are to be furnished with monitors to view the live proceedings.

Funding

6. This program shall be funded through the normal appropriation procedures.

DIRECTING CONGRESS NOT TO INCREASE THE FEDERAL MOTOR FUEL TAX

Senators CORMAN, JUBELIRER, ROSS, GREENWOOD, SHUMAKER, HELFRICK, MADIGAN, BELL, ANDREZESKI, FISHER, SHAFFER, HOLL, WILT, STOUT and O'PAKE offered the following resolution (**Senate Resolution No. 24**), which was read and referred to the Committee on Intergovernmental Affairs:

In the Senate, February 15, 1989.

A RESOLUTION

Directing Congress not to increase the Federal motor fuel tax.

WHEREAS, Some members of Congress have proposed significantly increasing the Federal motor fuel tax as a deficit reduction measure; and

WHEREAS, Such an increase in the Federal motor fuel tax is not in the national interest and will create unemployment, depress business activity, increase costs to all Americans by raising the cost of transportation and seriously limit the ability of the states to generate desperately needed highway revenues; and

WHEREAS, An increase in the Federal motor fuel tax would fall disproportionately on the nation's poor, on those who use vehicles for work purposes, and on citizens living in states where travel distances are greater and alternative transportation is unavailable; and

WHEREAS, Higher Federal motor fuel taxes would raise domestic transportation costs, cause American goods to be produced with additional costs and adversely affect the ability of American companies to compete with foreign exporters in overseas markets; therefore be it

RESOLVED, That the Senate of Pennsylvania oppose any increase in the Federal motor fuel tax for deficit reduction and urge the National Economic Commission to find other means of reducing the Federal budget deficit that would have a less harmful effect on citizens, businesses and state governments of the United States; and be it further

RESOLVED, That copies of this resolution be sent to members of the Pennsylvania delegation to the United States Senate and House of Representatives.

URGING THE SECRETARY OF TRANSPORTATION TO INVESTIGATE THE DANGEROUS TRAFFIC CONDITIONS EXISTING ON ROUTE 61 BETWEEN INTERSTATE 78 AND POTTSVILLE, PENNSYLVANIA

Senator RHOADES offered the following resolution (**Senate Resolution No. 25**), which was read and referred to the Committee on Transportation:

In the Senate, February 21, 1989.

A RESOLUTION

Urging the Secretary of Transportation to investigate the dangerous traffic conditions existing on Route 61 between Interstate 78 and Pottsville, Pennsylvania.

WHEREAS, At least 25 motorists and pedestrians have died in 21 traffic accidents since 1986 on a 16-mile stretch of Route 61 starting at South Centre Street in Pottsville and heading south to I-78; and

WHEREAS, That portion of Route 61 has been identified by the State as one of its 55 "problem corridors"; and

WHEREAS, The businesses and individuals who work and live in that area are in fear of their lives and livelihoods due to the number of traffic accidents that are occurring in that area; therefore be it

RESOLVED, That the Senate urge the Secretary of Transportation to investigate the dangerous traffic conditions existing on Route 61 between I-78 and Pottsville, Pennsylvania; and be it further

RESOLVED, That the Secretary of Transportation make recommendations at the conclusion of the investigation.

RELATING TO THE EXTENDED SCHOOL YEAR PROGRAM FOR AUTISTIC CHILDREN

Senators ANDREZESKI, REIBMAN, STOUT, STAPLETON, LYNCH, O'PAKE, JONES, STEWART, PORTERFIELD, DAWIDA, REGOLI and SHAFFER offered the following resolution (**Senate Resolution No. 26**), which was read and referred to the Committee on Education:

In the Senate, February 21, 1989.

A RESOLUTION

Relating to the extended school year program for autistic children.

WHEREAS, The Senate finds that, for autistic children, the extended school year program is essential due to the fact that repetition is an integral part of the autistic child's education plan; and

WHEREAS, The extended school year program provides additional education through the summer months for autistic and other special education students; and

WHEREAS, The extended school year program has recently been a source of controversy and debate concerning its benefits to special education students; therefore be it

RESOLVED, That the Senate of the Commonwealth of Pennsylvania instruct the Secretary of Education to review the extended school year program and to provide the Senate with a report as to the implications that such a program will have on the autistic student; and be it further

RESOLVED, That the Secretary of Education submit this report within 90 days from the passage of this resolution.

On behalf of the Commission on Crime and Delinquency (PCCD), I am pleased to forward you a copy of our federal FY-1989 state application for funds provided through the Drug Control and System Improvement Formula Grant Program established by the Anti-Drug Abuse Act of 1988. Under the Act, all state applications are to be submitted for legislative review but shall be deemed to be reviewed if the state Legislature does not comment on the application within 30 days.

The Drug Control and System Improvement Formula Grant Program established by the Anti-Drug Abuse Act of 1988 provides assistance to states and units of local government for the purpose of enforcing state and local drug laws and to improve the functioning of the criminal justice system with emphasis on violent crime and serious offenders. PCCD was designated by the Governor as the state office to apply for and administer these funds. Pennsylvania's FY-1989 allocation is \$4.936 million.

In its third year of administering these Anti-Drug Abuse Act funds, PCCD expects to utilize the funds to continue projects begun with the federal FY-1987 allocation, in addition to a very limited number of new initiatives. The attached application submitted to the federal Bureau of Justice Assistance on February 16, 1989 reflects PCCD's intentions.

It is with great pleasure that I submit the Department of Environmental Resources' Pennsylvania Conservation Corps Annual Report for 1988 as required by Act 112 of July 1984.

This report outlines the cumulative impact of the program from its inception in 1984 through December 1988. During this period, \$53,955,162 has been appropriated for PCC projects and program administration. Of the total \$53.9 million, \$26,409,669 (48.9%) was appropriated for wages and other costs as authorized by the Pennsylvania Conservation Corps Act, Act 112 of July 1984, and \$27,545,493 (51.1%) was appropriated for site development and materials' costs under the Recreation Improvement and Rehabilitation Act, Act 106 of July, 1984.

The purposes of the PCC program are to provide employment and training opportunities to economically disadvantaged youth between the ages of 18 and 25, and to foster economic development through labor-intensive improvement activities on public lands under the jurisdiction of the Department of Environmental Resources, the Fish Commission, the Game Commission, the Historical and Museum Commission, the Department of Military Affairs and local governments.

This report outlines the wide variety of public recreation, conservation and historical projects undertaken by corpsmembers in urban, suburban and rural areas of the Commonwealth, as well as the training, education and other benefits that accrue to corpsmembers.

The year 1988 was marked by an increased awareness of the contribution made by youth service nationwide. On October 13, PCC joined hundreds of other youth organizations both in Pennsylvania and across the country to celebrate "A Day in the Life of Youth Service." In all, more than 50 PCC projects honored the Day and showcased their accomplishments by planting eastern hemlocks, Pennsylvania's state tree, in ceremonies open to the public and the media. Governor Casey proclaimed October 13 Pennsylvania Youth Service Day.

The governor has shown his interest in PCC in a number of ways: first, he supported the extension of the program to June 30, 1989 and the appropriation of an additional \$14 million for PCC projects; second, to make the program more attractive to those disadvantaged youth whom it might benefit, he increased corpsmember wages from \$3.35 to \$3.85 an hour; finally, in recognition of PCC's role "in bringing together natural and human resources for the betterment of both," he proclaimed April 1988 Pennsylvania Conservation Corps Month.

In 1988, PCC continued to stress corpsmember development and training. Recognizing that basic skills—reading, writing and computation—are the foundation upon which all subsequent training must be built, PCC turned its attention to adult literacy. Beginning in January, all project operators were required to contact the nearest volunteer literacy council in an effort to secure tutoring for those corpsmembers in need of it. Their success in acquiring this tutoring, as well as other forms of training, is detailed in Table 13B.

Through PCC, eligible agencies are completing recreation, conservation and historical work that might not have been accomplished otherwise. For every public dollar spent, PCC is

returning \$1.31 in the value of projects completed. More important, corpsmembers are reaping the benefits of intensive on-the-job training, as well as job readiness skill training and placement services. When available and appropriate, corpsmembers are provided with the opportunity to obtain an equivalent high school diploma or to receive other formal education via the JTPA/SDA program or special arrangements with Vo-Tech schools.

Corpsmembers can work up to six months; in special instances, up to one year. From September 20, 1984 through December 31, 1988, over 7,600 corpsmembers participated in the program. Approximately 30 percent of these young men and women were former welfare recipients.

Participation in the Corps program provides a much needed work history and significantly increases the corpsmembers' opportunity to secure future full-time employment. To date, approximately 33 percent of former corpsmembers have gone on to other jobs after terminating from PCC.

The PCC experience—hands-on construction and renovation work, on-the-job and out-service training, the cultivation of the discipline, honesty and dependability essential in the workplace—all of this helps to build character, confidence and self-esteem. A former corpsmember wrote:

"I believe it to be a very successful program (at least for me). I learned a lot, and received skills that I didn't think I'd ever have. Therefore, I have more confidence in myself and my ability. Thank you!"

The program has important secondary economic benefits. For example, materials to construct projects are purchased from local vendors in most instances. Additionally, skilled tradesmen, who aid in construction and provide valuable job training throughout the life of the project, are hired locally.

Finally, the Corps can be mobilized quickly at the request of the Pennsylvania Emergency Management Agency to assist the elderly, the handicapped and the public in general, during declared or other emergencies. Tables 6 and 6A outline the extent of PCC assistance in past emergencies.

This report is proudly submitted on behalf of the many corpsmembers, crewleaders, and project operators who have contributed to the program's accomplishments and overall success.

Act 66 of 1981, directed the Public Employee Retirement Study Commission to study issues of public employee retirement, to formulate principles and objectives applicable to public employee retirement, and to recommend any new legislation deemed advisable. The Commission has identified the lack of a fiduciary responsibility and liability standard for the thousands of local government employee retirement systems in Pennsylvania as a significant deficiency, and this report contains the Commission's recommendations for remedying that deficiency.

The issue of fiduciary responsibility and liability was addressed for all private retirement plans in the Employee Retirement Income Security Act of 1974 (ERISA). Because ERISA does not apply to public retirement plans, fiduciary legislation is needed in Pennsylvania to establish a clear performance standard for all administrative aspects of local government retirement systems. The statewide retirement systems are not included in the proposed statute because the Commission believes adequate fiduciary standards already exist for those systems.

Properly designed fiduciary and liability standards for Pennsylvania's local government employee retirement systems will protect the taxpayers by increasing the probability that the retirement systems will be prudently run. Specific fiduciary standards will also protect active and retired public employees by requiring that their retirement systems be operated exclusively for the purpose of providing retirement benefits, by increasing the probability that the retirement systems will be able to pay their retirement benefits, and by making it clear whom to hold responsible in the event of problems. In addition, fiduciary standards will help public officials to know in advance what is acceptable behavior.

The first part of this report provides discussion and recommendations for each of the major elements of fiduciary responsibility and liability. The second part of the report is draft legislation implementing the Commission's recommendations for the General Assembly's consideration.

Pennsylvania's local government retirement systems have almost \$4 billion in assets, and the Commission believes that fiduciary responsibility and liability legislation is vital to the protection of those assets. Legislation to implement the Commission's recommendations on fiduciary standards for local government retirement systems will be introduced in the General Assembly in the near future. On behalf of the members of the Commission, I am soliciting your support for that legislation. I hope that the accompanying report will be of assistance to you in considering this important issue.

LEGISLATIVE LEAVE CANCELLED

The PRESIDENT pro tempore. The Chair recognizes the presence on the floor of Senator Fumo and his temporary Capitol leave will be cancelled.

The issue before the Body is a motion by Senator Loeper who moves that Senate Bill No. 335 be rereferred to the Committee on Appropriations. I would remind the Members of the Senate that the debate is limited to the issue of rereferral only.

And the question recurring,

Will the Senate agree to the motion?

Senator O'PAKE. Mr. President, I rise in opposition to rereferring this bill to the Senate Committee on Appropriations. All this bill does, Mr. President, is prevent the municipality from condemning land outside its own county if the host county disapproves of that condemnation for purposes of a landfill or expanding a landfill in the host county. I think it is very clear that it should not be a function of an out-of-county municipal authority to use the power of eminent domain to come in and condemn land so that it can dump its trash and its garbage in a county other than its own.

Mr. President, there is no fiscal impact on the Commonwealth of Pennsylvania by virtue of this legislation. This is clearly an attempt to kill this bill or bury it in the Committee on Appropriations. I support the gentleman from Allegheny, Senator Pecora, in his efforts to make sure that counties take care of their own trash. As you all know, last year we passed Act 101, and we gave counties broad new powers to control the flow of garbage and trash and solid waste disposal.

POINT OF ORDER

Senator LOEPER. Mr. President, I rise to a point of order.

The PRESIDENT pro tempore. The gentleman from Delaware, Senator Loeper, will state it.

Senator LOEPER. Mr. President, it was my understanding that the only issue under debate was the motion to rerefer, not the merits of the bill.

The PRESIDENT pro tempore. That is correct, and the gentleman will restrict his debate strictly to the merits of the rereferral and not the merits of the bill.

Senator O'PAKE. Mr. President, it is very clear that there is no fiscal impact on the Commonwealth or any of its subdivisions. There is no fiscal note that the Senate Committee on Appropriations could possibly come up with that will address any contingency in this plan, and, therefore, I respectfully urge my colleagues to allow this bill to be voted. I am sure there are constituents back home who want us to vote on this once and for all, and, therefore, I respectfully urge a "no" vote on the motion to rerefer so that we can face this on the merits today, before it is too late.

Senator LOEPER. Mr. President, as I indicated, the issue before us is the motion to rerefer to the Committee on Appropriations for a fiscal note. It is our view that it will have a significant impact fiscally upon the subdivisions of the Commonwealth and, therefore, by the Rules of this Senate, should properly be rereferred for consideration, and I would ask for an affirmative vote.

Senator FUMO. Mr. President, regrettably, I have to support the Majority on this procedural motion. I cannot conceive how the cost of the disposition of trash would not have a fiscal impact if we were allowed to do this or not allowed to do that. That in and of itself has a fiscal impact. Coming from Philadelphia, we are very sensitive to these types of issues, and I think we do have to study the numbers. As the Minority Chairman, I would urge that the bill be rereferred.

Senator O'PAKE. Mr. President, if the gentleman from Philadelphia had taken the time to read the bill, he would have realized that the exact language is—and I quote from page 4—"The host municipality may impose a municipal service charge on dumping at the site or facility, which charge must be reasonably related to the additional cost to the host municipality for extra services necessitated by the existence of the site or facility." So there is no fiscal impact on any political subdivision. As a matter of fact, I do not see how the Senate Committee on Appropriations would be able to come up with even the wildest guess as to a fiscal note. It is impossible to ascertain the possibility as the rule requires "an expenditure of Commonwealth funds or funds of any political subdivision." This is obviously addressed in the bill, and no further study by the Senate Committee on Appropriations could possibly shed any light on the fiscal impact of this legislation. I request a roll call vote.
