RESOLUTION INTRODUCED AND REFERRED

The PRESIDENT laid before the Senate the following Senate Resolution numbered, entitled and referred as follows, which was read by the Clerk: January 31, 1990

MEMORIALIZING THE GOVERNOR TO IMPLEMENT AN "ADOPT-A-HIGHWAY" PROGRAM IN PENNSYLVANIA

Senators AFFLERBACH, PECORA, STAPLETON, DAWIDA, BELAN, REGOLI, O'PAKE, GREENWOOD, PORTERFIELD, SALVATORE, BRIGHTBILL, MUSTO, REIBMAN, FISHER, RHOADES and SHAFFER offered the following resolution (Senate Resolution No. 134), which was read and referred to the Committee on Transportation:

In the Senate, January 31, 1990.

A RESOLUTION

Memorializing the Governor to implement an "Adopt-a-Highway" program in Pennsylvania.

WHEREAS, The increasing number of highways and an increasing number of motorists have contributed to an increase in the amount of litter along Pennsylvania roadways; and

WHEREAS, There is sincere concern about the quality of Pennsylvania's roadside environment, coupled with a desire to enhance that environment; and

WHEREAS, There is a need to create public awareness of environmental problems along Pennsylvania roadways; and

WHEREAS, Many civic organizations have demonstrated a willingness to participate in the removal of litter from our roadways; and

WHEREAS, Participants in an "Adopt-a-Highway" program would become personally involved in improving our environment by assuming the responsibility for litter pickup, mowing or otherwise beautifying a designated section of roadside environment; and

WHEREAS, Fifteen other states have successfully implemented "Adopt-a-Highway" programs; and

WHEREAS, Pennsylvania's implementation of such a program would benefit the environment and help maintain the natural beauty of our great Commonwealth; and

WHEREAS, The Pennsylvania House of Representatives has proposed House Resolution 243, which addresses this topic; therefore be it

RESOLVED, That the Senate of Pennsylvania memorialize the Governor to implement, through the Department of Transportation, an "Adopt-a-Highway" program in 1990.

Senator AFFLERBACH. Mr. President, I rise not to specifically debate the bill, but simply to bring to the attention of the Members that there are two bills on the Calendar dealing with this very same subject. One is the bill presently before us, Senate Bill No. 901, and the other is on second consideration, Senate Bill No. 333. Mr. President, Senate Bill No. 901 strikes at a problem that is most pertinent, particularly to our elderly population and anyone else who may suffer some sort of visual impairment. Very clearly, it makes an improvement in a situation that needs improvement, but I would also say that it is not as comprehensive nor as effective as Senate Bill No. 333. I would urge passage of Senate Bill No. 901 because it is a start. I would hope that next week we will take up Senate Bill No. 333, which is a much stronger start, and also pass that.

Senator BELL. Mr. President, I, likewise, concur with the remarks of the gentleman from Lehigh, Senator Afflerbach. To be a little more specific, Senate Bill No. 333 requires item pricing on the shelf. Senate Bill No. 901 does not require this. For a person going into a store and getting something off the shelf that has a price under it, that is not protecting the consumer. The Philadelphia Inquirer ran a series of articles on this and pointed out how the general public is not happy at all with the scanning that is done at the cash register, and the general public wants item pricing. The opponents, namely the retailers, will say, well, this will increase the cost of goods. The general public, according to the Inquirer articles—and I have also looked into this—feels that they are willing to pay a little bit extra so they do not get clipped on items which have one price on the shelf and another in the scanner. I know that Senate Bill No. 901 says if such is done, you can get the item for free if it does not cost, I think, over \$10. That does not protect the public.

Senator MELLOW. Mr. President, I need a point of clarification from some Member of the Majority on a very brief interrogation before I would recommend that the Members on this side of the aisle support House Bill No. 1401. I would like to interrogate someone on the Republican side, whether it be the committee chairman, which I think is the gentleman from Allegheny, Senator Pecora, or possibly the gentleman from Delaware, Senator Loeper, just for a point of clarification. I think more appropriately it would be Senator Loeper.

The PRESIDENT. Will the gentleman from Delaware, Senator Loeper, permit himself to be interrogated?

Senator LOEPER. I will, Mr. President.

Senator MELLOW. Mr. President, in the Township Commissioners magazine, third quarter of 1989, there was a strong position taken against this bill by the township supervisors, and I see where the bill has now been amended in the Senate. Does the amendment in the Senate answer the opposition that was expressed in the Township Commissioners magazine, third quarter of 1989?

Senator LOEPER. Mr. President, it is my information that we have never heard from the Township Commissioners Association relative to a position on the bill. There was an amendment that was added to it. The bill has been on our Calendar, and I would just indicate that we are not aware of any opposition to the bill.

Senator MELLOW. Mr. President, I will read it for the gentleman. Perhaps the gentleman from Allegheny, Senator Pecora, might be in a better position to answer it. The third quarter edition of the Township Commissioners magazine states their opposition to House Bill No. 1401, and it says that it "Amends the first class townships to empower commissioners to maintain certain alleyways with public funds."

The PRESIDENT. Will the gentleman from Allegheny, Senator Pecora, permit himself to be interrogated?

Senator PECORA. I will, Mr. President.

Senator MELLOW. Mr. President, I would just wonder if, perhaps, the gentleman from Allegheny, Senator Pecora, since I think he is the chairman of this committee, could make that clarification for us?

Senator PECORA. Mr. President, the bill was introduced for the sole purpose of small townships that have shopping centers and no parking areas for the residents of the communities. What they want to do is take the responsibilities by resolution or ordinance to accept the alleys and repair them to set up parking spots within the small townships.

Senator MELLOW. Mr. President, then, by my reading of the publication by the township supervisors, they oppose this part of the bill. Has that particular part of the bill been addressed in the amendments? It appears to me that on page 2 of House Bill No. 1401, Printer's No. 2966, that that particular part of the bill has been removed. The part of the bill was on lines 14, 15 and 16, subparagraph (b). Under Section 2013, it says that the "Township commissioners shall have the power and may expend public funds to open and maintain alleyways without regard to the limitations in section 2012." Was that the objection by the township supervisors and has that been addressed?

Senator PECORA. Mr. President, the township supervisors never contacted me on this legislation, so I have no knowledge of their objections or what their reasonings were.

Senator MELLOW. I thank the gentleman, Mr. President.

The only reason I mentioned it is because I have before me a copy of their publication where they have taken a position against House Bill No. 1401 based on that fact. All I am really trying to do is get a clarification.

Senator PECORA. Mr. President, my staff sent me a note here that the association helped in drafting an amendment to the bill and supported it. I was not aware of this. They worked with my staff, Mr. President.

Senator MELLOW. Mr. President, I thank the gentleman. That does clarify the fact that since the publication of the Township Commissioners magazine that we have, the amendment then has been added.
