MONDAY, June 18, 1990.

The Senate met at 2:00 p.m., Eastern Daylight Saving Time.

Commending the founders of the Pocono International Raceway.

WHEREAS, A group of sagacious investors, led by retired dentist, Doctor Joseph Mattioli, and his wife, Doctor Rose Mattioli, in the early 1960's purchased a 1,050-acre tract of land in the Poconos for the purpose of developing a major automobile racing facility; and

WHEREAS, After confronting and overcoming many obstacles, the racing facility was finally completed in June 1971; and

WHEREAS, Since its opening, Pocono International Raceway has become one of the leading motorsport facilities in the country, hosting two NASCAR Winston Cup Events, as well as a full card of road racing and motorcycle and truck racing events; and

WHEREAS, In the past five years, the raceway management, headed by Doctor Joseph Mattioli, has undertaken substantial programs for the improvement and beautification of the raceway; and

WHEREAS, Through the untiring efforts of Doctors Joseph and Rose Mattioli, the Pocono International Raceway has become one of the major cogs in the economic wheel of the Pocono Mountains area; therefore be it

RESOLVED, That the Senate congratulate Doctor Joseph Mattioli and his wife, Doctor Rose Mattioli, on a job well done; and be it further

RESOLVED, That a copy of this resolution be delivered to Doctors Joseph and Rose Mattioli.

**CREATING A TASK FORCE AND ADVISORY
COMMITTEE TO DEVELOP A PLAN TO
DIAGNOSE, TREAT AND REFER
SUBSTANCE ABUSERS**

Senators JUBELIRER, ROCKS, SALVATORE, LEMMOND, GREENWOOD, LINCOLN, REGOLI, GREENLEAF, FISHER, BRIGHTBILL, SHUMAKER, JONES, HOPPER, BELAN, REIBMAN, PETERSON, DAWIDA, SHAFFER, O'PAKE, STAPLETON, FATTAH, ANDREZESKI, WILT, PORTERFIELD, STOUT, HELFRICK, LYNCH, MUSTO, AFFLERBACH, RHOADES, LAVALLE, WILLIAMS, PECORA, MADIGAN, SCANLON, STEWART, CORMAN and BAKER offered the following resolution (*Senate Concurrent Resolution No. 172*), which was read and referred to the Committee on Rules and Executive Nominations:

In the Senate, June 18, 1990.

A CONCURRENT RESOLUTION

Creating a task force and advisory committee to develop a plan to diagnose, treat and refer substance abusers.

WHEREAS, Drug and alcohol abuse, including prescription drug abuse, is recognized as one of the most serious and immediate problems confronting our society today; and

WHEREAS, The Pennsylvania Medical Society, the Pennsylvania Osteopathic Medical Association and the American Medical Association have recognized substance abuse as their number one public health priority; and

WHEREAS, Physicians and other health providers are in a unique position to diagnose, treat and refer individuals with drug and alcohol abuse problems, and to educate against and prevent the occurrence of abuse; and

WHEREAS, Appropriate education and training of medical students, interns, residents, physicians and other health providers in substance abuse is an essential element in any comprehensive effort to combat the substance abuse problem; and

WHEREAS, The medical community of Pennsylvania has evidenced a strong desire and willingness to ensure that medical students, interns, residents, physicians and other health providers in Pennsylvania have available to them the appropriate education and training in substance abuse; therefore be it

RESOLVED, (the House of Representatives concurring), That, to accomplish these goals, a task force be created, composed of three members of the Senate, two from the majority party and one from the minority party, to be appointed by the President pro tempore of the Senate and three members of the House of Representatives, two from the majority party and one from the minority party, to be appointed by the Speaker of the House of Representatives; and be it further

RESOLVED, That an advisory committee be established to assist the task force; and be it further

RESOLVED, That the advisory committee shall include, but not be limited to, 14 members appointed by the President pro tempore of the Senate and the Speaker of the House of Representa-

tatives, one from the State Board of Medicine, one from the State Board of Osteopathic Medicine, five from the medical schools and colleges of Pennsylvania, one from the Osteopathic Medical College of Pennsylvania, one from the Pennsylvania Medical Society, one from the Pennsylvania Osteopathic Medical Association, one from the American Society of Addiction Medicine, one recovering physician and two from drug and alcohol service providers; and be it further

RESOLVED, That the task force recommend a plan to educate and train medical students, interns, residents, physicians, and health providers to ensure the early diagnosis, treatment and referral of substance abusers and to enable the medical students, interns, residents, physicians and health providers to educate against and prevent the occurrence of substance abuse; and be it further

RESOLVED, That the committee, if it deems necessary, explore sources of funding to cover the costs of the committee's activities and implementation of recommendations; and be it further

RESOLVED, That the task force prepare a report containing its findings and proposed necessary remedial legislation and deliver such report to the General Assembly no later than September 1, 1990.

An Act amending the act of March 10, 1949 (P. L. 30, No. 14), entitled "Public School Code of 1949," authorizing school districts to develop and implement integrated collaborative support service programs for certain students.

HB 247 (Pr. No. 2266) (Rereported)

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, further providing for deposits into the Judicial Computer System Augmentation Account; imposing additional fees; and making refunds.

HB 1294 (Pr. No. 3468) (Rereported)

An Act amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, further providing for exemption from registration fees; increasing the penalty for certain parking violations relating to handicapped and disabled veterans' parking spaces; and authorizing local authorities to permit handicapped persons and disabled veterans to issue certain statements.

Senator AFFLERBACH. Mr. President, I desire to interrogate the gentleman from Bucks, Senator Greenwood.

Senator GREENWOOD. I will, Mr. President.

Senator AFFLERBACH. Mr. President, could the sponsor tell the Chamber precisely what this amendment does?

Senator GREENWOOD. Mr. President, this amendment amends only that section of the bill that constitutes the members of the board that would oversee licensing for appraisers. The amendment does two things. It adds four members to what is in the bill a seven member board. It adds one representative from the banking community, one representative from the savings institutions and then two additional appraisers. The purposes for the amendment are, first off, to provide the members of the banking community, the members of the savings institutions community, the opportunity to (a) bring input into that board about the state of the art of lending and appraising within the financial communities, and (b) take information back from that board to the lending institution community. So, it is strictly intended as a conduit for information in this very complex process. The reason for adding the two additional appraiser members was so that by bringing on these two representatives of the lending commu-

nity, we do not unbalance the balance that exists in the bill which right now gives the majority on the board to the appraisers, which is, I believe, as it should be. That is what the amendment does and they are the purposes of the amendment.

Senator AFFLERBACH. Mr. President, does the gentleman know of any other professional licensure board in the Commonwealth of Pennsylvania wherein the Legislature has defined specific seats to be allocated to only members of other professions?

Senator GREENWOOD. Mr. President, I do not have familiarity with all of the various boards and licensing commissions in the state. I can tell you, for instance, the one board that I serve on myself, the Pennsylvania Trauma Foundation, we specify numbers of representatives from the hospital community, the doctors, the medical community, the nurses, et cetera. It certainly is not without precedent. I may add, if I might, that I believe eight of 14 states that have already gone through the process we are now engaged in have done precisely what this amendment does.

Senator AFFLERBACH. Mr. President, I would point out that the Trauma Foundation, first of all, is not a licensure board in the sense of licensing professionals as this board for real estate appraisers would be. Can the gentleman tell me if he is familiar with precisely why the federal government has requested that a board to license real estate appraisers be separate from any other real estate licensing endeavor?

Senator GREENWOOD. Mr. President, as I understand the requirements of the federal initiative in this area, there is a clear requirement that no one profession dominate this board, and that is clearly outlined in the guidelines. This bill, unamended, meets that requirement, and the bill with the amendment meets that requirement.

Senator AFFLERBACH. Mr. President, that concludes my interrogation, and I wish to comment on the amendment.

Mr. President, the federal government has taken an initiative to have the state set up independent licensure boards for real estate appraisers precisely in response to the savings and loan fiasco that has occurred nationwide. The reason for the request for an independent board is specifically to separate any conflict of interest from real estate brokers and real estate salespeople from real estate appraisers. Part of that initiative is also to separate any inherent conflict of interest of those who would be granting mortgages for the property from those who are appraising the value of the property. I believe that, very clearly, if we place individuals who may be asked to supply mortgages for a purchase of property on the board of real estate appraising, we have, in fact, compromised that board of licensure. Real estate appraisers should be distinctly separate and independent, as should the members of that board of licensure, from any inherent conflict of interest or even the idea that a conflict of interest may exist. Very clearly, this amendment would take away that clear separation. It would, in fact, create the idea that a conflict of interest may exist and, furthermore, it is unnecessary. If individuals from the savings and loan industry or the banking industry wish to

present information to the board of licensure for real estate appraisers, they can do so once that board is created and, likewise, the board may call in any of the financial institutions or any of the professional groups that represent them and request information. There is no need to guarantee two seats on that board to the financial industry. I believe it is an inherent conflict of interest. I do not believe it is what the federal government intended, nor do I believe it is good for setting up in the public perception the fact that real estate appraising will be separate and distinct from mortgage lending and from real estate sales. I ask defeat of the amendment.

Senator BELL. Mr. President, on this bill, the only reason it is in front of us is because of the savings and loan screw-up that has cost the United States of America many billions of dollars. The mandate that Pennsylvania change its law came in the basic legislation that told the United States administrators to go out and clean up the savings and loan industry. I am against putting anybody from the savings and loan on this board. That is like putting a fox in the chicken house.
