TUESDAY, September 25, 1990.

The Senate met at 1:00 p.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Mark S. Singel) in the Chair.

Senators PUNT, BAKER, SHUMAKER, BELL, MUSTO, BELAN, WENGER, STAPLETON, REIBMAN, SHAFFER, ROCKS, MADIGAN and RHOADES offered the following resolution (Senate Resolution No. 183), which was read and referred to the Committee on State Government:

In the Senate, September 24, 1990.

#### A RESOLUTION

Designating a flag to memorialize firefighters who died in the line of duty.

WHEREAS, Firefighters throughout this Commonwealth have discussed the commendability of having a flag to memorialize comrades who died in the line of duty; and

WHEREAS, After due consideration of the advisability of having such a flag, the Adams County Volunteer Firefighters designed and manufactured a Firefighters' Memorial Flag; and

WHEREAS, The Firemen's Legislative Federation of Pennsylvania has endorsed a flag designed and manufactured by the Adams County Volunteer Firefighters; and

WHEREAS, This flag was designed as a memorial flag for those firefighters who have died in the line of duty in this Commonwealth; and

WHEREAS, This flag has a field of blue with a gold keystone in the center which surrounds a Maltese cross, and at the bottom of the blue field, in gold capital letters, there is seen the phrase "Lest We Forget"; therefore be it

RESOLVED, That the Senate of Pennsylvania thank the Adams County Volunteer Firefighters for their artistic civicminded endeavors and commend the Firemen's Legislative Federation of Pennsylvania for its spirited support of a Firefighters' Memorial Flag.

### URGING THE GOVERNOR TO PROCLAIM THE WEEK OF SEPTEMBER 24 THROUGH 30, 1990, AS "MENSA WEEK"

#### A RESOLUTION

Urging the Governor to proclaim the week of September 24 through 30, 1990, as "Mensa Week."

WHEREAS, The week of September 24 through 30, 1990, is the beginning of a full year's observance in honor of the 30th anniversary of American Mensa; and

WHEREAS, Mensa, the internationally acclaimed roundtable organization composed of persons at or above the 98th percentile on standardized intelligence tests is generally acknowledged to exert a profound influence in the promotion and enhancement of the gift of intelligence on behalf of mankind and its members; and

WHEREAS, Mensa is engaged in charitable activities through its Gifted Children Program, its Scholarship Fund, and literacy programs conducted by local groups, and Mensa is engaged nationally, through the Mensa Education and Research Foundation, in granting scholarships to students throughout the United States: and

WHEREAS, American Mensa consists of 55,000 members from across the United States, and Mensa in the Commonwealth of Pennsylvania has approximately 2,500 members; therefore be

RESOLVED, That the Senate urge the Honorable Robert P. Casey, Governor of this Commonwealth, to proclaim the week of September 24 through 30, 1990, as "Mensa Week"; and be it

RESOLVED, That a copy of this resolution be transmitted to the Governor.

# DECLARING SEPTEMBER 24 THROUGH 28, 1990, AS "COMMUNITY BANKING WEEK"

Senators HOLL, JUBELIRER, SHAFFER, TILGHMAN, WILT, ARMSTRONG, PUNT, CORMAN, BELAN, PECORA, RHOADES, BELL, SHUMAKER, GREEN-LEAF, HELFRICK, HESS, LaVALLE, LYNCH, FISHER, LEWIS, WENGER, STOUT, O'PAKE, SCANLON, MELLOW, DAWIDA, STAPLETON, STEWART, ROCKS, HOPPER, LEMMOND, REIBMAN, GREENWOOD, FUMO, MADIGAN, SALVATORE and BRIGHTBILL offered the following resolution (Senate Resolution No. 187), which was read and referred to the Committee on Rules and Executive Nominations:

In the Senate, September 25, 1990.

#### A RESOLUTION

Declaring September 24 through 28, 1990, as "Community Banking Week."

WHEREAS, For over 100 years independent community banks in this Commonwealth have worked to provide for their local communities the local support necessary to grow and prosper. Local community banks have always put Pennsylvania first; and

WHEREAS, There are more than 200 locally-owned and operated independent banks with more than 750 banking offices found in small towns, rural areas, suburbs and cities throughout this Commonwealth. Collectively, they boast more than \$21 billion in assets and have more than 73,000 shareholders and 2.73 million account holders. Community banks are working citizens of their communities in every sense of the word. More than 12,500 full-time and 2,500 part-time employees work for Pennsylvania's community banks; and

WHEREAS, Community banks also work for their communities as an economic focal point where funds are "recycled." Community banks know that when money stays in town, it becomes a renewable resource, creating an economic cycle that constantly recirculates and revitalizes the community. On average, approximately 95 - 100% of the typical community bank's loan portfolio is reinvested in the community, usually within 50 miles of a bank office, and almost entirely within Pennsylvania's borders. The average community bank in Pennsylvania has over 30% of its holdings in commercial loans with local businesses and more than 50% in mortgage loans to local homeown-

WHEREAS, Community banks understand that bigger is not always better. Community banks focus on the prosperity of individuals and small businesses in their hometowns, not investments made at a far away headquarters where people do not share the same vested interest in a local community's economic health. In fact, Pennsylvania's community banks invest more than \$6.6 billion in residential and mortgage loans; more than \$4.5 billion in commercial loans; more than \$352 million in agricultural loans; and more than \$191.5 million in student loans; therefore

RESOLVED, That the Senate hereby declare September 24 through 28, 1990, as "Community Banking Week" and laud community banks across this Commonwealth for making Pennsylvania first in their financial commitments, their dedication as working neighbors, and above all, for serving as fiscally sound and reliable sources of economic lifeblood in communities all across this great Commonwealth.

An Act amending the act of November 26, 1975 (P. L. 438, No. 124), entitled, as amended, "Child Protective Services Law," further providing for confidentiality of records.

Senator BELL, from the Committee on Consumer Protection and Professional Licensure, reported the following bills:

#### SB 493 (Pr. No. 2499) (Amended)

An Act amending the act of July 1, 1987 (P. L. 187, No. 24), entitled "An act requiring retail gasoline dealers to post gasoline additive information; and imposing penalties," requiring the Department of Agriculture to establish standards relating to octane levels and additives, to develop a testing program and to enforce the standards established; and making an appropriation.

#### SB 1196 (Pr. No. 2500) (Amended)

An Act providing for consumer contracts; requiring plain language to be used in consumer contracts; providing for damages and limitations thereon, for opinions, for guidelines and for injunctive relief; and conferring powers and duties on various administrative agencies.

#### HB 8 (Pr. No. 4086) (Amended)

An Act relating to motor vehicle manufacturer-paid repair programs; requiring certain notice of such programs by manufacturers; requiring disclosure by dealers; providing for reimbursements in certain cases; and providing for sanctions.

#### HB 12 (Pr. No. 4087) (Amended)

An Act regulating the right to practice electrology; requiring the licensing of electrologists; providing for an Electrology Advisory Committee to the State Board of Cosmetology; making an appropriation; and providing penalties.

#### HB 243 (Pr. No. 4088) (Amended)

An Act relating to the practice of opticianry; requiring licensing of persons; and providing for injunctions and penalties.

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, further providing for limitation of actions relating to conversion and theft of timber.

An Act providing for the recognition and enforcement of money judgments obtained in another country.

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, providing for damages in actions on retail theft.

#### HB 1983 (Pr. No. 4090) (Amended)

An Act amending the act of August 22, 1953 (P. L. 1344, No. 383), known as "The Marriage Law," increasing fees to provide funding for domestic violence victims.

#### HB 2284 (Pr. No. 4091) (Amended)

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, providing redress for civil rights violations.

**HB 1069 (Pr. No. 4039)** — The Senate proceeded to consideration of the bill, entitled:

An Act amending Titles 24 (Education) and 71 (State Government) of the Pennsylvania Consolidated Statutes, further providing for the purchase of military service time; authorizing retirement credit for members of the Cadet Nurse Corps; further providing for termination of annuities, including disability annuities; transferring the pension service credit of certain Philadelphia Regional Port Authority employees to the State Employees' Retirement System; further providing for the terms of members of the State Employees' Retirement Board and for venture capital investments; authorizing creditable service for certain persons who were justices of the peace; clarifying out-of-State educational service for certain persons; further providing for retirement counseling; further providing for the compensation and classification of persons appointed by the Public School Employees' Retirement Board and the State Employees' Retirement Board; clarifying the authority of the boards regarding vehicles for authorized investments of the boards; providing for legal advisors; further providing for the annual interest rate; further providing for construction of the act; placing limitations on investments in companies doing business with Northern Ireland; and making a repeal.

Amend Title, page 2, line 25, by inserting after "INVEST-MENTS;": including enforcement officers and investigators in the Office of Attorney General and parole agents and parole warrant officers of the Pennsylvania Board of Probation and Parole within the definition of "enforcement officer" for retirement purposes;

Amend Sec. 6 (Sec. 5102), page 12, by inserting between lines 22 and 23:

"Enforcement officer."

(1) Any enforcement officer or investigator of the Pennsylvania Liquor Control Board who is a peace officer vested with police power and authority throughout the Commonwealth and any administrative or supervisory employee of the Pennsylvania Liquor Control Board vested with police power who is charged with the administration or enforcement of the liquor laws of the Commonwealth.

- (2) Any enforcement officer or investigator of the Office of Attorney General who is a peace officer vested with police power and authority throughout this Commonwealth and any administrative or supervisory employee of the Office of Attorney General vested with police power who is charged with the administration or enforcement of the criminal laws of this Commonwealth.
- (3) Any parole agent or parole warrant officer of the Pennsylvania Board of Probation and Parole, who is a peace officer vested with police power and authority throughout the Commonwealth, and any administrative or supervisory employee of the Pennsylvania Board of Probation and Parole vested with police power, who is charged with administrative or enforcement of the parole laws of this Commonwealth.

Amend Bill, page 35, by inserting between lines 3 and 4:

Section 23. (a) Any employee of the Office of Attorney General who comes within the definition of "enforcement officer" under the provisions of this amendatory act shall receive credited service as an enforcement officer for previous service in another agency of State government in which he performed services now performed by the Office of Attorney General and for service in the Office of Attorney General prior to the effective date of this amendatory act.

(b) Any parole agent or parole warrant officer of the Pennsylvania Board of Probation and Parole who comes within the definition of "enforcement officer" under provisions of this amendatory act shall receive credited service as an enforcement officer for service in the Pennsylvania Board of Probation and Parole prior to the effective date of this amendatory act.

#### SENATE RESOLUTION NO. 178, CALLED UP

Senator LOEPER, without objection, called up from page 5 of the Calendar, Senate Resolution No. 178, entitled:

A Resolution directing the joint State Government Commission to study ways in which the Commonwealth can better provide government services at minimal public cost by utilizing, where appropriate, private enterprise.

On the question, Will the Senate adopt the resolution?

SENATE RESOLUTION NO. 178, DEFEATED

Senator LOEPER. Mr. President, I move that the Senate do adopt Senate Resolution No. 178.

On the question,

Will the Senate agree to the motion?

Senator BELL. Mr. President, I oppose this resolution. This resolution asks for a study to be formed to bring out the benefits of privatization with respect to some of our governmental activities. I sat through a hearing on privatization on SEPTA, and I know what it meant. It meant that the work would be given to other people-private owners without union contracts—privatization to maintain the roads, state hospitals, community hospitals, prisons. We went down that road before, and we had some very gory details given to a committee on which I sat as to what would happen in a privately run prison, especially as to the quality of food. Trash removal, airports. Philadelphia wants to privatize their airport right now. As for community colleges, I know we would save a lot of money if we privatized the state university system. I have Cheyney in my district and West Chester adjacent to it. I am sure they could be run cheaper as far as the state is concerned if they were privatized.

Senator BAKER. Mr. President, I am fully cognizant of the arguments of my colleague. I would just make the point that the resolution simply calls for a study, and it may well be that his arguments would be borne out by the study. That is the purpose of having the study, so it can be a basis of recommendations for consideration of not only the services he mentioned, but of many other services, many of which might well be the subject of a beneficial privatization.

Senator AFFLERBACH. Mr. President, I join with my friend, the gentleman from Delaware, Senator Bell, to oppose this resolution. All of the Members of this Chamber will well recall that some years back the federal government decided to convene a similar commission which later became known as the Grace Commission. After many months of study and the expenditure of literally millions of dollars during that study, the Grace Commission released a voluminous report with well over a thousand recommendations by which the federal government could conceivably save money through privatization. The fact is that after ten years very, very few of those recommendations have been implemented whatsoever. In short, millions of dollars were wasted doing a study which is collecting dust on the shelves. I do not think we need a state level Grace Commission so we can waste additional funds at this level to put a study on the shelves, and I would oppose the resolution.

Senator BAKER. I would like to differ, Mr. President, slightly with my colleague who compares this study with the Grace Commission. The Grace Commission was done by an independent commission. This is using a staff organization which currently exists. It would certainly not be comparable in any way with the cost. Moreover, the Grace Commission was not to study just privatization. It was also to study, in addition to privatization, many other methods of saving money within the federal government which went far beyond privatization. I guess my main point would be that it certainly does not hurt if there is a possibility that, with the problem of budgeting that we have of government at all levels these days, if there is a way that we can save the taxpayers money and come up with a more efficient way of providing services, it certainly ought to be investigated. No one really has anything to fear from an investigation and a study that might save a lot of money in the long run.

Senator MELLOW. Mr. President, I would just like to make two points here. First of all, I totally agree with the comments by both the gentleman from Delaware, Senator Bell, and the gentleman from Lehigh, Senator Afflerbach, except there is one additional thing I would like to add. I believe there could be some question with the state parks, and we do know what type of opposition there has been to the privatization of state parks. I think, furthermore, Mr. President, if a study like this is needed, and perhaps it is, then I think the Committee on State Government here in the Senate, which is a duly formed standing committee in the Pennsylvania State Senate that is funded through our legislative management money that has a staff, and it is chaired by the gentleman from Schuylkill, Senator Jim Rhoades, I am sure would be very capable of making this particular type of study. I do not see where it has to be done by the Joint State Government Commission and then to be reported back to the Senate and to the House of Representatives. If there is a need for the study, we have the mechanism which we can put in place immediately. We have a standing committee with staff that has been funded that can report back in a short period of time to the Members of the Senate. Mr. President, I just think the amount of money that would be spent and the possibility of the consequences that may develop by having the Joint State Government Commission do it would not be appropriate, and at this time I would ask for a negative vote on the resolution.

#### SENATE RESOLUTION

MEMORIALIZING CONGRESS TO PASS
LEGISLATION WHICH GIVES INDIVIDUAL
STATES GREATER FLEXIBILITY IN
DEVELOPING PROGRAMS TO PROTECT THEIR
MUNICIPAL WASTE DISPOSAL CAPACITY AND
THE PUBLIC'S HEALTH AND SAFETY FROM
THE IMPORTATION OF MUNICIPAL WASTE
GENERATED IN OTHER STATES

Senators MELLOW, MUSTO, FISHER and LEMMOND offered the following resolution (Senate Resolution No. 188), which was read, considered and adopted:

In the Senate, September 25, 1990.

### A RESOLUTION

Memorializing Congress to pass legislation which gives individual states greater flexibility in developing programs to protect their municipal waste disposal capacity and the public's health and safety from the importation of municipal waste generated in other states.

WHEREAS, The capacity of disposal facilities located within this Commonwealth is significantly reduced by the importation of municipal waste generated in other states; and

WHEREAS, The reduction in capacity attributed to the importation of municipal waste from other states has the potential to limit available capacity to, and raise disposal costs for, municipal waste generated within this Commonwealth; and

WHEREAS, The Commonwealth must bear the costs associated with assuring the safe transportation and disposal of significant volumes of municipal waste generated by other states but disposed in facilities located within this Commonwealth; and

WHEREAS, The Commonwealth has undertaken a comprehensive planning and recycling program designed to provide adequate disposal capacity for municipal waste generated within this Commonwealth; and

WHEREAS, Increased importation of municipal waste generated in other states threatens to complicate the Commonwealth's long-term waste planning process, congest Commonwealth highways and endanger our citizenry by its transportation; and

WHEREAS, The Commonwealth's available landfill capacity is an important factor in its ability to encourage and sustain economic development; and

WHEREAS, Federal legislation is pending which would enhance the ability of individual states that have taken action to plan for their own disposal capacity to more effectively regulate municipal waste shipments from other states; and

WHEREAS, Under the pending legislation, these states would be able to limit the importation of municipal waste generated in other states and impose differential fees on municipal waste generated in other states; and

WHEREAS, The fees charged could differentiate between municipal waste imported and municipal waste generated by that state and also between municipal waste generated by different states; and

WHEREAS, The National Governors' Association recently recommended Congressional action to permit states to establish differential fees on waste imports to encourage states to develop their own capacity; therefore be it

RESOLVED, That the Senate of Pennsylvania support Congressional action that will allow the Commonwealth to more efficiently and effectively regulate the treatment and disposal within this Commonwealth of municipal waste generated in another state; and be it further

RESOLVED, That this authority should include the ability to impose limits and collect differential fees on municipal waste generated in another state and treated or disposed within this Commonwealth; and be it further

RESOLVED, That copies of this resolution be transmitted to the presiding officers of each house of Congress and to each member of Congress from Pennsylvania.

Senator LaVALLE. Mr. President, I move the Senate do now proceed to consideration of all bills reported from committees for the first time at today's Session.

The motion was agreed to.

#### PETITIONS AND REMONSTRANCES

Senator PETERSON. Mr. President, I guess I was amazed or puzzled or surprised a few moments ago when we defeated a resolution sponsored by the gentleman from Chester, Senator Baker, that directed a study. I guess I was also surprised that everybody on the Democrat side of the aisle opposed it. They talked of the cost of millions of dollars, comparing it to the cost of the Grace Commission. Well, as I read the resolution, or if they did read the resolution, I do not know how they came to that conclusion. So let us just review it a little bit. It says "WHEREAS, In a democratic, free enterprise system, the government"—that is us—"should work to insure that quality standards are met at the least possible cost to taxpayers...." Now I think that is something we all espouse, that we work to make government as efficient and effective, and provide the best service at the least price on an ongoing basis. Then it says: "RESOLVED, That the Joint State Government Commission appoint a task force to conduct a thorough study of ways in which the Commonwealth can provide government services at minimal public cost...." Now that is the function of this study and this is what I guess was going to cost millions of dollars, and I do not see how that could be. The state Local Government Commission has funding, I am told, adequate to do this study and many more. The task force that will be appointed will be Legislators from the different Bodies and the different sides of the aisle who will join hands and who will work with the staff of the state Local Government Commission to review certain things which I will later review. How is that going to cost millions of dollars?

Then it goes on and says, "...the task force may appoint an advisory committee...," which would be business types, professional types, that could advise, and, of course, their travel expenses and their per diems, but I am assured that there is plenty of funding in their present appropriation to take care of that. That is what they do in many studies. Let us review what they were asked to review. It says, "review and identify governmental functions which could better be performed by private enterprise...." I think governments do that every day. I think our present departments—General Services, PennDOT—make decisions every day whether they are going to have a consultant design a bridge or whether they have enough people in house to do that. I would hope we would evaluate in a lot of ongoing situations whether we should have the professionals in house when maybe it is a seasonal function that would be much more cost effective to hire consultants as needed and not in an ongoing bureaucratic way.

"Review existing privatization efforts on the Federal, State and local levels...." What does that say? It says, look around. See what other states have done. See what other transportation authorities have done. See what other mass transit systems have done. I think a lot of us recently attended something here that was put on by the Federal Transportation Commission downstairs at a breakfast one morning and talked about the problems that many states were facing with the tremendous costs of mass transit. We are not immune to that. That is a problem we face every budget year. I know this year when we appropriated a bond issue for \$57 million just to repair buses through our present system, it said something to me that maybe it is a system we really need to take a look at, and it does not seem to me that that is a threat. It is something that would be a support for state government, that maybe there is a cheaper way to provide mass transportation. Maybe there is not. Maybe it will not work, but across this country I am told these things are happening and maybe we ought to look and see what the cost effects are. It says, "establish standards of evaluation of existing governmental services by applying cost-benefit analysis and taking into account quality, safety and other performance standards...." I do not know what is so threatening about that.

It says, "review current bidding and procurement regulations to determine their efficiency...." What is threatening about that? I know in hearings of the Committee on Appropriations the last couple of years we were told that our system—it was a complaint brought to us by the SSHE system—that when they have the cash in the bank, our system of procuring a new roof, not a new building, takes five years, and if they wanted bond money, it takes six years. Now when you have the money in the bank and it takes five years to put a

roof on a building, I think we have a system that needs to be looked at, and here is the chance to have a look at it, and we voted it down.

"Review the possibility of integrating public and private services...." I think we should always take a look at when private enterprise and the public service can give us the best service to the people at the least possible price, and it says, "in particular, examine service areas, including, but not limited to, the following: transportation, including operation, construction, design of highways and transportation-related projects...." I happen to know that PennDOT does a lot of their design by private enterprise and most of their construction is done by private enterprise. What is threatening about them?

"Municipal services...." I served in local government for eight years, and we always evaluated whether we should buy another piece of equipment, and whether we had use of that piece of equipment enough to pay for it and have someone with the ability to maintain it, or were we better off hiring a local contractor eight times a year to provide that service and not own that expensive piece of equipment.

"Hazardous waste and environmental services...human services...hospital operation; housing and redevelopment programs; education and training services; and administrative services, including data processing...." Those are decisions that are made all the time. Do you have the data processing equipment in house, then hire the people who know how to use it? Or is it cheaper to contract and rent a service? Those are things that we should be doing ongoingly in state government, and I hope within the system we are.

Then it says, be "RESOLVED, that the Joint State Government Commission report the findings of its task force, together with recommendations for appropriate legislation, to the General Assembly as soon as possible." No time line. No deadlines to meet. It just says as soon as possible. That could be this year, next year in the legislative process or maybe five years down the road. We know sometimes the wheels of government turn very slowly. But as I read this, I just am amazed and I guess I am befuddled at why anyone would vote against it. Because what does this resolution say? Let us take a formalized look. Let us form a committee-you want to say-or a task force of Legislators using the Joint State Government Commission as our staff—a very inexpensive way. They are already funded, the money is already there, and I am told they are not totally booked up for the year. There is room for further projects—and take a look at how we are doing business. Is there any place in this whole system where maybe we could give better service for less money by using a private business instead of hiring state employees? That is just what it is all about. What is wrong with that? I think that kind of evaluation should go on daily and I hope it does go on in each and every department. Why we voted down this resolution to take a little formalized look at the legislative Body here for this reason is beyond my understanding, and I hope will be looked at sincerely again in the near future because it is the kind of thing we ought to be about all the time.

Senator MELLOW. Mr. President, as a public official much more famous than I will ever be said many, many times over and over during a campaign, here we go again. I guess here we go again. We are now in happy hour, a few legislative days prior to an election, and I guess we can expect to hear this from the Republicans as we convene Session every day and then conclude it in the evening. Unfortunately, the gentleman stated before that we did not read the resolution, and I can assure him that we did, but I question his ability to count because there were several Members of his own caucus including the first Member of his own caucus who led the charge to defeat the proposal. So even if all 23 Members on this side of the aisle thought it was not in the best interest of government to go ahead and to pass the proposal, and I think we felt on this side that it was not in the best interest based on the fact that a standing committee could do the same work, certainly the 27 Members who represent the same party as the previous speaker, had they shared his feelings, obviously Senate Resolution No. 178 would have been passed instead of defeated. So I really have to question, Mr. President, exactly where the gentleman is coming from with the exception that it is right before the election, and I know they are trying to the best of their ability to get any kind of an advantage possible, and perhaps this is just another step in that particular way that they are seeking advantage. But, Mr. President, the Committee on State Government, under the direction of the gentleman from Schuylkill, Senator Jim Rhoades—unless the gentleman does not have confidence in Senator Rhoades' ability to be able to do a study—is very capable and could do the exact same work and it would be done right here with Senate employees and with Members of this Senate in house who could do the work, and there is really not much more we can say on the issue.

Senator BAKER. Mr. President, it is possible that I may, on occasion, be justifiably accused of taking a partisan approach to a topic that comes before this Body. I am certainly a loyal Republican and supportive of the Republican candidates. However, I would have to suggest that the distinguished leader is off the mark in relating a long-term study which would report, I am sure, long after the election, to the hurly-burly of a political campaign. This has to do with the future of our Commonwealth. If I may be permitted a few brief remarks to put it in context, since it has been made an issue, Pennsylvania, in our preliminary census count, has lost population and will be losing political representation in Washington, reflecting that loss. I do not expect that there is going to be a widespread movement on the part of our state government to downsize in relationship to that loss of population. Maybe in the final count we will not lose it, but the fact is we will have a relatively stable population, rising costs and a budget we know is under pressure. Without even going into any partisan comments about the budget, it is safe to say that it will continue to be a pressure for this state and for every local subdivision within it. Taxpayers are virtually in revolt in this state and in many other states, and many local school boards have felt the sting of public response to tax increases

which they have had to levy this year. For that reason, it seems to me we in government ought to be accepting the responsibility for taking every means at our disposal to bring less costly, more efficient service.

I would have to just reiterate my previous comments to say that if anybody disagrees with the concept of privatization, then the way for that to be displayed is in a study of it. For those who purport to be in favor of rational consideration of government services to oppose a study, I do find questionable. However, I did have an explanation that possibly labor is opposed to this particular study and this, in the total scheme of things, minor resolution, but I feel that I will comment on that observation by saying I suppose, when the term "labor" is used, it means the organized labor movement, not necessarily representing all those who are laboring people. They are taxpayers, too. It is in their interest to have an efficient government and a cost-effective government. I have observed, and I think everyone has observed, that many problems of government and corporations in this country, when they become run for the benefit of those who are just in favor of doing things the way they have always been done, versus those who are seeking new, more efficient ways to do it, have, in some cases, led to the decline and to the loss of efficiency and loss of support and, in some cases, the inability to perform the functions for which they were originally intended. So it seems to me that we ought to be able to take a fresh look at government functions, many of which, by the way, are currently performed, as my distinguished colleague, the gentleman from Venango, Senator Peterson, has pointed out. I offer simply one piece of evidence. The mental health and mental retardation system has effectively used privatization in many of its services. In fact, if you compare the costs of the Department of Public Welfare run institutions versus those in the private sector with which the Department of Public Welfare contracts, you can find there is a considerable savings and a considerable difference in the cost of those services and not necessarily a distinction in the quality of service since DPW supervises these private contracts themselves. I think that is a model that could, perhaps, be applied to other parts of state or local government within Pennsylvania. I can say with no fear of contradiction that privatization is a movement whose time is coming. It is already here and in some respects it has already passed in terms of the importance of the idea and the concept as a way of saving money. I am sure we will be turning to it, and I would hope that the time will come when the Senate will agree to conduct this kind of a study, because if we do not, then we will surely be passed by by many other states where they are willing to make the kind of effort that this resolution calls for.

I have one final point. The gentleman from Lackawanna, Senator Mellow, discussed the existence of the standing committee, and I really have no great institutional preference for one means over another. However, I do not see why the leader of the Minority in this Body should criticize or imply that an existing commission established as a body of the Legislature cannot adequately perform a study function which falls

within its purview, whether it be the Local Government Commission or the Joint State Government Commission. They have a specific allocation of funds to do tasks exactly like the one this resolution calls for and, in fact, that is why they exist. As far as I am concerned, I hope through some means, through some mechanism, I will not find Senator Mellow opposing the idea of taking a hard look at ways in which we can save our taxpayers money.

Senator PETERSON. Mr. President, to be very brief, just a couple of responses to the Senator from Lackawanna, our esteemed Minority Leader, who said, here we go again. I just wanted to inform him that I did not plan to speak on this issue today. I guess I was just shocked when this issue came against opposition so strongly organized, and then I, for the first time, read the resolution and the more I read it the more amazed I was in his argument that it should be a standing committee. I think he has probably been a committee chairman. I have been Chairman of the Committee on Public Health and Welfare for a number of years and I know that is a committee that gets a lot of work. I would not have time to do this study. My staff would not have time to do this study. The Joint State Government Commission, a statutorily created committee by the House and Senate, this is exactly what they are there for. This is the kind of duty they were created for. This was the purpose. The standing committees in the House and the Senate have to deal with all of the communications across this Commonwealth from interest groups, have to deal with all the communications from Legislators in both Bodies, have to deal with the administration on regulatory review, and on and on it goes, and all the legislation that is drafted by Members and that Members want considered and to be reviewed and analyzed. I find my staff constantly overworked. To do this kind of a study in the Committee on State Government, I think, would be asking far more than their staff could possibly do. The Joint State Government Commission, if I understand correctly, is exactly why we created it. It is an inexpensive in-house way to take a broader look at issues and gather information. Now does this resolution change anything? No. What does it do? It comes back to the General Assembly with some facts and figures, and if the facts are that you do not want to change anything from the way we are doing it, you do not. We may get facts where there is just a little bit of savings and we decide we are not going to change it. But we may also get facts where the taxpayers of Pennsylvania could save hundreds of millions of dollars and, if that is the case, we ought to be looking at it.
