The Senate met at 11 a.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Mark S. Schweiker) in the Chair.

Senator OPAKE. Mr. President, the Senate has just adopted a resolution calling on school and other elected officials throughout Pennsylvania to do something about what we talked about last week. As you recall, last week in Philadelphia, the cradle of liberty, the Presidents' Summit for America's Future was held. I participated as a delegate, along with several hundreds of others. This was a unique gathering. Not only four of our present and former chief executives but thousands of community leaders very active in volunteer movements throughout this country were present. We convened to define and address the needs and means for encouraging the healthy and positive development of America's youth and America's communities and America's neighborhoods.

On Monday as a follow-up in Reading, I convened a minisummit of 45 leaders - religious leaders, community leaders, volunteer, and business leaders - and it was a very impressive meeting. The main message of both events is very clear: We need to involve our youngsters, our students, in productive activities that benefit them and their communities.

I am aware of a very good example of this at Reading Senior High School in Reading, Berks County. Over 300 students each year earn scholastic credits in return for their efforts in school as peer mediators, as tutors to younger students, as mentors for special needs youngsters, for helping with nonschool programs such as Meals on Wheels, and many other unselfish projects in and out of school. School administrators, community leaders, and the students themselves all attest to the positive results of this program in fostering a sense of community. I am sure that happens in many of our school districts throughout Pennsylvania but not in all of them. We need more such programs of volunteer service, service learning, if you will, in our schools across the Commonwealth. We need to foster and encourage them where they do not exist and we need to initiate them in other places.

The resolution I am introducing today recognizes that service to others is an important function of citizenship and of individual growth. We all journey through this life but once. We will all be judged by how we helped those in need. It is up to us now to carry the torch of volunteer service that was lit last week in Philadelphia to every school and every neighborhood in Pennsylvania.

I thank all of my colleagues for the unanimous vote in support of this resolution, and I would urge that we make this known and do our part to encourage the young people of today to realize that there is more to life than earning a paycheck, that we have to give back to our community and help those who are less fortunate and who need our volunteer commitment.
