MONDAY, February 2, 1998

The Senate met at 2 p.m., Eastern Standard Time.

The PRESIDENT (Lieutenant Governor Mark S. Schweiker) in the Chair.

SPECIAL ORDER OF BUSINESS GUEST OF SENATOR MICHAEL A. O'PAKE PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Berks, Senator O'Pake.

Senator O'PAKE. Mr. President, in observance of Groundhog Day, the Junior Achievement of Reading in Berks County is sponsoring a shadow day, and I am honored to have as my shadow today a student who is a senior at Fleetwood High School. She is the secretary of the student council. She was Fleetwood's representative for the Junior Miss contest. She is a very intelligent and ambitious young lady, very interested in government, although I understand her career goal is to be a school superintendent. I would like the Chair to recognize a guest Page who is my shadow for the day, Brooke Christman.

The PRESIDENT. Would Ms. Christman please rise so that the Senate may acknowledge you.

(Applause.)

PERMISSION TO ADDRESS

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Williams.

Senator WILLIAMS. Mr. President, I rise for a matter of personal privilege. Mr. President, when the Reverend gave the prayer a few minutes ago, in it he stated a prayer for a new sense of integrity in the Federal government. With what is in the news today, I take that to be a political swipe at the present administration concerning unsubstantiated allegations. I do not think that is appropriate, not to give each and every person or administration the due course of a process without being so judgmental that it is put in the form of a prayer as though each and every one agrees with that.

History certainly has shown us that things do reveal themselves one way or the other. That is the American way. History also shows us that in certain matters there is no claim by one party or another on certain behavior. And so I just think it was fundamentally flawed, inappropriate, and I reject that notion in the interest of fair play, in the interest of what the American people would have happen now, and that is for these matters, if they are the matters referred to, to play themselves out in due course.

I might also add, since the deity was invoked and since Christ was mentioned, his principles always were about fair play, due process, and judge that they be not judged.

SPECIAL ORDER OF BUSINESS CEREMONY IN COMMEMORATION OF GROUNDHOG DAY

The PRESIDENT. The Chair recognizes the gentleman from Indiana, Senator Stapleton.

Senator STAPLETON. Mr. President, you know, I have often heard the saying around here that it is a beautiful day in Pennsylvania. Well, it is a beautiful day in Punxsutawney, Jefferson County, Pennsylvania, and, Mr. President, I am not sure also that I really do not have a shadow as Senator O'Pake mentioned, but I do have a friend who saw his shadow today.

You know, here we are on February 2 in this great little community of Punxsutawney where that furry forecaster, the prognosticator Punxsutawney Phil, again told a record crowd of a little over 15,000 old people, young people, and children to expect 6 more weeks of winter. The shadow was there, which in groundhogese means there will not be an early thaw.

And this fellow Phil is quite remarkable, Mr. President. This is the 111th time for forecasting from his home in Punxsutawney, and now we have a documentary film called

"Groundhog, the Spirit of Punxsutawney," we have the great Bill Murray's film "Groundhog Day," and, yes, all the national coverage and visitors who were there today from as far away as Japan. Representatives from the foreign press were at the event this morning, and, yes, this year also is the first time ever that Phil's web site taken from the Internet could be watched live on their computer screens today.

I recall that Willard Scott, the great nationally known weather forecaster, has been in Phil's presence on several occasions, and as I indicated, all this took place at 7:24 this morning at Gobbler's Knob with the members of the Inner Circle and cheering spectators, including families and groups of college students from in-State and out-of-State. When he emerged from his burrow, I have been told that he stood up proud and tall and confident, and looking skyward and then towards the ground, he saw his shadow, forecasting 6 more weeks of cold winter weather. And I am quite confident, Mr. President, that most of the Members here today have the same confidence in this mature, reliable weather prophet.

It is true that the groundhog from Quarryville is bilingual and predicts the weather in more than just one language, as we have heard for many, many years, and this has caused some confusion to many of us as to whom to believe: Is it Phil from Punxsutawney, or is it Orphie from Quarryville? But I believe both groundhogs today saw their shadow, so they do have something in common, and I am sure we would like to hear a few words from Senator Wenger.

Thank you very much, Mr. President.

The PRESIDENT. The Chair thanks Senator Stapleton, so figuratively speaking, we will leave Jefferson County and travel east to Lancaster County, and I think Senator Wenger has some comments about the contributions of Orphie and the weather prediction.

The Chair recognizes the gentleman from Lancaster, Senator Wenger.

Senator WENGER. Mr. President, each year on Groundhog Day the Pennsylvania Senate, in our usual deliberative fashion, pauses to consider the wisdom of two great weather prophets, Punxsutawney Phil and Quarryville Orphie. When they agree, we all know when to expect the arrival of spring. When they disagree, we not only have confusion as to the arrival of spring, but it also raises the more profound question as to which groundhog to believe. And in this business, I am sure Senator Stapleton would agree that believing is a very major part of the process.

Now, this year, today on February 2, 1998, Quarryville Orphie saw his shadow and promptly scurried back into the burrow, assuring us of 6 more weeks of winter. And interestingly enough, Punxsutawney Phil had the same experience, and in the interest of State unity he agreed with the infallible Orphie that we will indeed have 6 more weeks of winter. Now, since Quarryville is a little bit to the east of Punxsutawney, I would point out, Mr. President, that Quarryville Orphie did indeed see his shadow before Phil had an opportunity to do so, so again, Orphie did come in first, but his prediction was confirmed by Punxsutawney Phil as well.

Now, the agreement between the two groundhogs certainly is significant at this time, and it remains to be seen, Mr. President, if this spirit of bipartisan harmony will prevail during the forthcoming budget debate and passage. Suffice it to say be in preparation for 6 more weeks of winter, the two great groundhogs have spoken.

And now, I have again been requested in the tradition of making a few comments in the Pennsylvania German dialect concerning our great weather prophets, and I can only say, Mr. President:

Die Pennsilfaanisch Deitsch bauere wisse es iss kee gebrauch fer die Orphie fechde, so lockern un gen mit die fliesse. Du die lang unnergleeder aw, griege en gute versarye vun hols fer die feierblatz un ruh, fer gewiss friehyaahr wedder koomt zeitlich.

SENATE RESOLUTION ADOPTED

Senators HOLL, ROBBINS, LOEPER, KASUNIC, KUKOVICH, WAGNER, AFFLERBACH, HELFRICK, SLOCUM, TOMLINSON, TARTAGLIONE, MOWERY, SALVATORE, COSTA, BRIGHTBILL, WENGER, TILGHMAN, ULIANA, STOUT, BELAN, GREENLEAF, CORMAN, O'PAKE, MELLOW, WHITE, SCHWARTZ, LEMMOND, RHOADES and HART, by unanimous consent, offered Senate Resolution No. 119, entitled:

A Resolution designating February 2 through 9, 1998, as "Boy Scout Week" in Pennsylvania.

On the question,

Will the Senate adopt the resolution?

Senator HOLL. Mr. President, this resolution honors one of American's most influential organizations, the Boy Scouts of America. This resolution designates the week of February 2 as "Boy Scout Week" in Pennsylvania.

It has been 88 years since the Boy Scouts of America was founded by Lord Baden-Powell back in 1910. Since that time, the world scouting movement has influenced literally thousands of young men, instilling confidence, imparting knowledge, and making boys into leaders. In fact, some of our history's most impressive leaders include Presidents, Congressmen, Senators, judges, and clergy, all having been Boy Scouts. The organization has even left its mark on the moon. Astronaut Neil Armstrong was an Eagle Scout, the highest rank in scouting.

Scouting is perhaps more important now than ever because in these days, many, many young men are living troubled lives and are hungry for guidance, the type of guidance which scouting provides. The organization gives young people a productive outlet for their creativity and a chance to grow in mind and body. It builds character and encourages good citizenship which, in turn, benefits our Commonwealth.

Mr. President, on behalf of all past, current, and future Boy Scouts, I urge the immediate adoption of this resolution.

And the question recurring,

Will the Senate adopt the resolution?

A voice vote having been taken, the question was determined in the affirmative.

Section 1. The act of August 9, 1955 (P.L.323, No.130), known as The County Code, is amended by adding sections to read:

Section 1216. Sheriff's Employes.—(a) Appointment and promotion of deputies and other employes in the office of sheriff of a county of the third through eighth class shall be made in the manner provided by the act of August 5, 1941 (P.L.752, No.286), known as the "Civil Service Act," except as otherwise provided in this section.

- (b) A county of the third to eighth class shall, within twelve months following the effective date of this section, enter into a contract with the State Civil Service Commission for the purpose of establishing a complete civil service merit system protecting the deputy sheriffs and employes of the sheriff's office. The contract shall be executed in accordance with the provisions of the "Civil Service Act," and each county is authorized to make the payments required by that act.
- (c) The contract shall provide for a civil service merit system for all current deputy sheriffs and employes. The State Civil Service Commission shall use only the provisions of the "Civil Service Act" in setting standards and principles for employment. The commission shall include in the system the same duties and obligations, rights, prerogatives, and appeals provided for employes by the "Civil Service Act." The agreement shall provide that persons employed on the effective date of this section shall continue in their present positions, without taking an examination, and may be removed only in accordance with section 807 of the "Civil Service Act." The agreement shall also provide that the compensation of all deputy sheriffs and employes of the sheriff shall be determined by the county.
- (d) Appointees shall be selected for each existing vacancy from the eligible list in the order of names of persons thereon who have received the highest average on the written examination. Appointments shall be made in the order of names of persons who have received the highest average.
- (e) Civil service examinations to test applicants shall relate to such matters and include such inquiries as will fairly test the merits and fitness of the persons examined to discharge the duties of employment.
- (f) All positions for deputy sheriff and employes shall be classified as competitive. Persons holding positions of deputy sheriff or employe on the effective date of this section shall continue to occupy those positions. New openings for a vacancy in the position of deputy sheriff or employe shall be classified as competitive on and after the effective date of this section.
- (g) In no case shall an applicant for promotion in the sheriff's office be considered until the applicant shall have first served three years in the sheriff's department. No member of the sheriff's office shall be eligible to take any promotional examination until after serving three years in the sheriff's office. Each member of the sheriff's department shall have his examination mark or grade increased by an additional one-half point for each year he served in the sheriff's department, but such additional points shall not exceed ten points.

(h) All applicants for examination shall undergo a physical examination, which shall be conducted under the supervision of a doctor of medicine. No person shall be eligible for appointment until a doctor certifies to the commission that the applicant is free from any bodily or mental defects, deformity or disease that might incapacitate him or her from the discharge of the duties of the position desired in the sheriff's department.

Section 1217. Political Activity by Sheriff's Employes.—(a) No employe shall use his official authority or influence for the purpose of interfering with or affecting the result of an election.

- (b) No employe shall take an active part in political management or in a political campaign. Activities prohibited by this subsection include, but are not limited to, the following activities:
- (1) Serving as an officer of a political party, a member of a National, State or local committee of a political party or an officer or member of a committee of a partisan political club, or being a candidate for any of these positions.
- (2) Organizing or reorganizing a political party organization or political club.
- (3) Directly or indirectly soliciting, receiving, collecting, handling, disbursing or accounting for assessments, contributions or other funds for a partisan political purpose.
- (4) Organizing, selling tickets to, promoting or actively participating in a fund-raising activity of a candidate in a partisan election or of a political party, or political club.
- (5) Taking an active part in managing the political campaign of a candidate for public office in a partisan election or a candidate for political party office.
- (6) Becoming a candidate for, or campaigning for, an elective public office in a partisan election.
- (7) Soliciting votes in support of or in opposition to a candidate for public office in a partisan election or a candidate for political party office.
- (8) Acting as recorder, watcher, challenger or similar officer at the polls on behalf of a political party or a candidate in a partisan election.
- (9) Driving voters to the polls on behalf of a political party or a candidate in a partisan election.
- (10) Endorsing or opposing a candidate for public office in a partisan election or a candidate for political party office in a political advertisement, a broadcast, campaign, literature or similar material.
- (11) Serving as a delegate, alternate or proxy to a political party convention.
- (12) Addressing a convention, caucus, rally or similar gathering of a political party in support of or in opposition to a partisan candidate for public office or political party office.
 - (13) Initiating or circulating a partisan nominating petition.
- (14) Soliciting, paying, collecting or receiving a contribution at or in the workplace from any employe for any political party, political fund or other partisan recipient.
- (15) Paying a contribution at or in the workplace to any employe who is the employing authority of the person making the contribution for any political party, political fund or other partisan recipient.
- (c) An employe or individual to whom subsection (a) or (b) applies retains the right to vote and to express an opinion on political subjects and candidates, and may engage in the following activities:
 - (1) Register and vote in any election.
- (2) Express an opinion as an individual privately and publicly on political subjects and candidates.
- (3) Display a political picture, sticker, badge or button when not on duty and at locations other than the workplace.
- (4) Participate in the nonpartisan activities of a civic, community, social, labor or professional organization, or of a similar organization.
- (5) Be a member of a political party or other political organization or club and participate in its activities to the extent consistent with this section.
- (6) Attend a political convention, rally, fund-raising function or other political gathering.

- (7) Sign a political petition as an individual.
- (8) Make a financial contribution to a political party or organization.
- (9) Be politically active in connection with a question which is not specifically identified with a political party, such as a constitutional amendment, referendum, approval of a municipal ordinance or any other question or issue of a similar character.
- (10) Otherwise participate fully in public affairs, except as prohibited by law, in a manner which does not materially compromise efficiency or integrity as an employe or the neutrality, efficiency or integrity of the sheriff's office.
- (d) Notwithstanding anything in this section or any other act to the contrary, no person shall be deemed ineligible for the office of school director solely on the basis that such person's political activities are otherwise restricted under this section.
- (e) Subsection (c) does not authorize an employe to engage in political activity while on duty or while in a uniform that identifies him as an employe. The sheriff of a county may prohibit or limit the participation of an employe or class of employes of the sheriff's office in an activity permitted by subsection (c), if participation in the activity would interfere with the efficient performance of official duties or create a conflict or apparent conflict of interests.
- (f) An employe who violates this section shall be removed from employment and funds appropriated for the position from which removed thereafter may not be used to pay the employe or individual: Provided, That, the State Civil Service Commission at its discretion may impose a penalty of suspension without pay for at least thirty days, but not more than one hundred twenty days, if it finds that the violation does not warrant termination.
- (g) An employe who is currently an officer in a political party or who holds a political office on the effective date of this section may fulfill the remainder of his term. Upon completion of the term, the provisions of this section shall apply.
- (h) The following words and phrases when used in this section shall have, unless the context clearly indicates otherwise, the meanings given to them in this subsection:
- "Contribution" means any gift, subscription, loan, advance, deposit of money, allotment of money or anything of value given or transferred by one person to another, including in cash, by check, by draft, through a payroll deduction or allotment plan, or by pledge or promise, whether or not enforceable, or otherwise.
- "Election" means a primary, municipal, special and general election.
- "Employe" means a person employed in the office of sheriff of a county. The term includes management employes, deputy sheriffs and clerical employes. The term does not include a sheriff of a county.
 - "Employing authority" means an employe's supervisor.
 - "Partisan" when used as an adjective refers to a political party.
- "Political fund" means any fund, organization, political action committee or other entity that, for purposes of influencing in any way the outcome of any partisan election, receives or expends money or anything of value or transfers money or anything of value to any other fund, political party, candidate, organization, political action committee or any other entity.

Senator COSTA. Mr. President, this amendment essentially takes care of or works with the other 62 counties in the Commonwealth of Pennsylvania, the third to eighth class counties,

and relates to the sheriff's office civil service practices in those counties. This amendment will essentially do the same thing which we did to Allegheny County a few weeks ago, and that is place the deputy sheriffs in those respective counties under the civil service process. It will also take those individuals out of the political activities, as was recently done in Allegheny County.

Mr. President, what took place in Allegheny County as relates to the sheriff's department there, we felt and their people believed it was a good government measure. Mr. President, I believe if it was a good government measure for Allegheny, then we should implement it across our Commonwealth, and I ask my colleagues to support this measure.

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Allegheny, Senator Hart.

Senator HART. Mr. President, I rise in opposition to the amendment. It is actually a separate issue to make the sheriffs from all the other counties aside from Allegheny civil service simply because the sheriffs in other sheriff's offices in the Commonwealth are not designated police officers, as are those in Allegheny County. Therefore, Mr. President, I urge a negative vote.
