SENATE

TUESDAY, May 11, 1999

The Senate met at 12 m., Eastern Daylight Saving Time.

The PRESIDENT pro tempore (Robert C. Jubelirer) in the Chair.

PRAYER

The Chaplain, Rabbi MAURICE NOVOSELLER, of Beth Chaim Synagogue, Feasterville, offered the following prayer:

Dear God, who dwells not only in the heavens above but within whom all of the universe resides, we invoke Thy blessings upon those gathered here, who in their daily pursuits subliminally invoke inspiration from the wisdom that comes from Thee.

Senator RHOADES. Mr. President, in the gallery today is an exceptional group of young ladies. They have the unique achievement of being the Nativity BVM High School Girls' Basketball Team, who captured the 1998-99 PIAA Class A State Championship after defeating Bishop Guilfoyle High School by a score of 74 to 67.

I am holding the front page of a newspaper which has been framed which says, "Truly Golden." These exceptional young women are led by seniors Marlyse Charney, Anne Dougherty, Brianne Guers, and Lauren Marshall, who also happens to be my niece; juniors Kristin Cuff, first team all-State Erin McGee, whose father was a State champ at St. Clair High School, Elizabeth Mohan, Jill Schane, and Lindsey Williams; sophomores Tia Carl, Michelle Dougherty, Katie Halcovage, Laura McDonald, Jennifer Reeves, Meggi Rothermel, and Jaime Williams; and freshmen Holly Behney, Ashley Edwards, Mary Hendricks, Jennifer Lang, Jamie Marshall, who also happens to be my niece, and Valerie Widman.

I want to point out something that you ought to know. This is a matter of pride. Last year I stood here and did the same thing for the Mahanoy Area Girls' Basketball Team. The Nativity girls were the Schuylkill League Champions, and that included all Class A, AA, AAA, and AAAA schools. They won all of that and went on to win the District XI finals and went against Marian High School, also from the same Schuylkill League. In the Eastern quarterfinals, Marian, Williams Valley, Lourdes, and Nativity, four Class A girls' teams from the Schuylkill League, were in the finals. It came down in the Eastern finals to Nativity and Williams Valley, and of course Nativity won.

I want to say that this effort, and we all acknowledge the girls and everything they do, but they are led by Ruth Weidman, who is their head coach. The last time Nativity won a State championship she was an assistant coach. Her ability as a coach, I will say she is one of the best in the Commonwealth of Pennsylvania, but added to that, she gives something to the coaching profession that goes beyond. She is a classy lady. She has girls who perform at 110 percent, but they are also respected because of their behavior, because of whom they are, and that is the Golden Girls from Nativity High School.

I would also note that these young ladies are not only expert basketball players, but 20 of the 22 are on the Honor Roll. And when I started asking about class standing, we were talking about first place, second place, third place, seventh place. So I think it goes to prove, and they have shown, that they are not only State champions as athletes, but they are also champions in the classroom.

So, Mr. President, I ask that the Senate extend its usual warm welcome and acknowledge the fine, young Golden Girls of Nativity BVM High School for their State championship.

Senator MELLOW. Mr. President, could we be at ease for a moment.

The PRESIDENT. At the request of Senator Mellow, the Senate will be at ease.

(The Senate was at ease.)

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Loeper.

Senator LOEPER. Mr. President, the conference report that is before the Senate at this time essentially contains a number of tax cuts that we have been able to put into place because of the economy that we have enjoyed in Pennsylvania this year. Particularly, Mr. President, I think it is noteworthy that the fiscal health of the Commonwealth and the budget surplus that we have experienced have really given us the opportunity as well as the responsibility to reduce State taxes. I think, Mr. President, that all of us in the Senate can take a great deal of pride in the measures that are before us today, and for the sixth consecutive year, 6 years in a row, we are telling Pennsylvanians that State taxes will be reduced, that substantially we are going to be able once again to reduce the

number that people are paying to the Commonwealth of Pennsylvania. I think we are showing continued progress in improving the tax climate to help create jobs and fuel community development throughout the Commonwealth.

Mr. President, the bill that is before us today reflects a combination of tax cuts that will provide over \$300 million in tax relief, one of the largest tax-cut packages ever enacted in the Commonwealth. This package, Mr. President, includes the significant tax reductions that the Governor had proposed in February. It includes a number of tax reductions that we, the Members of the General Assembly, felt should be priorities as well, and most notably the expansion of the property tax and rent rebate for our senior citizens in all our counties. This tax-cut package is very affordable, Mr. President. It is fiscally responsible, it is economically productive, and most of all, it is broad-based and fair. There are reductions for consumers of natural gas, there is another piece for broadening the tax forgiveness for low-income families, and this year, Mr. President, there were many more ideas advanced, including some affecting local taxes. By taking the moderate approach, we avoid setting up fiscal problems next year. This is a State tax reduction measure devoted to improving the State's tax structure, one with economic challenges in front of us, still we should not be foregoing tax cuts for jobs to pour money into local tax situations.

Mr. President, I believe that the conference report that is before us today contains a series of tax cuts in combination with a State budget that we approved last week, and that the combination of these two will enable Pennsylvania to compete, to provide the services our citizens seek while providing restraint on State spending that many of us favor in order that we can continue the predictability of our tax climate in the Commonwealth. An excellent budget has been put into place, and now, Mr. President, we can approve the tax cuts that are equally vital for Pennsylvania's future.

Mr. President, I urge an affirmative vote on the conference committee report.

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Bell.

Senator BELL. Mr. President, I will vote for this bill because about one-quarter of the tax cuts are the gross receipts tax on natural gas. Now, let us talk in plain language. I heat my house and I cook my food, at least my wife does, with natural gas. I pay a 5-percent gross receipts tax to the Commonwealth of Pennsylvania on that natural gas, and this bill in front of the Senate right now will eliminate that 5-percent gross receipts tax for a total of \$78,800,000. This means that every household in Pennsylvania that uses natural gas for heating or cooking will get a tax break. And this means money in the pocket, it means for every dollar you are now paying for natural gas, you are going to keep 5 cents. I am very much in favor of this bill.

The PRESIDENT. The Chair recognizes the gentleman from Favette. Senator Kasunic.

Senator KASUNIC. Mr. President, I intend to vote for this bill today because certainly it is doing things that we want to do, and that is reduce taxes. But, Mr. President, I think we missed an opportunity here, an opportunity that I think we had and we

could have moved forward on, and that is with the reduction of property taxes. I do not think there is anybody in this Chamber who is of the opinion that property taxes are in line and that we should not be trying to address reducing the taxes of the residents of the Commonwealth, of the homeowners of the Commonwealth of Pennsylvania. They are a crushing burden. Even though we are reaching out and we are going to be bringing more people, more senior citizens under the umbrella in terms of allowing them to participate in the rent rebate program and the property tax rebate program, there are still those senior citizens who will not be affected and will still struggle to remain in their homes. Property taxes are too high. They punish middle-class taxpayers here in the Commonwealth. Too often the fruits of their hard work and labor are diminished by increasing property tax bills.

Before Senate Bill No. 557 went to a conference committee, it contained a plan authored by Democrats to lower school property taxes. It is a good plan, it is fair, and it is affordable, and unlike property tax and rent rebate expansion programs, the Democratic plan would help all homeowners in Pennsylvania, not just those who meet certain income requirements and manage to wade through the bureaucratic red tape. Senate Bill No. 557 needed some work, but I believe the work should have been done here on the floor of the Senate, as it was done on the floor of the House. Too often we work behind closed doors, and too often middle-class Pennsylvanians get nothing, and nothing is exactly what middle-class Pennsylvanians got from this year's tax reductions.

The people of Pennsylvania deserve a break, Mr. President. Senior citizens deserve a break, middle-class homeowners deserve a break. We have cut taxes by billions of dollars in recent years. Homeowners pay taxes, too, and those taxes have gone up, not down. We should cut property taxes, and we should have started this year.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Cambria, Senator Wozniak.

Senator WOZNIAK. Mr. President, the reason I rise is because my wife and dad say they never see me on television, so I thought I would get up and make a little speech today. But the truth of the matter is that in 1991 the Majority in the Senate and the House, and I was a Member of the House at that time, under Governor Casey voted a very significant tax increase on the businesses and the people of Pennsylvania. That was a very agonizing vote for many people, and some people did not come back the next election cycle to govern. I was one of the fortunate ones. But one of the commitments made in 1991 was that when the opportunity arose, we would ratchet back those taxes that we increased. Under Governor Casey and under Governor Ridge we have ratcheted back those taxes.

What we have in front of us today is a menu of tax reductions by both parties that both Chambers have agreed to. We can argue that property taxes are a significant problem, but one of the things people argue about the most when we get back home is not so much the personal income tax, it is the school taxes. I think that this legislation is probably going to pass. We are probably moving dramatically forward in making Pennsylvania

extremely competitive. In my corporate Democratic mode, by making Pennsylvania business-friendly with this tax package, we can create opportunities and jobs for our citizens. In my Democratic social mode, I think we must be very concerned about the reality of our school property taxes. By not meeting our 50-percent funding mechanism here in the Capitol, we are forcing school boards throughout Pennsylvania to raise property taxes, which is probably the most regressive tax. It is my hope that as this economy continues to expand, perhaps next year, instead of making a large menu of corporate and business tax reductions, we look at trying to help our middle-class citizens in their endeavors in reducing property taxes.

But I want to make it clear to the people of Pennsylvania, the businesses of Pennsylvania, that in 1991 a commitment was made by this government to reduce its taxes that they asked or took from you. Today we are making a major step in that continuing commitment to reduce taxes.

Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I, too, want to rise to inform the Members of our General Assembly that it is time that we start to take a look at the property tax situation in our Commonwealth. This is the third opportunity that I have had to vote on budget measures, particularly tax cuts, business tax cuts in particular, and I am very happy to do so, and I think that to a large degree they are helping to make Pennsylvania more competitive. However, Mr. President, out there among the 67 counties of our Commonwealth, there are a lot of people who are complaining and crying out that they need our help as it relates to addressing the issue of the property tax situation.

We have an opportunity, we have had several opportunities in some ways to address that and we failed to do that. We failed to do it again this year, and I think we may be running out of time along those lines in the sense that we sort of have an obligation to address this issue sooner rather than later. In the particular school district in which I reside, the debate right now is whether or not to increase the millage rate by at least 3 additional mills, up to 106 mills. The surrounding school districts in and around my community are also worried about how high the tax increase is going to be this upcoming year.

One of the things that is driving that, of course, is the special education funding, and when I look at the formulas that exist with respect to special education funding, Mr. President, I see that Steel Valley School District in my district, a community that has been on the fringe and on the bubble as it relates to distressed status in our Commonwealth, is a school district that received less than a 3-percent increase, while I look at other school districts in other parts of Allegheny County that experienced 20-percent increases in special education funding but are clearly not in a position to warrant that type of an increase.

It is these disparities that are creating some of the problems in our local school districts. We need to address the property tax issue sooner rather than later, and I am disappointed that we have not been able to do that at this particular time, and I hope this body will take the lead like the House Democrats and the

House has done with respect to addressing those concerns that have been raised by so many people across our Commonwealth. So, Mr. President, I intend to vote for these tax cuts, as I have the last several years, but I hope that this body would very soon address the real crisis out there, and that is our property tax situation.

I thank you for the opportunity to make these remarks.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Hughes.

Senator HUGHES. Mr. President, I guess we are in a situation here, I was just looking at one of these colorful little charts that our staff provided, and it appears that once again we are in a situation of here we go again. Here we go again. In 1995-96, we did business tax cuts of \$237 million. In the 1996-97 budget, business tax cuts were \$259 million; 1997-98, business tax cuts were \$270 million; 1998-99, business tax cuts were \$395 million. I have these charts all over the place, and they all talk about the tax cuts, they talk about the huge budget surpluses we have. We are confronted again this year, Mr. President, with a budget surplus I guess that is totaling more than \$700 million, maybe even growing larger, an unprecedented appropriation going into our Rainy Day Fund. We now have a Rainy Day Fund of over a billion dollars, and here we go again: another huge tax cut for the business community. And I cannot fault trying to assist them, but the issue is parity, because there is no real direct relief for the average person.

My colleague, the Senator from Allegheny County who spoke just prior to me, talked specifically about property tax cuts and the impact that that could have on the average taxpayer, direct relief for the average person. We could be helping them, but we run away from them. And what we are hearing louder and louder, Mr. President, is a call to give the people the money. Give the people back their money, because in the end, if you look at all we have done over the last several years, we have clearly, as you can see again by our charts here, Mr. President, we have clearly given the business community back their money, but we have totally ignored the average person in giving him or her their money back. So these surpluses that we have right now, Mr. President, are really surpluses that ride on the back of the average taxpayer here in the Commonwealth of Pennsylvania.

The best way to do it, the best way to do it is the property tax, and we have a proposal for that. It would be nice to get the opportunity to have a full discussion of that proposal, but I am not sure that the system will allow for that, so we will use this opportunity right now, Mr. President, to evoke, if you will, one simple mantra: give the people their money. This surplus rides on their back, give them their money.

A property tax cut is probably the best and easiest and simplest way to do it, and it would help our local school districts and provide some direct assistance for the average homeowner across the Commonwealth. They have not gotten help. Some folks have gotten assistance, Mr. President, but the people, the average homeowner in this Commonwealth has not gotten help over the years. Again, here we go again, they will not get help again in this particular budget, in this particular tax cut

proposal. Give the people the money. That is all we have asked for. Again, more cuts for the business community, no real significant cuts for the average small businessperson and no real significant cuts for the larger businesspeople, but no real support, clearly no real support for the people who have created this wonderful economic environment in this Commonwealth, who have created, through their taxes, this major surplus, who have created a Rainy Day Fund of over a billion dollars.

The only people who are truly benefitting out of that, Mr. President, are the money managers. They are doing real well managing how to invest \$1 billion. They are doing extremely well. I guess many of us have chosen the wrong line of business. We probably should have gone into that line of business and become money managers, and I think we would be doing real well. The TV cameras cannot see it, but many of my colleagues are smiling right about now. We should have gone into that line of business and made a few dollars out of that because those are the guys who are doing real well. A billion dollars, trying to figure out how to invest that.

Give the people their money. It is fine to do tax cuts, it is fine to do business tax cuts, Mr. President, but we should also be doing something equally as significant for the average person in the Commonwealth of Pennsylvania.

Thank you very much, Mr. President.

And the question recurring, Will the Senate agree to the motion?

Senator MELLOW. Mr. President, I would just like to put on the record a few comments about Mike Barrasse. Mike Barrasse is an individual who has served as the District Attorney of Lackawanna County for the better part of the last 10 years. He has done an excellent job as District Attorney. BILLS ON FIRST CONSIDERATION

Senator WAUGH. Mr. President, I move that the Senate do now proceed to consideration of all bills reported from committees for the first time at today's Session.

PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Greenleaf.

Senator GREENLEAF. Mr. President, I thank the Senate for passing Senate Bill No. 846, which amends Section 9711 of the Judicial Code, which adds an aggravating circumstance to the list of circumstances on which the prosecutor may seek the death penalty. Specifically, this legislation adds an aggravating circumstance that permits the prosecutor to seek the death penalty in cases where the defendant committed the killing in order to collect life insurance proceeds.

Section 9711 prescribes a procedure for determining whether a person convicted of first degree murder receives life imprisonment or the death penalty. In order to impose the death penalty, the jury must unanimously find at least one aggravating circumstance and no mitigating circumstances, or that the aggravating circumstances outweigh the mitigating circumstances, otherwise the verdict must be life imprisonment. Currently, Section 9711 lists 18 aggravating circumstances and 8 mitigating circumstances. The aggravating circumstances must be proven beyond a reasonable doubt, and mitigating circumstances must be proven by the preponderance of evidence.

Michael Marino, the district attorney of Montgomery County, suggested this legislation to me in response to a case in which a husband killed his wife, allegedly to collect life insurance proceeds and to pay his debts. Mr. Marino was unable to seek the death penalty in this particular heinous crime because there was no applicable aggravating circumstance. In other words, the killing for life insurance proceeds was not at that time, and is not today, an aggravating circumstance. I certainly agree with Mr. Marino that murdering someone to collect life insurance proceeds is cold-hearted and is similar in nature to a contract killing, which is already listed as an aggravating circumstance.

So the Senate, by adopting this legislation, with House concurrence and the Governor's signature, will place this as an aggravating circumstance to be considered. It definitely would not guarantee the death penalty, but it would allow the jury to consider the death penalty in those cases in which a person kills an individual in order to collect life insurance proceeds.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Wagner.

Senator WAGNER. Mr. President, I rise to talk about an issue, since we are under Petitions and Remonstrances, that I am sure has been an issue of great public concern in the last several weeks since the tragic incident that occurred in Littleton, Colorado. It was a very tragic incident for a number of reasons: the innocent people who died as a result of that tragic incident, most of whom were very young people; another important reason that this occurred in schools that are considered to be safe places in this country; and also another very important reason that we all ponder and wonder why this occurred. In other words, the motive and the fact that the perpetrators of the crime were very young people.

Mr. President, there have been a number of tragic incidents that have occurred in the last several years in this country, and I would like to just list a few of them. On April 20, 1999, two heavily armed students, aged 17 and 18, allegedly killed 15 people in Littleton, Colorado. Mr. President, there have been a number of other incidents, one of which occurred in Pennsylvania on April 24, 1998, when a 14-year-old boy allegedly shot a science teacher to death in front of students at a middle school graduation in Edinboro. But it gets worse, Back on March 24, 1998, two boys, aged 13 and 11, killed four classmates and a teacher in Jonesboro, Arkansas. There have been a number of other incidents, Mr. President, where very young people the age of 14 were involved in homicides at schools across this country. I will not list them all, but what this all tells us is that a serious epidemic of youth violence is upon us in ways we never thought of before in America.

And, Mr. President, in the wake of these and other similar incidents, millions of parents across the country are asking, why? Why have these incidents occurred? Why do teenagers slaughter their classmates? What prompts them to resort to violence? What can we do to help our children and our neighbors' children cope with this problem and begin to reverse the tide of violence in our schools across America? Mr.

President, there is no single answer to this question, and certainly no easy answer to any of these questions, and they have been discussed publicly in meetings in Washington and State capitals across America.

Mr. President, I think there is one issue that needs to be discussed. Last week I introduced legislation that addresses one contributing factor to teen violence, and that is graphically violent interactive video games. The legislation would make it more difficult for children to buy, to rent, and to play games that are graphically violent and interactive in nature. My legislation, Mr. President, is not a panacea. It addresses one aspect of a complicated problem, a problem that quite frankly can be best addressed by parents overseeing their children, and I want to stress that as being the most important element and not necessarily this legislation or any legislation that this General Assembly or the Congress of the United States could pass.

Mr. President, any parent out there who is not paying attention to the video games that their children are playing at very young ages, 8, 10, 12, 14, better start paying attention. Why is that, Mr. President? Because there is a growing concern about the violent interactive games that children are playing and the negative impact that that is having on their development, and it is missing many of the adults throughout this country. And, quite frankly, it was missing me, and I have children. Interactive video games are one of the most popular forms of entertainment in today's society, especially among adolescents. Mr. President, consumers in the United States spend nearly twice as much on video games, \$10 billion, compared to movies, \$5 billion. Now that is a statistic that most people would never realize, that video games are twice as popular in this country as movies, especially to our children.

A 1993 study found that the most popular video game category among seventh and eighth graders and younger is fantasy violence, and I repeat that, fantasy violence. When I am talking about video games, I am not talking about a passive person sitting watching a movie, I am talking about someone playing a game where they are interacting in the violence as part of the game. The same study found that boys who play violent video games tend to have a lower self-concept in areas of academic ability, peer acceptance, and behavior. Since the study was done, video games have become more graphic and much more violent. Out of the \$10 billion spent each year on video games, 50 percent of that relates to violent interactive video games, equal to the amount of money spent on the movies that I talked about earlier.

While there is much debate about the effects of violent video games, some researchers believe that children who play them are more likely to resort to violence. They argue that the interactive nature of the games makes them more potentially dangerous than passively watching violent movies or violent television. Children become desensitized to violence not just by watching it, but more importantly, by participating in it in interactive video games.

One analyst, a retired Army Lieutenant Colonel, who was featured two Sundays ago on "60 Minutes," goes a step further. In his book on killing, "The Psychological Cost of Learning to Kill in War and Society," David Grossman finds disturbing

parallels between today's violent video games and the methods used by the military to teach how to kill. People are naturally reluctant to take a life, and the military has long struggled to learn how to teach them to do that. According to Grossman, military trainers use drilling to make firing a weapon an automatic response. Shooting ranges with pop-up targets were one of the first tools used to increase the shooting response in the military. Grossman says such training increased the Army's fire rate from 10 to 15 percent in World War II to more than 90 percent in Vietnam. And, Mr. President, I know firsthand, being in the military, that his information and data are correct. Today, Grossman says the military has begun to use virtual firing ranges that are very similar to the point-and-shoot video games that I am talking about here today. He worries that children who play the games may become conditioned to kill and. I repeat, to kill without thinking if they are faced with a stressful situation.

As a public official, Mr. President, and more importantly as a parent, I wish there was conclusive evidence of this whole issue of violent video games. However, I know instinctively that there is a direct correlation in the kind of violence I am talking about today and the popularity of violent interactive video games. The level of graphic violence in video games far exceeds that which is permitted in R-rated movies. And again I repeat, children 8, 10, and 12 can purchase these games, can rent these games, can play these games. They cannot go to a movie where they sit passively and watch violence, but they are permitted in our society today in our free market system to buy, to rent, to play these interactive video games. Why is there not some rating system in place similar to movies with violent interactive video games or the video game category in general?

Mr. President, that is what I am really talking about, and I am suggesting the following:

Number one, I am asking that all parents and guardians of children monitor and control video games that their children are playing. And I as a parent have begun to do that more recently and have become very astute in knowing what my children are participating in and playing in terms of video games in general, mainly due to the fact that 50 percent of them out there are violent in nature, and when I say violent in nature I am talking about decapitation, I am talking about dismemberment, I am talking about bloodshed beyond belief, where the person playing the game is initiating the violence. And that is the problem with these violent interactive video games. We are teaching our children how to kill. We are desensitizing them to violence.

Number two, I have introduced legislation that would make it a summary offense to sell, to rent, or otherwise provide violent video games to people under the age of 18. A violent video game is one that contains scenes of graphic violence, as defined by the Entertainment Software Ratings Board. The ratings issued by the board would have to be made available at all businesses that sell, rent, or have video games. That is really what this legislation does, and I would like to see it adopted in Pennsylvania.

Number three, I have also introduced a resolution urging Congress to require video game purchasers to submit their products to the Entertainment Software Ratings Board for review and rating so that all video games are appropriately rated, similar to how movies are rated, so that parents have an idea how violent these video games truly are.

Mr. President, what I am proposing is not censorship. Individuals and companies would still be free to create, sell, and rent violent video games. They could not, however, offer such games to minors, and that is really the issue here. We live in a free society, but there are certain things that should not be in the hands of children, Mr. President, that are freely in the hands of children in our society. They are teaching them things they should not be taught and desensitizing them to violence at home, in video parlors, while running their computers with disk games, in schools with disk games on the computers. They are available everywhere. And, Mr. President, that is truly what this legislation is all about.

In the last issue of Time magazine, it talks about kids growing up on-line and how they dwell in a world that many times is unreal and many times is not teaching them what we think technology is teaching them. It is teaching them the wrong things.

And, Mr. President, I know many of my colleagues have joined me as cosponsors of this legislation. I ask that more colleagues take a look at it. I actually have videos showing how violent these games are. I have had professionals in the area of psychology speak to it, and I appreciate the opportunity, Mr. President, to say a few words about it.

Thank you.
