# ANNUAL REPORT ON ADULT BASIC AND LITERACY EDUCATION

Dear Honorable Member of the General Assembly:

The Department is pleased to send you this report on the 1997-98 adult basic education activities in the Commonwealth of Pennsylvania provided under the Pennsylvania Adult Literacy Act of 1986 as amended in 1996. The \$8,525,000 made available by this legislation was combined with \$15,662,926 in federal funds to provide basic and literacy education services for educationally and economically disadvantaged adults of the Commonwealth.

Providers of these services include local education agencies, colleges, universities, corrections institutions, community-based organizations and literacy councils. These 226 agencies served over 56,000 adult students, preparing them to pass the GED test, obtain employment, advance in employment, and achieve competency in English language skills.

It is the goal of the Department that every adult Pennsylvanian who wants to improve his or her basic education skills has access to quality programs. This report highlights the activities conducted under the law to ensure that this goal is met through the instructional programs offered to the learners and the professional development opportunities made available to those engaged in providing instructional programs.

This report provides information for you on how the funds were utilized and how the services provided have made a difference to Pennsylvania's adult learners. We hope you will find the report informative and of benefit to you as you work to meet the needs and goals of all Pennsylvania's citizens.

### BILL ON THIRD CONSIDERATION AND FINAL PASSAGE

SB 555 (Pr. No. 1443) -- The Senate proceeded to consideration of the bill, entitled:

An Act regulating electronic transactions.

Considered the third time and agreed to.

And the amendments made thereto having been printed as required by the Constitution,

On the question, Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentlewoman from Allegheny, Senator Hart.

Senator HART. Mr. President, I rise in support of Senate Bill No. 555, as amended, and I ask my colleagues to support it as well. Senate Bill No. 555 is another step in our progress in Pennsylvania to becoming one of the most technology-friendly States in the United States. Senate Bill No. 555 is the Uniform Electronic Transactions Act. This act would facilitate and promote electronic commerce, or e-commerce, in Pennsylvania by giving legal recognition to digital signatures and legal recognition to electronic documents to be valid contracts in the Commonwealth. Mr. President, this legislation would validate anyone's opportunity in the Commonwealth to make a contract via the Internet with someone in Singapore or someone down the street. What it does is allows us to use something called an electronic or digital signature as a validation for a contract, something that current Pennsylvania law does not recognize.

As I have worked as the chair of the Committee on Finance and worked with Chambers of Commerce, the High Technology Council in Pittsburgh, and other organizations, I have learned that Pennsylvania has a great opportunity, Mr. President. Our opportunity is to become one of the most technology-friendly States in the United States. We are well on our way. With this legislation, we take one step further in not only welcoming with open arms and encouraging the growth of technology firms, but welcoming and encouraging the growth of other firms who wish to use this technology to grow their customer base worldwide, to make it a lot easier to make a contract with someone on the other side of the world.

This bill allows freedom for the contractor to make the decision as to whether they wish to use a traditional contract form-that is unaffected, so they could still use a handwritten signature—or it now gives them the opportunity to utilize technology so that they could actually have a contract that has no paper whatsoever, that is an electronic document that is transmitted between the parties and basically signed by what we will call in this legislation electronic or digital signature.

Mr. President, it is imperative, I believe, that we pass this legislation in this Commonwealth. The Internet represents for us one of the new economic frontiers, or it is the new economic frontier. It is filled with limitless potential for our businesses to grow and prosper. Storefronts are widening to include customers and window shoppers across the State, across the nation, and across the world. They would all be connected and be able to offer their products through the Internet. It is still growing, Mr. President. It is estimated that by 2002, electronic commerce will skyrocket from a \$43 billion industry to \$1.3 trillion in commerce by 2002. The Internet offers tremendous potential. I think many of us are familiar with the consumer products available through the Internet. This legislation expands us from being able to use it as a consumer tool for our own personal shopping to a tool for business growth. It means Pennsylvania firms will be among the first companies to have the legal structure that they need to do business over the Internet, as I said earlier. This

legislation gives them an early competitive advantage as many States have adopted some kind of acceptance of digital signatures, but they have not totally accepted the opportunity to validate contracts via the Internet. We also reinforce our current administration's commitment to making Pennsylvania completely high-tech friendly.

I would like to thank Governor Ridge and his staff for their help in developing this legislation and ensuring that we are ready and able to harness the benefits of the information superhighway. I would also like to thank an attorney in my district, Monica Deoras, for her help in this legislation as she got us started on it several years ago.

In our plan, Senate Bill No. 555 will enable individuals, businesses, and governments to use these e-signatures in legal and binding transactions, which they cannot do today. This kind of recognition will not only save businesses time in the passing of contracts back and forth, but it will also save them money and it will save them aggravation. In this way, we will be catching up with other parts of the nation which have already gone forward with these signatures, but also going ahead of them because our acceptance of an electronic signature is more technology-friendly.

The bill in today's final form advances the important tenets of our original proposal while tying our policies closely to the recommended uniform e-commerce bill that has been recommended and probably will be accepted by many other States in the future. This will ensure a smoother as well as a rapid move toward Internet commerce by all Pennsylvanians, whether they be large Fortune 500 businesses or small mom-and-pop businesses.

In addition to my staff's work on the legislation, I would like to thank Tom Hutton and Kevin Dellicker of Governor Ridge's staff, Steve Tuckey from Senator Loeper's staff, George Riddle and Greg Jordan from Senator Tilghman's staff, and Phil Dunn from Senator Tomlinson's staff for their assistance in preparing this legislation for a vote. I would encourage my colleagues, whether they use e-commerce or not, to please support this legislation and help Pennsylvania move forward.

Thank you, Mr. President.

Senator WOZNIAK. Mr. President, I move that the Senate do now proceed to consideration of the bill reported from committee for the first time at today's Session.

#### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Murphy.

Senator MURPHY. Mr. President, I rise today to urge my colleagues from western Pennsylvania to join with me to fight a dangerous initiative which stands to drive a wedge between the city of Pittsburgh dwellers and suburban residents and thwart progress on economic development. One bill recently vetoed by the city of Pittsburgh's Mayor Tom Murphy would have set unprecedented residency requirements for employment in the city, and I appreciate the mayor's veto of that bill. But I am also asking city council to let that veto stand.

Another issue that is on the November ballot in the city of Pittsburgh would call for residency requirements for construction workers. These may be backward-looking ideas, and I fear they will not only stand in the way of economic progress but erode any progress that has been made in bringing the city and the suburbs together. At best, they will cause hard feelings. At worst, they will drive a wedge between city and suburban residents at a time when we are trying desperately hard to create a spirit of regional cooperation.

Briefly, that first bill vetoed by the mayor would require that at least 35 percent of the employees on projects built using tax increment financing assistance live within Pittsburgh city limits. The ballot question would require 35 percent of construction workers on these projects to live within city limits. Meanwhile, suburban taxpayers who contribute financially to the city's economic development projects will lose the opportunity to vie for jobs. How could any of us go to our constituents, carpenters and electricians who do the building, and the students, men and women who will work at the stores and the stadiums, how can

we tell any of them your tax dollars will be used to build these projects, but you will not be able to earn dollars at them? I call that discriminatory and blatantly unfair to the people who should have every opportunity to compete on equal footing, the city and suburban residents alike, for available openings. I believe the quality and talent is there to compete, and we should let the people do so.

Not only is this an emotional issue, but it also stands to degenerate into a protracted legal battle that could be costly for the city and needlessly delay any construction projects. Mark my words, if enacted, there will be court challenges and they will be expensive, and we can expect other communities to retaliate by enacting their own ordinances to shut out city residents from jobs. And legislators here, I am sure, will submit bills to stop these practices by prohibiting State dollars from going to any city or county or community that engages in this sort of warfare. And how can we possibly try to encourage any employers to locate new jobs in a State where they are told who they can and cannot hire based upon an address?

The Pittsburgh region has long been accused of living in the Dark Ages politically, but recently leaders have begun to step out of the shadows of parochialism and patronage to embrace a more regionally sound and effective approach to governing, and we should continue to embrace that. Of course, that was before such promotion of these issues occurred. I believe the good people of the Pittsburgh city council have the best interests of their constituents at heart, and we should work together toward those ends. Indeed, we all want to see people employed, but I believe we are better off focusing our efforts on vigorous job training and recruitment rather than erecting barriers.

Mr. President, I urge my colleagues on both sides of the aisle from western Pennsylvania to do our part to promote cooperation by working together to encourage defeat of any bills that do not promote this cooperation and stand in that way.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Cambria, Senator Wozniak.

Senator WOZNIAK. Mr. President, I rise to support my colleague, Senator Murphy. And as a matter of fact, I have a bill right here for anybody who wants to sign on that will prevent the city of Pittsburgh from using artificial political borders for employment. Last year when this General Assembly, both the Senate and the House, went through the agonizing process of trying to come up with a capital budget that would be fair to rural Pennsylvania as well as to help the stadiums in our urban center, there were a lot of us who came from the rural parts of Pennsylvania, and I am not blaming Mr. McClatchy, I am not blaming Mr. Rooney, but they put a hybrid together to make it affordable and palatable to those of us who do not come from the Allegheny County region to be able to support a bill, knowing that within that are opportunities for the rest of Pennsylvania. However, when the council of Pittsburgh and all the other entities over there came to this Senator, they always came saying, but, John, this effort is regional. It is going to create jobs for your people, too.

Well, the other week there was a movie on television called Animal Farm, if anybody ever read that, by George Orwell. And it says all the animals are equal, but the pigs are a little more equal. So it is not good enough that Pittsburgh is getting two new stadiums. The council of Pittsburgh wants to say that 35 percent of the man-hours worked on those construction sites have to be from the city itself, not from Johnstown, not from Monessen, not from Beaver County, not from Washington County, but 35 percent. But of course, that is regional. It is going to help everybody.

It is not right, it is protectionism, and I think that this august body here has every right to step forward and tell the council of Pittsburgh that we do not agree with your philosophy, it is wrong, and instead of thanking the taxpayers all over Pennsylvania, from Union County, to Juniata County, to the counties in the northern tier whose moneys are going into these stadiums. you are saying it is not good enough for our people to have the opportunity to work there.

Let us make sure that this message is sent loud and clear. And if they do not retrace their steps and eliminate this effort. then let us move forward and pass the legislation that not only is it going to be Pittsburgh or Philadelphia or Johnstown or any other place, no political subdivision in this Commonwealth is allowed to put up walls and tariffs as to who can and cannot be employed within their borders using Pennsylvania taxpayer money.
