An Act amending the act of April 12, 1951 (P.L.90, No.21) entitled, as reenacted, Liquor Code, further providing for definitions, for standing at hearings on license applications, for posting of notice of application for a license, for issuance of licenses and for sales by liquor licensees; repealing provisions relating to certain types of licenses; providing for a public venue license and for a performing arts facility license; further providing for stadium or arena permits, for limiting number of licenses in each municipality, for places of amusement not to be licensed, for renewal of licenses, for local option and for unlawful acts relative to licensees.

#### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Schwartz.

Senator SCHWARTZ. Mr. President, I want to make some comments on some legislation that I introduced that I was hoping to be able to amend to legislation that we went over today, so I wanted to make some comments about it and hope to encourage our leadership here, the Majority leadership, to consider legislation, either my own or possibly be able to bring up legislation that would allow me to amend this legislation to it. I am talking about House Bill No. 519 that went over today, so I thought there might be an opportunity, hopefully, in the near future to be able to, when that bill comes up, to amend it with legislation that I have introduced as Senate Bill No. 940.

And you have heard, at least the public has heard a good bit about this legislation and what it does basically, and I will back up a little bit, if I may, Mr. President, just to say that this is talking about child care, talking about background checks on child care providers. Let me just say this: As a mother of two grown sons, I was a working mother when they were young, and most of the time I could rely on and trust the child care providers I left my children with. But being a mother comes with a certain amount of worry. There is no question about that. And while most of the time I could trust the child care providers, the fact is that here in Pennsylvania families who do rely on most types of child care have the reassurance of knowing that the care provider has passed at least minimal background checks, that they have passed child abuse and criminal background checks. The general commonsense rule is that if you want to provide child care, you must pass these simple background checks.

Yet this requirement applies only to certain child care settings, ranging from day care centers to private homes where four or more children are being supervised. The requirement, and this is unbelievable in some ways, does not apply to all providers. The fact is that in Pennsylvania there is a large hole in this basic guarantee for parents and for our children. The State does not require providers who care for three or fewer children in a home to undergo child abuse or criminal background checks, even if they are paid for with State funds.

Providers, advocates, and legislators committed to the children's well-being have urged the Governor to institute these minimal safeguards. Support for the checks continues to grow. The county commissioners, a bipartisan group, the County Commissioners Association of Pennsylvania, recently joined many of the advocates and child care providers with a call for the background checks for all providers. Yet, inexplicably, the Ridge administration steadfastly refuses to require background checks for all providers who are paid for with taxpayer dollars. Instead, the administration recently announced required checks for some but not all of the State-subsidized providers who care for up to three children. And only child abuse background checks, not criminal record checks, will be required.

These halfway measures are completely unacceptable. It is wrong to cut corners where children's safety is at risk. All providers whose services are paid for with public funds must be required to pass both child abuse and criminal background checks.

As the Governor knows, other States have learned that these checks are critical. In Michigan, for example, they discovered that they had paid millions of dollars for child care to 6,200 criminals whose crimes included more than 300 crimes against children. Yet our Governor continues to turn a blind eye to these disturbing facts. With every day that the administration fails to require background checks for all State subsidized providers, the likelihood that this failure will hurt Pennsylvania's children increases. Care provided in a home to three or fewer children makes up the fastest growing segment in the child care market. More and more child care is needed as more and more mothers prepare to leave the welfare rolls and join the work force, and many are choosing this kind of care.

Since the Ridge administration has refused to take action to protect these children, the General Assembly must step up to the plate. Senator O'Pake and I have introduced legislation in the Senate, as has Representative Connie Williams in the House, that will require all State-subsidized providers to pass a child abuse and criminal background check. All of these bills are now pending in the Senate committee. Representative Williams' bill, in fact, passed unanimously in the House and has come over to the Senate and is sitting in a Senate committee. Months have gone by, and still the Senate Majority has refused to bring them up for a vote.

So today, when I heard last week that Representative Katie True's bill, House Bill No. 519, was on the Calendar, was moving on a fast track, quickly moved through the House, moving very quickly through the Senate, it got through the Committee on Aging and Youth and the Committee on Appropriations last week, record time, and the Senate was supposed to vote on it today, and yet somehow it went over. One of the suspicions might be that I said I wanted to amend this legislation with this commonsense background check for taxpayer-subsidized child care providers, but in fact the bill has gone over and we are not going to vote on it today.

Now why are we afraid to debate this legislation? We should debate it. We should discuss it. I believe we should pass it. But if in fact the Majority feels this is not a good idea, that in fact taxpayer dollars could be spent on providing child care to three or fewer children in a home by someone who has a criminal background or a background of child abuse itself, these background checks that are paid for by the provider itself, it is not a cost to the State, if they in fact disagree, then vote against it. But at least let us have a chance to have our say on the floor of the Senate. I hope it is not just because the Majority is actually afraid that of course it would pass. Who could stand up and say, no, we actually think it is a fine idea for the State to be reimbursing criminals and those who abuse children with State taxpayer dollars for our most vulnerable children in child care settings.

So I call on the Majority to be willing to bring up the bill and to allow my amendment to have a hearing on the floor. My suspicion is that it would pass. And if in fact, as I say, there is a willingness to have criminals take care of our children, a willingness to have those who abuse their children paid for by the State to take care of our children, then let people vote that way. But at least let the public have a say. Let all those advocates and child care providers, the county commissioners, the many people who do not understand why we are not doing this, understand who

stands where. And I would say there is no reason to wait. We could do it today, obviously now it would be tomorrow, but we should do it soon.

I thank you for the hearing, and I look forward to others in this room joining me and calling on this administration to finally step up to the plate and make sure that our children are protected.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Northumberland, Senator Helfrick.

Senator HELFRICK. Mr. President, this morning I had the pleasure of meeting a group of people who came to see me down in the Rotunda and present to me thousands and thousands of petitions from people who are concerned and believe that our system of justice is flawed when it comes to the unfair imposition of the death penalty. The groups that brought these petitions to me were the Pennsylvania Prison Society, Pennsylvanians United Against the Death Penalty, the Pennsylvania Council of Churches, and the Pennsylvania Interfaith Coalition. Senator Kitchen joined me at the podium when I made these remarks: (Reading)

Thank you very much for being here today to support me and my colleagues in the Senate and the House who believe our system of justice is flawed when it comes to the unfair imposition of the death penalty. Our Constitution requires equal justice and equal treatment under the law. White, black, rich, poor, city, or country, it is not supposed to matter, but does it actually happen? No, I think we all know this does not actually happen. The legislators you see here today intend to do something about that.

As I said, Senator Kitchen stood right next to me at the podium when I said I want you to take special notice of something. Senator Kitchen and I are different in appearance. She is a black female Senator, I am a white male Senator. Do you see any other differences? No, not really. She represents the exact same amount of people in her district as I do. She has one vote in the Senate, as I do. We both have the same one vote, as any other Senator, including the leaders. Each Member is afforded the exact powers and privileges as one another. No distinctions are made because of race, religion, or color, and I am proud to say that no racial prejudices are tolerated in the Senate.

Now think about this: If I were a black man not involved in government and she was a white woman not involved in government and we each were convicted and sentenced for a capital crime, whom do you think would be given the death sentence? Because she is white or a woman, is she entitled to a different sentence than I am? Is she more or less of a threat to society than I am? I am thoroughly convinced after looking at the facts that if you are a poor black man, the odds of a fair and impartial trial and sentence are stacked against you. The death penalty is not punishment for a heinous crime, it is just a way of eliminating a person convicted of a crime from our society, whether they are actually guilty or innocent. Unfortunately, there are still many individuals with racial prejudices, and they reason that if a black person or a poor person is executed, so much the better. God help us if we do not try to stop and do something about this.

Being an elected official carries with it a tremendous moral responsibility along with a legal responsibility. The moral responsibility demands we protect the life and well-being of our constituents. It demands we punish, and punish severely, those who commit capital crimes and are properly tried and convicted, but that moral responsibility ends there. It does not give us the right to execute another human being, regardless of how heinous a crime was committed, even if we are 100 percent sure that that person is guilty, and I can assure you that we are never 100 percent sure.

Many of my colleagues who voted against the moratorium and a study of our justice system in regard to these capital crimes have told me privately that they agreed with me, but they were advised not to support this legislation because it was politically unpopular and could hurt them at election time. I hope that they are forgiven for their "no" vote. To trade one's political security for a possible miscarriage of justice in a life or death decision would be difficult, if not impossible, to forgive.

I believe the next time a vote is taken on this legislation, those with no prejudices will vote for the bill. It is our job to convince, respectfully but forcefully, those who profess no prejudice but who actually in their heart may have them. We must convince them that the time to harbor ill will towards others who may look different, who are poor, has long since passed, and that no one, no one is politically secure without compassion for their fellowmen.

And, Mr. President, I say that someday we will all be judged by a higher authority, a court much higher than anything in this State or legislature or this nation. Need I say more.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Berks, Senator O'Pake.

Senator O'PAKE. Mr. President, I want to follow up on the remarks of my colleague, Senator Schwartz, concerning the need to require criminal background checks for all day care providers in Pennsylvania. As Senator Schwartz quite properly pointed out, the law now says that if you are taking care of fewer than four children in your home and providing day care services, you do not have to undergo the criminal background check. Many of us for years have pointed out that for the sake of protecting small children, we must change this.

We react up here when there is a tragedy. Recently in Berks County a young child was killed, and in Altoona another young child was killed. I hope we do not have to wait for another child to be tragically abused, molested, or even killed in a day care center which is not regulated, is not licensed, did not have to undergo criminal background checks just because fewer than four children were being taken care of in that home.

What my legislation proposes, and this is the second Session now that we have tried, as Senator Schwartz's bill does, as Representative Williams' bill does which has passed the House and is awaiting Senate action, it just says that if the government is going to subsidize child care, that money should not be used to subsidize child abuse. The best way to prevent that from happening is to require criminal background checks so that adults who are going to be taking care of small children for many hours a day, who have a criminal background, that should be known to those who are going to entrust their children to that day care provider.

The State of Washington recently enacted this kind of requirement that we are suggesting should be the law in Pennsyl-

vania. In the State of Washington, where they have about 10,000 unregulated day care providers, in the first round they found 300 people with criminal records, and I think 13 of them were for child abuse and child molestation. In Pennsylvania we have three times the number of unregulated day care providers as the State of Washington. The potential for a terrible tragedy is out there. It would be compounding that tragedy if State subsidies or Federal government subsidies were actually being paid to that day care provider so that he or she could abuse the child or children who were entrusted to the their care.

Let us not wait for another tragedy to happen. The County Commissioners of Pennsylvania unanimously adopted a resolution calling on us to require criminal background checks for all day care providers when there is subsidy involved.

We hope that before this Session ends we will be given the opportunity to vote on our proposal. Whether it is mine or Senator Schwartz's or Representative Williams' is not the point. Let us put this issue out on the floor. Let us do what needs to be done. Let us not wait for a tragedy. Then we will wring our hands and we will say, well, the system failed. Let us not let the system fail. Let us prevent child abuse before it happens, and I think a very logical and prudent thing to do is to adopt our legislation that requires background checks for anyone who wants to provide day care for a child, no matter if they are caring for three or four. If it is four, they are licensed, they are regulated, and background checks are required. We are saying that when government subsidies are involved, it should not matter if you are taking care of fewer than four, and we urge this body to take note of that and do the right thing before a terrible tragedy happens and then we will react.

Thank you, Mr. President.
