SENATE

WEDNESDAY, February 7, 2001

The Senate met at 11 a.m., Eastern Standard Time.

The PRESIDING OFFICER (Jeffrey E. Piccola) in the Chair.

PRAYER

The Chaplain, Reverend LEE ELLENBERGER, of United Methodist Church, Stewartstown, offered the following prayer:

PETITIONS AND REMONSTRANCES

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Northampton, Senator Boscola.

Senator BOSCOLA. Mr. President, I rise today with a little bit of hope. Yesterday, Governor Ridge gave his Budget Address, and for the first time in the 6 years that I have been in office, he talked about the disturbing growth of landfills in Pennsylvania. This is an issue that I have been talking about ever since I was elected 6 years ago, and I keep calling on us to do something about out-of-State garbage in Pennsylvania. So I was really encouraged yesterday when he talked about it in his Budget Address, because I never heard him talk about it in his Budget Address before. So hopefully, Mr. President, this spells a change in this administration's attitude and policy toward dealing with the mountain of out-of-State garbage that is trucked into Pennsylvania day after day after day.

Pennsylvania has been America's dumpster for far too long, and while I am hopeful that Governor Ridge is sincere in his call for landfill legislation, I have to confess that I do have my doubts, because over the last 6 years I have heard talk about a moratorium, no new landfills, no new landfill expansions. But in the 18th Senatorial District alone, in Northampton and Monroe Counties, we have three landfills that have applications in for expansion permits. And it is disturbing, because in our

community the trucks are coming in constantly hauling this garbage in, and when you think about it, if we are taking all this out-of-State garbage into Pennsylvania and our landfills might be filled to capacity in 11 or 12 years, where is Pennsylvania going to send their garbage? No other State is going to want it, but our landfills are constantly being filled with out-of-State garbage.

So, throughout the last 6 years, this administration continually implied that our worsening landfill crisis was a national problem, or something that required a Federal remedy. Where have I heard that before? I have talked about that, that we do not do things sometimes in this State because we say we have to wait to see what the Federal government does. Meanwhile, as I said, there are three applications in Northampton County alone for landfill expansion permits. And what this means is that more garbage trucks will be rumbling across State lines with other people's garbage other than Pennsylvanians. And these expansions only continue to diminish the health, safety, and appeal of trying to live and raise a family in Northampton and Monroe Counties.

Mr. President, if the Governor is serious about enacting legislation to control landfill growth, I invite him to take a really close look at the four-bill package that I recently reintroduced. These proposals are nothing new. In fact, I have introduced and reintroduced them for as long as Tom Ridge has been Governor. These bills would tighten State landfill regulations and toughen enforcement against out-of-State waste haulers. This legislation would stem the tide of out-of-State garbage and police the heavy garbage trucks that race across our borders and into our communities every day.

Most importantly, Mr. President, my legislation would give local residents, the residents who live in these communities, a greater voice in the landfill permitting process. It would also turn the Governor's attention to a worthy bill that Representative Bud George introduced in the House which would roll back excess capacity in landfills. And I am sure Representative George welcomes the Governor's new spirit of teamwork as well.

Mr. President, if the Governor is serious about doing something to curb landfill expansion, and, as I said, I am very hopeful because I heard it in his Budget Address, I can assure him that legislators from both sides of the aisle would be more than willing to work with him, and I sincerely hope that he takes us up on this offer. After all, Pennsylvania's landfills continue to accept more and more trash from outside our borders. This only results in less capacity to handle our own needs.

Mr. President, Pennsylvania continues to hold the dubious distinction of being by far the biggest importer of garbage, and it is certainly not a legacy that I would want to leave as Governor.

Thank you, Mr. President.

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Venango, Senator White.

Senator M.J. WHITE. Mr. President, I share the lady's concerns. There is an old expression that says no good deed goes unpunished, and what Pennsylvania has done in the past 10 or 15 years--in fact, prior to my service in the Senate, I served on a Solid Waste Advisory Committee as a private citizen--is we have improved our landfill regulations, closed our substandard landfills, put in recycling, and we did everything that a responsible State does to responsibly manage its problem of solid

waste. Unfortunately, our neighbors have not been so responsible.

The Senator is correct that this is a Federal issue to a certain extent, and it is not a question of waiting for the Federal government to act. Our problem is a Supreme Court ruling, the Supreme Court of the United States, that has said that trash is interstate commerce, and as such, no State can discriminate against out-of-State trash or set up barriers against its importation. Now, that gives us a serious problem. While we obviously want to control the expansion of landfills within our State, we are not permitted to discriminate against the trash generated by our own citizens or not allowed to discriminate in favor of our own municipal waste landfills, of which there are many around the Commonwealth that are responsibly managed and are serving the needs of their communities at lower costs.

Secretary Seif, the Secretary of the Department of Environmental Protection, and his staff have been working on this very complicated issue for a long time, certainly before I got here. When I took over the chairmanship of the Senate Committee on Environmental Resources and Energy, this was high on our list of items to address. Obviously, we have not done it quite as quickly as I would have liked or as the gentlewoman would have liked and I understand that. With Trashnet, the Governor has done many Trashnet interceptions of vehicles coming in from out of State that have various vehicle violations. That is not discriminating against out-of-State trash, that is simply enforcing the laws of our roads, of our vehicle safety, laws that our citizens and all citizens have a right to see enforced. I agree that we probably should step that up and continue the Trashnet interceptions from time to time.

But on the more complex area of how we limit the amount of landfill space and expansion in the Commonwealth, I have been working with Members of the House and with Members of the Senate, and we have a bill, and while it is not perfect and perhaps will not meet everyone's requirements, it is still in the discussion stage, I will be most happy to share it with the gentlewoman for her impressions and observations. And while it may not get us the whole 100 yards, I think at this point we are ready to take 50 at a time, or as the football teams do, maybe even just a first down would be helpful.

So, I assure you this is an issue that has the Senate's attention, and we will continue to work on it, and we will look forward to having cooperation from both sides of the aisle, as well as both chambers.
