SB 221 (Pr. No. 227)

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, prohibiting criminal transmission of human immunodeficiency virus/acquired immune deficiency syndrome.

#### SB 406 (Pr. No. 418)

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, providing for sanctions for dilatory, obdurate and vexatious pleadings.

SB 655 (Pr. No. 697)

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, providing for the offense of home invasion.

#### SB 508 CALLED UP OUT OF ORDER

SB 508 (Pr. No. 850) — Without objection, the bill was called up out of order, from page 3 of the Third Consideration Calendar, by Senator BRIGHTBILL.

#### BILL ON THIRD CONSIDERATION AND FINAL PASSAGE

SB 508 (Pr. No. 850) -- The Senate proceeded to consideration of the bill, entitled:

An Act designating a portion of U.S. Route 1 in Chester County as the John H. Ware III Memorial Highway.

Considered the third time and agreed to,

On the question, Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Thompson.

Senator THOMPSON. Mr. President, I rise today to call on my colleagues to support Senate Bill No. 508, a bill that commemorates a section of Route 1 in Chester County as the John H. Ware III Memorial Highway. It is fitting and appropriate that we mark the life of this great man who left his mark on the community and the Commonwealth in several ways.

Mr. Ware was a business leader, serving 23 years as chairman of the American Water Works, the largest investor-owned water company in the United States. He also founded the Penn Fuel Gas Company and was a newspaper publisher, among other business interests.

Mr. Ware also left his mark on government. A friend and advisor to governors and Presidents, he served with distinction in this Chamber. He was elected to the Pennsylvania Senate in 1960, and left his mark as a legislator's legislator and was well known for his work in building coalitions. Mr. Ware left the State Senate in 1971 to represent Pennsylvania's 9th District in the Congress of the United States, where he served until 1975.

He also left his mark on education as a trustee of the University of Pennsylvania, Lincoln University, Widener University, Ursinus College, Pennsylvania College of Optometry, West Nottingham Academy, and Elwyn Institute.

Mr. President, John Ware left his most important marks on the community that he loved. Behind the political and business leader was a caring man who taught Sunday school for 52 years at the Oxford Presbyterian Church. He also found time to work with the Boy Scouts and helped dozens of civic and charitable organizations in Chester County. He gave of his time and money. He donated 19 acres of his family homestead for a senior citizens complex in Oxford, that is known today as Ware Presbyterian Village.

John W. Ware III died in July 1997 at the age of 88. He truly left his mark on the community that he loved. It is fitting that we honor this man and his legacy by designating this section of Route 1, a highway that connects many communities along the East Coast, to the memory of John H. Ware.

I urge a "yes" vote on Senate Bill No. 508.

The PRESIDENT. The Chair recognizes the gentleman from Lackawanna, Senator Mellow.

Senator MELLOW. Mr. President, I would just like to echo the words of Senator Thompson. I had an opportunity as a very, very young Member of the Pennsylvania Senate just a couple of years ago to be able to serve with then Senator Ware. I got to know him not only as a Member of the Senate, but also as a member of the United States Congress. There is no question in my mind, Mr. President, that he himself was a pioneer with regard to public utilities in Pennsylvania and indeed in the nation, especially with regard to water utilities, and I think it is only fitting and appropriate that today we do honor the memory of Senator Ware, not only to name part of U.S. 1 the John H. Ware III Memorial Highway, but also to mention his name on the floor of this Chamber.

Mr. President, there have been a lot of people who have distinguished themselves as Members of the Pennsylvania Senate, and I think it is appropriate from time to time that we acknowledge and remember the tremendous job they did, and today I want to compliment the Members of the Senate, and especially the prime sponsor of the bill, for bringing this to the Members of the Senate's attention for introducing the bill and to finally pass it here in the Senate today. We on this side of the aisle are honored to be part of that.

And the question recurring, Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentleman from Fayette, Senator Kasunic.

Senator KASUNIC. Mr. President, it is with great pleasure and honor that I rise today to introduce a special guest to the Senate of Pennsylvania. For the past 47 years the King Coal Association of Carmichaels, Greene County, has held the Coal Queen Pageant in conjunction with the King Coal Show. The pageant selects a young lady to represent the bituminous coal industry here in Pennsylvania.

An Act authorizing payments to certain entities for the purchase of automatic external defibrillators; providing for powers and duties of the Department of Education; requiring certain training; and providing for civil immunity for certain users of automated external defibrillators.

#### **BILLS ON FIRST CONSIDERATION**

Senator TOMLINSON. Mr. President, I move that the Senate do now proceed to consideration of all bills reported from committees for the first time at today's Session.

#### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentlewoman from Northampton, Senator Boscola.

Senator BOSCOLA. Mr. President, I rise today in support of Senate Bill No. 568, which I authored several months ago, and House Bill No. 996, which was just reported out of the Committee on Appropriations today, in honor of the memory of Gregory Moyer. These bills provide for the Commonwealth to provide automatic external defibrillators, AEDs, to every school, public or private, in the State.

Gregory Moyer was a constituent who was a sophomore at Notre Dame High School in East Stroudsburg when he was struck down by heart failure during a high school basketball game. A 15-year-old in the prime of his young life died in school because it took 25 minutes for the necessary medical treatment, in this case an automatic external defibrillator, to reach him. That is 25 minutes. According to the American Heart Association, for every minute defibrillation is delayed, the victim's chances of survival decline 7 to 10 percent. To date, the Gregory W. Moyer Defibrillator Foundation has raised over \$83,000 to purchase AEDs. They have even negotiated the price through bulk purchasing of AEDs, down from \$3,300 to \$2,100 per unit.

Senate Bill No. 568 and House Bill No. 966 will give those who educate in our community and serve our community the resources necessary to protect the lives we entrust with them. Mr.

President, if there is anyone in this audience who even doubts the need for the importance of such legislation, they need to talk to another constituent of mine, Mr. Vince McConnell. Mr. McConnell was attending a town meeting that I hosted in Bethlehem Township, and it was a town meeting that he wanted me to call because of an environmental problem that he felt seriously about in his neighborhood, and I called that meeting together. He was so upset with a certain company dumping on his land that this town meeting became very emotional. At that point he suffered a heart attack. Now, this was at my town meeting that I called, and this man suffered a heart attack.

But fortunately for Mr. McConnell, the Bethlehem Township Police Department had a defibrillator, and the reason they had a defibrillator was because I helped secure them a State grant so that the police in that township building would have that defibrillator, and it was through the Department of Community and Economic Development. So you have to imagine the feeling that a lot of us in that room had, and especially myself, when I was there to help this individual on an environmental problem, he suffered a heart attack and then a defibrillator that I was able to secure for the township saved his life. You cannot know how much that meant to me, and how I will never forget that experience. That AED was available on the spot and is credited for saving Mr. McConnell's life.

However, we cannot stop there. We must recognize that such opportunity exists whenever large communities gather. We must recognize that municipal buildings, police halls, and fire departments are just as vulnerable as our schools. So Senate Bill No. 568 and House Bill No. 966 is one way that we as legislators can help prevent another tragedy like the one that touched the Moyer family.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Dauphin, Senator Piccola.

Senator PICCOLA. Mr. President, yesterday Senator Mellow brought to the attention of the Senate, as well as the people of Pennsylvania, a situation that has occurred and is occurring in Lackawanna County relative to layoffs by the Corning Corporation after that corporation was the recipient of certain Commonwealth benefits under a variety of programs designed to enhance economic development. And I was, when I heard Senator Mellow's remarks, very impressed and very concerned about what the implications of those remarks meant to the various programs that we fund here in the Commonwealth of Pennsylvania, and I checked into the background and I have to fully agree with Senator Mellow that we need to keep an eye on these programs when we commit Commonwealth dollars to programs designed to enhance economic development.

With respect to the Corning Corporation, however, there is some good news that I was not fully aware of yesterday, and the good news is that most of the \$9.5 million that has been committed to Corning has not yet been released, and that is good news because now we do not have to be in a position to demand any refund. The programs that were accessed were as follows, as best as I can determine them after checking with the various agencies involved. Three million dollars was committed from the Job Creation Tax Credit Program, and that is a program that is based on the jobs that are created and the tax year in which they were

created. And so far, as of this date, none of those moneys have been accessed by the corporation. There was a \$2 million commitment from the Infrastructure Development Grant Program, and to date no moneys from that program have been accessed. In addition, there was a \$2 million opportunity grant, and again that grant has not been made to the company, and a \$1.5 million Customized Job Training Program Fund was tapped, and it has not yet been accessed by the corporation. The only funds that may have been accessed because of the nature of the program was about a \$1 million commitment through the Department of Transportation for transportation funds to improve highway infrastructure, presumably for access to these sites or this particular site. And we do not know for sure whether that program has been tapped or not.

So the key and most important thing to realize here is that the Commonwealth has not yet, while we have committed the funds, not yet actually handed those dollars over to Corning.

I agree with Senator Mellow. I think we need to keep our eyes on these kinds of programs, and if the corporations are not living up to their commitments, not creating the jobs that they have indicated that they are going to create, then I think we need to make sure that these funds, these Commonwealth tax dollars, are not turned over to such a corporation.

The further good news is that the corporation has until April of 2003 to create the 2,500 jobs that it has committed to creating. It is subject to some debate on whether or not that is possible. I am going to be an optimist and hope that it is possible. I believe that it is possible. I think it will be marvelous for Pennsylvania and marvelous particularly for northeast Pennsylvania if that is accomplished. The Corning Corporation, in return for the \$9.5 million commitment, has committed to invest private funds in the amount of \$175 million. And that, if it is done and if that commitment is lived up to by that corporation, it will be a marvelous benefit to Pennsylvania, particularly northeastern Pennsylvania.

I personally am going to take the optimistic view and believe that the glass is half full rather than half empty. And while I certainly deplore the layoffs that have occurred—it is never a good thing when people are laid off from jobs—it is my hope and my desire that those people will be rehired and that many more jobs will be created in this particular location.

This issue points out the importance for both parties, as well as both branches of the legislature, the House and the Senate, as well as the Governor's Office and the administration, to monitor these programs, to make sure that when we provide tax dollars to Pennsylvania corporations or out-of-State corporations to entice them to come into Pennsylvania, that we should be sure that these dollars are spent wisely, appropriately, effectively and efficiently, and most importantly, the commitments that are made when these funds are committed, these commitments are lived up to.

I think from my observation, and I am not intimately familiar with the Corning Corporation, but I think they are generally a good, solid corporation. And they are the kind of corporation that I think we need to persuade to come to Pennsylvania, to create a climate here in Pennsylvania where Corning and other kinds of corporations like Corning will come and create jobs throughout the State, in northeast Pennsylvania and all over Pennsylvania. It is my understanding that Corning already employs approximately 1,200 employees in other parts of Pennsylvania, not in the north-

eastern part of Pennsylvania, and so they have somewhat of a history of working here in Pennsylvania.

I want to take this opportunity to thank Senator Mellow for bringing this issue to the attention of the Senate and also to the people of Pennsylvania, and also to take this opportunity to urge that we all monitor these programs in every aspect that we can to make sure that the commitments made are commitments lived up to.
