The Senate met at 1:30 p.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Robert C. Jubelirer) in the Chair.

REPORTS FROM COMMITTEES

Senator LEMMOND, from the Committee on State Government, reported the following bills:

SB 856 (Pr. No. 985)

A Joint Resolution proposing integrated amendments to the Constitution of the Commonwealth of Pennsylvania, providing for retention election of justices of the peace.

SB 857 (Pr. No. 1991) (Amended)

A Joint Resolution proposing an amendment to the Constitution of the Commonwealth of Pennsylvania, requiring an individual to pass a certification examination before filing a nominating petition to become a district justice and before assuming office as a judge of the traffic court in the City of Philadelphia.

SB 1383 (Pr. No. 1880)

An Act authorizing the City of Warren, Warren County, to sell and convey certain Project 70 lands free of restrictions imposed by the Project 70 Land Acquisition and Borrowing Act.

HB 529 (Pr. No. 572)

An Act amending the act of June 5, 1913 (P.L.419, No.276), entitled "An act to authorize the display of the State, county, city, borough, or other municipal flags on public buildings in the Commonwealth," providing for display of the Pennsylvania flag over memorials, caskets and at funerals of certain persons.

HB 590 (Pr. No. 3851) (Amended)

An Act amending the act of August 5, 1941 (P.L.752, No.286). known as the Civil Service Act, further providing for the commissioner's salary and meeting times; providing for delegation of authority to the director; further providing for residency and for recordkeeping requirements; eliminating the certification of payrolls; requiring the commissioners to submit an annual report; revising the records retention period; deleting citizenship and oath requirements; further providing for the filling of vacancies; requiring citizenship to be the deciding factor in a case of equal qualifications; eliminating certain requirements for promotion without examination; further providing for the distribution of public notice of examinations and requirements for maintaining eligibility lists and for the procedure for certain eligibles who waive consideration for a promotion, for procedures for filling a position, for the requirements of the probationary period; providing for the expansion of the authority of the director to approve temporary assignments; eliminating certain performance standards; requiring probationary performance evaluations and evaluation forms; further providing for a period of removal from eligibility lists; authorizing the commissioner to impose penalties; and providing copies and notices to the director.

HB 1995 (Pr. No. 2969)

An Act establishing the William Penn Liberty Medal of Honor; providing for awarding of medals, for an advisory board and for design and cost of medals.

HB 2100 (Pr. No. 3852) (Amended)

An Act amending the act of June 21, 1957 (P.L.390, No.212), referred to as the Right-to-Know Law, further providing for definitions, for examination and inspection and for extracts, copies or photostats; providing for denial of access to public records, for redaction, for response to requests for access and for final agency determinations; further providing for appeal from denial of right; and providing for court costs and attorney fees, for penalty and for immunity.

HB 2131 (Pr. No. 2843)

An Act amending Title 37 (Historical and Museums) of the Pennsylvania Consolidated Statutes, further providing for the Pennsylvania Historical and Museum Commission, for powers and duties of the commission and for publications and reproductions; and making a repeal.

An Act amending Title 51 (Military Affairs) of the Pennsylvania Consolidated Statutes, authorizing certain members of the Pennsylvania National Guard to operate State-owned vehicles for certain security purposes.

CONSIDERATION OF CALENDAR RESUMED

SENATE RESOLUTION No. 230 CALLED UP OUT OF ORDER, ADOPTED

Senator TOMLINSON, without objection, called up from page 6 of the Calendar, as a Special Order of Business, Senate Resolution No. 230, entitled:

A Resolution honoring in memoriam Stephen Girard as an exemplary merchant, mariner, banker, philanthropist, humanitarian,

patriot, founder of Girard College in Philadelphia and a great Philadelphian, Pennsylvanian and American.

On the question, Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Bucks, Senator Tomlinson.

Senator TOMLINSON. Mr. President, Senate Resolution No. 230 honors the memory of Stephen Girard, an exemplary merchant, mariner, banker, philanthropist, humanitarian, patriot, founder of Girard College in Philadelphia, and a great Philadelphian. We have a lot of great Americans - George Washington, Thomas Jefferson, Benjamin Franklin - but there are many, many great American heroes who are not quite as known.

Mr. President, Stephen Girard is the founder of Girard College and was born in France in 1750. He came to the United States as a young merchant mariner and embraced three great causes: liberty, philanthropy, and humanitarianism. He left his country at the age of 12, became a cabin boy and soon became a captain on a merchant ship. During the Revolutionary War, during the blockades of New York, he was diverted to Philadelphia. He stayed in Philadelphia and became a great success as a businessman and became involved in the first bank of the nation, and in the War of 1812, he loaned the insolvent United States Treasury \$7 million to enable this nation to win the war. Also, he loaned this State, the State of Pennsylvania, \$100,000 with no requirement for repayment to get Pennsylvania through some very difficult times. In 1793, during the vellow fever epidemic when it struck Philadelphia, Girard did not flee the city as many other of his well-known peers did. Instead, he established a hospital, cared for the sick, and used his own finances and resources to bury the dead. Today one of the greatest legacies that Mr. Girard leaves is Girard College.

GUESTS OF SENATOR ROBERT M. TOMLINSON AND SENATOR SHIRLEY M. KITCHEN PRESENTED TO THE SENATE

Senator TOMLINSON. Mr. President, I am here along with Senator Kitchen to introduce a few guests on the floor. First, before I introduce the president of Girard College, I would like to introduce Thomas Baggio, the alumni director for Girard College, and Mike DiMeo and his wife, Frances, from my district in Bensalem. Mike is not only a lector and an active community citizen involved in many activities in Bensalem and Lower Bucks County, but also when I was a high school athlete growing up, Mike announced all our high school games on the local radio station and had a great distinctive voice. And, of course, it is because of Michael that I rise today to offer this resolution. Many of the fond memories of his days at Girard College and the things that college did for him and many other young people in this country when they needed a place to go, when they did not have the financial resources, when things were difficult in their families, Girard College was an institution that Mike and many other people could go to get a good education and go on to be very successful young men, and now young women.

In fact, Mike wrote a book called, "The Stone Cocoon" about his experiences at Girard College and what that college and what the discipline and the academic programs did for him and his fellow classmates at Girard College.

So, Michael, thank you very much, and I ask that the Senate give Mike applause for that.

(Applause.)

Because of Stephen Girard's benefaction and being such a wealthy man and giving so much back to the community, that college has evolved into a great institution, and now I understand they have women there and they have just built a couple of new dorms and have around 600 students and are trying to grow to 1,000 and are still offering many, many young people in the Philadelphia area and the Commonwealth of Pennsylvania an opportunity at success in life, offering a good, rigorous academic program.

To describe some of the things that are going on at Girard College now, I would like to ask the president of Girard College, Joseph Devlin, to please step up and address the Senate on some of the activities and advances that Girard College has made in recent years.

The PRESIDENT. The Chair is pleased to welcome the president of Girard College and ask for his comments, and we look forward to hearing from him.

Mr. DEVLIN. Thank you very much, Mr. President, Members of the Senate, distinguished guests. Special thanks to Senators Kitchen and Tomlinson for introducing and supporting this resolution honoring the founder of the school.

Actually, Girard College is not a college at all. It was named that and it is very misleading to a lot of people. It was named "college" because it was modeled after an academic boarding school in France, as our founder was a Frenchman and he referred to it as a college in his will. Today we are 600 students. All of the students are there on complete scholarships. It is a privately-funded institution from the estate of Stephen Girard. All of the students board. There are no day students at all, and our mission really is to serve at-risk children. So all of the children who come to Girard College have to meet the original guidelines in terms of being poor and having not more than one biological parent in the family. The children are good kids. They come to a school that is very impressive. We have 43 acres of greenery really in the middle of Philadelphia, so we are really an oasis. It is an academic school. We have an elementary, a middle, and a high school. And as Senator Tomlinson said, we have just been able to build a new elementary school and three new dormitories, the first building on our campus in 70 years. This will enable us to grow the school from the current 600 to 800. Ultimately, we would like to get to 1,000, but we can see our funding getting us to 800 students. All of our students are college preparatory, of course, as they reach high school, and 100 percent of our students go on to 4-year colleges and universities.

According to the will, the first preference is given to the children of Philadelphia, the second to the State of Pennsylvania, and I would welcome students from needy families from all of your districts to come to learn a little bit about Girard College, and we would love to reach out to more of the State. Most of our kids do come from Philadelphia. We are 50 percent male, 50 percent female, so we are coed. Although it is a

nondenominational school, there is a strong work ethic which really comes from Stephen Girard that we feel very committed to, and we are very strong in community service. In first grade it is as simple as making beds, but by senior high school, all of our students must volunteer a minimum of 40 hours a year off campus in an organization of their choice. It can be either a church, their neighborhood, their communities, the Franklin Institute, any of those opportunities. To date, we have educated about 22,000 young men and women in our 154-year history. We are going strong, we have a very strong endowment, and as a result of that we are able to give scholarships to our young men and women.

Thank you very much. If you would want to learn more about the school in any way, I would be happy to contact you or one of your aides and make that opportunity available to some of the students in your district.

Thank you very much.

(Applause.)

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Kitchen.

Senator KITCHEN. Mr. President, it is indeed an honor to cite a very good thing in the Third Senatorial District, and right now, today, despite its distinguished history, poor children are being educated at Girard College. They have one of the higher percentages of children going on to college, somewhere within 80 percent go on to college and do very well. So we are glad to just honor his memory and what Stephen Girard stood for for so many years.

Today was a very enlightening day, because I learned that my colleague, Senator Tomlinson, is an historian, and we learned facts today about Mr. Girard that I think would probably be well-known and acknowledged in the district. So I do thank you. It has been a good afternoon.

GUESTS OF SENATOR ANTHONY H. WILLIAMS PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator A.H. Williams.

Senator A.H. WILLIAMS. Mr. President, we have in our audience, and frankly, this is one of the great things about PCN, because tonight all across the Commonwealth the greatest sorority in the Commonwealth will be on television, and they are with us today in our audience. They are led by my Aunt Audrey. Her AKA sisters are with us today. I would like her and her sisters to stand.

The PRESIDENT. Would you stand so we may welcome you to the Senate of Pennsylvania.

Senator A.H. WILLIAMS. For those who do not know the history of some of these sororities and fraternities, for generations when people of color would come out of schools of color, employment opportunities were not always plentiful. These sororities and fraternities have been, for generations,

methods of accomplishment, charitable contribution, and scholarships. Thinking of the old phrase, lifting yourself up by your bootstraps, well, they are the laces, the boots, and the support of many generations of people of color in our community. They have proliferated lawyers, doctors, teachers, and they continue to do such. They are role models to all of us, and they literally go from grandmothers to young women who are teenagers entering colleges of higher learning, and they have stood the test of time within our communities to support all of us in the things they do. I am grateful that the Senate has taken its time to recognize their efforts, and I am grateful that they are here with us today. God bless, and continued success.

SPECIAL ORDER OF BUSINESS 2001 KING COAL QUEEN PRESENTED TO THE SENATE

Senator STOUT. Mr. President, on behalf of Senator Kasunic and myself, it is my pleasure today to once again introduce a very special guest to the Senate of Pennsylvania.

As many of you know, for the past 48 years the King Coal Association, located in Carmichaels, Greene County, has a Coal Queen Pageant in conjunction with the coal show for the purpose of selecting a young lady to represent the coal industry of southwestern Pennsylvania. This year Miss Valerie Berish, the 2001 Pennsylvania Coal Queen, is from Masontown, Fayette County, a district represented by our colleague, Senator Kasunic. Miss BERISH. Good afternoon. I would like to take this opportunity to say thank you to those who made my visit to Harrisburg possible - Senator Kasunic, Senator Stout, and his office staff. As this year's queen, one of the highlights of my reign has been touring Emerald Mine in Greene County. While in the mine, I was given the opportunity to run mining machinery. From this experience, I gained a finer appreciation for the coal industry. Throughout the year, I have attended many functions representing the coal association. This, by far, has been a

once-in-a-lifetime experience, to be able to speak in front of the Pennsylvania Senate.

CONSIDERATION OF CALENDAR RESUMED

SENATE RESOLUTION No. 234 CALLED UP OUT OF ORDER, ADOPTED

Senator BRIGHTBILL, without objection, called up from page 6 of the Calendar, as a Special Order of Business, Senate Resolution No. 234, entitled:

A Resolution recognizing the week of May 6 through 12, 2002, as "Suicide Awareness Week" in Pennsylvania.

On the question, Will the Senate adopt the resolution?

The PRESIDING OFFICER. The Chair recognizes the gentlewoman from Montgomery, Senator C. Williams.

Senator C. WILLIAMS. Madam President, in 2000, suicide claimed 1,348 lives in Pennsylvania and more than 28,000 lives nationally, and there may be as many as 16 attempted suicides for every completed suicide in the Commonwealth alone. Madam President, suicide is a preventable public health problem that can be reduced with increased community information, education, and greater use of crisis intervention, mental health, and substance abuse services. But unfortunately, suicide also has a devastating and long-lasting impact on the family members and close friends who are left behind by suicide victims. In turn, those family members and friends of the victims are put at higher risk of mental illness and suicide as the result of their loss. That loss can fuel a vicious cycle of suicidal tendencies within a family, leaving its members feeling alone and devastated with few places to turn for help.

Madam President, the Commonwealth currently does not have a statewide suicide prevention plan, and I believe we should work together toward the development of such a plan. I also want to encourage every county to develop a county-level suicide prevention plan to increase the accessibility and availability of suicide prevention.

Therefore, we are here today and have offered a resolution recognizing the week of May 6 through 12, 2002, as Suicide Awareness Week in Pennsylvania, so we might be able to address this issue in an effort to prevent future suicide tragedies. In designating this week Suicide Awareness Week, I believe we can increase the level of awareness to reduce the incidents of suicide among the residents of all 67 counties of the Commonwealth. Thank you for supporting this resolution, because suicide is a devastating tragedy that can and should be prevented in Pennsylvania.

Senator BOSCOLA. Madam President, I am offering a resolution to recognize the 31st anniversary of Pennsylvania's ratification of the 26th amendment to the United States Constitution. The actual anniversary fell on the last Saturday in April without even a mention of it in our local papers, but with 2 weeks remaining until the primary election, I thought today would be a perfect opportunity to talk about the 26th amendment and our right to vote.

As you know, the 26th amendment lowered the voting age to 18. Prior to the ratification of the 26th amendment in 1971, citizens were required to be at least 21 years old in order to vote. Pennsylvania became one of the 39 States to ratify the 26th amendment when this State legislature voted in favor of

ratification on April 27, 1971. President Richard Nixon signed the 26th amendment into law on the 4th of July in 1971 and said that 18-, 19-, and 20-year-old voters would, quote, "...infuse into this country some idealism, some courage, some stamina, some high moral purpose, that this nation always needs."

Madam President, in 2 weeks voters in Pennsylvania will have the opportunity to cast their ballots in May's primary election, and I hope by observing the work of this legislature to ratify the 26th amendment, it will encourage our youngest citizens to appreciate the right they have been given to go to the polls and cast their vote on May 21. It should disturb all of us that voter turnout has shown a steady decline in our country. We began the 20th century with a 75-percent turnout in the first presidential election in the 1900s, and a few years ago we ended the 20th century with only about half of the potential voters, 51 percent, voting in the 2000 presidential election. And as we all know, that election will go down in history as one of the closest presidential elections ever held in this great nation.

So I hope everyone, especially our youngest voters, will take note of this anniversary by exercising their right to vote in the upcoming 2002 elections.
