The Senate met at 1 p.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Robert C. Jubelirer) in the Chair.

The PRESIDENT. The Chair recognizes the gentleman from Lackawanna, Senator Mellow.

Senator MELLOW. Mr. President, would Senator Brightbill permit himself to be briefly interrogated?

The PRESIDENT. He will.

Senator MELLOW. Mr. President, could Senator Brightbill explain to us exactly what this amendment is going to accomplish?

Senator BRIGHTBILL. Yes, I would be happy to, Mr. President. The Joint Resolution proposing an amendment to the Constitution of the Commonwealth is intended to require that for an individual to become a district justice, he must first pass a precertification examination to be a candidate, so that the individual is certified to be qualified to do the job. The problem has occurred, both in elections as well as in appointments, that people have been appointed or elected to these positions and then do not pass the test and the qualifications, in which case there is an immediate vacancy, which causes a problem.

What the amendment does is makes the same requirement for the Philadelphia traffic court candidates and nominees.

Senator MELLOW. Mr. President, one of the concerns that I have is, and I would hope that maybe the gentleman can address the issue, what happens in the case where there is no election and there is a vacancy based on either death or resignation? Would the Governor then be compelled only to appoint an individual to either the traffic court, if this amendment carries, and/or as a member of the lower judiciary, the magisterial court, if that person has passed the exam? And it is my understanding that the exam is only given twice a year based on the program, and therefore, unless you are a lawyer and you are learned in law, you would not have the ability to be appointed to a vacancy by the Governor, unless in some previous year you went to magisterial school, is that correct, Mr. President?

Senator BRIGHTBILL. Mr. President, assuming for purposes of my answer that the facts set forth relative to how often they give these tests are in fact correct, the answer is yes. I would add though, Mr. President, that if this constitutional provision were adopted by the people, it would seem then that the court system would necessarily be more responsible if they responded by providing a mechanism where people could take these exams and pass this, if it were for appointments. So I think that is more of a mechanical problem than a problem relating to what should be part of our Constitution.

Senator MELLOW. Mr. President, finally, the amendment, however, that is being offered by Senator Brightbill, only on this point, deals with the Philadelphia traffic court, is that correct?

Senator BRIGHTBILL. Mr. President, the bill already deals with district justices, which would be the rest of the State, and this amendment is to bring in the Philadelphia traffic court to make it consistent statewide. My understanding is that the responsibilities in the Philadelphia traffic court are very similar to the responsibilities of a district justice.

Senator MELLOW. Mr. President, I thank the gentleman.

Mr. President, it was explained to us by the Members of our Caucus from Philadelphia that the Philadelphia traffic court deals

only with traffic-related problems, especially with tickets, and therefore it does not go to the same extent that is dealt with in the magisterial court. Because of that, they did not feel that it was important that the individual must sit and pass a test prior to an election or prior to an appointment by the Governor. For that reason, Mr. President, with regard to the traffic court and this amendment, I ask for a negative vote.

The PRESIDENT. The Chair recognizes the gentleman from Lebanon, Senator Brightbill.

Senator BRIGHTBILL. Mr. President, I would just respond, not being personally familiar with the Philadelphia traffic court, having never had an encounter with them, happily, it would seem to me that it is the responsibility of the court to develop a test, and if that test would be different for the Philadelphia traffic court, that would be within the court's prerogative. Nevertheless, whatever test exists for the Philadelphia traffic court would have to be passed in order for someone to become either a nominee or an appointee to that position. It just seems like this is good, efficient government statewide. This problem has persisted over a number of years. This is not a knee-jerk reaction.

Senator RHOADES. Mr. President, I ask that the resolution be left open for anyone who wants to sign on this resolution, to please do so.

The best way I can summarize this is that every year we propose this resolution and designate a day as Unity Day in Pennsylvania. What we are looking for is to recognize the purpose of eliminating racism and fostering relations based upon community respect, harmony, and justice in this Commonwealth. It is a result from within our home community when we had the KKK come in to demonstrate, our community came together, and when I say our community, our whole county, and from that we have asked that every year we designate a day and present that, and this year October 6 is Unity Day. I ask that this resolution be approved by the Senate.

And the question recurring, Will the Senate adopt the resolution?

On the question, Will the Senate adopt the resolution? The PRESIDENT. The Chair recognizes the gentleman from Lackawanna, Senator Mellow.

Senator MELLOW. Mr. President, last Tuesday a gentleman who graced this body on more than one occasion in various types of celebrations passed away. His name was Gino J. Merli, and his obituary appeared yesterday in the New York Times. Mr. Merli was buried on Saturday of this past week. And I want to read just a few of the accomplishments of Gino Merli, because he was a recipient of the Congressional Medal of Honor during World War II at the age of 19.

He was awarded the Medal of Honor during World War II for operating a machine gun that blocked a German advance against the United States Army at an outpost in Belgium. Mr. President, the description of what took place that evening is rather astronomical when you consider what the American soldiers were going through and what a young man did at the age of 19, who had to quit high school for the purpose of trying to enlist in the military, and I am going to read some of the things that I believe are very important, and I think the Members of the body who are with us right now and those who might be listening will find it to be equally important for a true American hero.

Mr. President, Mr. Merli fought with the First Infantry Division in two epic battles. On June 6, 1944, he took part in the D-Day invasion of Normandy, going ashore at Omaha Beach. In December 1944, Mr. Merli was in the Battle of the Bulge. In both battles, Mr. President, Mr. Merli fought as an American soldier and was not injured. But it was the firefight outside of a Belgium town, midway between the two campaigns, that brought him the nation's highest award for valor.

On September 4, 1944, Mr. Merli was a machine gunner with the First Infantry Division's 18th Infantry when 14 men from his company set up a roadblock near the village of Sars la Bruyere, a few miles from the French border. At least 100 German soldiers came down a cobblestone road and their fire knocked out one of the American's two machine gun positions. Private Merli and his assistant gunner killed several members of the German patrol from the surviving machine gun position, but then, Mr. President, Private Merli's assistant machine gunner was killed by return fire. The remaining members of his unit either retreated or were killed, wounded, or captured. Refusing to abandon his position, Private Merli was alone in his foxhole at midnight, and he held off several more German attacks, expending about 2,000 rounds of ammunition himself.

Once, when continuing to fire would have given Private Merli's position away, a group of Germans approached his foxhole and saw what appeared to be two dead soldiers inside, the body of Private Merli and his assistant. Private Merli was laying underneath the assistant gunner, and he was lying below, pretending to be dead. The Germans prodded Private Merli's body in the buttocks with their bayonets, inflicting four wounds, but he did not cry out. Satisfied that he was dead, the German soldiers departed. Then Private Merli once again began to fire.

At daybreak, the remnants of the German patrol surrendered after American troops opened a counterassault. Private Merli then jumped from his gun pit, having survived with a finger wound and four bayonet wounds to the buttocks. He was wounded on two other occasions, Mr. President, in October 1944, when he was caught in a shelling near Aachen, Germany,

and in the Battle of the Bulge, where he suffered leg and wrist wounds.

On June 15, 1945, Private Merli, at the age of 19, received the highest award, the Medal of Honor, from President Harry Truman. The citation noted the losses and confusion that Private Merli inflicted on the enemy and the toll of the aftermath of his long night at the machine gun position at Sars la Bruyere. On the battlefield lay 52 enemy dead, 19 of them who were directly in front of his gun.

Private Merli was the son of a coal miner.

Recounting the events of September 1944 in an interview with Tom Brokaw-Mr. Merli, incidentally, appears in the book, "The Greatest Generation Speaks"--but recounting the events of the 1944 event in an interview with Mr. Brokaw, Mr. Merli said, "...I can vividly remember now every move, every second from eight that evening to nine the next morning." He also recalled in that book that after this had taken place, the next day he had asked for and received permission after his ordeal had ended to go to the town church. "I asked Sergeant Patinski if he wouldn't mind if I went and prayed for the dead-our dead and their dead. No matter how bitter you were against the enemy, you still had the heart to pray for him. Because he was in the same boat as you and I."

Mr. President, Mr. Merli died on Tuesday of last week, after suffering for several years with Parkinson's. He was buried on Saturday, June 15, 2002, which was 57 years from the day that he received the Medal of Honor from President Harry S. Truman at the age of 19. He is survived by his wife, Mary, and he has a brother Joe, a sister, Emma, and he had a brother Chet, who preceded him in death. He also has a son Gino, who is a medical doctor, a son Philip, a daughter, Maria, and six grandchildren. Mr. President, I knew Gino Merli. He lived in the same town that I have lived in all of my life. Here was a man who never once profited on anything that he did. He was a true American hero and a man who will be missed. And as I said, in yesterday's New York Times they have an article that appears about Jack Montgomery, who died at the age of 84, and Gino Merli, who died at the age of 78, two Medal of Honor recipients who both died on the same day, last Tuesday, and I thought it was important that we take the opportunity to thank and congratulate and pay tribute to a true American hero who has been on the floor of this Senate with us, but more importantly, he was prepared, ultimately, to pay the price so that we can enjoy the freedoms that we have today. He was just a wonderful person, a man who really cannot be replaced, and I think it is important that the record today here in the Senate of Pennsylvania reflect the accomplishments of an outstanding American and a true American hero.

Thank you, Mr. President.
