TUESDAY, November 25, 2003

The Senate met at 11:30 a.m., Eastern Standard Time.

The PRESIDENT (Lieutenant Governor Catherine Baker Knoll) in the Chair.

#### **PRAYER**

The Chaplain, Reverend Dr. BRYAN REYNOLDS, of Cornerstone Fellowship Christian Church, New Florence, offered the following prayer:

### SPECIAL ORDER OF BUSINESS GUESTS OF SENATOR DONALD C. WHITE PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Indiana, Senator Don White.

Senator D. WHITE. Madam President, today I would like to welcome Bernadette Reynolds, the wife of our guest Chaplain today. Dr. and Mrs. Reynolds have been very generous with their time to come to Harrisburg and offer an opening prayer for our Session, so I ask the Senate to extend its usual warm welcome.

Thank you very much, Madam President.

The PRESIDENT. Will Bernadette and Dr. Reynolds stand so we can give you a round of applause.

(Applause.)

### GUESTS OF SENATOR SHIRLEY M. KITCHEN PRESENTED TO THE SENATE

The PRESIDENT. Today, the gentlewoman from Philadelphia, Senator Kitchen, has invited Mr. Sam Evans to be her guest in the Senate, and I ask her to introduce our guest from Philadelphia.

Senator KITCHEN. Madam President, it is an honor to introduce Mr. Samuel L. Evans, the oldest active Democrat in the country. On November 11, Mr. Evans celebrated his 101st birthday. He is with Commissioner Ethel Barnett, and at this time, I request that the Clerk read the citation that we are presenting to Mr. Evans, and he will reply with a thank you.

The PRESIDENT. The Clerk will read the citation. (The Clerk proceeded to read.)

Whereas, Samuel L. Evans of Philadelphia celebrated his one hundred first birthday on November 11, 2003; and

Whereas, Mr. Evans, who has been credited as being the oldest active Democrat in this nation, has also made significant contributions through his work as a producer of classical music at the Academy of Music and through his management position with the Philadelphia Orchestra. To his great credit, he was appointed by former President Franklin Delano Roosevelt as Coordinator of the United States Division of Physical Fitness to aid the War Effort in 1940, and he was selected as a member of the Columbia University World Study Tour in 1948. A prominent figure in the civil rights movement, he was appointed by former President Lyndon B. Johnson as Czar of the War on Poverty. Mr. Evans is perhaps most notably known as the founder of the American Foundation for Negro Affairs, the organization which was selected in 1991 by the United States Department of Health and Human Services as a role model for the nation. He was a member of the New York University Frontiers of Knowledge Study in Integrated Concepts, Science, Philosophy and Education, and in 1970, Mr. Evans was appointed as Executive Vice President of the Bicentennial Corporation, where he spearheaded the efforts to organize the celebration of this nation's two hundredth anniversary. He is also well-known as the author of the poem, "Requiem for Ten Million Slaves," which is a short work calling for a memorial to all those who lost their lives to slavery. The poem was set to music by Philadelphia composer Donald Diller and performed by the Morgan State University Choir; and

Whereas, Through his participation in the Democratic process and the many leadership roles he has held, Mr. Evans has exercised and put to positive use the freedom given to all citizens of this nation, and in doing so, he has proved himself to be a role model worthy of emulation;

Now therefore, the Senate of the Commonwealth of Pennsylvania heartily congratulates Samuel L. Evans on his one hundred-first birthday; wishes him the best of health and further appreciation from all who have come to know and thus respect and admire him;

And directs that a copy of this document, sponsored by Senator Shirley M. Kitchen, be transmitted to Samuel L. Evans.

(Applause.)

The PRESIDENT. The Chair recognizes the gentleman, Mr. Samuel L. Evans.

Mr. EVANS. Madam President, Members of the Senate of the Commonwealth of Pennsylvania, just to be here today surrounded by you, the givers of law and the makers of law, is in itself an honor and I grant it as a privilege, but to be here today surrounded, sitting here today, is in itself a distinction, for it fills my living and being all 101 years. I accept this honor with my highest appreciation, and wish for you the blessings that only heaven can give.

Thank you.

(Applause.)

The PRESIDENT. I want to take a couple of minutes to introduce the guests of Senator Kitchen who are with Sam. Most of you know Ethel Barnett. She was chairwoman of the State Civil Service Commission for many years. Also, Betty M. Thompson, William Jones, and Earl Venson are here. Thank you so much for bringing Sam here today.

(Applause.)

The Chair recognizes the gentleman from Lebanon, Senator Brightbill.

Senator BRIGHTBILL. Madam President, I was very touched to see Mr. Evans, and I would note for the Members that when Mr. Evans was born, we were closer in time to the Civil War than we are today to World War II. It really shows how quickly things

have changed in terms of our society, but, in fact, when Mr. Evans was born, this Capitol, this building that we are in now was under construction, I believe, and certainly had not as yet been dedicated. So he certainly would have more than one lifetime of great experiences that he could share with people.

The other point I would make for Mr. Evans is that we are happy to get him a registration card so he can spend the next 100 years as a Republican.

(Laughter.)

The PRESIDENT. I would like to add to that, Senator. I have known Mr. Evans for many, many years, and his memory is remarkable. He can tell you something about every single president since Franklin Delano Roosevelt, and he knew each one of them personally. I think that is a great achievement, because not many of us can ever make a comment or statement like that, so we are blessed to have him, plus all the work that he has done for the youth in Philadelphia. I have watched him work, and I have known him for 33 years, since 1970, so we are all honored that he took the time to come here today to greet us. We have much to be thankful for.

Thank you.

The Chair recognizes the gentleman from Berks, Senator O'Pake.

Senator O'PAKE. Madam President, Sam Evans is a living legend, and he proves that if you live a lifetime in the political arena, you can live forever, and we are glad to see Sam here. He has done so much for his community, for the city of Philadelphia, and for everyone who came to him for help. We appreciate what he has done, and we wish him many more years being involved in good government and making sure that the right people are elected in the city of Philadelphia and here in Pennsylvania. One hundred and one years; amazing. I hope that his mental alertness and interest in his community will continue for many, many more years in the future.

God bless you, Sam.

SENATE CONCURS IN HOUSE AMENDMENTS
TO SENATE AMENDMENTS

HB 888 (Pr. No. 2919) -- The Senate proceeded to consideration of the bill, entitled:

An Act amending the act of August 26, 1971 (P.L.351, No.91), known as the State Lottery Law, further providing for definitions, for program generally, for generic drugs, for restricted formulary, for reimbursement, for nonliability, for the Pharmaceutical Assistance Contract for the Elderly Needs Enhancement Tier, for the Pharmaceutical Assistance Review Board; providing for pharmacy best practices and cost controls; further providing for penalties, for the Prescription Drug Education Program, for terms of rebate agreement and for amount of rebate; providing for a Pharmaceutical Assistance Clearinghouse; further providing for annual report to General Assembly; and providing for construction with Federal programs and for continued use of Tobacco Settlement Fund.

#### On the question,

Will the Senate concur in the amendments made by the House to Senate amendments to House Bill No. 888?

Senator BRIGHTBILL. Madam President, I move that the Senate do concur in the amendments made by the House to Senate amendments to House Bill No. 888.

On the question,

Will the Senate agree to the motion?

The PRESIDENT. The Chair recognizes the gentleman from Berks, Senator O'Pake.

Senator O'PAKE. Madam President, very briefly, much has been said about this bill already. I do not intend to belabor the point, but over the decades we have cast many very important votes on the Senate floor. This ranks right up there. This allows us to fulfill the promise to provide prescription drugs to 100,000 more senior citizens in Pennsylvania. Now, how did we get here? It took a lot of bipartisan cooperation, it took the leadership of Governor Rendell, it took the lobbying of thousands and thousands of senior citizens in Pennsylvania, and I think it is very appropriate as we break for the Thanksgiving recess that we say thanks to our senior citizens and extend prescription drug coverage to 100,000 more.

This will allow income limits for PACE to increase to \$14,500 a year for an individual and \$17,700 a year for a couple. This is a significant increase for PACENET eligibility, as the limits will now go to \$23,500 for individuals and \$31,500 a year for couples. This begins on January 1, and there may be some confusion because the Medicare amendments that just passed the U.S. Senate and probably will be signed into law do not take effect until the year 2006. This will allow immediate relief for about 100,000 more senior citizens in Pennsylvania, senior citizens who have lost their PACE eligibility or their PACENET eligibility because of slight increases in Social Security cost of living. It is the right thing to do, it is the humane thing to do, it is the compassionate thing to do, and I commend everyone here who had a part in that effort, especially the Governor, who made it all come together.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Lehigh, Senator Dent.

Senator DENT. Madam President, I rise to offer my support for House Bill No. Bill 888. I supported previous increases in PACE and PACENET eligibility, and I am very proud to do so again today.

Today is a landmark day for our older residents. The action we will be taking in just a few minutes in this Chamber will provide true relief for many families. Prescription drug costs continue to rise at a rate unmatched by increases in a family's income. In fact, those increases are especially difficult for older residents who live on fixed incomes. As has been noted so often, the system actually worked against itself, as the modest cost-of-living adjustments in Social Security benefits pushed some senior citizens over the current PACE and PACENET income limits. That meant that the few extra dollars they received in their Social Security checks were eaten up by prescription drug costs. PACE participation, which reached nearly 500,000 in the late 1980s, has since fallen by more than half to about 224,000 this year.

As I noted before, today is a landmark occasion because our actions here are matched by similar events in Washington. Just moments ago, just a few hours ago, the U.S. Senate passed legislation. Pennsylvania's older residents are indeed fortunate to have access to the best State-operated prescription drug program in the nation, and now Congress has acted to provide similar assistance to all older Americans. The U.S. Senate's passage today of the Medicare Prescription Improvement and Modernization Act fulfills the commitment made by both political parties to bring needed prescription drug assistance to

our senior citizens. I strongly support and applaud this new Federal prescription drug program. The new Federal program will not penalize Pennsylvania with a maintenance of effort provision, such as we faced with CHIP. That means the Commonwealth should be able to use the Federal funding to underwrite some of the current costs of PACE and PACENET. The infusion of Federal support means Pennsylvania could consider further expanding PACE and PACENET coverage to even more citizens at a later time.

Yes, Madam President, today is a landmark day for all senior citizens. Today we provide them with needed assistance and ease the financial burden that many face. Today is a culmination of efforts by so many in both Chambers and on both sides of the aisle who worked the practical legislation that enabled the Commonwealth to expand PACE and PACENET without bankrupting the system. The people of Pennsylvania appreciate those efforts, and we thank them for their advocacy over the years. Now it is time that we take the next step and send House Bill No. 888 to the Governor.

# SPECIAL ORDER OF BUSINESS SUPPLEMENTAL CALENDAR No. 3

BILL REREPORTED FROM COMMITTEE AS AMENDED ON THIRD CONSIDERATION AND FINAL PASSAGE

SB 940 (Pr. No. 1297) -- The Senate proceeded to consideration of the bill, entitled:

An Act providing for intergovernmental cooperation in cities of the second class; establishing an intergovernmental authority; providing for financing, for bankruptcy and for sovereign immunity; and making an appropriation.

Considered the third time and agreed to,

And the amendments made thereto having been printed as required by the Constitution,

On the question, Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentlewoman from Allegheny, Senator Orie.

Senator ORIE. Madam President, I would like to submit my remarks for the record, please.

The PRESIDENT. Without objection, the remarks will be made a part of the record.

(The following prepared remarks were made a part of the record at the request of the gentlewoman from Allegheny, Senator ORIE:)

Senate Bill No. 940 results from strong bipartisan support in this hallowed hall, and I rise today to speak on it, because the city of Pittsburgh is a vital asset to both my district and the southwestern region of the Commonwealth. I want to see a thriving city as much as anyone else.

Although many of my constituents work in the city, I did seek to get involved in city affairs. However, when the mayor came to Harrisburg claiming a fiscal crisis and proposed to seek higher taxes on my constituents, I was compelled to investigate and get involved.

As with any other public policy problem we as legislators face, we must first determine the cause of the problem and then design

legislation to address that cause.

We were initially told that the city had fiscal problems due to a declining population and declining tax base. Indeed, these are real problems experienced by many municipalities in the Commonwealth, and Senator Logan has rightfully raised this issue on many occasions. I think it is safe to say that we all recognize that our local tax system is archaic and fraught with problems that we in the General Assembly should address. Many, including the city, continue to argue that in light of a declining population and tax base, that new taxes are needed on commuters and businesses for "fairness" reasons.

While I think that the fairness argument can go both ways when you consider the great deal of benefits that commuters and businesses bring to a city, this argument does not answer the question of what has caused the city of Pittsburgh to be in the financial condition it finds itself in

As I looked closer, I found that between 1984 and 2002, population in the city declined almost 20 percent. Yet, total revenues increased 73 percent and total expenditures increased 72 percent, both more than inflation over that time period (according to the Allegheny Institute).

In October 1996, the Competitive Pittsburgh Task Force cited a decrease in fire risk in recent years, due to improved building codes, sprinklers, and smoke detectors, resulting in a 76-percent reduction in structure fires in the previous two decades. Yet, no reductions were made in fire protection costs.

In order to keep the rates for water customers in these neighborhoods at the same rate as other water customers in the city, the city pays subsidies to those customers who use a private water company. At the same time, there are reports that the water plant is only being used at one-third of its capacity.

Public safety spending rose from \$76 million to \$199 million, an astonishing \$123 million, or 162 percent above the 1984 amount.

The city of Pittsburgh benefitted tremendously as a result of the 1-percent RAD sales tax, receiving over \$145 million since its enactment. The monies from the RAD tax were clearly intended for recreational and cultural assets. However, the city has used them to fund residential and business projects.

According to a survey by the Pittsburgh Tribune-Review, Pittsburgh's use of municipal bonds is exceptionally high compared with that of other cities.

As a result of these and other findings, I believe that it is not clear that the problems with the city's finances are directly caused by the lack of taxing authority. Rather, the more direct causes appear to result from a combination of city practices, including, among other things:

The failure to adjust the structures and services of the city to reflect changes in its demographics, unsuccessful economic development policies, policies which increase the amount of tax exempt land in the city, the city's use of tax increment financing and its debt and loan practices, the diversion of RAD tax revenues received, and the failure to make changes recommended over the last decade which could have saved the city hundreds of millions of dollars over the last 7 years, among other things.

That the cause of the city's fiscal condition is not the result of inadequate revenues is especially true in light of the fact that the city has existing tax authority which it has chosen not to exercise and holds a very large number of assets, many of which are tax exempt parcels of property. Indeed, just yesterday, bills were introduced in city council that could allow the city to generate as much as \$120 million annually.

I firmly believe that our fundamental obligation to the taxpayers is to get our government's house in order before asking them to pay more for it. It is the intent of Senate Bill No. 940 to do this by comprehensively addressing all of the practices and institutions which make up the financial structure of the city of Pittsburgh. Clearly, the fiscal matters of the city extend from the operation of the office of the mayor and city council to each department, bureau, and authority connected to the city. Any related entity which lends money, borrows money, spends money, holds tax exempt property, and receives or transfers employees, money or assets must be a part of the equation.

For this reason, Senate Bill No. 940 establishes a strong fiscal oversight board comprised of finance and municipal government experts, to be known as the Intergovernmental Cooperation Authority. This fiscal oversight board will be empowered to address the city's fiscal issues in a holistic manner, to include budgetary practices and every

component of the city's governmental structure.

As I noted before, Senate Bill No. 940 results from a strong bipartisan effort in this Chamber. The measure is supported by both the outgoing and the incoming Allegheny County executives, one a Republican and one a Democrat. It is also supported by the public, as indicated by the recent Pennsylvania poll and a KQV radio poll. Both polls indicated strong opposition to increased taxes and support for a fiscal oversight authority.

I believe Senate Bill No. 940 is the prudent approach to the issue. I believe that it is the approach that the taxpayers in my region have a right to expect. Therefore, for all of these reasons, I urge an affirmative

vote for its passage.
