MONDAY, March 8, 2004

The Senate met at 2 p.m., Eastern Standard Time.

The PRESIDENT (Lieutenant Governor Catherine Baker Knoll) in the Chair.

## PRAYER

The Chaplain, REVEREND J.R. DAMIANI, of Family Worship Center, Lansdale, offered the following prayer:

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Wonderling.

Senator WONDERLING. Madam President, I rise to recognize the guests of Reverend J.R. Damiani, who is serving today as our guest Chaplain. He resides in my legislative district in Lansdale, actually Upper Salford Township, and he is here with his family in the gallery. ## SPECIAL ORDER OF BUSINESS MEMORIAL TRIBUTE TO THE FORMER SENATOR FRANK J. O'CONNELL

The PRESIDENT. The Chair recognizes the gentleman from Luzerne, Senator Lemmond.

Senator LEMMOND. Madam President, as the Senator who followed Senator Frank O'Connell in the Senate, I am truly honored to offer the following resolution and ask for its immediate adoption and that it be held open for further signatures following the reading, and I ask the Clerk to read the resolution at this point.

The PRESIDENT. Senator Lemmond offers the following resolution and asks unanimous consent for its immediate consideration. The Chair hears no objection.

#### **SENATE RESOLUTION No. 208 ADOPTED**

Senator LEMMOND, by unanimous consent, offered Senate Resolution No. 208, which the Clerk read as follows:

A Resolution expressing condolences on the passing of the Honorable Frank J. O'Connell, formerly a Member of the Senate of Pennsylvania.

WHEREAS, Senator Frank J. O'Connell of Luzerne County died on January 31, 2004; and

WHEREAS, Frank J. O'Connell began his public service career with 12 years of service as a member of the Council of the Borough of Kingston; and

WHEREAS, In 1966, Frank J. O'Connell was elected to the first of six terms in the House of Representatives, where he represented communities in Luzerne County; and

WHEREAS, During his tenure in the House of Representatives, he was elected as Chairman of the Republican Caucus, as well as the ranking Republican on the Appropriations Committee of the House of Representatives; and

WHEREAS, In 1978, Frank J. O'Connell was elected to the Senate of Pennsylvania to represent the 20th Senatorial District, then consisting of all or parts of the counties of Bradford, Luzerne, Monroe, Pike, Susquehanna, Wayne and Wyoming; and WHEREAS, During his tenure in the Senate, Senator O'Connell served as Chairman of the Committee on State Government, as well as a number of various Senate committees where he authored and co-authored legislation on a variety of issues such as local government, volunteer fire services, agriculture, transportation, small business, law enforcement and health care; and

WHEREAS, Senator O'Connell was a diligent advocate for the people of northeastern Pennsylvania and was an aggressive advocate for the interests of his constituents; and

WHEREAS, Widely known as the "Big O," Senator O'Connell was known for his great sense of humor, his fiery and passionate advocacy and his well-honed sense of independence; and

WHEREAS, Senator O'Connell left the Senate in 1985 and began a new career as a representative of various causes and clients, while being free to spend more time with his family and friends; and

WHEREAS, Senator O'Connell, who was preceded in death by his wife Mary, is survived by his children, Molly, Sharon and Frank, and their children and grandchildren; and therefore be it

RESOLVED, That the Senate of Pennsylvania expresses its deep sorrow at the death of this passionate gentleman; and be it further

RESOLVED, That the Senate express its deep gratitude for the services rendered, lessons imparted and friendships shared; and be it further

RESOLVED, That the Senate extend its condolences to the family of its former colleague, the Honorable Frank J. O'Connell, and directs that copies of this resolution be presented to his children.

On the question, Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Blair, Senator Jubelirer.

The PRESIDENT pro tempore. Madam President, no matter how much larger than life a person is when they serve, after they have been away for a while, recollection can truly start to fade away. Thus, it is important that we keep those memories alive and pass them along as part of the broader record and the story of this Senate.

Today we recall the indelible life and service of one of our colorful colleagues, Frank J. O'Connell. It has been more than 20 years since he last answered a roll call, but for those of us who served with him, he was indeed quite memorable, or in the word of a current popular advertisement, "priceless."

Frank O'Connell did not have a particularly lengthy tenure in the State Senate, but the manner in which he served, the way he engaged in issues and debates, with Irish charm and humor and steadfastness, was unforgettable. He was so unabashedly proud of his Irish heritage that he signed his letters in green ink. Back in the days before the nickname "celebrity" was all the fashion, when you mentioned the "Big O," in sports it meant Oscar Robertson; in politics, everyone knew you meant Frank O'Connell. You see, he had the sort of outside character and personality that made him representative of not just his district but an entire region. There was a unique way he said "Poconos," with respect and affection for the great northeast. He was a master of the rough-and-tumble politics in that part of the Commonwealth. He knew when to laugh, when to growl, when to battle, and when to make peace. He had an overriding commitment to service - in the military, in the community, in the world of politics that defined his generation.

Let me tell you, he never shied away from controversy and never complained about his name appearing in newspaper articles and editorials. "I do not care what they say about me, just as long as they spell my name right," was a trademark phrase. He served as chairman of the Committee on State Government, something his successor, Senator Lemmond, does so well now, when that was a landing point for a run of highly contentious issues, including reapportionment in 1981, which I remember too well. Frank was very forceful in his point of view, but he also knew how to hammer out compromises when it was time for action. He was very helpful in jump starting the legislation to write the modern Sunshine Law, and I worked with him on that most important piece of legislation. He was a central player in the highly-charged congressional redistricting effort, one that proved to be so much fun it almost shortened my political career considerably in 1982. If things ever threatened to get dull, one of his committee counterparts was the ever loquacious Jim Kelley, now a senior judge on the Commonwealth Court, who always had a constitutional point of order or two or three, just to get things stirring, and that amused him to no end.

Frank commanded respect, he commanded attention, and when the administration acted in his area without consulting or alerting, he would register his irritation by observing that he was sick of being treated like a mushroom, kept in the dark and fed a lot of crap. And then, of course, he threatened to knock their socks off. He probably never had much use for polls to find out what people were thinking, because he was involved in organizations all over the community. It is doubtful anyone had more of an open-door policy when it came to meeting with constituents than did our late beloved colleague, Frank O'Connell. He just loved people. He just loved people, and he loved the give and take of politics. So this was a nearly perfect place for him, if only Governors did not so sorely test him. He contributed a great deal in style and so much in substance.

Madam President, and wonderful members of Frank's family, he will be greatly missed and well remembered. Frank, you knocked our socks off. Rest in peace.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Luzerne, Senator Lemmond.

Senator LEMMOND. Madam President, I have heard that phrase so many times, knock your socks off, but I have never heard it without all the adjectives that went before it, and they were mighty and they were red and they were purple and they were just the way he was. Frank O'Connell, the "Big O," was a superb legislator for all of us in northeastern Pennsylvania. He was passionate, compassionate, he loved politics, and one of his redeeming social qualities, which he self-proclaimed, was he hated lawyers. Most of the time he really laid off on judges, calling for the demise of Brominski and Hourigan, who were president judges in succession in Luzerne County, far before their eventual demises. There were some lawyers to whom he made some minor exceptions, but we never talked law when I was with him.

He was the ultimate family man. Mary was his star. Frank, Molly, and Sharon, his children, were his debating partners at dinner or wherever he could find them, drive with them, whatever it took. He was to all of us the consummate politician. He was the Tip O'Neill of Pennsylvania politics, whom we enjoyed for his oratorical skill and his knowledge of what was happening here and at home. He had a disposition which was absolutely all his own. He had two lists of people, ones he liked and the others just did not get on it. And when he got to the end of that list, I am not sure that was not the time that he thought maybe, hey, okay, Harrisburg was fun, we will go on to the next thing.

All of us, anyone whoever came in contact with the "Big O" knew where he stood. There were no questions. And no one today, other than one or two in this body, makes a point more positively, more robustly, with so much power, so much emotion, and I say that the "Big O," without question, without equal, had the pointiest finger that has ever been pointed in this Senate.

At home in Kingston, he forged Home Rule, he taught us in the Senate how to chair a committee, he made a difference. All of us would love to be known for having made a difference. At home he spearheaded the Cross Valley Expressway, and if it does not sound big to you, it connects I-81 with the rest of Pennsylvania to the north. My own kids still feel it was Frank O'Connell who got them schoolbuses so that they would not have to cross major highways to get to school in Dallas. He was effective. He was results oriented in a day when that was the hallmark of who we were in the Senate. Chairman Clarence Bell annually and persistently warned us of the evils of turkey season. The "Big O" dreamed of turkey season. There was none better, other than perhaps Mr. MacNett, at mastering the intricacies of year-end legislative dynamics and moving forward what he always swore were solely his constituent-oriented bills. Electricity was in the air when Frank walked into a room, onto a golf course. People energized him, loved him, whatever. He was a presence. He was Wyoming Valley's Irishman of the Year. He signed everything, as Senator Jubelirer said, in green ink, and in our office we have retired, in his honor, all of our green markers.

We learned from him, we respected him, we are glad to honor him today, and I thank all of you for doing this for a great gentleman who once walked among us.

The PRESIDENT. The Chair recognizes the gentleman from Luzerne, Senator Musto.

Senator MUSTO. Madam President, in 1966, I recall very well when Frank O'Connell ran for the State House. It was his first venture in State politics, and during that time and campaign, he campaigned on the fact that he would be a full-time legislator. When he was elected, he sold his business and devoted full time to being a good, good legislator, and I learned from Frank that a legislator serves his people 24 hours a day, 7 days a week.

I had the opportunity to enter the House of Representatives in 1971, and of course, Frank was already in the House and our districts adjoined each other. We did an awful lot of work together back in our home districts, and it was always a pleasure to be at a meeting with Frank O'Connell because you knew exactly where he stood and he would not stand for any nonsense, as he put it. He accomplished much for his district, and especially Luzerne County as a whole. I recall how relentless Frank was during the fight for the Cross Valley Expressway in Luzerne County, and naturally, he was successful, and he was successful at many, many projects in our area of Luzerne County and the State as a whole.

We should also pay tribute to Frank for the work that he did for miners and their widows. Oh, how he loved them and worked so hard on their behalf with his service and legislation. Working with Frank in the House and in the Senate, I admired him much as an individual and as a legislator, and especially when Frank worked on legislation, always with a mindset of improving the quality of life for his constituents. And oh, how he loved his family, his wonderful family. Frank would always talk about them with such pride. The legacy that he leaves is Frank O'Connell, a great family man, a good legislator, and a great friend. Rest in peace, Frank. God be with you.

The PRESIDENT. The Chair recognizes the gentleman from Lebanon, Senator Brightbill.

Senator BRIGHTBILL. Madam President, I came here in 1983 and Frank left in 1985, so I cannot say that I knew him well. The one thing that I recall very clearly is a lesson that he taught me one day in caucus, and I have given that example many times, many places, to many groups about how the Pennsylvania Senate works. It had to do with consensus. Frank was running a bill that had something to do with voter registration. I do not remember the details of the bill, but it came up in caucus and it was marked to run and it did not generate very much controversy or discussion at that point in time because everybody was ready to vote for it. I was brand new, and there were two other new Senators at that point in our Caucus, one was Senator Wenger and the other was Senator Guy Kratzer from the Allentown area. Senator Kratzer raised his hand and said to the Caucus that he was having some difficulty because his voter registration clerk was opposed to this bill. Of course, I looked around the room and no one else was having a problem and I was new there and I thought that it was 49 to 1, let us move on. Frank O'Connell raised his hand and said, I do not believe that person really understands what this bill is about, may I call her? And Guy said, yes. He said, let us go over the bill, I will call her. He had the votes, he would have passed the bill that day, Senator Kratzer would have put up his "aye" vote.

Apparently as a result of that conversation, we were back the next day, the bill came up, Senator Kratzer was fine, and put up an "aye" vote. In the interim, Frank O'Connell called the clerk of the voter registration office and explained what the bill did. I do not know if they faxed a copy down or how they did it, but he got Guy's vote and the bill passed 50 to 0. It was a lesson that made a real impression on me. I mean, at that point I have spent many, many hours in Caucus, had many events, and it made a real impression on me as a brand new Member about how important this place is in terms of consensus building and how we can work together.

My second clear recollection, I actually had a number of recollections, my problem is that a number of them are not recollections that I can relate on the floor of the Senate in a public setting, but he was a great guy and he was a lot of fun and he was fun in caucus. But the other recollection is the caucus that we had in 1983 when we raised the taxes to balance the budget in the beginning of Governor Thornburgh's second year. Of course, once again, I am sitting there and I am a new guy. The Democrats were not going to give us any votes, we needed 26, and we had 27 in the Caucus, and I think the leadership decision was nobody gets off because, clearly, if one got off, everybody wanted to get off, and let me tell you, that was a tough day for Frank. Frank did not want to put that vote up, and there must have been some things that happened in the Thornburgh administration, Charlie is laughing, that he was not exactly tickled with, and we sat there and I remember at one point Frank was bright red, as red as the Clerk's coat, and he was pounding his fist, and poor Senator Jubelirer, our leader, was up there and took the brunt of it. But at the end of the day, we walked up here to the floor and put up 27 "aye" votes and we did what we had to do to keep the Commonwealth moving forward.

He was a great man, and one of the things that we tend to forget when we work here, because we know each other well and we know each other as individuals, is, indeed, just to get here is a very special privilege, and Frank was very much a special person in a group of special people, and we missed him. We did get a great substitute, Senator Lemmond, and he has been delightful to work with and an equally strong proponent for his district. But, Frank, we did miss him, and it was always fun when he lobbied and came back. You know, it was always fun to have him come back and talk about old times and be the strong advocate that he was. He had a great life, and to his children, you should be proud of your Pop, he was a great man.

The PRESIDENT. The Chair recognizes the gentleman from Schuylkill, Senator Rhoades.

Senator RHOADES. Madam President, it is hard for me to believe that my buddy has been gone since 1985. It does not seem that long. What was funny, though, when we began this ceremony the lights began to go out, and I started to laugh and I thought, you bugger, you are at it again, because that would be something that he would do. He could do that, be kidding you, and by the same token he could turn around and get serious and get right down to work in the process. I miss him very, very much because he was a very, very special man to me. You know, you have some favorite people, some friends during your life, and you really cannot measure them all, but he is one man that I measure, and I will put it this way, aside from my family, he is one of the men in my life that I truly admired.

When I got here in 1980, that was when we took over the Majority for the first time in many, many years, and I will tell you what, he took me under his wing, and I will say this, he taught me how to fly. He taught me how to fly so well that when we walked through the hall, Senator Jubelirer and Henry Hager would shake their heads and say, oh, God, here comes trouble, and normally we were because we were that tight and we did some different things and it was extremely difficult. Some of the Members do not know how difficult it was at that time to get some things passed, especially with only 26 votes, but like I said, I do not think I could have learned better from anyone.

I remember when we started we had Conrail abandoning all the tracks. The man who called the northeast delegation together was Senator O'Connell, and then he ended up making me chairman. I do not know how he did that, but I said, look, I am just new here. He said, you will be all right, you will be all right, you will be the chairman. I said I did not know enough, and he said, you will be all right, I will take care of you, and he took care of me. He ordered a bus, we went down to Washington, we met with the congressional delegation, he knew how to do all of those things, he did not have to think about it, did not have to ruffle. He could ruffle feathers, and I will not say he did not, but, by the same token, he had the touch. He had a real good touch. I remember one time in caucus I was getting attacked on an intended pro-life vote. He said, leave him alone, I know what his Bishop is like. I was down on the steps and I saw when his Bishop came out down in Allentown. Leave him alone. And everybody let me alone. I remember a budget vote when I sat in the back here, it was 25 to 24. Every one of our leadership came back to get me to vote for the budget, and I said, you are shutting my hospital down, my unemployment office, my health office, you are doing all these things, I only came here in January and I will be going home in June. Senator O'Connell came back and said, you guys have to help this guy out. Henry Hager would not come down. He said, every time there is a key vote, Jim, you always pull that. I said, that is the only time you talk to me. I learned that from Frank, too. You know, you learned when to squeeze them, when not to squeeze.

You know, all this talk we are having about slots right now, he was the predecessor. He was way ahead of slots, because somewhere in all the dealings that he did in terms of amendments and the way he put them in, remember when we had blackjack games and card games in bars? He put that amendment in and we all voted for it. We did, and we did not know it was there, and we were on break and could not get back for about 2 or 3 weeks. We were scurrying to get back here, and he was laughing his head off. He enjoyed that one. Like I said, he was a master at what he did.

But, I think the other thing I would like to say, too, is I do not think I have ever seen anyone who has, during his time and after his time, been able to work both sides of the aisle in both Chambers, and he did that exquisitely, but it was because he was respected by the people he worked with because when he gave his word, his word was good. He may have extracted his pound of flesh, but you knew what he was doing and why he was doing it. He was tough, and that is what I respected about him, because he

was not afraid to take anybody on. He was tough as nails, but he had a heart as big as the rest of his body, and when he committed to something, you knew he was committed all the way. When he left, like I said, I felt like I lost a buddy, and I probably lost someone I could get in trouble with, but, by the same token, too, I loved when he would come to visit. It was a chance to sit down with him, just to talk, and also to get his perspective on what was going on and what was happening. That is why I always looked forward to when he was coming back from Florida, once or twice during the summer we got together and had dinner, and it was just always great to see him. I looked forward to it. Seeing him in the hall, it was, hey, Senator, how are you? Then we would go to the office and sit and talk for a while.

To his family, I know Molly probably best of all, we served on the State Board together. She is probably as fiery as her mom and dad. Her mom was quiet, but I think her mom also knew how to give orders, and with all due respect to Frank, when mom talked, I think he also was able to adjust to the height of where it was coming from, but that was because of the great love that he had. The other thing, too, is I think I will have to have this printed and put up on the wall. Frank always used to say, if you cannot defend both sides of the issue, you do not deserve to be here. You know, it was a funny way of saying you should, too, but what he was basically telling you was that you should know the pro and you should know the con, because when you make up your mind somewhere along the line, you should know why and you should know how.

So, I will miss him, but from that standpoint, I guess the blessing I would leave is, may the road rise to meet you, may the wind be always at your back, may the sun shine warm upon your face, the rain fall soft upon your fields, and until we meet again, may God hold you in the palm of his hand. Love you, Frank.

The PRESIDENT. All those in favor of the resolution will please rise for a moment of silence in memory of former Senator Frank J. O'Connell.

(Whereupon, the Senate en bloc stood in a moment of silence in solemn respect to the memory of Senator FRANK J. O'CONNELL.)

The PRESIDENT. The Chair declares the resolution unanimously adopted.

Senator LEMMOND. Madam President, it occurs to all of us at this late point in the proceedings that we have not mentioned that Senator O'Connell's sister joined us this afternoon with her husband, and that we have been joined by Molly, Frank, and Sharon, the three children, the debating partners, who have been just stalwart supporters of Frank and all that he has stood for in the Wyoming Valley and far beyond. We are delighted that you are here to hear the good words from all of us. Thank you so much for coming, and our best to everyone else in the family. There are, I believe, 121 relatives scattered around. The O'Connell's are, if nothing else, very prolific.
