The Senate met at 11 a.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Catherine Baker Knoll) in the Chair.

PRAYER

They are all master's degree students at LaRoche College in Pittsburgh. Colleen Cochenour and Cesare Cardi are nurse practitioners, and John Gido is a management student. GUESTS OF SENATOR MICHAEL A. O'PAKE PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Berks, Senator O'Pake.

Senator O'PAKE. Madam President, we are very proud in Berks County of our outstanding student athletes, and we have in the gallery today six of those outstanding high school seniors who have distinguished themselves and earned credits for their families, their schools, and their community. They started off today with a breakfast at the Reading YMCA.

Chad Henne is a senior at Wilson Senior High School. He was a Parade all-American, a U.S. Army all-American, all-State, and he is a quarterback. He will not be going to Penn State, as many had hoped, but he will be going to the University of Michigan, and first I would like you to recognize Chad Henne.

The wide receiver from Wilson Senior High School whose outstanding football career included being named Lancaster-Lebanon first team wide receiver, he is undecided on college, weighing several offers, is Jim Geosits.

From Reading High School, heavily recruited all-State, U.S. Army all-American, will be attending the University of Miami on a football scholarship, James Bryant.

Also from Reading High School, an outstanding member who played offense and defense, he was Lancaster-Lebanon defensive lineman of the year, is undecided on college as we speak, but we are honored to have Nate Luigard and his mother, Deb, who works in my Reading office.

Our wrestling team did very well. We have a national wrestling champion as well as a Pennsylvania champion from Reading High School. Also, his brother had an outstanding wrestling career, he was in the PIAA State tournament, and I would like the Chair to recognize the two wrestlers, Charles Griffin and Joe

Ortiz, and their coach, Kriss Bellanca, from Reading High School.

Madam President we are very proud and grateful for these young men. They have done well, and I know they will do even better in their college careers.

Congratulations. (Applause.)

PERMISSION TO ADDRESS

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Hughes.

Senator HUGHES. Madam President, I stand to offer a congratulatory resolution and hope that every Member of the Pennsylvania Senate will sign on to this resolution.

Something very significant happened in the last week or so in our great city of Philadelphia. The Overbrook High School Mock Trial Team won the 2004 State Mock Trial Championship. The significant thing about that, Madam President, is not the fact that this team, which is led by coach Phillip Beauchemin, started out with 24 team members, but that it wound up with only 5 team members in the final competition. The significant thing, Madam President, is not the fact that this team won its first Mock Trial State Championship in 1997, is not the fact that this team won two State championship titles, four public league championships, and four regional championships all in the last 7 years, but the fact that this team competed with schools all across the Commonwealth, and as I alluded to briefly earlier, competed with only five team members and a coach who was seriously ill throughout the majority of the season. It is a tribute to this school, which is pretty much known for its historical mastery in the sport of basketball, with graduates such as Wilt Chamberlain, Wally Jones, and Andre McCarter, and people of that nature, that it is known in this capacity for a tremendous skill level in competition.

They are not here today, but this resolution is here for all Members of the Senate to hopefully sign on to and congratulate them. Most teams across the Commonwealth had team members in double-digit numbers, but this team had the bare minimum of five members, and were coached and counseled by graduates of Overbrook High School who came back to the school to help them out. We are extremely proud of their work, their effort, their commitment to academic excellence. They are a proud testament that when given support, when given a chance, that any citizen of the State, any child in this State, no matter what their situation, when given support and commitment, any child in this Commonwealth can succeed.

So, we will not talk about who they beat for the State championship. It was a team from Pittsburgh, but we will not talk about who they beat in winning the State championship. We will mention, however, that they beat them with a jury vote of 12 to 2. They beat them 12 to 2. We will not say who they beat, but they beat them badly. They gave them a Saint Joseph's University kind of whipping. But we are extremely proud of the Overbrook High School 2004 State Mock Trial winners. They won the State championship, they did it with the bare minimum number of members on their team, and they did us proud, not just from my district but from the entire State. They are now headed to compete in the national championship against 44 other high school teams in Orlando, Florida, on May 7 through May 9 of this

year, and we hope every Member of the Pennsylvania Senate signs on to this resolution and support and encourage them in an extreme and dramatic way so they can win the national championship.

Senator COSTA. I would like to take a moment to recognize a number of those individuals. They captured the State AAAA title by defeating Parkland High School 57 to 48 in Hershey on March 20 of this past month.

CONSIDERATION OF CALENDAR RESUMED THIRD CONSIDERATION CALENDAR

BILL ON THIRD CONSIDERATION AND FINAL PASSAGE

SB 679 (Pr. No. 1549) -- The Senate proceeded to consideration of the bill, entitled:

An Act amending the act of April 14, 1972 (P.L.233, No.64), known as The Controlled Substance, Drug, Device and Cosmetic Act, prohibiting possession or transporting of liquefied ammonia gas under certain circumstances; prohibiting possession of certain precursors and chemicals used in the manufacture of controlled substances; and imposing duties and responsibilities relating to clandestine drug laboratories upon the Pennsylvania State Police.

Considered the third time and agreed to,

And the amendments made thereto having been printed as required by the Constitution,

On the question, Shall the bill pass finally?

The PRESIDENT. The Chair recognizes the gentleman from Bradford, Senator Madigan.

Senator MADIGAN. Madam President, I rise today to urge support for legislation that will significantly increase penalties for manufacturing a deadly drug known as methamphetamine. Senate Bill No. 679 will give law enforcement agencies greater tools to stop production of this dangerous drug, which is becoming an epidemic in our rural areas, and it will help to protect our children and communities from the lethal and highly addictive drug.

Meth production is a problem in all areas of Pennsylvania, but particularly in the northern tier, which has been often called the meth capital of the world. In my district, it has become an epidemic causing suffering, addiction, and death, and not just for those who make it and use it. Two weeks ago, one of my local papers in their Sunday edition had the full front page on meth and half a dozen pages outlining the impact in the communities. It was the start of a 3-day series, and ironically, 2 days later, after the third one was printed on Tuesday, two Bradford County sheriff deputies became the latest victims of this growing epidemic of death and violence. Mike VanKuren and Chris Burgert were gunned down as they tried to serve a collection warrant on an individual who had two producing meth labs on his property. Their deaths are the latest tragedies in a series and a trail of suffering that this drug has caused.

My bill will make it a crime to possess the ingredients to make this drug. This includes anhydrous ammonia, a chemical commonly used as a fertilizer on our farms. The bill would make it illegal to possess or transport liquefied ammonia gas for any purpose other than an agricultural or industrial use. It would also set stiff penalties for possessing large quantities of other methamphetamine ingredients, including dietary supplements ephedrine and pseudoephedrine, common decongestants found in cold medications. Many of the ingredients used in meth manufacture are available at pharmacies and grocery stores and are readily available to the general public in small quantities, but they are becoming more and more available to young people. The bill is intended to save lives and make it easier for our law enforcement

individuals to crack down on those who manufacture this deadly drug.

Madam President, meth has invaded our communities. It has put our children at risk, it has led to the death of many people, including two dedicated officers. Mike VanKuren and Chris Burgert gave their lives trying to protect others from the horrors of methamphetamine. We owe it to them and to the many victims of methamphetamine to redouble our efforts to stop this deadly scourge. Passage of this bill is a crucial first step.

Thank you for your consideration.

I am a DES daughter because my mother was one of 4.8 million pregnant women who took DES between 1938 and 1971. Like all of those women, my mom thought DES was this new wonder drug. It was the medical breakthrough that she had been waiting for. Her first child was stillborn and she just wanted to make sure that when I was born that would not happen again. Her doctor told her that DES would prevent a miscarriage and ensure a healthy pregnancy. But, as we now know today, this wonder drug actually made the rates of miscarriage, premature delivery, infant mortality, and infertility worse. Not only that, but those children who are exposed to DES are at greater risk for cancer and infertility, which is something I also know from personal experience.

Thanks to the efforts of Jean Golomb, DES Action has made a very big impact across our Commonwealth, with very little funding that they received from the Department of Health over the years. So, for all the women here in Pennsylvania who are battling the effects of DES exposure, especially those women who may not even be aware of the effects of DES, I hope this recognition will serve to support continued outreach efforts, education, and public awareness.

In the past, Senator Mellow has been a leader on this issue and has introduced this resolution. This year I am pleased to join him as a joint sponsor. As we both know, Lupus is a lifelong disease that causes the immune system to attack the body's own tissue and organs, including the joints, kidneys, heart, lungs, brain, blood, and skin. Lupus is neither infectious nor cancerous. Lupus can affect men and women of all ages, but occurs with much greater frequency among women and develops most frequently between the ages of 15 and 44. Lupus also is more prevalent among African-Americans, Latinos, Native-Americans, and Asians. The causes of Lupus are unknown and there is no cure. The Lupus Foundation of America estimates that about 1 1/2 million Americans have a form of the Lupus disease. More people suffer from Lupus than from leukemia, multiple sclerosis, cerebral palsy, and cystic fibrosis combined. Yet. Lupus remains an unknown sickness in our Commonwealth and in our nation. Many people are unaware that they have Lupus because its symptoms are similar to those manifested in other afflictions. While there is no cure, heightened awareness of the disease's indications, severity, and prevalence, can result in earlier diagnosis and better treatment. We do know that improved diagnostic techniques and evaluation methods are contributing to the early diagnosis and treatment of Lupus. With current methods of therapy, 80 to 90 percent of people with Lupus can look forward to a normal lifespan.

Madam President, I urge my colleagues to join Senator Mellow and me for unanimous approval of this resolution declaring April 2004 as Lupus Awareness Month in Pennsylvania.

(The following remarks were made a part of the record at the request of the gentleman from Bradford, Senator MADIGAN:)

I quote from a confidential report issued by the U.S. Department of Justice:

"Methamphetamine producers in several areas of the United States are manufacturing condensed ammonia for use as a substitute for anhydrous ammonia in the lithium/ammonia methamphetamine production method (also known as the Birch reduction or Nazi method). Many have resorted to this practice as anhydrous ammonia has become less accessible in some areas because of increased law enforcement pressure and the risks associated with acquiring, transporting, and storing anhydrous ammonia. Law enforcement officers and first responders should exercise extreme caution when seizing and decontaminating sites where condensed ammonia was produced and used in methamphetamine production."

This new development, the production of condensed ammonia, a homemade chemical, has the same destructive effect on our communities as commercially produced ammonia gas or liquified ammonia gas.
