The PRESIDENT. The Chair recognizes the gentleman from Beaver, Senator LaValle.

Senator LaVALLE. Madam President, I just have a few remarks regarding railroads and why I will ask the Senate to vote "no" on House Bill No. 1117. This bill is being disguised as a homeland security bill. Madam President, the reality is that it, in part, provides for further civil immunity for railroads. In my 30 years in government at almost all levels, the railroads have been the least cooperative of any organization I have dealt with, and many of the concerns have revolved around safety issues. Their answer to safety concerns has almost always been no answer or do not bother us.

Let me share a story that all too often has happened in my district. I live in Rochester, Pennsylvania. We have a railroad and a river. Between the railroad and the Ohio River there is a park that kids play in, and a flag park. Last year I was at that park with my granddaughter, and sitting on the track was a Norfolk Southern engine and train. There was nobody on the train, and kids are fascinated by trains, so we kept looking for people on the train. The train was parked, the engine was running. An hour later a Yellow Cab pulls up, two guys get out with their gear and get on the train. That happens all too often, unattended vehicles on railroad tracks, and the railroad now is looking for civil immunity or further civil immunity. I think that is a disaster waiting to happen, and if this is a terrorist or a homeland security bill, if my granddaughter and I had had a bomb, we could have gotten on the train, taken it to Conway Yards, and blown the whole yard up and nobody would have known the difference. I think it is a bad bill, and I think before we do anything to help railroads, they need to do something or at least be encouraged to be a little more responsive to people who have complaints about safety.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Washington, Senator Stout.

Senator STOUT. Madam President, I would like to respond to my colleague, Senator LaValle, about his concerns about some improprieties created by the railroads and their operation. This legislation has come before us at the request of Homeland Security here at the State level. They needed that because since 9/11 this environment has changed seriously and the railroads need to be able to take action to prevent trespassers and so forth from coming on their property who possibly could be doing some damage to the trains or to railroad equipment, and so forth.

Now, this legislation is reasonable legislation, and the railroads still have liability for people who have a legitimate purpose to be on the railroad. This is for people who do not come on railroads without the consent of the railroad, people come onto their property, set up camps, and operate vehicles, and so forth, on their property, so this is needed legislation on behalf of the railroad industry and homeland security in Pennsylvania. We need to improve House Bill No. 1117 and move forward.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny Senator Ferlo.

Senator FERLO. Madam President, with all due respect to my colleague, this bill has nothing whatsoever to do with homeland security, and I am very disappointed this is being dealt with very late in the evening with all the other urgencies like the State budget and all the other agenda items that have been so critical to the Senate over the last couple days. There are a couple of other bills that are going to fly through tonight.

I want to thank the Majority Leadership for not wistfully putting through a previous bill that would have dealt with stripping and wiping away the rights of utility consumers across the Commonwealth of Pennsylvania, and, in their wisdom and in their good judgment, I want to thank them for not dealing with that bill tonight and holding it appropriately for public hearings. But, here comes another one of these late-night lobbyists, the slippery folks down the hallway, to shoot through a bill that really we should give a lot more thought to.

Again, this bill has nothing to do with homeland security. It even criminalizes an activity which I am not necessarily going to condone, but the fact of the matter is a lot of young people play at or near the railroad yards. This would actually criminalize somebody who happens to ride the rail or somehow interacts with a piece of equipment along the railroad right-of-way to the extent that there could be a 1-year sentence or third-degree misdemeanor with a \$25,000 fine. There are a lot of communities now that have urban parks and public rights-of-way, walking areas and garden areas that are at or near or adjacent to railroads, and I can think of a number of them in my own Senate district. Again. this gives undue consideration to the railroad interests, and I think my colleague, my friend and dear colleague, Senator LaValle, is right in speaking about this industry. I have many folks here who have been local public officials, and certainly those among the consuming public who have ever tried to call or phone or deal with the likes of railroad managers and owners. I am thinking back to the many times in the city of Pittsburgh where the mayor and city council, at the request of community groups, had all kinds of public safety issues, only to get the phone hung up on them by the railroad interests, not even the courtesy of a sit-down meeting. They basically hide behind their Federal laws and preemptions and do not even have the courtesy to return calls to deal with critical railroad issues going through the urban core communities, traffic issues, speed issues, safety issues. They just do not give a damn, to be quite honest with you, Madam President. That is a shame, and I do not see why we are bending over backwards to protect the narrow self-interest of a bunch of railroad company executives who do not want to take the time to appreciate the concerns and criticisms of those who rightfully raise issues in a cooperative spirit with the railroad

Again, this is an overreaching bill that is not necessary, has nothing to do with homeland security, and even criminalizes folks who might be on a snowmobile and travel over a railroad right-of-way. It is a bad bill and should go back through a public hearing process and come back again.

Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Washington County, Senator Stout.

Senator STOUT. Madam President, the railroads are a vital part of our State's transportation network. It is very important that we have a vibrant railroad system for the economy of Pennsylvania, and we need to have security included in this legislation. No pun intended, vote "yes" for House Bill No. 1117, do not let it become derailed. Do not derail House Bill No. 1117, vote "yes."

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Logan.

Senator LOGAN. Madam President, will somebody on the Majority side stand for interrogation?

Senator BRIGHTBILL. Madam President, I will be glad to. The PRESIDENT. The Majority Leader says he will. You may continue.

Senator LOGAN. Madam President, can the Majority Leader define the term "civil immunity" in this bill?

Senator BRIGHTBILL. Madam President, no.

Senator LOGAN. Madam President, can somebody on the Majority side define "civil immunity" and what it means in this bill?

Senator BRIGHTBILL. Madam President, we are consulting here now, and we will be happy to give the gentleman a definition if he does not mind waiting a minute.

The PRESIDENT. The Senate will be at ease.

(The Senate was at ease.)

Senator BRIGHTBILL. Madam President, if the gentleman looks at section 8339.1, I think that while that is the general rule for railroad civil immunity, it really constitutes a definition of what that is, and I think that by reading that section, one would understand what civil immunity would be as applied to a railroad.

Senator LOGAN. Madam President, can the Majority Leader explain if we had any hearings here in the Senate or the House on this?

The PRESIDENT. Senator Brightbill, did we have any hearings here in the Senate or the House?

Senator BRIGHTBILL. Madam President, I am informed by Senator Madigan, who is chairman of the Committee on Transportation, that this bill and the contents of this bill parallel a similar bill introduced by Senator Stout which passed the Senate and was sent to the House. My understanding is that for some reason they did not pass Senator Stout's bill but instead sent this over as a bill, House Bill No. 1117, sponsored by Representative Maher. While we did not have a hearing on it, we did have a process, we did have a meeting, it did come to the floor, it did go through 3 days. We have had a process on this issue before, we just did not have it in this bill form. I would be curious to know what the roll-call vote was. I would not be surprised if the people who are opposing it now probably— I see one over there indicating that he voted "no." Well, I will bet he was the only one.

The PRESIDENT. The Chair recognizes the gentleman from Lackawanna, Senator Mellow.

Senator MELLOW. Madam President, may we go at ease so that we can verify exactly what that roll-call vote was so we can satisfy the very distinguished Majority Leader of the Senate?

The PRESIDENT. The Chair recognizes the gentleman from Lebanon, Senator Brightbill.

Senator BRIGHTBILL. I would enjoy that, Madam President, because it is something I certainly want to know. I am sure, though, that Senator Ferlo's recollection is very good.

A Resolution designating September 16, 2004, as "Stepfamily Day" in Pennsylvania.

On the question, Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Stack.

Senator STACK. Madam President, I have remarks for both resolutions that I would like to submit for the record. However, I reserve the right to come back later, Madam President.

(The following prepared statement was made a part of the record at the request of the gentleman from Philadelphia, Senator STACK:)

Family Day in Pennsylvania

Madam President, I am not going to talk about the statistics I presented last year when I introduced this same resolution. You may recall it simply stated the obvious, that teenagers who eat dinner with their parents frequently are more likely to stay out of trouble, and are less likely to do drugs. We do not need statistics or any more studies to prove that. We know this, families know this, the people of Pennsylvania know this but, Madam President, sometimes in this day and age of work, work, work, run here, run there, a cell phone always in our ear, we forget to slow down and remember what is really important.

That is why I am proud to introduce this resolution. If this resolution passes and as a result a son gets to tell his dad about that fly ball he caught, or a working mom gets to hear her little girl explain why she got

a star at school, Madam President, that will make me happier than passing the budget on time.

Madam President, 2 years ago, the National Center on Addiction and Substance Abuse, otherwise known as CASA, at Columbia University launched Family Day as an annual event to take place on the fourth Monday of each September. As I said, this effort was launched because of the results of research that CASA conducted showing how teenagers who spend dinner time with their parents are less likely to do drugs or get into trouble. I ask you, Madam President, is there a better gift to give to our children than our time?

I therefore proudly offer this resolution declaring the fourth Monday of September, September 27, 2004, as Family Day in Pennsylvania. Thank you.

Stepfamily Day

Madam President, approximately half of all Americans are currently involved in some form of stepfamily relationship. Given that, I believe that it is common sense that the more we support the stepfamily, the stronger we make the fabric of American families and society. Many Pennsylvanians and many of us in this Chamber have seen firsthand the love and stability provided by stepfamilies.

Madam President, stepfamilies are a fact of life. They deserve to be recognized. They deserve our support. Please join me in designating September 16, 2004, as Stepfamily Day in Pennsylvania.

And the question recurring,

Will the Senate adopt the resolution?

A voice vote having been taken, the question was determined in the affirmative.
