Senator GREENLEAF. Madam President, I rise to ask you to recognize several families who are seated in the gallery and who have traveled to Harrisburg today to witness the Senate's consideration of a resolution I am offering, along with 23 other colleagues, which designates the month of May 2005 as "Tuberous Sclerosis Complex Awareness Month" in Pennsylvania.

Seated in the gallery are Peter and Sharon Stachelek and their three children, Tamara, 6, Allyson, 3, and Nathaniel, 2, as well as Peter and Sharon's parents, Connie Stachelek and Stan and Letty Stauffer. The Stachelek family, who lives in Chalfont, Senator Conti's district, has a strong interest and desire in bringing greater public awareness to the residents of Pennsylvania about a rare genetic disorder called Tuberous Sclerosis Complex, or TSC, which is easier to pronounce.

Their daughter, Tamara, was diagnosed with TSC at 21 months of age. She is now 6 years old and takes medication to help control her seizures and receives various forms of therapy. Peter and Sharon have formed Team Tamara, a nonprofit association to help raise awareness of TSC and fund research. Like many of you, I had never heard of TSC, that is until last year when one of my constituents, Letty Stauffer, the grandmother of Tamara, contacted my office about this genetic disorder and her desire to raise public awareness about this disease on behalf of her granddaughter.

With that, I would now like to ask the Senate to give its usual warm welcome to my guests, the Stachelek family and Stauffer family.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Greenleaf.

Senator GREENLEAF. Madam President, TSC, as I have indicated, is a rare genetic disorder that causes tumor growth in vital organs such as the brain, kidneys, heart, eyes, lungs, and skin. TSC commonly affects the central nervous system and results in a combination of symptoms including seizures, developmental delay, behavioral problems, skin abnormalities, and kidnev disease. The name tuberous sclerosis comes from the characteristic tubor, or root-like, growths in the brain that calcify with age and become hard or sclerotic. This genetic disorder, once known as Bourneville's disease, was first identified by a French physician more than 100 years ago. TSC affects 1 in 6,000 babies in our country, and does not discriminate by race or gender. The Tuberous Sclerosis Alliance estimates that 50,000 Americans and 1,000,000 individuals worldwide have TSC. It is caused by a genetic mutation, either inherited or spontaneous. In the Stachelek's case, it was spontaneous.

TSC is the largest known genetic cause of epilepsy, and the second largest identifiable genetic cause of autism. It frequently goes undiagnosed because of the obscurity of the disorder and the mild form that the symptoms may take. There is currently no cure for TSC, although treatment is available for a number of the symptoms. The National Institute of Neurological Disorders and Stroke is studying this disorder, which may one day lead to new avenues of treatment, methods of prevention, and ultimately a cure.

Early detection of TSC has the potential to reduce developmental delay. Greater public awareness and education about TSC is necessary to ensure early detection of and proper treatment for this genetic disorder, which is why I am offering this resolution today.

With that, I would appreciate your support for the adoption of this resolution that will designate the month of May 2005 as "Tuberous Sclerosis Complex Awareness Month" in Pennsylvania. Thank you.

(4) 40 Pa.C.S. Ch. 61 (relating to hospital plan corporations) or 63 (relating to professional health services plan corporations).
"Health savings account." As defined in section 223(d) of the Internal Revenue Code of 1986 (Public Law 99-514, 26 U.S.C. § 223(d)).

Section 4. Special tax provisions.

(a) General rule.—The following shall be excluded from taxation under Article III of the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971:

(1) any contribution to a health savings account by an account beneficiary or the employer of that account beneficiary that conforms to section 223(a) and (b) of the Internal Revenue Code of 1986 (Public Law 99-514, 26 U.S.C. § 223(a) and (b));

(3) any amount paid or distributed out of a health savings account that is used exclusively to pay the qualified medical expenses of the account beneficiary; and

(b) Taxable distributions.—The following shall be included in the income of the account beneficiary and shall be subject to taxation under Article III of the Tax Reform Code of 1971:

(1) Any amount paid or distributed out of a health savings account that is used for any purpose other than to pay the qualified medical expenses of the account beneficiary.

(2) Any excess contribution distribution that has not previously been included in the account beneficiary's income.

(3) Any amount of the account beneficiary's income attributable to an excess contribution distribution.

(The following prepared remarks were made a part of the record by the gentleman from Philadelphia, Senator STACK:)

Madam President, I rise today to offer a resolution designating the week of April 30 through May 7 as "Safe Kids Week" in Pennsylvania.

Since its founding, our nation has been rich in resources. However, our greatest national asset has always been and will continue to be its children. Bright, healthy children grow into adults and carry on the tradition of making this country greater with each generation.

A country committed to greatness cannot afford to lose a single child, and yet, each year more than 5,000 children are killed by unintentional injuries. The fact is, the number one killer of children under 15 is unintentional injury. These children are killed in falls, automobile crashes, fires, and by drowning or choking. No matter the cause, the fact remains that these injuries are preventable.

Through new safety technologies and parent education, this country has cut the child mortality rate from unintentional injury by 40 percent in the last 15 years. Despite this effort, injuries still claim more young lives than any other cause or disease. In addition, over 90,000 children each year are permanently disabled by unintentional injury.

Clearly, there is still more work to be done. The U.S. Surgeon General tells us that up to 90 percent of childhood injuries could be prevented through universal use of child safety seats, bicycle helmets, poison control education, smoke and carbon monoxide alarms, pool alarms, and pool fences. As part of "Safe Kids Week," the Pennsylvania Safe Kids Coalition and 41 local chapters will sponsor car seat checkups and awareness events throughout the State.

Over 1,000 Pennsylvania children lost their lives to violence and injury from 1998 to 2002. With aggressive outreach and smart public policies, I hope we can bring this number down to zero.

In conclusion, Madam President, I ask for unanimous approval for this resolution, proclaiming April 30 through May 7 as "Safe Kids Week" in Pennsylvania.

#### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Fumo.

Senator FUMO. Madam President, at this time in our nation's history, when the glorious legacy of the New Deal, Social Security, is under attack by the party in power in Washington, I want to take a few moments to commemorate the passing of the man whose great vision brought a measure of basic financial security to all people, regardless of their social status. Franklin Delano Roosevelt believed that everyone had a right to share in the American dream, and he believed that government had the power to help fulfill that dream for all people.

A column in the New York Times yesterday, by Bob Herbert, mourned not only the passing of FDR 60 years ago, but also mourned how far our contemporary government leaders have strayed from his ideals. Because Mr. Herbert said it so well, I would like to share his column with you now. The headline read "A Radical in the White House." (*Reading*:)

Last week - April 12 to be exact - was the 60th anniversary of the death of Franklin Delano Roosevelt. "I have a terrific headache," he said, before collapsing at the Little White House in Warm Springs, Ga. He died of a massive cerebral hemorrhage on the 83rd day of his fourth term as president. His hold on the nation was such that most Americans, stunned by the announcement of his death that spring afternoon, reacted as though they had lost a close relative.

That more wasn't made of this anniversary is not just a matter of time; it's a measure of the distance the U.S. has traveled from the egalitarian ideals championed by FDR. His goal was "to make a country in which no one is left out." That kind of thinking has long since been consigned to the political dumpster. We're now in the age of Bush, Cheney and DeLay, small men committed to the concentration of big bucks in the hands of a fortunate few.

To get a sense of just how radical Roosevelt was (compared with the politics of today), consider the State of the Union address he delivered from the White House on Jan. 11, 1944. He was already in declining health and, suffering from a cold, he gave the speech over the radio in the form of a fireside chat. After talking about the war, which was still being fought on two fronts, the president offered what should have been recognized immediately for what it was, nothing less than a blueprint for the future of the United States. It was the clearest statement I've ever seen of the kind of nation the U.S. could have become in the years between the end of World War II and now. Roosevelt referred to his proposals in that speech as "a second Bill of Rights under which a new basis of security and prosperity can be established for all regardless of station, race or creed."

Among these rights, he said, are:

"The right to a useful and remunerative job in the industries or shops or farms or mines of the nation.

"The right to earn enough to provide adequate food and clothing and recreation.

"The right of every farmer to raise and sell his products at a return which will give him and his family a decent living.

"The right of every businessman, large and small, to trade in an atmosphere of freedom from unfair competition and dominated by monopolies both at home or abroad.

"The right of every family to a decent home.

"The right to adequate medical care and the opportunity to achieve and enjoy good health.

"The right to adequate protection from the economic fears of old age, sickness, accident and unemployment.

"The right to a good education."

I mentioned this a few days ago to an acquaintance who is 30 years old. She said, "Wow, I can't believe a president would say that."

Roosevelt's vision gave conservatives in both parties apoplexy in 1944 and it would still drive them crazy today. But the truth is that during the 1950's and 60's the nation made substantial progress toward his wonderfully admirable goals, before the momentum of liberal politics slowed with the war in Vietnam and the election in 1968 of Richard Nixon.

It wouldn't be long before Ronald Reagan was, as the historian Robert Dalleck put it, attacking Medicare as "the advance wave of socialism" and Dick Cheney, from a seat in Congress, was giving a thumbs down to Head Start. Mr. Cheney says he has since seen the light on Head Start. But his real idea of a head start is to throw government money at people who already have more cash than they know what to do with it. He's one of the leaders of the GOP gang (the members should all wear masks) that has executed a wholesale transfer of wealth via tax cuts from working people to the very rich.

Roosevelt was far from a perfect president, but he gave hope and a sense of the possible to a nation in dire need. And he famously warned against giving in to fear.

The nation is now in the hands of leaders who are experts at exploiting fear, and indifferent to the needs and hopes, even the suffering of ordinary people.

"The test of our progress," said Roosevelt, "is not whether we add more to the abundance of those who have much; it is whether we provide enough to those who have too little."

Sixty years after his death we should be raising a toast to FDR and his progressive ideas. And we should take that opportunity to ask: How in the world did we allow ourselves to get from there to here?
