The Senate met at 11 a.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Catherine Baker Knoll) in the Chair.

It is a wonderful day, and I look forward to participating in it many more times, and I seek the unanimous support of my colleagues.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Madam President, I rise this afternoon to ask unanimous consent for the following resolution designating the week of May 1 through May 7 of this year as "Juror Appreciation Week."

Madam President, every year the legal profession, along with the Pennsylvania Bar Association and various county bar associations, celebrate the lull during the month of May with a variety of educational and outreach programs. As part of that endeavor, Madam President, we celebrate the participation of our citizens across the Commonwealth who serve on juries. We all know the jury system, as we recognize it today under our American jurisprudence, traces its lineage back to Henry II, who set up a system to resolve land disputes using juries. A jury of 12 free men were assigned to arbitrate in these disputes, and unlike the modern jury of today, these men were charged with uncovering the facts in the case on their own rather than listening to evidence and arguments in court. The use of the jury system as we recognize it also was codified for the first time in 1215 when King John signed the Magna Carta, making trial by jury an implied right of the English citizenry. Article XXXIX of the Magna Carta reads, "No free man shall be arrested, or imprisoned, or deprived of his property, or outlawed, or exiled,

or in any way destroyed, nor shall we go against him or send against him, unless by legal judgement of his peers, or by the law of the land." Many of these colonies adopted the jury trial system, including Pennsylvania, which first included the right to a trial by jury in its Colonial Charter, and later in the various Constitutions adopted in the Commonwealth. The right to a trial by jury was also included in the Bill of Rights adopted in 1791, and jury trials in criminal cases are protected rights in the Constitution and the 5th, 6th, and 7th Amendments, and also the 14th Amendment of our Constitution ensured that the right to a trial by jury applied at the State level for both criminal and civil matters, and a grand jury in some serious cases.

The right to a jury trial has also been described as one of the most fundamental rights of a democratic society because of the fairness and equality of treatment attributed to a trial that is heard and decided by a group of one's peers rather than representatives of one's government. Over the past several years, Madam President, the Pennsylvania Supreme Court and various other groups across the Commonwealth have studied ways to enhance jury service. Various proposals have been introduced, some by my colleagues in this Chamber today, that would do such things as increase juror pay, provide child care services to jurors, as well as a number of other initiatives to make it easier for people to serve on juries.

Madam President, I have had the privilege of working with my colleagues in the General Assembly, but also with members of the judiciary, in particular, President Judge Joseph James from the Court of Common Pleas in Allegheny County, to try to find ways to improve the manner and the way which we select juries in this Commonwealth. Specifically, we introduced Senate Bill No. 668, which has been moved out of the Committee on Judiciary. This legislation is intended to expand jury pools in all counties so that juries are more diverse by race, age, and experience, producing a jury that is truly representative of communities in which a trial is occurring.

Madam President, while it is important to have some of these changes and recognize the history of our jury process here in our country and Commonwealth, it is also important that we recognize the services of people who have served on juries in this Commonwealth and encourage more of our citizens to do so. Jury service is crucial not only to the trial of the particular matter that a jury is called to hear, but also it is critical to our entire system of civil and criminal justice.

So, Madam President, to those jurors who have served or are serving now, we say thank you. Further, we encourage all of our citizens, when having the opportunity, when they are called to participate in this very important civic duty, that they do in fact serve.

Madam President, thank you for the opportunity to speak.

Senator STACK. Madam President, I rise to offer a resolution along with my fellow Senator, Connie Williams, proclaiming April 23 through 30 as "Days of Remembrance of Victims of the Holocaust." April 25 is known to Jews around the world as Yom Hashoah, Holocaust Remembrance Day. In Europe, thousands of Israeli students will hold a memorial service at Auschwitz, called the March of the Living. In Israel, air raid sirens will sound, and businesses will close. The whole country will come to a standstill. However, April 25 is not just a day for Jews to remember the Holocaust; it is for everyone, no matter your religious or ethnic background.

Next Tuesday the Pennsylvania Jewish Coalition will hold its annual Holocaust civic commemoration at the Capitol. I hope all my colleagues will be in attendance at this event. We will remember those who perished, honor those who resisted, and most of all pledge, never again.

Thank you, Madam President.

The PRESIDENT. The Chair recognizes the gentlewoman from Montgomery, Senator Connie Williams.

Senator C. WILLIAMS. Madam President, many of us know the basic facts of the Holocaust. Six million Jews murdered, millions of others imprisoned and killed, including homosexuals, gypsies, the disabled, as well as political and religious dissidents. Many of us have seen a film or read a book about the Holocaust. However, this is not enough. We cannot ignore humanitarian crises that are going on right now in Africa. We cannot ignore the religious persecution in Asia and the Middle East. We cannot stand aside as certain world leaders continue to deny the facts of the Holocaust. We cannot stand aside as hate groups make spectacles of themselves at military funerals.

Madam President, Holocaust Remembrance Day is not just about the past, it is about our future. What are we doing about the genocide and intolerance that is taking place today? What are you doing? What are we all doing about Darfur and other areas where our fellow human beings are being murdered? The genocide in Darfur alone has claimed more than 400,000 lives since 2003. More than 100 people a day continue to die, 5,000 each month. In our own country, people continue to be judged by their race, their faith, their sexual orientation. How can we say, never again? The Holocaust, genocide, an intolerance of any sort is a symbol of total disregard for humanity and human rights. It goes against everything our country was founded on.

Madam President, we must find answers to these questions. Next week as we observe the Days of Remembrance in Pennsylvania, everyone should consider that. Thank you.
