# SENATE RESOLUTION No. 348 CALLED UP OUT OF ORDER, ADOPTED

Senator BRIGHTBILL, without objection, called up from page 7 of the Calendar, as a Special Order of Business, Senate Resolution No. 348, entitled:

A Resolution designating the week of October 16 through 22, 2006, as "Infection Prevention Week" in Pennsylvania.

Senator ROBBINS. Madam President, I would like to submit remarks for the record.

The PRESIDENT. Without objection, the remarks will be spread upon the record.

(The following prepared remarks were made a part of the record at the request of the gentleman from Mercer, Senator ROBBINS:)

Madam President, I rise to ask support for Senate Resolution No. 348, designating the week of October 16 through 22, 2006, as "Infection Prevention Week" in Pennsylvania.

Every year, more than 800 million Americans visit their physicians, and over 33 million are admitted to hospitals, with many undergoing medical procedures that have a risk of infectious complications. Inhospital infections affect more than 2 million patients annually. In addition to increased morbidity and mortality, these infections raise health care costs by more than \$5.5 billion. Education and improved procedures have significantly lowered patient infection risk in hospitals and other health care and group facilities.

The Association for Professionals in Infection Control and Epidemiology, representing more than 11,000 infection prevention and control professionals, sponsors International Infection Prevention Week with this year's theme being "Infection Prevention: It's in Your Hands."

Health care providers in the many health care facilities of Pennsylvania are set to observe this week with programs and activities and renew their efforts to prevent health care associated infections, thereby reducing the burden of human suffering and disease.

One of those health care providers is Susan DeMaison of the Meadville Medical Center in my district, who brought this issue to my attention.

I urge my colleagues to stand with infection prevention and control professionals as they work to improve patient and health care worker safety and reduce the risk and occurrence of health care associated infections.

I ask that the Senate of Pennsylvania designate the week of October 16 through October 22, 2006, as "Infection Prevention Week" in Pennsylvania.

Finally, Madam President, I would like to personally thank Senator Lemmond, who has always shown interest and support of our history, so all of us may know. He has always supported people knowing the history of everyone in this country, and without Senator Lemmond's support, I know that we would not be voting for this bill today.

Senator ERICKSON. Madam President, I submit the following remarks for the record.

The PRESIDENT. The remarks will be spread upon the record.

(The following prepared remarks were made a part of the record at the request of the gentleman from Delaware, Senator ERICKSON.)

Madam President, Senate Resolution No. 311 addresses the Federal Aviation Administration's plan to redirect air traffic from the Philadelphia International Airport over Delaware County. Currently, air traffic from the Philadelphia International Airport travels over the Delaware River, without significant impact on the residential areas of Delaware County or the nearby John Heinz National Wildlife Refuge.

This resolution calls on the Federal Aviation Administration to conduct at least three public hearings throughout Delaware County to address the following issues: Properly inform residents and government officials of the Federal Aviation Administration's proposed air traffic diversion plan; explore the health, safety, and impact on quality of life by diverting air traffic over a densely populated residential area; afford residents and government officials an opportunity to provide meaningful comment on the plan; and obtain additional input on the environmental impact of its flight diversion plan.

Further, Senate Resolution No. 311 would require that copies of this resolution be transmitted to the presiding officers of each House of Congress and to each Member of Congress from Pennsylvania and to the Federal Aviation Administration.

And the question recurring,

Will the Senate adopt the resolution?

Senator C. WILLIAMS. Madam President, I offer the following remarks for the record.

The PRESIDENT. The remarks will be spread upon the record.

(The following prepared remarks were made a part of the record at the request of the gentlewoman from Montgomery, Senator CONSTANCE H. WILLIAMS:)

Madam President, I rise today to ask for unanimous consent for immediate consideration of a resolution declaring the month of November as "Hydrocephalus Awareness Month" in Pennsylvania. This is a serious neurological condition that occurs when there is an abnormal accumulation of fluid within the cavities in the brain. The only treatment is brain surgery that involves inserting a tube called a shunt into the brain to drain the fluid to another part of the body. The excess fluid can cause head enlargement and blurred vision, learning disabilities, and impaired physical development. If left untreated, it is a fatal condition.

I will hazard a guess that many of you are not familiar with this condition, although you have heard of spina bifida, brain tumor, and Down's syndrome. Hydrocephalus has a higher incidence rate than brain tumor and spina bifida and is on par with Down's syndrome.

Why is it critical that we draw attention to this condition? Well, for one, the current standard of treatment was designed in 1952 and involves inserting a shunt into the brain. The treatment carries serious risks of shunt failure, infection, and over-drainage.

Some facts are that this condition affects as estimated one million Americans from newborns to senior citizens; 1.5 of every 1,000 babies are born with this condition; over 375,000 older Americans have this condition, which often goes undetected for years or is misdiagnosed as dementia, Alzheimer's, or Parkinson's; the majority of cases have an unknown cause; and with appropriate diagnosis and treatment, many patients with this condition can live normal lives, but there is no known cure.

I hope that you will join me in drawing attention to hydrocephalus. With more research, treatment will improve vastly, and the quality of life for people diagnosed with this chronic condition will be better.

And said bills having been considered for the first time, Ordered, To be printed on the Calendar for second consideration.

### BILL ON FIRST CONSIDERATION AND REREFERRED

Senator BRIGHTBILL. Madam President, I move that the Senate do now proceed to consideration of the bill reported from committee for the first time at today's Session.

The motion was agreed to.

The bill was as follows:

And said bill having been considered for the first time,

Upon motion of Senator BRIGHTBILL, and agreed to by voice vote, the bill just considered was rereferred to the Committee on Appropriations.

### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Hughes.

Senator HUGHES. Madam President, as the Senate is aware, recently I have begun a process of conveying the stories of young people who had their lives taken away as a result of gun violence. These are stories reported by April Saul in the Philadelphia Inquirer, and they are available at the Web site Philly.com.

I will read you the story posted on Friday, January 20, 2006, of Darnell Winn, who was 15 years old, 15 years old. (Reading:)

It is as if the minute Darnell Winn, 15, was shot and killed that Saturday night, the street started screaming his nickname, "Mook." His nickname was spray-painted on abandoned houses, freshly tattooed on friends' forearms, and scrawled on teddy bears on the sidewalk at 20th and Mifflin Streets in South Philadelphia where he was killed.

Mook's mother, Darcell Winn, says her son, a ninth grader at South Philadelphia High, was not good at reading and writing, but loved art. "God takes one thing from you and he gives you another thing," she said. She paid \$130 a month so Darnell could send drawings to a correspondence art school.

In Mook's room, his brother Da'Shawn, who is 2 years old, tries to open a box of paintbrushes Mook received for Christmas. His mother regards the boy she gave birth to at 40. "God takes one," she said, "and I guess he gave me the baby."

A riveter, Darcell Winn was working when her mother called around midnight with confusing news. She thought, "Lord, it's not time for me to punch out." Earlier, she had reminded Mook and his brother Dawoyne, 16, who were both staying the night at their grandmother's, that they needed nice clothes for her birthday the next day. The brothers were heading home to get nice clothes to celebrate their mother's and aunt's respective birthdays when the shots rang out. The police are still investigating. --The brothers were heading home to get clothes to celebrate their mother's birthday when Mook was shot.

In a school composition last year, Mook wrote: "I believe that people should not be able to get a gun...I believe that people should have to pay taxes. I believe in God because he is a powerful man. I believe in luck. I believe there is a pot of gold at the end of a rainbow. I will go to college and get a great J.O.B."

I know, Madam President, that today is a day of celebration for the history of this building. Unfortunately, the history of this building contains some work and some things done that we should not be proud of. Today, Madam President, we put in the official record the story of the loss of the life of Darnell Winn, who at 15 years of age was shot on his way home to pick up some clothes, some nice clothes to celebrate the birthday of his mother. He was a ninth grader at South Philadelphia High School. He could not read very well, so he took up art and was good at that. He believed in God, he believed in people paying their taxes, he believed in luck, he believed there was a pot of gold at the end of every rainbow, and he believed that he wanted to go to college to get a job, and he also believed that people should not be able to get a gun. His life was lost, and the opportunity of his future is gone. Today we recognize the life and the loss of Darnell Winn, 15 years of age.

The PRESIDENT. I ask the Senators and staff to stand for a moment of silence for Darnell Winn, another victim of gun violence.

(Whereupon, the Senate en bloc stood in a moment of silence in solemn respect to the memory of DARNELL WINN.)
