The Senate met at 1 p.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor Catherine Baker Knoll) in the Chair.

### BILLS REPORTED FROM COMMITTEES

Senator PICCOLA, from the Committee on State Government, reported the following bills:

### SB 916 (Pr. No. 1105)

An Act authorizing the Department of General Services, with the approval of the Governor, to grant and convey, at a price to be determined through a public solicitation for proposals, certain lands, buildings and improvements situate in the City and County of Philadelphia, known as the Philadelphia State Office Building.

### SB 962 (Pr. No. 1156)

An Act authorizing the Department of General Services, with the approval of the Governor, to grant and convey, at a price to be determined through a public solicitation for proposals, certain lands, buildings and improvements situate in the First and Second Wards of the City of Pittsburgh, County of Allegheny, known as the Pittsburgh State Office Building.

Senator GREENLEAF, from the Committee on Judiciary, reported the following bills:

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, imposing a district attorney justice fee for convictions.

### SB 860 (Pr. No. 1072)

An Act establishing the Public Service Lawyers Loan Repayment Assistance Program to provide repayment assistance to qualified applicants employed by eligible organizations; and providing for the powers and duties of Pennsylvania Higher Education Assistance Agency.

### SB 861 (Pr. No. 1194) (Amended)

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, further providing for the number of judges in the courts of common pleas.

### SB 704 (Pr. No. 1189) (Amended) (Rereported)

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Public Welfare Code, further providing for Intra-Governmental Council on Long-Term Care and for rules and regulations for personal care homes and assisted living residences.

#### SB 886 (Pr. No. 1195) (Amended)

An Act amending the act of February 19, 1980 (P.L.15, No.9), known as the Real Estate Licensing and Registration Act, further prohibiting certain acts.

### HB 13 (Pr. No. 1536)

An Act amending the act of February 2, 1965 (P.L.1860, No.586), entitled "An act encouraging landowners to make land and water areas available to the public for recreational purposes by limiting liability in connection therewith, and repealing certain acts," further providing for liability of landowners toward recreational users, persons or property for acts or acts of omission by recreational users.

### HB 778 (Pr. No. 1977) (Amended)

An Act amending Titles 30 (Fish) and 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, further providing for classification of offenses and penalties, for chemical testing to determine amount of alcohol or controlled substances, for operating watercraft under influence of alcohol or controlled substance and for county intermediate punishment programs.

### HB 881 (Pr. No. 1978) (Amended)

An Act amending Title 34 (Game) of the Pennsylvania Consolidated Statutes, further providing for killing game or wildlife to protect property, for provisions relating to unlawful devices and methods and for exceptions to unlawful use of lights while hunting.

### SPECIAL ORDER OF BUSINESS GUESTS OF SENATOR MICHAEL A. O'PAKE PRESENTED TO THE SENATE

An Act amending Title 62 (Procurement) of the Pennsylvania Consolidated Statutes, providing for contracting with veteran-owned businesses; and imposing duties on the Department of General Services.

Amend Title, page 1, line 4, by removing the period after "Services" and inserting: and other Commonwealth purchasing agencies.

Amend Sec. 1 (Chapter Analysis), page 2, line 1, by striking out "General Assembly" and inserting: standing committees

Amend Sec. 1 (Sec. 2201), page 2, lines 8 through 13, by striking out all of said lines and inserting:

"Active service." Full-time military duty, other than active duty for training, as a member of the United States Army, Air Force, Navy, Marine Corps or Coast Guard, or their reserve components or the National Guard. The term includes full-time service for more than 30 consecutive days performing active state duty for emergencies as a member of the Pennsylvania National Guard.

"Purchasing agency." A Commonwealth agency authorized by law to enter into contracts for itself or as the agent of another Common-

wealth agency.
"Veteran." An individual who performed active service in the armed forces of the United States, including the reserve components and the National Guard, who was discharged from the active service under honorable conditions and who is domiciled in this Commonwealth.

"Veteran-owned business." A business not less than 51% of which is owned by one or more veterans, or in the case of any publicly owned business, not less than 51% of the stock of which is owned by one or more veterans, and the management and daily business operations of which are controlled by one or more veterans.

"Veteran work force utilization business." A business identified by the department as one which develops and implements special processes and procedures for recruiting, retaining, training or developing veteran employees and whose work force is no less than 10% veterans.

Amend Sec. 1 (Sec. 2204), page 3, lines 21 through 23, by striking

out all of said lines and inserting:

(7) Assure that participation by veteran-owned businesses is appropriately factored into the evaluation of proposals for supplies, services or construction when a purchasing agency uses the competitive sealed proposals method under section 513 (relating to competitive sealed proposals).

(8) Certify businesses that have been identified as veteran

work force utilization businesses.

Amend Sec. 1 (Sec. 2207), page 4, lines 8 through 21, by striking out all of said lines and inserting:

§ 2207. Report to standing committees.

Each purchasing agency shall annually, before October 1, report in writing to the Veterans Affairs and Emergency Preparedness Committee of the Senate and the Veterans Affairs and Emergency Preparedness Committee of the House of Representatives concerning total contract dollars awarded to veteran-owned businesses by the purchasing agency during the preceding fiscal year. The report shall include a list of all veteran-owned businesses that participated as contractors, subcontractors or suppliers during the preceding fiscal year. The department shall report to the standing committees concerning the total number of businesses certified as a veteran work force utilization business during the preceding fiscal year. The report shall include a list of all veteran work force utilization businesses during the preceding fiscal year. The purchasing agencies shall submit the initial reports to the standing committees under this section on or before October 1, 2008, or on or before October 1 at least 12 months after the effective date of this section, whichever is later.

(b) Property description.—The property to be conveyed pursuant to subsection (a) consists of approximately 0.26-acres more or less known as 108 West Washington Avenue and more particularly bounded and

described as follows:

BEGINNING at the intersection of the northerly line of Washington Avenue with the easterly line of Aetna Street; thence south, eighty-nine (89) degrees fifty-five (55) minutes east, ninety-four (94) feet along said northerly line to the westerly line of an eighteen foot alley; thence at right angles along said westerly line of said alley north, no (0) degrees five (5) minutes east, one hundred twenty-one (121) feet to the southerly line of another eighteen foot alley; thence at right angles north, eightynine (89) degrees fifty-five (55) minutes west, ninety-four (94) feet along said southerly line of said last mentioned eighteen foot alley to said easterly line of Aetna Street; thence at right angles south, no (0) degrees five (5) minutes west, one hundred twenty-one (121) feet along said easterly line of Aetna Street to the place of beginning.

Containing: 0.26-acres, more or less.

(c) Conditions.-The conveyance shall be made under and subject to all lawful and enforceable easements, servitudes and rights of others, including, but not confined to, streets, roadways and rights of any telephone, telegraph, water, electric, gas or pipeline companies, as well as under and subject to any lawful and enforceable estates or tenancies vested in third persons appearing of record, for any portion of the land or improvements erected thereon.

(d) Covenant.-Any conveyance authorized under this act shall be made under and subject to the condition, which shall be contained in the deed of conveyance, that no portion of the property conveyed shall be used as a licensed facility, as defined in 4 Pa.C.S. § 1103 (relating to definitions), or any other similar type facility authorized under State law. The condition shall be a covenant running with the land and shall be binding upon the Grantee, its successors and assigns. Should the Grantee, its successors or assigns, permit any portion of the property authorized to be conveyed in this act to be used in violation of this subsection, the title shall immediately revert to and revest in the Grantor.

- (e) Deed of conveyance.-The deed of conveyance shall be by Special Warranty Deed and shall be executed by the Secretary of General Services in the name of the Commonwealth of Pennsylvania.
- (f) Costs and fees.-Costs and fees incidental to this conveyance shall be borne by the Grantee.
- (g) Deposit of proceeds.-The proceeds from the sale of the land and building shall be deposited in the State Treasury Armory Fund.
- (h) Disposal.-In the event the conveyance is not executed within six months of the effective date of this act, the Department of General Services may dispose of the property for the Department of Military and Veterans Affairs in accordance with section 2406-A of the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929.
