#### **PERMISSION TO ADDRESS**

The PRESIDENT. The Chair recognizes the gentleman from Fayette, Senator Kasunic.

Senator KASUNIC. Madam President, I rise to recognize five brave heroes from the 32nd Senatorial District who made the ultimate sacrifice in defense of their country. As we debate the important issues of the day, we too often lose sight of the men and women who continue to serve our nation in faraway places.

There is no greater distinction, Madam President, for an American citizen than to serve his country, and, Madam President, there is no greater sacrifice that an American can give other than giving his life in defense of his country, in the defense of freedom, democracy, and liberty.

These five men are representative of thousands who have lost their lives. Each of them could be our son, daughter, husband, wife, grandchild, brother, or sister. We owe them and their families our gratitude, our support, and a permanent place in our hearts and in our prayers.

Army Master Sergeant Arthur L. Lilley courageously sacrificed his life in June, less than a month ago, in Afghanistan. He enlisted in 1990 and received over 25 combat medals throughout his decorated career. A veteran of Desert Shield and Desert Storm, but more importantly, a loving husband and father, he will never be forgotten.

Private First Class Nils G. Thompson died in 2005 at the hands of a sniper. A deeply devoted Christian, he served his nation with honor, pride, and loyalty. He was honored with both the Purple Heart and the Bronze Star. Those who know him will never, never forget Nils.

Eric R. Hull, a graduate of Uniontown Area High School, made the ultimate sacrifice in 2003 in Iraq. Like so many of our men and women fighting in Iraq, a roadside bomb tragically felled him. He was a principled man who always met every challenge he faced head-on, and his bravery and courage will always be remembered. Eric is survived by his wife, his two children, and parents.

Marine Private First Class Shelby J. Feniello of Connellsville bravely sacrificed his life in 2006 while rushing to assist his fellow troops in Iraq. He earned an associate's degree in accounting, but he bravely responded to the call following the attacks on September 11 on our nation. Shelby's courage and passion made him a natural leader in his platoon, and he will be remembered as a superior Marine who always put others' needs before his own.

Army First Sergeant Christopher C. Rafferty, whose family hails from Brownsville, was a 19-year-old Army veteran, a man whose values preceded his pristine record. He lived by the seven Army values - loyalty, duty, respect, selfless service, honor, integrity, and personal courage. Christopher lost his life in 2006 while courageously serving our nation in Afghanistan.

Madam President, our fallen soldiers will forever live on in the memories of all who were fortunate enough to know them. We must never forget or underestimate the ultimate sacrifice given by these heroic individuals and their families.

With our recent celebration of the birth of this great nation at 231 years of age, I thought it would only be fitting to honor and commemorate the bravery of all our service personnel, our men and women who are overseas. I ask that in these difficult times we take a few moments to pray for them and thank them for risking their lives, putting their futures on hold, and in many cases, making the ultimate sacrifice to ensure our safety and our freedom.

Madam President, we honor these men and women, we love them, we miss them, and for those who paid the ultimate sacrifice, they will never ever be forgotten.

Thank you, Madam President.
