ANNUAL LOW-LEVEL RADIOACTIVE WASTE PROGRAM REPORT

Dear Secretary Corrigan:

Enclosed is the Department of Environmental Protection's Annual Low-Level Radioactive Waste Program Report to the Pennsylvania General Assembly. This report covers calendar year 2006.

The report provides a summary of the current activities of the Appalachian States Low-Level Waste Compact, a list of all low-level radioactive waste (LLRW) generators in the compact, and the amounts of LLRW disposed by volume. It also contains a discussion of LLRW generation trends, including waste minimization and financial statistics relating to all aspects of the compact.

The Pennsylvania Low-Level Radioactive Waste Disposal Act (Act 1988-12) requires that this report be prepared each year. The enclosed report is based on data from the U.S. Department of Energy's Manifest Information Management System (MIMS). MIMS is a national database that contains the actual volume and radioactivity of LLRW disposed of at the three existing commercial LLRW disposal facilities in the country.

An Act providing for a report on potential climate change impacts and economic opportunities for this Commonwealth, for duties of the Department of Environmental Protection, for an inventory of greenhouse gases, for establishment of Climate Change Advisory Committee, for a voluntary registry of greenhouse gas emissions and for a climate change action plan.

SPECIAL ORDER OF BUSINESS GUESTS OF SENATOR BOB REGOLA PRESENTED TO THE SENATE

For 35 years, Operation Outward Reach has trained inmates in State correctional institutions in the trades of carpentry and masonry. By working with individuals who are about to be released from incarceration, Operation Outward Reach gives them experience with skills that can help them find meaningful employment once they are outside the prison walls.

What makes this program even more special is that Operation Outward Reach provides construction services for low-income homeowners, fire companies, and small municipalities and only charges them for the cost of the materials. This program, which started at the State correctional facility near me in Greensburg, has grown to also serve correctional facilities at Huntingdon, Cresson, Mercer, Somerset, and Albion, as well as the women's facility at Cambridge Springs.

In addition to celebrating its 35 years of service, Operation Outward Reach recently received another very special honor as it was recognized for its work and achievements by the American Correctional Association. This national organization selects only one treatment program for this honor each year, and we as a Commonwealth can take great pride that Operation Outward Reach is the 2007 recipient.

Madam President, I ask that the Senate welcome Mr. Ray Thompson and extend our appreciation for all the good work he has done and for all the good work that is done by Operation Outward Reach.

(The following prepared remarks were made a part of the record at the request of the gentlewoman from Montgomery, Senator C. WILLIAMS:)

Madam President, I rise to ask your support in declaring November 15, 2007, as Pennsylvania GIS Day. GIS, or geographic information system, is a progressive technology that has transformed the way we live and work.

Have you ever wondered how the navigation system in your car actually knows where to go? How do soldiers know every inch of their surroundings when they are at the base of huge mountain ranges? The answer, ladies and gentleman, is GIS technology.

Geospacial technologies, like GIS, global positioning systems (GPS) and digital mapping have become everyday tools that we rely on to deliver public safety and emergency response. It is used in medicine, economic development, homeland security, for education, workforce analysis, transportation, agriculture, historical preservation, and even for travel and advertising.

If you would like to see some good examples of GIS technology, you should take a few minutes to visit some of the GIS exhibits in the Capitol rotundas on November 15. You will be amazed at how this type of technology has changed daily living.

The United States Department of Labor has identified geospacial technology, biotechnology and nanotechnology as the three technologies with the greatest potential for growth and job creation. Employment in the geospacial technology industry is growing by 10 percent to 13 percent per year and the demand for geospacial technology services is creating new jobs in a wide range of fields.

Pennsylvania is a leader in research and training in geospacial technology and is home to many of the nation's leading geospacial technology firms.

I hope that you will join with me in drawing attention to GIS by declaring November 15, 2007 as Pennsylvania GIS Day.
