#### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Berks, Senator O'Pake.

Senator O'PAKE. Mr. President, during the last political election, automated robocalls reared their disturbing heads once again, and I want to commend the distinguished Majority Leader for introducing Senate Bill No. 34, which seeks, once again, to ban political automated robocalls. These are definitely an invasion and an intrusion into the privacy of homeowners as they are sitting at home, trying to enjoy dinner, and they get this automated political robocall. There is no opportunity to discuss political issues because it is very one-sided, since it is automated.

I know last year we did pass this in the Senate, and I would be hopeful that, in a bipartisan spirit, we can act quickly and send this to the House and hopefully have it await a more favorable conclusion. So I commend Senator Pileggi, and we promise to work with him to end this very obnoxious, intrusive practice, which unfortunately seems to be gaining steam not only here but throughout the country.

Senator FONTANA. Mr. President, I would like to welcome all the new Members to our Chamber in anticipation of a hard-negotiating budget season coming up, and I know if we are all working together, we can build a consensus and pass a budget on time.

Senator LOGAN. Mr. President, I am back from my leave.

Senator PILEGGI. Mr. President, I would like to thank the gentleman from Berks County for his remarks, and I look forward to working with him for swift passage of the bill that I have sponsored, which has many cosponsors in this Chamber, that would ban political robocalls.

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Farnese.

Senator FARNESE. Mr. President, last night, as we all know, our new President made the ball circuit, but he also had the opportunity to point out the men and women who are serving across this great land in uniform. And of course, I want to join in again--and actually, last night, I received many well wishes from my district to the men and women serving from the First Senatorial District--and congratulate them and share in the inauguration of our new President.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Ferlo.

Senator FERLO. Mr. President, I just want to recall some of the final debate and discussion from the last Session before we reconvened, and it was on the critical issue of utility reform.

Just very briefly, Mr. President, I want to reiterate my concern and my clarion call for restoring the consumer protections under the Chapter 14 provisions of the Public Utility Code. I think it is very critical in recognizing these cold winter months and the economic hardships that so many people are severely facing throughout our Commonwealth. And yet we continue to have folks who are basically freezing to death in their own homes because their gas and light has been shut off.

I believe we need to restore some of the balance between the rights and the prerogatives of the utility companies to run a profitable business at a fair rate of return, but at the same time, I think our common call and our common sense of humanity needs to recognize how critical it is right now during these hard economic times. We need to restore the ban on winter shutoffs that have led to the deaths of a significant number of Pennsylvanians, and it is morally repugnant, as far as I am concerned, and I hope and pray that this great Senate would take up this call as we continue to move toward debate on utility rate relief, rate caps, Public Utility Commission consumer protections, and the like.

The PRESIDENT. The Chair recognizes the gentleman from Cambria, Senator Wozniak.

Senator WOZNIAK. Mr. President, shortly, we are going to be reconvening for voting Sessions. In February, we are going to hear the Governor's discussion of the state of the State and his Budget Address, and I just want to reiterate that although these times are very difficult, please keep an open mind.

I know it is so easy to say no to everything, but we have a structural situation in our budget that is going to be very, very difficult to correct. It is going to take cooperation, it is going to take collaboration, and it might make some very tough decisions for some Members, but I am hoping that on February 2--I believe that is the day--we will have an opportunity to see what the Governor lays before us and what path we will have to take. And I know that this Senate will persevere and do well over the next few months.
