#### Dear Mr. Corrigan:

On behalf of the Department of Environmental Protection (DEP), I have enclosed the Annual Report of the Pennsylvania Energy Development Authority (PEDA) for fiscal year 2008-2009. In this time period, PEDA granted over \$15 million to 29 clean energy projects, including nearly \$3.8 million to five "shovel-ready" alternative energy and energy efficiency projects through the American Recovery and Reinvestment Act (ARRA). In this time period, staff of the Pa. Department of Environmental Protection also developed the 2009 PEDA funding solicitation to award an additional \$21 million in funding for energy projects, which included another \$10 million in ARRA funds. Those grants were awarded to 25 projects just after the reporting period, on August 10, 2009.

The PEDA program continues to provide funding for energy efficiency and alternative energy projects that promote clean energy and supports the manufacturing and installation of clean energy products here in the Commonwealth. These projects help reduce our reliance on fossil fuels and conventional energy sources, increasing grid reliability and helping organizations of every type to reduce their energy consumption, and ultimately their expenses.

## SPECIAL ORDER OF BUSINESS **GUESTS OF SENATOR MICHAEL J. STACK** PRESENTED TO THE SENATE

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Stack.

Senator STACK. Mr. President, I would like to take this opportunity to introduce everyone in this Chamber to a very special young man who displayed exceptional bravery and commitment to helping another citizen in need.

On the floor today, with his family, is Michael Kogan. He is joined in the Senate by his mother, Ida Kogan, and family friends Lara Narita and Nugzar Manashvili. Michael lives in Bensalem, which is located in Bucks County, Senator Tomlinson's district. I have gotten a chance to meet Michael through many functions in my district in northeast Philadelphia.

The reason Michael is so special is that he displayed incredible courage and selflessness last April while driving along Route 1 in Bucks County. He noticed that there was a woman stranded by the side of the highway. He knew that it was a very hazardous situation, so he pulled over. He tried to help Reyna Castro, who had a flat tire. While he was retrieving items in his trunk to help her, a motorist slammed into the back of Reyna's car at 70 miles per hour. Reyna, who was standing at the back of her own car waiting for Michael, was killed instantly. The motorist hit Reyna's car with such force that her car slammed into the back of Michael's while Michael was standing at his trunk trying to get items to fix a flat tire.

Well, Michael was very lucky to survive, but he lost both legs. And those of us from Philadelphia or southeastern Pennsylvania know how hazardous that area of the road is to even think about pulling over. And Michael paid a heavy price for trying to be a good Samaritan and a courageous person.

But let me tell you about this young man. He is the most selfless person you will ever meet. If you get a chance to see him--and I hope you do get a chance to see him today--he has nothing but a smile on his face and the most pleasant disposition that you will ever see. I think he represents what we all try to talk about, courage and selflessness in our young people here in Pennsylvania. I am particularly glad to see that we have some young people in our gallery today so that they get a chance to be inspired by this young man's courage. So we are very thankful to have him here, along with his mother and his friends.

Michael was here to visit us previously, and we ended up, with the crazy schedule that we have had in the past year, we ended up not having Session, so Michael did not get a chance to come and meet our colleagues here. But he was in the process of his rehabilitation, and while in my office, in the hallways of this Senate, he took his first steps without using any assistance - no wheelchair, no canes. Michael has told us that he believes the Senate of Pennsylvania is a good luck charm. It is a very special place. Maybe it has some kind of spiritual power.

So we are very pleased to have him here, and, Mr. President, I would like to ask that we give him a warm welcome. We have already awarded him a Senate citation, and we are so happy to have him here.

Senator WOZNIAK. Mr. President, this is a classic example of government gone bonkers. Somebody in the Health Department, somewhere, somehow decided that by the letter of the law, homemade baked pies at a church bazaar are illegal, wrong, and forbidden by the Commonwealth of Pennsylvania. This is the type of thing that befuddles the general public.

And I just want to bring one other issue up. I might bring it up later on, because it is now in the Department of Education. Since tomorrow is Mike O'Pake's birthday and also Groundhog Day -a number of years ago, I had a schoolteacher in one of my school districts, and every year, he baked groundhog cookies for his children. But the Department of Education, based upon the nutrition that I guess somehow we passed, said it is forbidden for elementary school kids to have a groundhog cookie or a cupcake or something else because it is going to lead to obesity and all kinds of craziness in our school system.

So shortly down the line -- I approve of baking pies at home, and I also think little kids should be able to have a little birthday party in the classroom with a cupcake or a groundhog cookie once in a while. It is not the intention of the Commonwealth of Pennsylvania to be Big Brother for groundhog cookies, grandma's baked pies, or anything along those lines. So if there is anybody out there who is an enforcer who is listening to this, lighten up a little bit.

HB 1779 (Pr. No. 2403) -- The Senate proceeded to consideration of the bill, entitled:

An Act designating a bridge in Clarks Summit, Lackawanna County, as the John E. Fitzgerald Memorial Bridge.

Upon motion of Senator PILEGGI, and agreed to by voice vote, the bill was laid on the table.

#### SB 53 (Pr. No. 1663) (Amended) (Rereported)

An Act amending Title 20 (Decedents, Estates and Fiduciaries) of the Pennsylvania Consolidated Statutes, in intestate succession, further providing for forfeiture; in wills, further providing for modification of wills; in grant of letters, further providing for advertisement of grant of letters; in administration and personal representatives, further providing for duty of personal representative; in apportionment of death taxes, further providing for enforcement of contribution or exoneration of Federal estate tax; in powers of attorney, further providing for implementation of power of attorney; in estates, further providing for applicability of rule against perpetuities and for modification of conveyance by divorce and for effect of divorce on designation of beneficiaries; in trusts, further providing for notice of representation, for creditor's claim against settlor, for actions contesting validity of revocable trusts, for claims and distribution after settlor's death, for removal of trustee, for trustee's duty to inform and report, for illustrative powers of trustee and for limitation of action against trustee; in principal and income, further providing for power to convert to unitrust and for retirement benefits, individual retirement accounts, deferred compensation, annuities and similar payments; and making conforming amendments to Title 15.

#### SB 213 (Pr. No. 1664) (Amended) (Rereported)

An Act authorizing the Commonwealth of Pennsylvania to join the Interstate Compact on Educational Opportunity for Military Children; providing for the form and enforcement of the compact; imposing additional powers and duties on the Governor, the Secretary of the Commonwealth and the compact administrator; and establishing the State Council on Interstate Educational Opportunity for Military Children.

#### SB 432 (Pr. No. 433) (Rereported)

An Act providing for the protection of victims of sexual violence, for duties of law enforcement agencies, for procedure and for penalties.

## SB 642 (Pr. No. 697) (Rereported)

An Act amending the act of July 2, 2004 (P.L.492, No.57), known as the Sign Language Interpreter and Transliterator State Registration Act, further providing for definitions, for responsibilities of Office for the Deaf and Hard of Hearing and for State registration required; providing for provisional registration; and further providing for change of personal information, for registration violations and for suspension, denial, nonrenewal or revocation of State registration.

On the question,

Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Kitchen.

Senator KITCHEN. Mr. President, Black History Month is an annual event in which we commemorate the struggles and victories of African Americans in our history and their contributions to society. Carter Godwin Woodson, an African American historian, created Negro History Week on February 7, 1926. The name was changed to Black History Week in the 1960s during the American Civil Rights movement. The event was expanded to Black History Month in 1976.

This is a special time, Mr. President, for all of us to highlight the many accomplishments of African Americans in our nation's history, many of whom are from Pennsylvania. There were trailblazers like Pennsylvania's first black congressman, Robert N.C. Nix, Sr., and his son, Robert N.C. Nix, Jr., who was the first African American Chief Justice to sit on a State Supreme Court. Juanita Kidd Stout was the first African American woman to be elected judge in the United States and the first African American woman to serve on any State Supreme Court.

We cannot forget former Senator Hardy Williams, whom we lost in January. Hardy Williams was a community activist who served as a Representative and then as a Senator for 30 years. He was the first African American candidate for mayor in Philadelphia to garner widespread public support, showing that an African American could, and did, win as mayor. His efforts led to the election of other independent Democrats throughout the city, from committeepeople to the mayor's office, including the first African American mayor of Philadelphia, W. Wilson Goode.

Through our resolution, we as Senators can set aside the entire month of February to recognize the many contributions of the African American community to Pennsylvania and our nation.

Senator TARTAGLIONE. Mr. President, as our State and our nation debate the best options for reforming healthcare, it is important to remember that the most inexpensive and most effective way to accomplish our goals is through individual understanding. Every citizen can enact his or her own healthcare reform. That is why I am honored to join my colleagues today in supporting the goals of National Wear Red Day in Pennsylvania.

In many cases, the pen is mightier than the scalpel. Information about prevention is as effective to achieving our healthcare goals as legislation. For many years, heart disease was seen as a men's disease. As recently as 5 years ago, only a small fraction of women knew that it is also a leading killer of women in America. Slowly, through the efforts of the American Heart Association and the Go Red for Women campaign, women in all walks of life have begun to realize that their risk is as great as that of men. While women have responded tremendously to the campaign educating them on the risks of breast cancer, heart disease continues to kill more women than all cancers combined.

I am proud to take part in the introduction of a resolution, today, intended to continue the momentum toward making women understand all of their health risks while giving them the knowledge they need to reduce those risks. By taking steps to improve their health, women can not only save our healthcare system hundreds of billions of dollars, but they also can save their mothers, daughters, sisters, and friends.

Mr. President, I ask my colleagues to support the resolution and to reach out for information that can lead to a happier future for all of us.

A Resolution expressing sadness on the passing of Miep Gies and honoring her memory.

On the question, Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Mr. President, today, I rise to ask the Senate for an expression of sadness on the death of Miep Gies. Miep Gies was the protector of Anne Frank. This particular hero passed away a few weeks ago at 100 years of age.

The reason for this resolution is twofold. First, over the years, thousands of children in Pennsylvania have read "Anne Frank: The Diary of a Young Girl." Well, it seems to me that we should also recognize and honor the person who protected Anne Frank.

That diary would not have been written if Miep Gies and her husband, Jan, had not valiantly protected Anne Frank in the attic of their home.

Throughout history, there are those special heroes who risk their own lives to save others. In Israel, for everyone who saved a Jew during the Holocaust, a tree was planted in their honor. It is called the Forest of the Righteous. If one looks at the history that we as a people have had century after century, who are these special people who risk their lives to save others? You know, they are very hard to identify or classify.

You would think they might be the academics who, out of knowledge, would step forward. Sometimes they are. More often, they are not.

You would think they would be the religious leaders of the community. Sometimes, religious leaders have stood up, such as Saint Maximilian Kolbe. A parish in his honor is in my district. Saint Maximilian Kolbe gave his life for that of another person in one of the concentration camps.

You might think they are government officials who would stand up to risk all to save others. Sometimes, they have been. More often, they have not.

It turns out that if you look and really try to identify those throughout history, you will find that they are ordinary people. They are farmers. They are merchants. They are people who work in factories. Today, as we honor in this resolution Miep Gies--who, as I said, just passed away 2 weeks ago, and who, at her own risk, and at the risk of her family, saved not only Anne Frank but three other members of the Jewish faith in Amsterdam during the war--let us also honor all who, in human history, have risked all to save other people.

When we do that honor, and in this resolution today, we remind ourselves that the human spirit can still overcome the hatred and the genocide that has so often taken place in this globe's history. Also, today, in paying tribute to Miep Gies, we celebrate ordinary people who do extraordinary acts, and for that, we are all grateful, and we praise them.

Thank you, Mr. President.

A Resolution supporting "National Black HIV/AIDS Awareness Day" on February 7, 2010, in Pennsylvania.

On the question, Will the Senate adopt the resolution?

The PRESIDENT. The Chair recognizes the gentleman from Philadelphia, Senator Hughes.

Senator HUGHES. Mr. President, this resolution asks that the Senate recognize February 7, 2010, as "National Black HIV/ AIDS Awareness Day" in Pennsylvania. We have spoken on this floor on numerous occasions with respect to the scourge of this particular disease. Given the history of our work on this particular issue and, unfortunately, given the length of history of the existence of this disease, which is nearly 30 years, I rise again on the floor of the Senate of the Commonwealth of Pennsylvania to ask for unanimous support in recognizing February 7, 2010, as "National Black HIV/AIDS Awareness Day" in Pennsylvania.

Unfortunately, this disease has been in existence for 30 years. It is a disease that is completely avoidable. It is a disease that is completely preventable. It is a disease that, in fact, Mr. President, just does not have to be. I have spoken about the alarming statistics on this floor on several occasions, but I will repeat them.

Thirteen percent. Despite the fact that 13 percent of the population of this nation is African American, 55 percent of all HIV/AIDS deaths exist in the African American community. One other alarming statistic, Mr. President, is that HIV is the leading cause of death for African American women aged 25 to 34 years. I will repeat that again, Mr. President. HIV is the leading cause of death for African American women between the ages of 25 and 34.

This is a disease that is, as I have said before on this floor, completely preventable. It does not have to be. We are encouraging support for this resolution to continue to try to wage the war on this very devastating disease that has, over the last 30 years, found a way to isolate itself into communities that unfortunately remain, in so many ways, defenseless, largely because they do not have the resources to deal with the struggle of HIV and the ancillary issues that surround it.

We have spent time talking about this issue in Pennsylvania and, of course, in my home city of Philadelphia. We have spent time around the nation, and in fact, we have had the opportunity and the responsibility to spend some time fighting this disease around the world. But we know that Pennsylvania must stand up again and again and again, in every community and in every environment and in every place possible, to lift up our voice and to do whatever we can to fight the fight against this disease known as HIV/AIDS. Even in an environment where the resources seem to be dwindling, we must continue to raise awareness and raise consciousness.

So, Mr. President, we are asking for unanimous support from all of the Members of this body. We ask that the resolution remain open at the desk for additional cosponsors. We have numerous already, but we hope that more will sign on. We will hopefully see that our work on this disease extends beyond the recognition of February 7, 2010, as "National Black HIV/AIDS Awareness Day," and that it finds itself embodied in the legislation and the budgetary priorities that are necessary to wage a successful struggle.
