I am pleased to submit the Pennsylvania Conservation Corps (PCC) annual report for fiscal year 2008-09, the Corps' 25th year of operation. Last year, 307 young men and women were given the opportunity

Last year, 307 young men and women were given the opportunity to gain self-confidence and improve their employability as members of the PCC. More than 114 corpsmembers completed courses at vocational-technical schools and technical training centers, 16 took at least one college class, and 16 earned GEDs. Despite the sluggish economy, nearly a third of all corpsmembers moved directly into jobs upon leaving the Corps.

During the fiscal year, the PCC completed 47 projects in 33 counties. Corpsmembers constructed or renovated 150 campsites, 19 pavilions and 67 support buildings, improved or developed 195 miles of trails and 115 acres of wildlife habitat, helped preserve 11 historic buildings and 3,100 historical artifacts, and planted more than 34,000 seedlings and trees--to name just a few of their accomplishments.

I am pleased to present you with a copy of the Annual Report of the Office of Small Business Advocate for Calendar Year 2009.

In carrying out its mission in 2009, the OSBA was guided by the realization that every dollar a business must spend on utility service or workers' compensation insurance is a dollar unavailable for expanding that business, creating jobs, or increasing pay and benefits.

As highlighted in the Annual Report, two categories dominated the OSBA's utility-related case load in 2009: First, the rates to be charged for default service electricity after the generation rate caps expire. Second, the electric conservation programs to be implemented under Act 129.

Small business customers should benefit significantly from the requirements in Act 129 that default service electricity be purchased through competitive bidding and that the rates of one customer class not subsidize the rates of another customer class. For example, the OSBA challenged the use of an index to set the 2009 default service rates for Duquesne Light Company's medium commercial and industrial ("Medium C&I") customers. The resulting settlement adopted the OSBA's

position that the rates should be set by direct purchases in the competitive market. Because of the OSBA's intervention, Duquesne's Medium C&I customers saved an estimated \$23 million in 2009 and are likely to pay less for default service in 2010 than they did in 2008.

The most significant savings because of the OSBA's activities in the more traditional utility rate cases in 2009 are as follows:

- The distribution rates for the small business customers of UGI-Penn Natural Gas were set about \$1.5 million per year lower than they would have been under the company's proposed allocation of the rate increase.
- The distribution rates for the small business customers of UGI-Central Penn Gas were set about \$480,000 per year lower than they would have been under the company's proposed allocation of the rate increase.

In addition to savings for utility ratepayers, the OSBA also helped produce savings in the workers' compensation premiums paid by employers (outside the coal industry). Specifically, the Pennsylvania Compensation Rating Bureau proposed a 0.7% increase in the 2009 premiums for the cost of providing medical care for injured workers and for the cost of paying wages while those workers are off the job. In contrast, the OSBA recommended a 7.8% decrease. After considering the competing arguments, the Insurance Department ordered a decrease of

The economic problems many citizens and municipalities faced this year have led to a slight decrease in the number of in-force flood insurance policies, as well as an increase in the number of communities not

participating in the program.

During this upcoming year we will continue to encourage the purchase and maintenance of flood insurance by communicating its importance at outreach events, publications and media events. We will also join the Department of Community and Economic Development (DCED) and Pennsylvania Emergency Management Agency (PEA) in their efforts to educate and inform the municipalities of the importance of community participation.

Senator STACK. Mr. President, it is that time of year again. As you can see, I am wearing a green tie, and you are going to hear in a moment from my friend and colleague, otherwise known as the other Senator wearing a green tie, Senator Rafferty. We are both offering this resolution which proclaims March 2010 as "Irish American Heritage Month" in Pennsylvania. This year's theme is "St. Patrick, Model of Unity for the Church and the World."

St. Patrick's Day gives us an opportunity to honor the patron saint of Ireland and all people of Irish descent around this time of year, whether that descent is real or imagined. During Irish American Heritage Month, Pennsylvanians can take this entire month to honor the contributions that Irish Americans made to Pennsylvania and to our country. The Irish influence on our history is apparent in the churches and the schools that they founded, in our growth as an industrialized nation, in the military, in politics, and, well, in just about every facet of our society here in Pennsylvania.

Irish from across Pennsylvania will celebrate Irish American Heritage Month. Whether in big parades in Philadelphia--and one of these times, we are going to have you there, Mr. President--whether in Philadelphia or Scranton or in smaller celebrations in Girardville, Schuylkill County, Irish pride will be displayed and celebrated. Mr. President, I ask that we, the Members of the Pennsylvania Senate, display and celebrate the many contributions that Irish Americans have made to our Commonwealth and our nation by adopting this resolution, attending a parade or a celebration, or wearing some green on Wednesday, March 17.

Senator RAFFERTY. Mr. President, once again, I stand and join my colleague and my friend from Philadelphia County, Senator Michael Stack, in presenting a resolution for approval honoring Irish American society during the month of March. Mr. President, I am mindful of the saying, "wearing a bit o' the green," as Senator Stack and I are both wearing green ties today. Actually, that saying derives from Saint Patrick, for when you look at Irish culture, and you look at the presidential flag of Ireland, it is actually blue and gold. And when people say "wearing o' the green," it is derived from the three-leafed shamrock that Saint Patrick used to teach about the Holy Trinity throughout Ireland. So consequently, the wearing of the green grew out from that, and if you ever have the chance to visit Ireland, you will see the many colors of green, the variations in the fields throughout all of Ireland. So it is well-known and rich in the green color. And certainly, March is a time when we wear the green to show our pride in our Irish ancestry.

Mr. President, it is not just a day to celebrate with a parade. It is a time for us to reflect as well. As Senator Stack said, the history of our country and of our Commonwealth in particular is rich with Irish American influence, not only in politics, in religious life, not only in the medical community and the legal community, but also in the military. And, Mr. President, it was a colonel from Ireland who headed up the Pennsylvania Long Rifles during the American Revolutionary War. And who can forget the sacrifices made at the Battle of Gettysburg by the Irish Brigade? General Meade himself was of Irish ancestry. So there are a number of individuals throughout the history of the United States--the Sullivan brothers, famous from World War II--who dedicated themselves to the betterment of this Commonwealth and the betterment of the United States of America. Senator SMUCKER. Mr. President, late in February, a gentleman by the name of Amos Funk passed away at the age of 98. His is not a household name, but it should be. Everyone who

takes pride in our agricultural traditions, everyone who appreciates the substantial economic contribution of agribusiness, and everyone who cherishes a productive farming future in Pennsylvania owes a debt of thanks to Amos Funk. A man of faith, he believed deeply in the responsibility of caring for the land. Through his life's work and passion, he earned the title of "father of Lancaster County farm preservation."

Lancaster County, long recognized for agricultural prominence, was the frontline example of where prime agricultural land was threatened by heavy development pressure. There, the seeds were planted for the agricultural preservation programs that have taken root in most Pennsylvania counties. To deal with the special challenge of preserving property owned by Amish and Mennonite families, the Lancaster Farmland Trust was created. Amos Funk provided a lot of the vision, energy, and innovation behind these programs. His brand of leadership involved both learning and doing. The results show. Lancaster County has 86,000 acres preserved over the past quarter-century, and more are added each year.

He worked both ends of the equation. It is important to keep good land in agriculture, but it is equally important to keep farmland in good shape by using the best practices. Soil and water conservation are common topics for discussion nowadays. Amos Funk was a pioneer in these areas, starting way back in the 1930s. We consider it a remarkable accomplishment when someone devotes 25 years in one place or to one cause; Amos's commitment to farmland conservation covered more than 75 years. State and national leaders sought his advice and secured his participation in numerous conservation and preservation efforts. It appears that he had only one answer: Yes.

Without the leadership of Amos Funk, agriculture would be much diminished in our economy. His is a most extraordinary and lasting legacy born of a fervent desire to do the right thing. Thank you, Mr. President.
