SPECIAL ORDER OF BUSINESS GUEST OF SENATOR ANDREW E. DINNIMAN PRESENTED TO THE SENATE

Senator ORIE. Mr. President, I move that the Senate do now proceed to consideration of all bills reported from committee for the first time at today's Session.

PETITIONS AND REMONSTRANCES

The PRESIDING OFFICER. The Chair recognizes the gentleman from Philadelphia, Senator Hughes.

Senator HUGHES. Mr. President, I rise to speak briefly, but I think it is important and relevant at this moment. We are concluding our business for this week, Mr. President, and possibly all of us are waiting with great anticipation for what could potentially be momentous action to occur in Washington, D.C., in our United States Congress, this weekend. We have deliberated long and hard here in this body for years about the issue of advancing the need to cover, at least at this point in Pennsylvania, about 1 million people who have no health insurance in the Commonwealth.

We have a history in this State of, in many cases, rising to the occasion. We were one of the first States in the nation, if not the first State in the nation, 20-some-odd years ago, to put in place the CHIP Program, the Children's Health Insurance Program. We saw it to be appropriate and right and in order a few years ago to create a program called adultBasic to provide health insurance to adults in this Commonwealth because they were working, they were working hard, they were getting up early in the morning, they were working all day, many of them working late into the

evening, in many cases they were women, in most cases the sole breadwinners of their families, but they could not afford to purchase the health insurance that they needed.

We created adultBasic to try to respond to that need. We were somewhat responsive. Hundreds of thousands of people over the years have gotten coverage. But because of financial reasons, because the costs of the premiums have gone up dramatically, we cannot keep that program at the same level, where it should be. Many of us, myself included, have introduced specific pieces of legislation to try to address the issue of providing coverage, high-quality health insurance coverage, for the 1 million or so adults in this Commonwealth who have no coverage. We have not been successful, but we have always tried to advance the ball, always tried to raise the level of conversation.

I rise at this moment, Mr. President, because I think it would be inappropriate for us to leave this Chamber and not speak to the issue in some respect and not recognize, in some respect, the fact that our Representatives in Congress may be making a momentous decision that will impact all of us. Personally, I support the need to provide coverage. I support the need for the passage of the legislation that is currently in front of the United States House of Representatives and the United States Senate. I support that. I think it is important. I think it is crucial.

I know that ever since Teddy Roosevelt, the Rough Rider, ever since prior to the completion of the Panama Canal over a hundred years ago, Presidents of this country have been calling for the need to provide health insurance, high-quality health coverage for those who do not have it. We have been waiting, and we have been waiting, and we have been waiting. We have gotten to the point now, after at least a year's worth of oftentimes contentious conversation and contentious discussion, we have gotten to the point where legislation has passed both the House and the United States Senate and is poised and ready for final passage and to be signed into law. I hope that our Federal Representatives do not miss this long-sought opportunity and allow this moment to pass them by.

There are millions and millions of people in this nation, and over a million people in this Commonwealth, who have been waiting for years—in many respects, decades—for action on this issue. Most of them are hardworking individuals. Many of them are women. Most of them are raising families. A significant portion of them are the sole breadwinners in their households. They are the ones who are bringing home the dollars to try to feed their families, to put a roof over their houses, and to try to meet their responsibilities to pay their bills. They cannot afford insurance. Insurance rates have gone up, over the last decade, almost 100 percent. Premiums have gone up almost 100 percent - a 15-percent increase per year, Mr. President.

Millions of people go wanting. There are countless specific stories of people whom we have talked about on this floor, who are working - in fact, nurses who are providing care to the sick and the infirm, especially the elderly, who cannot afford a policy on their own. They place themselves in harm's way, but they cannot afford coverage for themselves.

We are at this moment. We have never gotten this close before in the history of this nation. Legislation has moved forward. Legislation is poised. We have not been successful here in this Chamber, in the State, but we now face the opportunity--as many of us called for, let the Feds handle it--we now face the opportunity that the Federal government may be poised to act. Hopefully, in spite of the lies; hopefully, in spite of the tarnished reputations; hopefully, in spite of the smear campaigns, our Federal Representatives will have the appropriate faith and the appropriate guts to take a leadership stance and move this nation forward.

There are nations around the world who have what we do not have, as far as healthcare is concerned. What we have in this nation, Mr. President, are the best doctors, the best hospitals, and the best healthcare institutions of any country in the world. We have the best providers. We do not have the best system to allow people to access those providers. And that is the problem. There are nations all over this world that have better systems of support and access than we do. It is time for this nation to meet its challenge. It is time for this nation to rise to the point where we can say that everyone in this country is treated equally, equitably, and has access to the care that they deserve.

There are folks who are suffering as we speak, Mr. President, with hundreds of thousands, if not millions, of dollars in bills sitting on them for healthcare problems that were not of their own making. There are people who are waiting for access, and they cannot get access. There are people who are waiting for care, and they cannot get care. There are people trying to figure out how to pay for what they have, and they cannot figure out a way to pay for it.

We are poised at this position. We have never been this close. Never. Since Teddy Roosevelt, the Rough Rider, since before the completion of the Panama Canal, every President, from Roosevelt all throughout - Reagan, Truman, Clinton, both Bushes - has said we need to get this done. We are at the point of getting it done. Hopefully, we will rise to the call of the need of our nation.
