PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Ferlo.

Senator FERLO. Mr. President, good afternoon, everybody. Welcome back. I think, for all of us, it probably feels like we never left. I am really glad we had Constitution Month just pronounced by way of a formal resolution. I hope the first place we send that resolution is to Director James Powers, Jr., our so-called director of Pennsylvania Office of Homeland Security, because I think he seems to have forgotten his oath of office, and I assume he took an oath of office.

I am very upset, obviously, and I do not think I speak only for myself. I am sure other colleagues would join me in this matter, and certainly most of the constituents whom I represent. I would like to reach over to the aisle opposite and grab the little booklet out of Senator Folmer's pocket. He usually carries the U.S. Constitution and Bill of Rights. I do not have it before me, but hopefully this august body does not need to be reeducated or reminded about the importance of the Bill of Rights in our Constitution. And even in our own State Constitution, thanks to the heritage and struggles of the people of the Commonwealth, we have guaranteed civil rights and civil liberties. Those civil rights and civil liberties have been run over roughshod by this department, especially in the pronouncement of late, in the last few

weeks. I think everybody is painfully aware of the activities under a \$103,000 State contract initiated by the Rendell administration, \$103,000 hiring some bogus company that calls itself the Institute of Terrorism Research and Response.

First of all, this company and the people involved in it are the biggest scam I have ever seen. They basically download public information off of the Internet, everything about terrorism in Israel and Palestine, supposed threats, eco-terrorists -- it is all a bunch of baloney. They take this information, package it, and presumably send the State of Pennsylvania an invoice every month for a portion of that \$103,000.

Now, I cannot understand--it is nice for the Governor to get out in front of this issue and try to distance himself and his administration from the undemocratic, violative actions of Director Powers and this contract agency, but the fact of the matter is this individual should be fired or he should be forced to resign and there should be a full investigation of the activities of this subcontractor.

As you may know, for the last 5 years, I have been very involved in energy independence issues, trying to build sustainable principles, policies, and buildings within the city of Pittsburgh and throughout my three-county Senate district. And for the last 5 years, I have been able to host what is referred to as a social networking of individuals--I am talking about intellectuals from the academic community, folks from the research and development community, small business entrepreneurs who have developed products or processes or intellectual property on all things green and sustainable principles--and we get together once a month. Basically, it is held in a public forum. It is a public event. In the spring, I happened to have held one to allow the county executive in Allegheny County an opportunity to talk to about 250 folks about whatever he and his department and his administration were involved in on sustainability-related issues. Lo and behold, in the extensive documents that were released by the Rendell administration, my little Green Drinks party made the headlines. For some reason, it was important enough for this company, to which we are paying \$103,000, to issue a report on that activity.

And if you look at the--I cannot expect every colleague to go through these hundreds of reports that the Governor did release. Now, I know I am animated in my comments on a lot of issues, and my colleagues are certainly aware of that, and my constituents as well. Apparently, they chose to reelect me, because I do not even have an opponent. Even a Republican does not want to run against me, so I must be doing something right. But the fact of the matter is, you know, in one of the memos by this company, they are talking about the "...Environmentalists Called Upon to Prevent 'Greenwashing in Pittsburgh. Activist communications discussing...." I will not read on, but basically it is known as Green Drinks. Basically, the environmentalist activists talk about Dan Onorato speaking about sustainability principles, blah, blah, blah, go to Mitchell's Tavern, and it is a grand pronouncement. And what is really interesting is not the fact that they took public information--obviously, we had a lot of people out; it is a public event--but they listed it as a low-to-moderate security terrorist risk. This is a social networking event with a couple of hundred folks from the academic community, the scientific community, research and development firms, small business people, politicians, community activists, you name it. They come to Green Drinks once a month. I sponsor it. It is a great event. I

invite President Scarnati to come out to Pittsburgh to speak about sustainability issues. We would love to have you, but you may get listed as a low-to-moderate risk.

And what is low-to-moderate? Low-to-moderate is Level 3 and Level 4. "Moderate (Level 3): Available intelligence and recent events indicate that hostile elements have the capability to take action against the target and that such an attack is within the adversary's current intent. It is assessed that an attack is likely to be a priority and might well be mounted." Yes, some of the appetizers were not tasty; but Mitchell's is a great bar. They put out a great spread. Nowhere could I ascertain what the terrorist threat was. There was no food poisoning. It is a wonderful restaurant, and it is home to many events, cultural, political, or otherwise.

I am just using this in a joking way to illustrate that the plethora of reports that were released are typical of intrusive activities, or monitoring, or somehow characterizing what is our protected free speech and right of assembly in this country, in our great United States of America, and in our Commonwealth. And for this company to have been hired in excess of \$103,000 to engage in what are clearly violations of law--I am filing a complaint with the Justice Department and U.S. Civil Rights Division of the Justice Department. I am going to file a complaint under the State Ethics Act, with John Contino. I am going to file a report with the Inspector General. The Inspector General is supposed to be looking after contracts and monitoring contracts.

But this gentleman, Mr. Powers, needs to go. He is the point person. If there are other people, they need to go. I am not going to make excuses or be apologetic for that. It does not mean I do not respect the gentleman in terms of his past military track record. God bless him. But the fact of the matter is that he knows better.

What I find most reprehensible in all of this documentation that has been released by the administration is the fact that he basically--and I do not know if he is looking for his next job with the Marcellus Shale industry or not--but basically, he has taken the verbatim language of the industry representatives and put it on his letterhead, in his mouth, to talk about those who are opponents of Marcellus Shale. I am not an opponent of Marcellus Shale. It is a recognized industry for which I believe we should create an appropriate environment for appropriate development. I do not happen to agree with the rush to judgment on it. I still believe strongly in the need for a moratorium. I am going to support a severance tax. We have over 15,000 wells drilled, or in the processes of being drilled. And I say respectfully, I see no contradiction in supporting a severance tax.

The fact of the matter is we are rushing to judgment. We are creating a gold rush without thinking and fully ascertaining the scientific, environmental, and ecological impacts. Earlier today, in West Virginia, we had an explosion in the Marcellus Shale. Methane gas was hit coming out of the coal reserve. We have an equal number of coal reserves in Pennsylvania, in addition to our sister State down below in West Virginia. I just feel a rushing to judgment.

We should be more moderate in how much development of Marcellus Shale we allow. There is a lot out there already. We need to tax it. But I think we need to take a step back from the precipice of what could be an environmental disaster. Am I being an alarmist? No. We have already had a lot of documented incidents. There have been over 800 citations issued by the DEP and the Pennsylvania State Police. My point being, is this gentleman

working for homeland security? Is he working for the Marcellus Shale industry? I would like to know that.

Notwithstanding my aggravation and what everybody in this room should be offended by, including the Pennsylvania constituents we all represent, is the violative actions done to our civil liberties, our right to free speech, and our right to assemble. There just seems to be a developing pattern in this country. I was victimized, along with many other Pittsburghers, and this is where I criticize our own local government, both the mayor and the county executive, for basically turning over our city and our region to homeland security forces during last year's G-20, a total violation of the rights of assembly and free speech. And I recognize the importance of protecting international leaders as well as our own President. But the fact of the matter is they went overboard in denying people's right to assemble.

In fact, today, the Inspector General for the Federal government came out and criticized the FBI in a formal memo, saying the FBI basically lied about monitoring peaceful anti-war protesters during the G-20 of a year ago. The only thing I was doing was asking for the use of Point State Park, something we spent millions of dollars fixing up, something that has always been used in assembling protests. And was I even criticizing the G-20? No. I was having a blue-green jobs rally about the environment, with the steelworkers, the mine workers, and others about the changing paradigm of the jobs that are available, now and in the future, building toward energy independence -- hardly a radical confluence of anarchists.

So obviously, I am upset. Powers needs to resign. The Governor needs to fire him, and there should be formal investigations by State agencies and the Federal government. I do not let Attorney General Corbett off the hook. I do not let the Dauphin County District Attorney off the hook. They seem to be visible on other matters. This is a violation of everybody's civil rights and civil liberties. I resent it, and it should be investigated.

This issue is not going away, as far as I am concerned, because it is just part of a broader pattern in American society. And I do not care if you are pro- or anti-Marcellus Shale. I do not care if you are a Tea Party member or a Marxist, socialist, or someone on the left. People have the rights to free speech and assembly and to engage in democratic advocacy and education. That is what our country is all about.

So I just want to make it clear how upset I am. I am not letting this go by the wayside. I will reiterate my request that this gentleman Powers be fired or resign. Apparently, he is MIA. I do not know if he went to Israel or ducked out of Dodge with his partner. But they are pulling the biggest scam. You have some former drug agent from some Israeli police force, coupled with some yo-yo retired cop from York, PA, and together they pulled this scam of marketing what is basically public information on the Internet. And for some reason, it rises to the level of a formal contract with State government at \$103,000 a year? No wonder why people are sick and tired of State government and this august body as well.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentlewoman from Luzerne, Senator Baker.

Senator BAKER. Mr. President, I appreciate the comments of my colleague from Allegheny County, and I, too, want to assure the public that we intend to fully investigate. The Senate Committee on Veterans Affairs and Emergency Preparedness has called a hearing for next Monday, September 27, to do just what my colleague has suggested, to look at a contract of sole source, a no-bid contract, that was offered to a company whose credentials we are not clear about. People were targeted for no other reason than exercising their fundamental rights to free speech and assembly. We are all greatly concerned about that. The constituent who blew the whistle on this contract lives in my senatorial district. I have had multiple people knocking on my door, sending me e-mails, and questioning whether or not they are on some list somewhere that is going to impact their lives down the road.

We need to investigate fully. The committee has sent letters requesting the presence of multiple members of the administration, of State agencies, of the contractor, and we want to get to the bottom of it. So, next Monday, I would invite any of my colleagues who do not sit on the Senate Committee on Veterans Affairs and Emergency Preparedness to feel free to join us, to ask the questions, to listen to the testimony, and then make the recommendations that we feel are necessary moving forward. We are very concerned about citizens being targeted, and this is something that we intend to get to the bottom of.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Montgomery, Senator Greenleaf.

Senator GREENLEAF. Mr. President, I rise to address the issue of the Marcellus Shale. We all are concerned, obviously, about what is happening and our State's involvement in it, both for and against. I will give you an example of two constituents with whom I have had conversations.

One was a neighbor who actually lived in my district in the southeast, but he had property upstate. He called me and complained that there was a drilling a little over 1,200 feet away from his home there, and the drilling had caused contamination of his drinking water to such an extent that he had lost all use of his property. In addition, I spoke to another individual recently who owns property in the Coudersport area and has invested a substantial amount of money for his family into the property and into the home, but he does not own the mineral rights. So as a result, he is at the whims of people who do own the mineral rights, and he has no control right now of whether they come on the property or not, whether they start drilling or not, and whether they pollute his well and his drinking water, which would then render his property useless.

We have, as we all know, a significant amount of drilling and leases that are being signed for drilling. We have leased two-thirds of our public land for drilling and, obviously, I think it is important for us not to lease the other third until we find out how it is being done, how properly it is being done, what has caused pollution in well drinking water, and how we can prevent it from happening in the future. We all want to encourage the use of our natural resources in the Commonwealth of Pennsylvania, but not at the cost of having another environmental disaster like we had with the strip mines. I have had the opportunity to look at many strip mines in the northeast over the term I have been a State Senator, and they are still there. You could put this Capitol building in many of them, a couple of capitol buildings, in many of these strip mines, and they have been there for a century. We do not want to face the same situation with the drilling. I know

that Senator Baker will be looking into this, and I applaud her for doing that. We have to make sure that we do not create another disaster.

There has been tremendous damage to our infrastructure and our roads and the access and egress from these properties by trucking. There are different ways that we can alleviate that problem. There have been reports on the impact on farmland and forest land. There is the responsibility of who is going to reclaim these sites, the impact on the municipalities, and the impact on our water. There have been a number of reports and newspaper reports about the number of--I think it is about 1,400 citations that were issued in the last couple of years in regard to this activity. Apparently, there are about 15,000 gallons of chemicals added to fresh water for the fracking process. What happens to the material that is returned from the drilling process? What is happening to that? It is usually put into a pond. How is that handled? Is it being properly handled? Is it being dumped back into our water system, into our streams and our lakes? We have to make sure that does not happen.

A recent newspaper article said that the Pennsylvania Land Trust Association said there were about 1,435 violations and, according to the Pittsburgh Post-Gazette, those consisted of violations of the Clean Streams Law, improper construction of wastewater impoundments, 277 poor erosion sedimentation plans, and 154 violations for discarding industrial waste--including drilling wastewater containing toxic chemicals--onto the ground or into the streams.

What I am going to be doing today is introducing a piece of legislation that would make sure that for every contract that is signed for drilling purposes, the landowner is protected. First of all, they should know what potential environmental liabilities there are. We have done some research on this, and even though the drillers themselves are the primary responsible persons, the landowner is subject to a common lawsuit for damages to their neighbors. And so, for example, in my constituent's situation, the law now states that if you are within 1,000 feet, I believe, of the drilling and your well is polluted, it is presumed that the driller did it. If you are beyond 1,000 feet, there is no presumption, but there is the ability for the landowner to be sued for that pollution if the person who has been subject to the pollution can prove that. And also, I think it is important for us to provide in these contracts that these landowners are indemnified, that not only are they held harmless, but also that the drilling company will indemnify our landowners in these areas who are signing these leases to make sure that the drillers, not the landowners, take care of this and pay for those damages, if there are any.

So I thank you, Mr. President, for allowing me this time. I know that our committee will be discussing this issue tomorrow in greater length, and I urge an affirmative response and an affirmative resolution to this matter. In closing, I also feel that those people who are doing the drilling should be paying for our inspections--and the responsibility falls on DEP's shoulders to do those inspections, to make sure it is done in a proper way--that they are the ones who are paying for this cost, and not the Commonwealth of Pennsylvania.
