# GUEST OF SENATOR VINCENT J. HUGHES PRESENTED TO THE SENATE

Senator HUGHES. Mr. President, obviously, there is a little bit of buzz in the room right now, and it is not necessarily because we are inching forward in getting a State budget done. Inching forward would be the appropriate term. The buzz comes from the fact that we have a special guest amongst our midst, and without going through the blurb that was presented, I am just going to, if you will, Mr. President, read excerpts from this resolution that I have here with me.

Whereas, Bernard Hopkins is being honored upon capturing the World Boxing Council Light Heavyweight Championship.

Whereas, a Philadelphia native-that is right, I said it, a Philadelphia native; I will say it one more time, a Philadelphia native; I think he is from Philadelphia, if you might want to ask--Mr. Hopkins is the current WBC, WBC Diamond, International Boxing Organization and "The Ring" light heavyweight champion and a former undisputed middleweight champion.

On May 21, 2011, he became the oldest fighter to capture a significant belt when, at 46 years of age, he toppled Jean Pascal, who was 18 years younger than him, by unanimous decision and won the WBC Light Heavyweight Championship. Having defended a world middleweight title for a record 20 times, Mr. Hopkins is lauded as one of the greatest middleweights of all time. To his great credit, he has accumulated 60 career wins with 34 knockouts. Mr. Hopkins is truly deserving of recognition and praise for utilizing his exceptional ability with diligence and for

his tenacious pursuit of excellence. I want to underscore that, Mr. President: his tenacious pursuit of excellence.

Mr. President, it gives me great honor, and I think for all of Pennsylvania--we obviously claim him as a Philadelphian, but he clearly is a native son of the State of Pennsylvania. He represents, in so many ways, what we can all achieve with determination and persistence, when given a chance.

Mr. President, I recognize as our guest, Bernard Hopkins. (Applause.)

The PRESIDING OFFICER. The Chair recognizes the champ.

Mr. HOPKINS. I like that.

First, I would like to thank everyone. I am honored to be here. I know you have a busy day. I know it is a busy time of the year, especially around this time.

I would like to acknowledge a person from my darkest times, which became one of my times of discipline and also where I wanted to go in the future of my life, and that is Mr. Rudy Battle. He is the commissioner of the State Athletic Commission for boxing and wrestling.

(Applause.)

I do not want to put him on the spot, but I have to say something that was positive to me. He had the time to visit me when others did not, because they either threw the key away or gave up on me. And I was that type of person coming up where, in most cases, I would not blame you. But in spite of that, Mr. Battle, who lived in the neighborhood called Germantown, saw me run around in the streets. He saw that I had ability, but I used it in the wrong way. He used to drive down the street to go to his block, which was the second block of Sharpnack Street, which is the second unit block, and he used to say, why do you not go to the gym and get off the corner? I never knew what this person, who we called old guy, was doing or what he did for a living. Then I realized that he was into boxing, and he used to be into fencing. But I did not listen.

I did not listen to a lot of people. I did not listen to my mother. I did not listen to my father. I did not listen to anybody in the neighborhood who was telling me that I was headed in the wrong direction. But to speed it up, I wound up in the State penitentiary at Graterford at 17, certified as an adult, and then for the last 2 years of that 5 years, I wound up in Dallas State penitentiary, which is further up, near Wilkes-Barre. I reached out to the guy to come see me because, of course, that was a lonely, dark place that I put myself in because of my decisions, not because of other people's decisions. He came up there, and we sat in the visitors' room--and let me remind all of you, I have been out 23 years, walked off 9 years of parole without a parking ticket, and became Bernard Hopkins, the future Hall of Fame Bernard Hopkins, who broke records, set records.

(Applause.)

I say that, to say this: It is not really all about me. It is all about having faith in people. I am not a guy who knows everything about politics, but I pay attention. Whether you are a Democrat or a Republican, whatever decisions we all make together as one, they affect lives. They affect lives in a big way, in a way that we have no understanding, sometimes, by not actually seeing it physically.

I am a guy who could have been the status quo or could have been a statistic. I started off that way, but I saw something, and it turned me around. I must say that it took more than just being in a box, in a 5-foot-by-8-foot cell. It took more than seeing people in situations where I would never want anybody to be. It took something in me to be able to rehabilitate myself. I needed to know that I wanted to be different.

Once I got that discipline, and once I was released, in 1988, I transformed that mentality. To be incarcerated--where there is normally an easy way to say you never want to be back, you are going to be on a straight path, but once you reach society, and once you reach the distractions of good and bad that come, as we live in this world, that is when the real test comes, and I knocked that out.

No matter how much I have achieved, how much I have in my bank account, and how much people acknowledge me, I am humble enough to say that everybody cannot be a Michael Jordan, everybody cannot be a Bernard Hopkins. I go to the suburbs, I talk in Delaware, I talk in Pennsylvania, north Philly, south Philly, and I tell people that everybody cannot be Jay-Z. Everybody cannot find a quick way out, but if you have an ability, use it to the best of your ability.

I had enough time to come back and grab my career and make something out of it, but I had to go through some challenges with my decisions. It took that man to have faith in me and come up and say, if you want to be a boxer, I am there for you. I will direct you to the people to talk to. And he did. I am glad that he is healthy and he is alive to see this day. He spent his time, his gas, and showed concern. He knew I had the ability. A lot of people have that ability, but they never get a chance to explore it because of the decisions they make in their lives.

I am humbled to be here. I know I am being long, but I am humbled to be in this position because I worked to be here. I know I have worked, and I have sacrificed, and I stayed away from the distractions, trust me, that athletes have in front of us. I know I am a role model because that keeps me on point, that keeps me on the straight path because I am in a position now that people are watching me--and I want them to watch me because it makes me stop at the stop sign, and it makes me go when the light says go. Why? Because I am being watched. I like that.

Now, since I have the light on me in a different way, in a way that I do not have to look over my shoulder, how can I be an example for the obese kids who eat bad foods? How can I be an example when people say you are 46 years old and you are in great shape and still fighting like you are 25? But do you know how I got there? Let me tell you. It is easy to say, well, I am just that good. I am this, I am that. But do you know how I got there? There were some investments that I made in myself. Like going to the bank, if you put money up—that is one thing about a young kid, they learn to put money up early, to invest and leave the principal, and to get the interest and live off the interest, like the principal does not even exist.

So I have to let them know that I did not just get here because I am that good. There was a process of investment. I stayed away from drugs. I did not smoke. I did not hang out. I did not treat my body badly. I relaxed. I took care of myself and dealt with the life struggles that we are going to have, whether we like it or not.

Just look at this as a candle, before I close. The life candle that burns in all of us, of which we have no control, that is going to burn whether we like it or not. That is the candle lit on its wick. Now, your lifestyle lights that candle. If your lifestyle of living is bad on this end, look at this candle as it burns because we live on this earth, because we have been born. When a candle

is lit on both sides, which end is going to burn quicker?

So that is why I was blessed, other than being blessed at being good at boxing. That is why I am getting what they call the investment. I am getting the interest that I invested in myself by doing these things I just mentioned.

That is why you see a 46-year-old guy still boxing. I do not have to box for money, I am proud to say, not bragging. I do not have to box because I owe taxes, I am proud to say. I am not boxing because of a negative. Do you know why I am boxing? Not only because I can, but because I went back and got some of that investment, and in doing that, I broke George Foreman's record. At that time, he was the oldest champion. He beat Michael Moorer for the Heavyweight Championship of the World 15 years ago.

So, I thank you for being patient. I know you have to take care of a lot of things tougher than boxing, but I say that no matter if you are Republican or Democrat, the decisions that we make together today have a lot to do with how people live tomorrow. Thank you.

(Applause.)

The PRESIDING OFFICER. The Chair thanks the champ for his comments, and the gentleman from Philadelphia for his introduction.

The PRESIDENT. The Chair recognizes the gentleman from Lehigh, Senator Browne.

Senator BROWNE. Mr. President, today I rise to ask my colleagues to support Senate Bill No. 200, the Safety in Youth Sports Act. This legislation will set requirements and procedures for coaches, athletes, and schools regarding the risk of concussions to our student athletes.

Certainly, and justifiably, Mr. President, there is heightened public awareness of the dramatic occurrence and consequences of head trauma resulting from sports competition. The media has done a great job in increasing public awareness of the frequency and severity of concussions among athletes at all levels, from professionals to interscholastic teams.

Mr. President, as you are aware, it was not all that long ago that these injuries were downplayed. It was common, after a violent collision, just to say that a player got his bell rung. Often, these players were told to just shake it off and get back on the field. We now know that severe and repeated concussions and head trauma dramatically impact the brain, and too many players are paying a heavy price for those injuries. We are aware of that now more than ever. In some cases, athletes' careers, and even their lives, have been cut short by the intensity and cumulative impact of those injuries.

By their very nature, most times many scholastic athletes must be dragged off the playing field, regardless of their injuries. That is where it is up to us, as responsible adults, to step to the forefront, show some common sense, and act accordingly. For the most part, as we are all well aware, those coaches and mentors do that.

Senate Bill No. 200 sets specific guidelines for treating students showing signs of brain trauma. First and foremost, those students must immediately be taken out of the game and be thoroughly evaluated by an appropriate medical professional who is trained in the evaluation and management of concussions before they return to play.

The second component of the bill requires the State to take a proactive role in addressing concussion injuries. The Department of Health and the Department of Education will post information regarding head injuries and concussions on their Web sites.

Young people and their parents will be required to review information regarding the risks of these injuries before the student may participate in scholastic sports activities again.

In addition, my bill would require coaches to be trained yearly in a program regarding the risk of brain injury in scholastic sports. They must be fully aware of the warning signs of these injuries and know what to do when they take place.

Mr. President, studies show that when high school athletes suffer concussions, as many as 40 percent return to action prematurely and set themselves up for a serious injury in the future. Perhaps most troubling, as far as current occurrences in scholastic sports, 16 percent of football players reported returning to play the same day they lost consciousness.

Given these alarming statistics, it is appropriate that our educational institutions have in place better protections for our students who are at risk of sustaining permanent brain injury, or even death, due to head trauma they experience while playing scholastic sports. I thank my colleagues in advance for their support of Senate Bill No. 200, a very important measure for the future protection of our scholastic athletes.

Thank you very much, Mr. President.

The PRESIDENT. The Chair recognizes the gentlewoman from Venango, Senator Mary Jo White.

Senator M.J. WHITE. Mr. President, I rise to voice my strong support for this bill, and to thank Senator Browne for his leadership on the issue. Unfortunately, the bill only addresses the PIAA, and as many people know, there are many, many children, apart from those participating in PIAA events, who are at risk for this type of concussion in athletic contests.

There is a wonderful program--WPSU television put it on, you can get it on the Internet under "Conversations from Penn State"--with the NFL's chief person responsible for advising them on concussions, talking about the impact on children, particularly children whose brains are not yet developed, and that includes just about anyone under age 21, according to this expert. I think parents need to be more aware. They need to recognize the signs of a concussion. They need to know when to take their children out of a competitive situation when this occurs and have them evaluated.

So, I thank Senator Browne for this. I urge everyone to watch that program, every parent who has children who participate in sports. One of the high incidences of these types of injuries, ironically, occurs in cheerleading, and girls, in fact, have a higher incidence of concussions than boys, which I found absolutely startling. So, I urge everyone to get more information on the subject, and I urge everyone in this body to support Senator Browne's bill. Thank you.

The PRESIDENT. The Chair recognizes the gentlewoman from Cumberland, Senator Vance.

Senator VANCE. Mr. President, I rise to urge strong support for Senator Browne's bill. With the increasing number of very young children participating in sports, it is vital to establish a baseline so we know if a child has suffered injuries, that we have very clear evidence of that. I think, sometimes, we think of football, but we should think of soccer and a lot of other sports that

we do not perceive to be that difficult and injurious, but they are. So I thank Senator Browne for this bill and urge a "yes" vote. Thank you.

The PRESIDENT. The Chair recognizes the gentleman from

Lackawanna, Senator Blake.

Senator BLAKE. Mr. President, as someone who played midget football, 4 years of high school football, and 2 years of Division I football at Villanova, I had a few experiences with concussions, and I did not have the protections that will be offered to our student athletes with regard to this legislation. I want to commend Senator Browne, everyone who worked with him, and all the stakeholders and experts who made this possible. I certainly offer full support, and that of our Caucus, for this legislation. Thank you.

Boltz certain lands situate in Union Township, Lebanon County, in exchange for Kyle A. and Tamara J. Boltz's granting and conveying certain lands to the Commonwealth of Pennsylvania, Department of Conservation and Natural Resources, to be added to those existing lands at Swatara State Park; authorizing the Department of General Services, with the approval of the Governor, to grant and convey to the Susquehanna Township Authority a permanent sanitary sewer easement over certain lands of the Commonwealth of Pennsylvania, situate in Susquehanna Township, Dauphin County; authorizing the Department of General Services, with the approval of the Governor, to grant and convey to the County of Lackawanna Transit System Authority (COLTS), certain lands situate in the City of Scranton, Lackawanna County, in exchange for a certain tract of land from COLTS situate in the City of Scranton, Lackawanna County; and making a related repeal.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Blair, Senator Eichelberger.

Senator EICHELBERGER. Mr. President, in 1866, a group of county officials met to discuss common problems and exchange ideas on how to address those problems. This August will mark the 125th anniversary of county officials getting together in a group now known as the County Commissioners Association of Pennsylvania, or CCAP.

Unlike most other States, Pennsylvania's counties geographically overlap the municipalities we call boroughs, townships, cities, and, of course, one incorporated town. Counties provide a different set of services, and those services are more numerous and extensive than those of most other types of municipalities.

The Federal and State governments have required counties to provide protective services for children and youth, mental health and mental retardation programs, drug and alcohol prevention and treatment programs, and services for the aging. Counties provide our primary court system and maintain district attorney and public defender offices as well as county prisons, juvenile detention centers, and probation offices. Counties provide 911 emergency dispatch service, making sure that police, ambulance, or fire companies get where they are needed.

Counties are deeply involved in economic development and planning to improve our communities. They are responsible for comprehensive land use planning and planning for the proper disposal of solid waste. Counties also uphold the foundation of our democracy by administering all elections and keeping a registry of voters. Counties are tasked with the responsibility for maintaining real property assessments upon which all other local taxing districts rely. Finally, like the Commonwealth and other municipalities, counties have highway and bridge maintenance responsibilities.

Handling all of these responsibilities as a county commissioner is a daunting task, and CCAP plays a vital role in helping

commissioners, county executives, and county council members. CCAP, a statewide nonprofit, nonpartisan organization, provides education, information, insurance, technology, and other services that support effective county government. Although often acknowledged for its government advocacy role in Harrisburg, the association mainly works to provide county officials with information as to best management practices.

CCAP provides human resource assistance, such as helping counties establish cafeteria benefit plans for their employees through its Best Flex program. CCAP operates a County Managed Care Resource program to assist counties in administration of the behavioral health managed care systems. It likewise provides deferred compensation programs and multiple insurance programs such as workers' compensation.

As a former county commissioner, I am pleased to sponsor this resolution to acknowledge the important work of counties and the County Commissioners Association of Pennsylvania. I am happy to say that I am joined today by the chairman of the Local Government Commission, Senator Robbins, who frequently works closely with CCAP; the Minority chair of the Committee on Local Government, Senator Blake, who will be offering some remarks shortly; and perhaps most interestingly, I am also joined by a number of my colleagues who served as former county officials: Former Delaware County executive director and former president of county council, now-State Senator Ted Erickson, is with us; former Westmoreland County commissioner, and now-State Senator Kim Ward; former Chester County commissioner, and now-State Senator Andy Dinniman; former Berks County commissioner, and now-State Senator Judy Schwank; and last, but certainly not least, former Bucks County commissioner, and now-Lieutenant Governor Jim Cawley.

Thank you, Mr. President. I would be happy to leave this resolution open at the desk for Members to cosponsor, if they have not already. I ask for an affirmative vote on this resolution, and I now ask the Chair to recognize Senator Blake.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Lackawanna, Senator Blake.

Senator BLAKE. Mr. President, I rise proudly to join my colleague and friend, Senator Eichelberger, the chairman of the Committee on Local Government, in acknowledging the County Commissioners Association of Pennsylvania and its extraordinary legacy of 125 years of service.

Mr. President, I reside in Lackawanna County, which is the 67th and newest county established in Pennsylvania. As a result of my former experience in county government, I have had a long history of working with the County Commissioners Association. I just want to echo the comments of my colleague about the extraordinary work that the association does. Keep in mind, Mr. President, that county commissioners across this State often represent both executive and legislative powers of their respective counties, in the 67 counties. That power is very important, it is very powerful, and, in fact, it is the County Commissioners Association that interprets the concerns of its county commissioners to the Local Government Commission and to the Senate.

So I want to extend my deep thanks to Senator Eichelberger for his leadership and for this acknowledgment. And obviously, I want to extend deep gratitude for the service of our current Senators who are former officials in county government.
