Senator VANCE. Mr. President, today I have the really distinct pleasure of introducing Big Spring High School senior Vinny Todaro, who captured the 2012 PIAA Class AA Cross Country Title on November 3 with a time of 16 minutes. Senator VANCE. Mr. President, nurse anesthetists were the first professional group to provide anesthesia in the entire United States, and they are the oldest recognized group of advanced practice nurse specialists. Nurse anesthetists have to have a graduate-level program, nationally accredited, and then they must pass a national certifying exam. More than two-thirds of all rural hospitals rely on certified nurse anesthetists to provide their anesthesia care. Without these advanced nurse anesthetists, more than 1,500 facilities would be unable to maintain trauma stabilization and surgical and obstetrical capabilities. I ask the Senate to join me in supporting this resolution.

Senator BOSCOLA. Mr. President, this resolution designates January 2013 as "National Blood Donor Month." Victims of trauma, surgery patients, and organ transplant patients all need blood to stay alive. Despite advancements in research and technology, there is no medical substitute for replacement of human blood. Throughout the country, a patient is in need of blood every 3 seconds, and one unit of donated blood can save up to three lives. Volunteer blood donors provide nearly all of our country's supply. According to the Keystone Miller Blood Center in my district, 40 percent of the U.S. population is eligible to donate blood, but only 5 percent actually donates. So 40 percent eligible, and only 5 percent actually donates.

During the winter months, blood centers across Pennsylvania have difficulty finding adequate supply of blood donations. Mr. President, I do believe that education is key to providing a long-term solution to low donor rates that affect blood banks and centers statewide. We need to insure their supplies do not dwindle, especially during these trying winter months. Just a half-hour, one-half of an hour spent donating a pint of blood could save the lives of three people. We need to let more people know that fact, and we need to educate the children of our Commonwealth about donating, because for many, this is literally a matter of life or death. This is not just simply about donating a pint of blood, it is about giving back to our community and bringing people together to help one another.
