An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, in preliminary provisions, further providing for definitions; in organization, further providing for Chief Justice and president judges; in community and municipal courts, further providing for the Philadelphia Municipal Court and for jurisdiction and venue and providing for hearing officers; and, in traffic courts, further providing for jurisdiction and venue and for the Traffic Court of Philadelphia.

ther providing for supervisory relationship to offenders.

SB 601 (Pr. No. 1188) (Amended) (Rereported)

An Act amending Titles 44 (Law and Justice) and 45 (Legal Notices) of the Pennsylvania Consolidated Statutes, modernizing publication of Commonwealth legal materials; providing for uniformity in electronic legal materials in the areas of designation, authentication, preservation and access; conferring powers and duties on various Commonwealth agencies; and, in publication and effectiveness of Commonwealth documents, further providing for definitions, for the Joint Committee on Documents, for general administration, for payment for documents, for distribution of publication expenses, for effect of future legislation, for publication of official codification, for deposit of documents required, for processing of deposited documents, for preliminary publication in Pennsylvania Bulletin, for permanent supplements to Pennsylvania Code, for pricing and distribution of published documents, for automatic subscriptions, for required contractual arrangements, for official text of published documents, for effective date of documents and for presumptions created.

SB 700 (Pr. No. 1135) (Rereported)

An Act amending the act of April 6, 1956 (1955 P.L.1414, No.465), known as the Second Class County Port Authority Act, further providing for membership of the authority; and providing for Department of Transportation Regionalization and Privatization Study.

SB 928 (Pr. No. 1189) (Amended) (Rereported)

An Act amending the act of December 5, 1936 (2nd Sp.Sess., 1937 P.L.2897, No.1), known as the Unemployment Compensation Law, further providing for contributions by employees; establishing the Service and Infrastructure Improvement Fund; and further providing for the Unemployment Compensation Fund.

HB 84 (Pr. No. 62) (Rereported)

An Act amending the act of June 30, 1981 (P.L.128, No.43), known as the Agricultural Area Security Law, further providing for the purchase of agricultural conservation easements; and abrogating regulations.

Senator BAKER. Mr. President, as we debate this year's budget, we should take a moment to salute the very Americans who have defended our right to speak freely, to assemble, and to live in a land of law and liberty. This week, "State Veterans' Homes Week" is a golden opportunity to honor and thank the residents

and staff of Pennsylvania's six veterans homes. Even better than a resolution, I encourage all of you to visit one of the homes and remind America's heroes that they are not forgotten. Take time to listen to their tales of heroism and struggle, to hear why they served, where they served, and what they did for democracy.

Then beyond a visit, we must show our defenders that we remember them by supporting their needs in the budget process and beyond. As a board member of the Gino J. Merli Veterans Center in Scranton, I have the privilege of talking to these still-proud soldiers who defended our freedoms in their younger and stronger days. They never fail to impress or inspire with their stories and their infinite patriotism. The entire staff, from the doctors, nurses, to the aides and therapists, display the same patriotism and respect as they tend to the needs of these great American heroes. The State veterans homes are one of the most visible ways in which we honor our obligation to our nation's defenders. We have improved the physical plant of the homes and the quality of care, which has led to an extremely high patient satisfaction level, but that does not mean the homes are not without challenges. With the State budget process in its final stages, we must keep the veterans in these homes in the forefront of our minds and our priorities. They were often the first to defend our flag and should be the last to suffer in a budget shortfall.

Throughout the year, many volunteer groups visit the homes to socialize, sing, to donate blankets, and to make the veterans homes their true home. Veterans homes are caring for the aging veterans in Scranton, Erie, Hollidaysburg, Philadelphia, Pittsburgh, and Spring City. The staff in each home works to maximize the independence of the very sick, aging, and injured veterans, and their spouses. So we salute the 1,600 veterans and their caregivers during State Veterans' Homes Week, and I encourage everyone to visit a veterans home and say thank you to our heroes. Remember them in the State budget, a reminder that we have not forgotten that we are forever in their debt.

Senator RAFFERTY. Mr. President, I am proud to stand here today in support of the gentlewoman from Luzerne County's resolution honoring our veterans homes. I am a proud member of the Southeast Veterans Center Advisory Council. I am the Senate representative, and I have been since my second year in the Senate. It is a very moving experience for me to be there to work with the administration in the home to make sure that our heroes are taken care of on a daily basis. It is our opportunity to give back to them for all that they gave to us in this great country. So, I am proud to stand with Senator Baker. I commend her for this resolution, and I side with her on, as we progress with the budget negotiations, we must be mindful of those residents of the veterans centers and of the men and women who made it possible for us to gather here today.

Senator GORDNER. Mr. President, I, again, join with my cochair, Senator Tartaglione, as we offer this 100th anniversary resolution. Earlier this month at the Department of Labor and Industry, Secretary Hearthway and many folks from the department gathered in order to recognize this historic event. The Department of Labor and Industry provides a lot of different resources and services to men and women across this great Commonwealth, whether it is workforce safety, unemployment compensation, or workers' compensation. Earlier, we dealt with a piece of legislation by Senator Corman dealing with boilers. The list goes on and on about how the men and women who serve in that department affect our lives on an everyday basis.

Again, oftentimes it is not until we have these type of anniversaries that we really say thank you and realize the importance of what they do. But as chair of the Committee on Labor and Industry since 2006, I have really grown to respect the men and women who are with the department, and the leadership that has been there. I thank Secretary Hearthway, who has provided a great amount of leadership and energy to that department. We wish the folks there congratulations on their 100th anniversary, and look forward to doing many other activities over the coming months and years in order to better serve the folks of this great Commonwealth.

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Mr. President, I am proud to be here to support this resolution with my co-chair, Senator John Gordner, marking the 100th anniversary of the Department of Labor and Industry. The department was created in 1913 with the intention of keeping useful statistics and enforcing new labor laws, improving safety, and fostering efficiency. No one can argue that it has not worked. In its first year, the department issued new regulations for movie theaters, requiring that the exit doors be unlocked and exit signs be visible. That year, the department also studied the effect of head lice in factory efficiency. Not surprisingly, it was found that head lice reduced efficiency, and employers who were previously unconcerned with head lice got interested quickly. The department also recommended that cigar rollers not put cigars in their mouths while rolling them, as it was considered unsanitary for the roller and the smoker.

The department conducted inspections of more than 15,000 businesses that first year; 4,000 were bakeries and 5,000 were

garment businesses. So yes, times have changed. In the first 100

years, the department's rules, advice, and support have cut worker's injuries by two-thirds and cut their rate of on-the-job deaths by one-thirtieth of what it was back then. Over that time, the department has adapted to a quickly changing economy and it has taken on functions of job training, career counseling, job placement, and economic development. Technology is changing in the workforce more quickly than ever before. The Department of Labor and Industry is adapting to those changes by preparing workers for new careers, and finding ways for everyone, whatever challenges they face, to participate in a new community. I am hoping that the next 100 years will see the same progress for Pennsylvania workers that we have seen in the last 100 years.
