Senator WASHINGTON. Mr. President, I stand here today to make the announcement that we have spent more than a year working to write legislation that would help strengthen the laws that protect children in this State. The event that sparked these bills was truly horrific, but I am also proud of the work that we have done to make sure that it never happens again. As a survivor of child abuse, I do not care whether my name is on any of these bills. I just want to get this done so that no child will have to go through what I went through in my younger years. Senate Bill No. 1116 is an important component of this package. It will streamline and improve the investigation of suspected child abuse. Specifically, this legislation will overhaul the duties and roles of multiple disciplinary, legislative, investigative teams that entitles responsibility with investigating reports of child abuse. These collaborative teams will work together to provide the most efficient, advanced methods of investigating possible instances of child abuse. In my capacity as Democratic chair of the Senate Committee on Aging and Youth, my first priority throughout this process has been protecting children. Passing this legislation will insure that every case of suspected child abuse is properly investigated, bringing abusers to justice and helping victims and families heal.

I want to thank all of my colleagues, especially Senator Mensch and Senator Ward, as well as all of the staff involved in drafting this package of bills. I am truly humbled by the support of this particular piece of legislation. While I am happy to see the legislation come to final passage, our work is far from done. Senate Bill No. 1116 is just one part of the package, and I look forward to sending this and the rest of the bills to the Governor's desk very soon.

Senator SCHWANK. Mr. President, I wanted to stand briefly to congratulate Senator Washington on this important legislation. I think you realize, as I do, as former county commissioners, that when we are presented with horrific cases of child abuse, a specific investigation is often engendered within the county to help address the issue. Now with this legislation, I believe we will have a more uniform process across the Commonwealth. This will not be just a special event, this will be something that happens on a regular basis and will insure the safety of children unknown who are currently being subjected to child abuse. I am greatly pleased to see this happen.

Many years ago, there was a case, a young boy, Maxwell Fisher, that really rocked our county, the death of this young boy at the hands of his parents. The special investigation that occurred as a result of that really helped to change the way we dealt with child abuse in my home county, Berks County. So, I am very pleased to see legislation of this type passed. I just note to my colleagues, is it not interesting that after all of these years, and certainly we are so well aware of the problems of child abuse, that it has taken us a long time and a lot of effort to comprehensively cover this subject. But I am sure glad, and I know they are, that we have.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentlewoman from Luzerne, Senator Baker.

Senator BAKER. Mr. President, we cannot overlook the importance of what we are doing today to help our fire companies, nor can we overlook the virtue of what our volunteer firefighters do for us each day. This bill was one of the chief priorities advanced by State Fire Commissioner Ed Mann and firefighters at a joint hearing of the Senate Committee on Veterans Affairs and Emergency Preparedness, along with the Majority Policy Committee, which we held in Gettysburg in October. Senators Alloway, Erickson, Waugh, and Yaw joined me at the hearing as we heard from speaker after speaker about

how difficult it is to fight fires in the new millennium. Although firefighters sounded the alarm about a host of issues at our hearing, the root of all the hurdles, not surprisingly, was money.

Cash-strapped budgets have a domino effect on emergency response. It becomes a vicious cycle. A lack of money causes a seemingly endless need for fundraisers, which leads to the loss of volunteers, which further strains those left to pick up the slack. In the world of public safety, a shortage of money, volunteers, training, and equipment can have deadly consequences. You may recall that last Session, Senator Ward led the charge to expand grants to volunteer fire companies. House Bill No. 1706 builds upon her efforts by increasing the amount of loans that the fire companies can borrow for essential apparatus and equipment. While the costs have skyrocketed, loan limits have remained frozen at inadequate levels. In 1984, a self-contained breathing apparatus was \$900, and today the cost is \$5,000. A pumper truck cost about \$100,000, and today, it is \$525,000, again, more than five times. Under House Bill No. 1706, loan limits will double. The increase, although it does not keep up with inflation, provides a marked improvement. Many fire companies are waiting to purchase equipment, and their purchasing decisions rest on passage of this bill today.

So, we need to keep fighting for our firefighters. Many people do not realize that 97 percent of our firefighters are volunteers in the Commonwealth, more than almost any other State. Where 40 years ago, we had volunteers of about 300,000, today, we are down to a number of about 50,000. Yet, without the promise of a paycheck or even a thank you, these men and women voluntarily don pounds of equipment and run into burning buildings in danger of collapse in order to save our loved ones and our treasured property. I urge you to support this legislation, and in doing so, support firefighters of this Commonwealth who answer the call day and night. Our firefighters have been sounding the alarm for years about their challenges. We must continue to work to answer their call. This is an important first step in that effort, and I urge an affirmative vote.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Washington, Senator Solobay.

Senator SOLOBAY. Mr. President, the previous speaker very eloquently laid out this entire bill, the importance of it, and the outcome of what passage of this bill does. As a member of a department myself for many, many years who has utilized this volunteer loan assistance program for purchases of equipment, I know exactly what she said when she spelled out the importance of needing not only to double the costs that folks can be able to borrow, but the importance of what our volunteers do across the entire Commonwealth.

Another unique part of this program is, and I think the Fire Commissioner's office can back up these statistics, but in the entire length of this program since it has been going on, I do not think there has been one default on any of the loans that the fire departments have taken out, which again stands for the integrity of our emergency service providers across the Commonwealth. So, with of all that, I ask for an affirmative vote on this, and I also have some additional comments to add to the formal record.

The PRESIDENT. Without objection, the remarks will be spread upon the record.

(The following prepared remarks were made part of the record at the request of the gentleman from Washington, Senator SOLOBAY:)

Mr. President, I am pleased to see the final passage of House Bill No. 1706. This bill amending Chapter 73 of Title 35 (Health and Safety) of the Pennsylvania Consolidated Statutes increases the loan amounts under the Volunteer Loan Assistance Program (VLAP).

When this bill is signed into law, it will greatly enhance what has been a proven effective program for fire companies and volunteer rescue services or volunteer ambulance services. VLAP has been a lifeline to first responders across the Commonwealth for some time. However, without amending the law, more and more fire and rescue operations were finding the program to be too limiting in its loan amounts and thereby making it difficult for them to acquire resources necessary to carry out their respective missions.

One of the highlights of this legislation is that it does not call on any sort of tax or fee increase on the part of the citizens of the Commonwealth. The legislation merely enables fire and rescue/ambulance companies to access existing funds. There is no projected possibility of the new higher loan amounts adversely impacting existing funds. This is truly a positive mechanism for assisting our first responders with virtually no negative effects on any governmental entities or the taxpayers.

I appreciate the opportunity to support this legislation.

The PRESIDENT. The Chair recognizes the gentleman from York, Senator Waugh.

Senator WAUGH. Mr. President, I rise to support the bill and to reinforce comments made by the previous two speakers to the extent that I would also like to add congratulations to both, it is interesting, Representative Baker, whose bill this happens to be, but also our champion here in the Senate, at least on our side, our own Senator Baker, for the hard work that she put in recognizing, as she said, the fact that this is a priority, a number-one priority that has been outlined for a good number of years now by especially our volunteer, but all fire services in Pennsylvania in general, working together to make sure that a very successful program that has been in place for a number of years without change continues and continues to provide exactly what it was intended to provide many years ago when it was implemented, and that is loan assistance. I stress this and it is really why I got up. It is easy to think that when we talk about helping to provide funding for, especially in this case, our volunteer fire services, we are talking about giving money or grants to them. There are some of those programs. This program is a self-sustained, self-sufficient, if you will, continual loan program that revolves, and as we place money into it, it is lent at low interest to the departments, and they take advantage of that as they go out to purchase not only their equipment, the fire trucks and the hardware and whatnot, but also other provisions that help them provide the valuable services that they provide to the communities across this Commonwealth.

When you think about the amount of money, taxpayer dollars that are saved each and every day by these volunteer organizations--you know, there are numbers that range anywhere from \$7 billion to \$10 billion in taxpayer savings that are seen annually by the volunteer services in our communities. So, this is really not a price at all, other than the fact that we are putting bonded money into an account, and as Senator Solobay--I should say Chief Solobay--so eloquently pointed out, there have been zero defaults on this, and I think that alone speaks volumes for the

integrity of our volunteer services here in the Commonwealth, not only the fact that they provide the services that they provide, but the fact is that they never leave us hanging, if you will, when it comes to repaying these loans, and that is a real credit to them.

So, I want to thank Senator Baker for her leadership, Chief Solobay for his, and I appreciate the support of all of the Members today.
