The Senate met at 1 p.m., Eastern Standard Time.

SENATE BILL RETURNED WITHOUT APPROVAL

The PRESIDENT laid before the Senate the following veto communication in writing from His Excellency, the Governor of the Commonwealth, advising that the following Senate Bill had been returned without approval:

SB 3, entitled:

An Act amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in abortion, further providing for definitions, for medical consultation and judgment and for the offense of abortion on unborn child of 24 or more weeks gestational age, providing for dismemberment abortion ban and further providing for reporting.

The Clerk read the veto message as follows:

December 18, 2017

TO THE HONORABLE SENATE OF THE COMMONWEALTH OF PENNSYLVANIA:

Pursuant to Article IV, Section 15 of the Pennsylvania Constitution, I am returning herewith, without my approval, Senate Bill 3, Printer's Number 283.

This legislation eliminates the right for women to make informed decisions regarding their health care and criminalizes medical procedures used by physicians in consultation with their patients. Further, the bill provides no exception for victims of rape or incest or for fetal anomalies incompatible with life, even though these anomalies may not be discovered until the fetus reaches 20 weeks.

This legislation is an extreme restriction on women and medical professionals and interferes with crucial decision-making between patients and their physicians. Physicians and their patients must be able to make choices about medical procedures based on best practices and standards of care. The prohibitions under this bill are not consistent with the fundamental rights vested by the Fourteenth Amendment of the United States Constitution.

For the reasons set forth above, I must withhold my signature from Senate Bill 3, Printer's Number 283.

On June 26, 1989, the revised Public Official and Employee Ethics Law was enacted which re-authorized the State Ethics Commission. The State Ethics Commission is responsible for issuing various types of rulings on matters within its mandated jurisdiction. Pursuant to the law, the Commission is mandated to forward, quarterly, a copy of every Opinion, Advice of Counsel, and Order issued to one law library in each county, one public library in each county, the State Library, the State Senate Library, each authority appointing a Commission member, the Pennsylvania Association of County Commissioners, the Pennsylvania Association of Boroughs, the Pennsylvania State Association of Township Supervisors, the Pennsylvania State Association of Township Commissioners, the Pennsylvania State School Boards Association, and the Pennsylvania League of Cities. Your agency is either specifically identified in the above requirement or has been selected as a library to which this mailing will be made pursuant to the above authority. As such, enclosed please find decisions of the State Ethics Commission from October 1, 2017 to December 31, 2017. Due to budgetary restraints, a CD containing said rulings will replace paper copies that were previously sent.

For your information, the Commission generally issues these types of decisions as follows:

<u>Commission Opinions</u> - Opinions are advisory rulings issued by the State Ethics Commission regarding the duties and responsibilities of public officials and employees under the Public Official and Employee Ethics Law. Opinions are catalogued by year of issuance followed by the sequential number of the opinion during that year. As such, opinions relating to 2017 will begin with the number 17-001 and proceed there from as decisions are rendered.

Advice of Counsel - The Commission's Chief Counsel is authorized to issue similar advisory letters. Such letters are issued generally when there is prior precedent for counsel to rely upon in issuing a decision or when the provisions of the State Ethics Act directly provide the answer to the question posed. Advice of Counsel letters are numbered with the year and a 500 series number that progresses in order therefrom as rulings are issued. If more than 100 such letters are issued, a 600 series number will then be used.

Orders - Commission orders are issued at the end of an investigation and are determinations as to whether or not there has been a violation of the State Ethics Act. Commission orders are categorized numerically from the date of the first order in 1979. That is, the first Order issued was Order No. 1. All orders proceed there from.

It is recommended that Opinions, Advices of Counsel and Orders be maintained separately (in numerical order) so as to afford better retrievability

The enclosed items are being forwarded for retention, cataloging and for the purpose of being publicly available for review by citizens of the Commonwealth of Pennsylvania who may have an interest therein. Senator WILLIAMS. Mr. President, I am proud and honored today that we are joined by Imam Kenneth Nuriddin, Rajan Muhammad, James Beverly, and Representative Ronald Waters. A little bit about my friend. He was born and raised in west Philadelphia, and his family is from Barbados. He entered the U.S. Army at age 17 and served proudly in Germany and Vietnam. He entered the Nation of Islam in 1972, and after joining the Nation of Islam, the Imam began a lifelong pursuit of the Arabic language and the Quran. In the late 1970s, he began volunteering in the county prisons and serving as Imam. He served as the department head for Arabic Islamic Studies at Sister Clara Muhammad School in 1978 for 15 years, eventually becoming assistant director of education. In 1972, he helped start the United Muslim Masjib and became the first resident Imam. Not long after, he also helped formulate a program within the Netter Center for Community Partnerships at the University of Pennsylvania, building bridges and relationships with various groups in west Philadelphia. Currently, the Imam is serving as the resident Imam for the Philadelphia Masiib.

I also close with this, there are two distinct parts: one, I am grateful he took the time and long travel to come here today to show the vast representation of relationships we have across the senatorial district and our communities of faith, and we are greatly honored. But most importantly and most proudly on this particular day, he and I share that the most troubled, underserved, under-tried, disrespected, and long-awaiting Philadelphia Eagles, today is our day, Imam. I thank you for raising in a moment that we collectively should reflect upon the greatest football team in Pennsylvania today. I am not saying too much about the Philadelphia Eagles right now because I will say more later on. Thank you for being here.

The PRESIDENT. Would the guest of Senator Williams, the Imam, please rise so that the Senate may give you its usual warm welcome. Thank you for your service, Imam, thank you for being a great Eagles fan, and thank you for your prayer today.

She has participated in study tours in China, India, and Japan. She has traveled to 47 countries and all continents except Antarctica. She has completed home stay experiences in Japan, the Netherlands, Norway, Israel, the West Bank, and Greece. She has traveled to the outback of Australia, tropical rainforests in Brazil, Paraguay, Argentina, tribal villages in Panama, and the interior of Alaska.

In the community, Jennifer has sold programs at the Little League World Series and has worked for the American Red Cross, the American Cancer Society, and the March of Dimes, just to name a few. Incidentally, she also likes to cook, read nonfiction, visit museums, and spend time with her husband and dog. Jennifer is joined today by her husband, Zachary; Loyalsock Township School District Superintendent Gerald McLaughlin; and high school Principal Dr. Matthew Reitz.

As the Teacher of the Year, Jennifer will travel around the State meeting with and working with other educators and will serve on several Pennsylvania Department of Education committees. She will also represent Pennsylvania in the National Teacher of the Year competition in 2019.

Mr. President, I ask my Senate colleagues to please join me in recognizing Jennifer Wahl, her husband, and her school support team from Loyalsock Township School District, and wish her well as she represents the best of Pennsylvania educators during next year's National Teacher of the Year competition.
