Senator SCAVELLO. Mr. President, I would like to introduce my constituent and friend, Reverend Sean Hinton, who is serving as guest Chaplain today and offered the opening prayer for Session. Reverend Hinton is an ordained minister with the Assemblies of God. WHEREAS, The Honorable Edwin B. Erickson, III, a former member of the Senate of Pennsylvania who represented the 26th Senatorial District passed away on January 8, 2019, at 80 years of age; and

WHEREAS, Affectionately known to his family members and friends as Ted, Dr. Erickson was born in Philadelphia in 1938 and was the son of the late Ruth and Edwin Erickson, II; and

WHEREAS, A 1956 graduate of Haverford High School, Dr. Erickson earned a bachelor's degree in biology and chemistry from Albright College in 1960; and

WHEREAS, Dr. Erickson taught general biology, anatomy and physiology, cell physiology and zoology at Drexel University and East Stroudsburg University; and

WHEREAS, In 1969, Dr. Erickson earned a doctoral degree in biochemistry and microbiology from Bryn Mawr College; and

WHEREAS, From 1969 through 1973, Dr. Erickson was a tenured assistant professor of biology at Hamilton College in northern New York; and

WHEREAS, Dr. Erickson was also a former member of the Army Science Board, where he served as an advisor to the United States Army on scientific and technological matters; and

WHEREAS, Dr. Erickson returned to Delaware County to serve as Director of Public Health and later as Chief Administrative Officer of Upper Darby Township; and

WHEREAS, In 1982, Dr. Erickson was elected to Delaware County Council and served as chair from 1987 to 1989; and

WHEREAS, Dr. Erickson served as Regional Administrator for the Environmental Protection Agency, Region III, before again returning to Delaware County to serve as its executive director from 1992 to 2001; and

WHEREAS, Dr. Erickson won a special election to the Senate of Pennsylvania in 2001 and served until his retirement in 2014; and

WHEREAS, As a member of the Senate, Dr. Erickson served as chair of the Majority Policy, Local Government and Public Health and Welfare Committees and as minority chair of the Local Government and Environmental Resources and Energy Committees; therefore be it

RESOLVED, That the Senate honor the life and achievements of the Honorable Edwin B. Erickson, III, and express heartfelt condolences to his wife, Katherine J. Abele Erickson, son, Jonathan, three grandchildren, Edward, William and Alexandra, and many other family members and friends; and be it further

The PRESIDENT. The Chair recognizes the gentleman from Delaware, Senator Killion.

Senator KILLION. Mr. President, this afternoon I offer this condolence resolution in honor of our former colleague, the late Senator Edwin B. Erickson, Ted, as we knew him, who passed away on January 8, 2019, at the age of 80. Senator Erickson earned a Ph.D. in biochemistry from Bryn Mawr College in 1969. Following this achievement, he was a tenured professor of biology at Hamilton College located in northern New York through 1973. Prior to that, Senator Erickson earned a bachelor's degree in biology and chemistry from Albright College and taught general biology, anatomy and physiology, cell physiology, and zoology at both Drexel University and East Stroudsburg State College.

His time in public service was served at all levels of government from municipal to Federal. Senator Erickson served as director of public health for Upper Darby Township, Delaware County, and later as the township's chief administrative officer. He was elected to Delaware County Council in 1982, serving as its chair from 1987 to 1989, before moving on to a position with the U.S. Environmental Protection Agency, Region 3, as a regional administrator. This territory included Pennsylvania, Delaware, Maryland, Virginia, West Virginia, and the District of Columbia. Senator Erickson returned to Delaware County government as executive director from 1992 to 2001. It was during this time that Ted and I became really good friends and he was a mentor to me. Ted was about 20 years my senior, and I was a young county councilman in my early 30s and thought I was a lot smarter than I actually was. Ted used to come into my office sometimes and say, councilman, you might want to think about that before you move forward with that idea, and 99 percent of the time he was right. I learned a lot from Senator Ted Erickson.

In 2001, he was elected Senator of the 26th Senatorial District. During his time representing this district in Harrisburg, he served as chairman of the Senate Committee on Public Health and Welfare, the Committee on Local Government, and the Majority Policy Committee. Additionally, he was vice chair of the Committee on Environmental Resources and Energy and the Committee on Local Government. Upon his retirement in 2014, he modestly acknowledged the successes from his time in this Chamber including legislative achievements in healthcare, environmental standards, data integrity, and alternative energy portfolio standards. He also specifically noted accomplishments in human services, commenting that helping people who cannot help themselves is where we need to be. He authored the community-based health care bill, Act 10 of 2013, which expanded access to primary and preventative care through the creation of the Community-Based Health Care Program.

I appreciate the opportunity today to offer this resolution and honor this truly remarkable man. My deepest sympathies and condolences go out to his wife, Kathy; his son, Jonathan; his grandchildren, Alexandra, Edward, and William; and to all of his family and friends.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I rise to extend condolences to the family of Senator Ted Erickson. As was mentioned by Senator Killion, first and foremost, Senator Erickson was an honorable man, someone who was very proud. When he gave you his word he kept his word, and I think that is something that is extremely important. He was always very welcoming to our Members, our new Members in particular, when they joined committees, making certain that they understood processes and the matters that were before those respective committees. But probably, as was mentioned by Senator Killion, the work that he had done, he worked closely with our friend and colleague, Senator Yudichak, on a number of issues in the area of the environmental space, particularly, the alternative energy portfolio conversation, as well as others.

I think what he brought to this Chamber was the breadth of his previous experience in other forms of government that lent itself to our discussion and our conversations as we went forward. When you think about a gentleman and a statesman, Ted Erickson is one of the folks who come to mind. So, on behalf of my Members here who had the privilege of serving with Senator Erickson, we, too, extend our condolences to his family.

The PRESIDENT. The Chair recognizes the gentleman from Centre, Senator Corman.

Senator CORMAN. Mr. President, very briefly, it is amazing looking around the Chamber, Senator Erickson has only been retired for 4 years before he passed and yet there are many Members on this floor who did not get to serve with him. We have had so many changes over the last few elections. I think the Senator from Allegheny said it best, Senator Erickson was a gentleman. First and foremost, he was a gentleman. He had his positions and his positions were important to him, he fought for his positions, but he was someone with whom you could disagree without being disagreeable. At the end of the day, we made our votes, win or lose, and we were all friends when we walked off the floor. That is our job, you advocate strong for your position, and Senator Erickson always advocated strong for his position. But at the end of the day, everyone has a reason for why they are where they are on positions. It does not make them a good person and you a bad person, or vice versa, and he understood that.

In my time I had a chance to serve maybe 14 years with Senator Erickson and I do not ever remember him being cross with anybody. I do not ever remember him in a shouting match with anybody or calling someone out for doing something. He went about his business serving the people of Pennsylvania and Delaware County, and that is a lesson for all of us, I think, as we serve in this Chamber. So he was a great person to serve with, he was a good friend. Even though I have not seen him in a couple of years, I miss him knowing that he is gone, but he is someone that we all will always remember here on the floor of the Senate. Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Mr. President, Senator Erickson represented part of Chester County. He was a gentleman. He was a very special person. He was easy to work with, he understood how people in Delaware and Chester Counties felt. He represented them so well, and he was a good friend. Ted would never let partisanship stand in the way of the friendship, just as Senator Killion would not, and my other colleagues, Republican and Democratic colleagues in the suburbs--we are all together, we understand what we need do in the interests of the people. Ted loved dogs like I do. In fact, one of his great joys in retirement was walking his poodle, which was actually a cousin of my poodle. But with all that said, Ted represented the very best kind of public leader. Senator Killion said it well when he described his career at the Federal, State, and local levels. So if we want to have a model, a Senator of excellence to inspire us, if we want someone who is a model to help us understand how we could best serve the people of this Commonwealth, it is Ted Erickson, and I stand to present this brief eulogy and to recognize the many contributions that Senator Erickson made to the Commonwealth of Pennsylvania.

Senator BROOKS. Mr. President, today I am excited to introduce to the Senate a team of talented athletes and all-around winners who hail from the 50th Senatorial District. I am so proud to say that the PIAA Class A State Football Champions hail from Farrell High School in Mercer County. Farrell is the first undefeated team to win a State championship in Mercer County history. Adding to this record, their coach, Jarrett Samuels, has earned recognition as Coach of the Year, and linebacker and quarterback, Kyi Wright, has won Player of the Year from the Pennsylvania Football Writers Association. What a pleasure it is to congratulate the Farrell Steelers and Coach Samuels.

Kyi Wright went for 129 yards rushing and completed all four of his pass attempts for 111 yards. Pitt Panther fans will be ecstatic to know that Kyi will be playing for the University of Pittsburgh next year and, who knows, maybe in 4 years he will return as a Steeler. Maybe not this time as a Farrell Steeler, but as a Pittsburgh Steeler.

Farrell finished with 500 total yards on only 36 snaps. Their coach has been known to say, you can make excuses or choose to make history. The Farrell Steelers decided to make history. Mr. President, please join me in congratulating Pennsylvania's PIAA football champions, the Farrell Steelers, Farrell superintendent, Dr. King, and Principal Fowler.

A Resolution recognizing the month of January 2019 as "Cervical Cancer Awareness Month" in Pennsylvania.

The PRESIDENT. The Chair recognizes the gentlewoman from Berks, Senator Schwank.

Senator SCHWANK. Mr. President, this resolution designates January as "Cervical Cancer Awareness Month." Four thousand women in the United States die each year from cervical cancer, and more than 12,000 women are actually diagnosed with cervical cancer. It once was the second-leading cause of death among women, and it is ironic because it is one of the most preventable forms of cancer. There is a very high cure rate if detected early enough. Among the two things that we recommend that people do, women most certainly, is to have a Pap test. But another important part of this is for both young men and women to receive a vaccination from the ages of 9 up to about 24 for human papillomavirus, HPV. So both men and women can have a role in helping to prevent this disease and, hopefully, that will continue to make sure that people are more aware of this disease and we can continue to reduce the number of deaths.

Thank you, Mr. President.

And the question recurring,

#### PETITIONS AND REMONSTRANCES

The PRESIDENT. The Chair recognizes the gentlewoman from York, Senator Phillips-Hill.

Senator PHILLIPS-HILL. Mr. President, I rise to speak about the importance of today, January 28, which is National Data Privacy Day in the United States. Mr. President, each of us in this body has a family member, a friend, a neighbor, or more importantly, a constituent, who has been affected by having their personal data stolen. It truly is the crime of the 21st century. Mr. President, as a Commonwealth, we need to do more to better protect the data of those we serve, the residents of Pennsylvania. Too often government is the last to respond to the rapidly changing world around us, and that is not acceptable. We must be proactive in protecting the sensitive information that is held by the State and other governmental entities.

Mr. President, last week, the Senator from Jefferson County appointed me to serve on the Senate Committee on Communications and Technology. I am exceedingly grateful for the opportunity to serve on this committee because we have many great and challenging issues confronting our Commonwealth when it comes to how we best secure our data to insure that we safeguard the personal information that government compels Pennsylvanians to disclose, so that we are not only meeting industry standards, but we become a leader in this area for the 21st century. I am proud to sponsor these pieces of legislation in the Senate to address this important issue. We have seen cyber attacks severely impact the Departments of Education, Human Services, and Corrections over the last few years. These are not just anecdotes. These are real-life situations with real consequences. Mr. President, we must move our Commonwealth's information technology systems into 2019 standards because if the past is a guide, then standards need to come up to the modern era so that when these attacks happen, our State government will not leave our taxpayers, our citizens, and our employees vulnerable. And that is why I am joining my colleague from Lancaster County, Senator Aument, to overhaul and modernize our State's IT systems. Our bill would consolidate the administration and management of the State's IT under the Office of Information Technology so we are better prepared to deal with the cyber threats of tomorrow and in the years to come.

Another bill I am sponsoring will best protect our students, who continue to see every aspect of their school and home lives become more and more digital with every passing year. This bill provides policies and protections for the collection and use of student data to insure that we are safeguarding our next generation. In addition, I will introduce a bill to address how data breaches are managed in Pennsylvania moving forward, including notifications for residents who may have had their data stolen or compromised in the event of a data breach in State government. It would provide a remedy for those who have their personal information compromised in a data breach as well. The bill is also forward thinking in assigning responsibilities for developing future policies to insure that all branches of our State government are doing everything in their power to reduce the risk of future data breaches in Pennsylvania.

Mr. President, these bills are important because the scope of the problem is so staggering. A 2018 identity fraud report found that there was almost \$17 billion stolen in 2017 from consumers who were notified about their personal data being exposed to a data breach. IBM found that the worldwide average cost for each data breach in 2018 was \$3.86 million, an increase of 6.4 percent from the prior year. Here in the United States, the average cost of a data breach is \$7.91 million, the most costly of any nation in the world. And based on the data, this issue is only going to get worse with each passing year. We are currently not taking seriously the damage that a cyber attack could inflict, nor are we adequately guarding the valuable commodity our present system of cyber defense is called upon to protect.

Mr. President, I encourage my colleagues to review these bills and to join me so that we can insure that all Pennsylvanians are better protected from having their personal information fall into the wrong hands.
