The Senate met at 11 a.m., Eastern Daylight Saving Time.

The PRESIDENT (Lieutenant Governor John K. Fetterman) in the Chair.

Senator MENSCH. Mr. President, today it is my pleasure to introduce to you my guests, the Pike family, Wilfred, Marian, and Amelia, who are seated in the gallery. Will is a 1970 graduate of William Tennent High School in Bucks County, where he played football, basketball, and baseball. He then went on to attend Temple University earning a master's degree in health education. Additionally, Will worked as a health and physical education teacher for East Penn School District at Eyer Middle School in Lehigh County from 1977 to 2010, before retiring in 2010. There he coached both football and basketball. Very importantly, today, Will is the president of a community nonprofit organization promoting prevention, supporting recovery, and offering hope against substance use disorder called Project Live in the Upper Perkiomen Valley. Currently, she has joined her husband, Will, and is a volunteer and a group facilitator for Project Live in the Upper Perkiomen Valley.

Lastly, it is my honor to introduce you to Will and Marian's daughter, Amelia. Amelia graduated from Upper Perkiomen High School in 2002, where she was a member of the National Honor Society. Amelia also attended the Governor's School for poetry. She graduated in 2007 from Moravian College with a bachelor of arts in psychology. Amelia also completed 2 years of master's level course work at Chestnut Hill College in psychology. Amelia has also helped train three amazing service dogs, which she has used, Christy, Mugsy, and Teddy. She volunteered with Mugsy doing talks about service dogs and training and presenting to various service organizations in the area. Amelia has also earned a certificate as a certified peer specialist and works for Salisbury Behavioral Health as a CPS.

- (3) The school security guard has complied with training requirements under subsection (b).
- (4) The school security guard has satisfied the requirements under sections 111 and 111.1 and 23 Pa.C.S. § 6344 (relating to employees having contact with children; adoptive and foster parents).

(d) Active law enforcement officers.--Active law enforcement officers shall be exempt from the training requirements for school security guards under subsection (c) (1) and (2) upon presentation to the school entity or nonpublic school of evidence of their completion of the training requirements under 53 Pa.C.S. Ch. 21 Subch. D (relating to municipal police education and training).

(e) Retired law enforcement officers.--A retired law enforcement officer shall be exempt from the training requirements for school security guards under subsection (c) (1) and (2) if the retired officer:

- (1) complies with section 8.1 of the Lethal Weapons Training Act; or
- (2) has been issued a firearm training and qualification card under section 5 of the act of December 13, 2005 (P.L.432, No.79), known as the Retired Law Enforcement Identification Act.]

The PRESIDENT. The Chair recognizes the gentlewoman from Allegheny, Senator L. Williams.

Senator L. WILLIAMS. Mr. President, from the moment we were presented with a bill to allow armed security guards in our schools, I have been very vocal and very clear about my concerns with their lack of training. I am not talking about school police officers or school resource officers who are trained law enforcement officials. SPOs and SROs have over 900 hours of training and experience. I was, and still am, deeply concerned about security guards who have been hired by third-party vendors with no law enforcement training and no law enforcement experience brandishing a live firearm around our kids. But despite my concerns, armed security guards are permitted to walk the halls of our schools with only 40 hours of Act 235 training and a basic school resource officer training offered by NASRO. Now I am being asked to vote for a bill that would further delay implementation of the statutory requirement for NASRO training, a minimal training that security guards are required to have prior to carrying a gun in our schools on how to interact with students. Armed security guards who lack the same training and experience as our law enforcement officials should not be allowed to carry firearms in our schools, period. My amendment would repeal the provision in the law allowing armed security guards in schools, and I urge my colleagues to adopt this amendment.

The PRESIDENT. The Chair recognizes the gentleman from Cambria, Senator Langerholc.

Senator LANGERHOLC. Mr. President, I rise and respectfully ask for a "no" vote on this amendment from the gentlewoman from Allegheny County. Succinctly, armed security guards are required to undergo three specific types of training. First, they cannot have any prohibited offenses. Second, they must complete the Act 235 training, which is an education and training program in the handling of lethal weapons, law enforcement, and protection of rights of citizens. Third, they must undergo any type of child abuse clearances. Quite simply, Mr. President, to permit this extension will require schools whose personnel have not complied with the training to be eliminated, allowing our schools to be unsafe. I can speak to a specific school within my district, and I am sure there are other schools throughout the Commonwealth that have had armed security guards in place for many years. We must not permit this to happen, not on our watch. I ask for a "no" vote on this amendment.

This is a common-sense amendment that will insure that only those who are properly trained will have a weapon around our kids. Thank you.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Mr. President, this week we have had a great opportunity to learn more about the Indian festival of Diwali. The Indian community is increasing in great numbers throughout the Commonwealth. In my area, if I draw a 25-mile circle around Exton, which is about the center of Chester County, there are now 36,000 residents of Indian descent. Back in 1979 when I looked at the United States Census, which was 50 years ago, there were only four residents of Indian descent. So, we are following in the direction of William Penn to welcome all who come here. We always remember that William Penn was an immigrant and a dissenter, and he established Pennsylvania to be a place where all could come and be welcomed and be a place of religious liberty. Thanks to the vote yesterday, we are going to assure the safety of all our houses of worship.

Diwali honors the theme of the traditional religious holidays, Christianity, Judaism, and Islam, in the theme of good versus evil, and the theme on the holiday, lights are lit, and lanterns are

put outside of houses, There is a special ceremony where we light a special candle, because in almost all-faith traditions, it is the battle of evil versus good. In almost all-faith traditions, it is the belief that we are to be a light unto the world. In Judaism, we have the Hanukkah lights, in Christianity, you have the Christmas lights. It is always light that lights up the darkness, and when it lights up the darkness in that struggle between good and evil, it also gives us, as human beings, hope; and without hope and the possibilities that hope presents, our life loses much of its meaning, does it not?

So, we all together can jointly celebrate the holiday of Diwali. It represents the struggle that we all go through of good versus evil. It represents our obligation to give light unto the world, and, in fact, we now have in my district the first school district in the Commonwealth to have Diwali as a day off from school, and this is not unusual. If you study the ethnic history in America, what you will find is that as a group increases in numbers, the community will do its best to respect and welcome that tradition as well. So, the final message of Diwali is this: let us all be a light unto the world, let us all do our good in the world, and let us live a life based on hope and the possibilities. As the poet Emily Dickinson said, in our lives, let us dwell on possibilities. Thank you so much.

Senator MENSCH. Mr. President, today I rise to offer a resolution recognizing October 8, 2019, as "National Hydrogen and Fuel Cell Day" in Pennsylvania. Mr. President, scientists and engineers across the country will celebrate Hydrogen and Fuel Cell Day on October 8, aptly chosen for the atomic weight of hydrogen, which is 1.008, translating to 10-8, or October 8.

The United States is a world leader in the development and deployment of fuel cell and hydrogen technologies. In Pennsylvania, we are seeing a focus of hydrogen as an energy carrier and a pathway to good environmental stewardship. One example that comes to mind is PDC Machines, located in Warminster Township, Bucks County. PDC Machines is continuously working to develop new technologies related to hydrogen fuel cells and encouraging growth within this sector. In fact, today, they are participating in the Ride and Drive event located on Commonwealth Avenue until 2 p.m., to celebrate National Hydrogen and Fuel Cell Day. **PETITIONS AND REMONSTRANCES**

The PRESIDENT. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Mr. President, today marks 4,854 days since the Pennsylvania legislature last raised the minimum wage. That is more than 13 years, and it is far too long. Throughout the last 13 years, one of the most popular arguments advanced by those who oppose the higher minimum wage is that a raise would actually hurt the people who we are trying to help. The theory that if we raise the minimum wage, employers would start laying off workers or reducing their hours to compensate for higher payroll costs. Small businesses are most vulnerable to a higher minimum wage, they say. Extensive academic research of real-life data from across the country has largely refuted this oft-repeated political dogma. That is why I found it more than a little ironic when I learned that a low minimum wage, like the \$7.25 rate we pay in Pennsylvania, may be costing small business owners more than it saves them.

In a new report, the small business HR management company, Gusto, found that 7 out of 10 workers who make \$7.25 an hour leave their jobs each year. In other words, the annual turnover rate for minimum wage workers is 70 percent. That is more than double the overall employee turnover rate, which is about 32 percent. Gusto based its finding on data from tens of thousands of its client companies. In addition, the company found that workers who earn higher wages are a lot less likely to leave their job. The annual turnover rate for workers who make \$10 an hour is 55 percent; at \$15 an hour, the rate drops to 41 percent. In other words, fairly paid workers tend to keep their jobs longer, and employers who pay fair wages tend to spend a lot less on

recruiting and training new employees. I think we can all agree that employee retention is good for workers and businesses. My legislation, Senate Bill No. 12, would accomplish both of those objectives.
