#### 2019 ANNUAL REPORT OF THE PENNSYLVANIA AUTO THEFT PREVENTION AUTHORITY

The PRESIDENT laid before the Senate the following communication, which was read by the Clerk as follows:

COMMONWEALTH OF PENNSYLVANIA Auto Theft Prevention Authority 5 Kacey Court, Suite 201 Mechanicsburg, PA 17055 TO THE HONORABLE GOVERNOR TOM WOLF AND MEMBERS OF THE PENNSYLVANIA GENERAL ASSEMBLY:

In 2019, we at the Pennsylvania Automobile Theft Prevention Authority marked a great milestone in our history: 25 years of reducing vehicle crime in the Commonwealth. Since our inception, and through strategic funding, we've helped realize a 79 percent reduction in vehicle theft in the Commonwealth, compared to the national decrease of 51 percent.\* While nationwide vehicle crimes have been on the rise since 2015, Pennsylvania's rates continue to decline.

In 2019, ATPA grantees contributed to:

- Recoveries of \$32 million in vehicles and parts
- 700 arrests associated with auto theft-related crime
- 1,077 convictions related to auto theft-related crimes
- Court-ordered restitution of \$2.1 million to the victims of those crimes

This success is significant to every Pennsylvanian, as vehicle crime reduction not only prevents costly increases in insurance premiums but also significantly impacts community safety. While some vehicles are stolen as a crime of opportunity for the thief to "get across town," many are stolen by complex, professional theft rings whose tactics often involve violence, financial fraud, identity theft, and international trafficking. Perhaps most importantly, many crime sprees begin with the theft of a vehicle, leading to the dangerous and costly ripple effect of the subsequent crimes.

The Pennsylvania Automobile Theft Prevention Authority is a legislatively mandated, public-private entity that cannot and does not use tax dollars. Pennsylvania insurers fully fund the organization through yearly assessments. Grants are distributed to law enforcement agencies based on need and utilization plan. Grant renewals are contingent on audits and results. For every dollar assessed since inception, we have realized a \$6.36 return -- all without cost to the Commonwealth.

You can be certain of our continued diligence in reducing any threat to our collective safety and financial security that vehicle crimes pose. We look forward to serving the citizens of the Commonwealth for another 25 successful years as we support our grantees, educate the public, and train law enforcement to detect and solve these ever-evolving crimes. We are grateful for the opportunity, and we thank you for your support.

Senator PHILLIPS-HILL. Mr. President, we can never say thank you enough to the men and women who have served and serve in our Armed Forces. Many times, we introduce veterans who are guests to the Senate or offer our support for resolutions to commemorate those servicemen and women. Other times, we name a highway or bridge honoring someone who paid the ultimate sacrifice. Today, we are taking another step to say we recognize those who served and sacrificed during more recent conflicts. This bill will designate March 6 as Persian Gulf War Veterans Day, and October 7 as Global War on Terrorism Veterans Day in the Commonwealth. These two conflicts included more than 2.5 million Americans who served, and sadly, more than 6,000 of those Americans lost their lives, including 324 Pennsylvanians. The bill also requires the Governor to annually issue a proclamation encouraging all public schools and educational institutions to observe these special days by conducting exercises recognizing the contributions and sacrifices made by these veter-

Finally, I need to give a very special recognition to my constituent, Sergeant Harold Redding of Spring Grove, who brought this issue to my attention. Harold is a Vietnam Veteran, and the culmination of his Army service did not end his service to our nation. In 2018, Harold's advocacy led to the permanent designation of March 29 as Vietnam Veterans Day in Federal law, which was long overdue. He, like so many Vietnam Veterans, yearned to be warmly welcomed home. Once the Vietnam Veterans Day designation was accomplished, Harold turned his advocacy efforts toward Gulf War Veterans to insure they are honored and

welcomed home with dignity and respect. We are grateful for his tireless efforts to insure that no veteran's service to our nation is ever forgotten.

I would appreciate an affirmative vote to honor the fine men and women who have served our country during these times of war.

Senator IOVINO. Mr. President, this amendment would completely maintain the integrity of the underlying legislation to create a veteran-owned business logo for such businesses to display; however, it would not designate that the estimated \$200,000 cost required to administer the program come from the Veterans' Trust Fund, or VTF. The \$200,000 cost impact is provided by the Department of Military and Veterans Affairs. The department would administer the program and supports this amendment. A \$200,000 hit to the VTF represents a 13-percent reduction in funding available for grants to support veterans, according to the latest available numbers in the 2018-19 fiscal year. VTF grants typically go to organizations, nonprofits, and county departments of veterans affairs, entities whose mission explicitly supports veterans. The DMVA estimates the number of veterans who would be impacted by the raiding of the VTF is conservatively 10,000, or possibly upwards of 15,000 veterans who are supported by the organizations that benefit from VTF grants. More critically, DMVA reports 470 veterans in crisis, or eligible family members in crisis, and that "in crisis" is a qualifying factor for a VTF grant to an individual, would be impacted.

It is likely that the veterans impacted by a 13-percent decrease in the Veterans' Trust Fund come from nearly every county and every district in this Commonwealth. I strongly support the creation of a logo designating veteran-owned businesses, but do not believe this initiative should come at the expense of existing programs that are helping our veterans. Instead, I ask for the adoption of amendment No. A6343 to Senate Bill No. 957 to require that separate funding be appropriated to maintain the financial integrity of the Veterans' Trust Fund and the integrity and ability of the fund to directly support the veterans of this Commonwealth.

Senator BARTOLOTTA. Mr. President, I respectfully ask for a negative vote on the amendment. Senate Bill No. 957 permits the Department of Military and Veterans Affairs to utilize existing resources like the Veterans' Trust Fund to implement this small but worthy program for our veterans. The Veterans' Trust Fund has been used in the past to help implement State programs for veterans, including the veterans' designation on driver's licenses. That being said, my legislation directs any fines from the program to the Veterans' Trust Fund. Furthermore, Senate Bill No. 957 permits the department to establish fees to cover the cost of verification. As such, I do not believe this amendment is necessary, and I ask for a negative vote.

Developing a special logo to draw attention to their service to our community is one simple way that we can support their dream while giving them a way to serve our communities, once again, in a different capacity as leaders in business and industry. I urge my colleagues to cast an affirmative vote on Senate Bill No. 957.

The PRESIDENT. The Chair recognizes the gentlewoman from Mercer, Senator Brooks.

Senator BROOKS. Mr. President, Senate Bill No. 331 creates a firefighter training pilot program to allow PASSHE schools and our community colleges to partner with local high schools and career and technical schools in providing firefighter training to interested high school students. Many of our firefighters are reaching retirement, and younger firefighters who can answer the call in the future are in short supply. This legislation is designed to get individuals interested and trained at a younger age to help insure that fire calls do not go unanswered in the future. This bill builds off the success that Harrisburg Area Community College

saw in partnering with local high schools for fire training. By making programs like this more accessible, it is my hope that we can expand the opportunity to help our fire departments rebuild their dwindling numbers. Providing training to young students in a close and convenient location is one way we can attract first responders who do so much for our communities. It is also my hope that this legislation will provide a valuable tool for our emergency responders to increase their numbers. Our local firefighters are there day and night to protect our communities. Can we imagine if these local heroes, who give so much, were to disappear from public service? I ask my colleagues to support this legislation, as well as our firefighters in our local communities by attending their events.

Thank you so much, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Mr. President, will the sponsor of the bill stand for friendly interrogation?

Senator BROOKS. Mr. President, yes.

Senator DINNIMAN. Mr. President, the question I have is this: some of our school districts have programs that are trying to accomplish exactly what the gentlewoman is doing, and thank you for having this bill. It is very important. We have programs, for example, where a student can get 40 certifications. So, if a school district is involved with programs that already exist, they can still apply, correct, to the PASSHE or community college? There is nothing in this bill that would prevent that from happening?

Senator BROOKS. Mr. President, this legislation will not interfere with current programs in place. It only expands opportunities for programs to grow and allow more access to these programs.

Senator DINNIMAN. Mr. President, in essence, just so I get it right, and thank you, again, Senator Brooks for standing, but not only that, but for the bill, it is a good bill. I want to make sure that if a school is already involved in a program with another school for training in emergency services, that they could also be able to apply to further get involved with one of the community colleges and universities. I do not see anything in the bill that would prevent it, but I want to make sure that my interpretation was correct.

Senator BROOKS. Mr. President, it is our intent in this legislation to do that, and we are just adding access to these programs and hoping that our younger students are able to participate. Also, if you look in the legislation, it actually requires, when possible, that each region of the State offer these programs.

Senator DINNIMAN. Mr. President, thank you for answering the question. I do understand. I just wanted to clarify because of concerns in my own county which has such a program in the schools, and so a school district that is currently in it can also apply to a community college or anything else, and you have answered that affirmatively, and your staff has as well. So, I appreciate that, and again, thank you for this good piece of legislation.

Senator BROOKS. Mr. President, thank you. Senator DINNIMAN. Thank you, Mr. President.

#### PETITIONS AND REMONSTRANCES

The PRESIDENT. Senator Tartaglione has submitted remarks for the record. Without objection, the remarks will be spread upon the record.

(The following prepared remarks were made part of the record at the request of the gentlewoman from Philadelphia, Senator TARTAGLIONE:)

Mr. President, today marks 5,097 days since the Pennsylvania legislature last raised the minimum wage. That is almost 14 years, and it is far too long.

We are living through a period of great change in the United States and here in Pennsylvania. Recent events have caused us all to reexamine and reshape how we interact with one another, as well as how we interpret ideas like freedom and equality. In the business world, some organizations are adapting to the expectations and demands of our new reality. As the COVID-19 pandemic spread across the nation, and as the public lauded essential workers for their selfless dedication to their jobs and their communities, many employers began to offer something more substantive, something to help those workers keep a roof over their heads and food on their tables. Many companies began to provide hazard pay and enhanced benefits, like paid leave, to those employees who were unable to work from home, those who risked their own health and well-being so that the rest of us could stay well-stocked with life's necessities and so that our healthcare needs were being met.

A few companies have taken this novel approach a step further. Just last week, Target Corporation announced that it will make its pandemic-related pay increases permanent company-wide while paying a one-time bonus to all frontline workers and bolstering its paid leave, childcare, and family care programs. The raises lift the starting salary at all Target stores and distribution facilities to \$15 an hour. That is 25 percent higher than the industry average in the U.S. Over the last 3 years, Target has raised its starting wage by \$4. Target is one of the largest retailers and private-sector employers in the nation. The company is showing that a \$15 minimum wage and generous employee benefits are not only possible, they are good for business, too. Unfortunately, the more some things change, the more others stay the same. Major employers like Amazon, Kroger, and Starbucks have already rescinded pandemic-related pay increases. In fact, their \$2 and \$3 raises did not even survive the month of May.

Mr. President, there have been 478,000 new COVID-19 cases recorded in the U.S. since the end of May. That accounts for 27 percent of the total number of U.S. cases since the start of the pandemic. We are still seeing tens of thousands of new cases every day. Frontline workers are still facing the same job-related hazards they were last month and in the months since the start of the pandemic. Much of corporate America has been up to its familiar, cynical tactics in their board rooms and executive suites, too. As millions of American workers have suddenly found themselves unemployed, many top executives are reaping huge windfalls. Last month, the CEO at JCPenney pocketed a \$4.6 million bonus 5 days before the company's bankruptcy filing. Other top executives at the company collected \$1 million in bonuses. About three dozen top executives at Whiting Petroleum Corporation, Chesapeake Energy Corporation, and Diamond Offshore Drilling Inc. have collected a combined \$50 million in bonuses despite the major downturn experienced

by the petroleum industry due to the pandemic. At Whiting, the CEO was rewarded with a \$900,000 pay raise after his company's stock price plummeted from \$55 a share to under \$2, then filed for bankruptcy on his watch.

Mr. President, we often hear right-wing ideologues disparage our efforts to raise the minimum wage to a family-sustaining level. They want to convince the public that the free market--the unfettered labor market--will tell us what fair wages should be. On the contrary, the instances I have mentioned here are just a few examples of how that myth cannot and does not exist when the corporate elite reward themselves handsomely even in the worst of economic times. Yet, even in the best of times, employee wages consistently lag behind economic growth. Now, more than ever, we in the Commonwealth must take a stand against growing income disparity and enact real, positive change for Pennsylvania's low-wage workers. The General Assembly must consider and adopt my Senate Bill No. 12. At long last, we must raise the minimum wage.

The PRESIDENT. The Chair recognizes the gentleman from Chester, Senator Dinniman.

Senator DINNIMAN. Mr. President, sometimes I will put it in writing and sometimes I will rise personally each day until we take care of the critical needs in education. Many students were not provided an adequate education during the pandemic, especially students in poorer areas and rural areas where there was no opportunity for Internet connections. We cannot afford to lose a generation of students, and we need to act now before we leave, as well as when we return. As the Department of Education gives out their guidance recommendations, the expense of this is going to be tremendous. They have not yet given out the guidance in terms of school and bus transportation. So, I want Members to be aware that just because we passed a 12-month budget for public education, it is not going to take care of the emerging needs of our school districts. Even in my own area, which has one of the best tax bases and some of the wealthiest school districts, we see the majority of school districts raising their property taxes. In some cases, we actually see the dismissal of teachers--in one district, up to 57 teachers and staff members. So, I want to make sure we are all continually aware of this.

Also, let me suggest some possible actions we can take, actions that I have discussed with the Majority chair of this committee, who has been most helpful and cooperative in making sure we meet the needs of education. For example, if the pandemic continues or increases, we need to have a clear policy that if it is in one school, say in Easton, we do not necessarily close all the schools in the Commonwealth, as we did this last year. We need to have a clear definition of what online education is all about. It is not simply putting something online. It is working with the students. It requires special skills. It requires the acceptance of the fact that you put your lesson plans and lectures online so they can be accessed at any time. We need to make some determination as to what we are going to do with the testing and whether we are going to continue to use the keystone test, and under what conditions, if the pandemic reemerges or continues. We need to figure out how we can continue and replicate some of the volunteer education programs that are currently going on. My IU, and I have worked with them, has a volunteer retired teacher program so we can work with students who are having difficulty with online learning.

We need to certainly begin to help and urge the schools to help each student, especially in elementary school, who are scared, afraid, and do not know what to make of this pandemic and the wearing of masks. This is the type of discussion we have to be sensitive to and make sure it takes place in the public schools. Today, we made one very positive step when we passed the certification bill, because we do not even know how many teachers will remain in the schools when the school year begins, and we have such a shortage of teachers now, especially substitute teachers. So, Mr. President, all I am trying to say is this: let us not think that the issue of education was done and over with when we did the 12 months. We have to make sure every child is educated. We cannot just say that online learning is the answer without establishing the qualifications and the means of accomplishing this.

Let me say one last thing in this regard and that is: if we continue to assume that for our tens of thousands of non-English learners in this Commonwealth--in fact, in my own school district, West Chester School District, we have 547 non-English learners--that a curriculum delivered online in English is doing the trick, it is not. The curriculum needs to have simultaneous translation, and we have to make sure that is accomplished. It is not an expensive thing. It is the same thing you use when you are traveling as a tourist somewhere. It goes back and forth. So, I am simply bringing these issues up and will continue to bring them up--as my colleague, Senator Tartaglione, has done a tremendous job on unemployment--so we take care of students.

A final comment on another issue. We still have thousands and thousands of people who have not received their unemployment checks, going all the way back to March 15. In my district alone, we have documented 300 such people, and we know there are hundreds more who are out there. This is unconscionable. These people at first called with frustration. Now, they are calling our office in utter despair. What am I to do? How am I going to feed my family? Many of them have taken out loans. How am I going to repay these loans? I understand the overwhelming volume that Labor and Industry has, but let us also understand that we have an increasing number of desperate people out there who are unemployed and have not received their checks since March 15. By the way, they cannot get their Federal money either because that is connected to that check.

One lady summed it up this way. She said, I did everything I was supposed to do with the pandemic. I understood when my employer sent me home, and now, unfortunately, I do not even know if I will have a job because my store may not survive during the pandemic. I educated my kids at home, and I kept my kids at home, just as I was told to do. I wore my mask, and I wore my gloves. I did not go out of my house very much. I did everything I was supposed to do in this pandemic, but when is the State of Pennsylvania, the Commonwealth, going to do something for me? When am I going to receive that check that has been due for over 3 months? I cannot survive anymore, Senator, she told me. I am in desperate need. I am rising with that woman and the 300 people we have documented in my district alone.

Understand, I am in the wealthiest district in this Commonwealth. I am in a district which has always had the lowest unemployment rate. If we are getting these calls, I imagine it is happening in other districts. If we have 300 that we have documented, I imagine there are probably another 600 out there in the district that did not even know to call us. So, this is an urgent call. We have to take care of these people. They are in a horrible situation. Can you imagine any Member of this body trying to go about 3 months without being paid; if they have no reserves in

the bank; if their car is being repossessed; if they do not even know whether they can pay their rent; and they have not received the State or Federal money? This is an untenable and unacceptable situation, and we in this Senate and the administration have to answer the needs of these citizens, our brothers and sisters who are in need and who are desperate, in this Commonwealth. So, Mr. President, I make two appeals, one is for those situations, and the other is for the children who did not receive a real education this spring, and we have to make sure they do so, both over the summer and into the fall.

Thank you, Mr. President, for your indulgence in allowing me to do this remonstrance. Thank you, again.
