In negotiable instruments: Further providing for negotiable instrument, for issue of instrument, for signature and for discharge by cancellation or renunciation. In funds transfers: Further providing for payment order and definitions, for security procedure, for authorized and verified payment orders, for unenforceability of certain verified payment orders, for misdescription of beneficiary, for misdescription of intermediary bank or beneficiary's bank, for rejection of payment order, for cancellation and amendment of payment order and for liability for late or improper execution or failure to execute payment order. In letters of credit: Further providing for formal requirements and for choice of law and forum. In warehouse receipts, bills of lading and other documents of title: Further providing for definitions and

index of definitions and for control of electronic document of title. In investment securities: Further providing for definitions, for rules for determining whether certain obligations and interests are securities or financial assets, for control, for applicability and choice of law and for protected purchaser. In secured transactions: Further providing for definitions and index of definitions, for control of deposit account and for control of electronic chattel paper. Providing for control of controllable electronic record, controllable account or controllable payment intangible. Further providing for attachment and enforceability of security interest, proceeds, supporting obligations and formal requisites, for afteracquired property and future advances, for rights and duties of secured party having possession or control of collateral, for additional duties of secured party having control of collateral, for duties of secured party if account debtor has been notified of assignment, for request for accounting and request regarding list of collateral or statement of account, for law governing perfection and priority of security interests, for law governing perfection and priority of security interests in deposit accounts and for law governing perfection and priority of security interests in investment property. Providing for law governing perfection and priority of security interests in chattel paper and for law governing perfection and priority of security interests in controllable accounts, controllable electronic records and controllable payment intangibles. Further providing for when filing required to perfect security interest or agricultural lien and security interests and agricultural liens to which filing provisions do not apply, for perfection of security interests in chattel paper, deposit accounts, documents, goods covered by documents, instruments, investment property, letter-of-credit rights and money, perfection by permissive filing and temporary perfection without filing or transfer of possession, for when possession by or delivery to secured party perfects security interest without filing and for perfection by control. She also is an assistant dance teacher, where she helps teach beginner and intermediate dancers. She is also a member on her competitive dance team. When she is not competing, Abby enjoys spending time with family and friends, traveling, and watching her younger brother, Owen, play baseball. The PRESIDENT. The Chair recognizes the gentlewoman from Montgomery, Senator Muth.

Senator MUTH. Mr. President, in its current form, Senate Bill No. 831 lacks the public protections for landowners as well as community members and our environment. Mr. President, my amendment would simply require that both the Pennsylvania Department of Environmental Protection and the Pennsylvania Public Utility Commission have adequate staffing to carry out the provisions of this legislation and to inspect and enforce regulations along the various pipelines across our Commonwealth, both currently built and those needed to be built to implement carbon capture sequestration and transport. My amendment would require that within 3 months of the effective date of this Act, the Pennsylvania Department of Environmental Protection would dedicate 100 employees to administering the duties and responsibilities imposed on the DEP by this legislation. It would also require that the Pennsylvania DEP and the Pennsylvania PUC each dedicate at least 50 additional pipeline inspectors to perform the duties and responsibilities imposed by Senate Bill No. 831. My amendment also states that the department may not designate current DEP employees to meet this requirement and actually hire the new staff needed to actually oversee these projects. It also indicates that the PUC may not designate current employees to dedicate and to maintain 50 additional pipeline inspectors.

Mr. President, the Federal Pipeline and Hazardous Materials Safety Administration, also known as PHMSA, indicates that Pennsylvania already has more than 93,500 miles of underground pipelines throughout our Commonwealth, and that is before we even start to talk about carbon capture and storage or the

fee

development of hydrogen hubs and related infrastructure in our Commonwealth. Any further pursuit of carbon capture and storage in our State would most certainly require a significant and costly investment in newly constructed pipelines to transport this captured carbon. We cannot pursue a program like this without adequate staff to inspect and ensure the safety of these pipelines in our backyards, near our schools, and everywhere else across this Commonwealth. In conversations with the PUC, they indicated that they currently have 19 pipeline inspectors on staff and have 6 vacancies, and remember, that is just for the existing pipeline infrastructure. The DEP indicated that they have 24 water quality specialists on staff who are tasked with inspections of service-related items associated with oil and gas development and 37 oil and gas inspector positions, 5 of which are vacant. Mr. President, if we are going to require any additional responsibilities or establish new programs under the Department of Environmental Protection or the PUC, we need to address the staffing complement, and my amendment would do just that. I ask my colleagues for an affirmative vote on this amendment.

The PRESIDENT. The Chair recognizes the gentlewoman from Montgomery, Senator Pennycuick.

Senator PENNYCUICK. Mr. President, April is the Month of the Military Child in Pennsylvania, where we support the more than 32,000 children with parents in the military. This month is very personal to me and many of my colleagues. When we don the uniform, it is not just us who serves, our families serve as well. As a retired lieutenant colonel and a mother of four, I know

firsthand the challenges these children face. Seventeen moves across the United States and the world, 15 different schools from K through 12, Military children only know one constant, and that is change. They can relocate, say goodbye to friends, adapt to new schools, and, of course, cope with their parents' multiple deployments

I have watched my own children navigate the complexities of military family life. Sometimes good and sometimes bad. Sometimes it is: I do not know what my address is, just look in my backpack because we will be moving soon. And other times it is: if the gentleman at the door is in a battle uniform, mom is only hurt; if the gentleman at the door is in his Class A, she is dead. The words of a 6-year-old. Now I watch my children navigate these complexities as they balance raising their own families while they are in the military.

So, today, I encourage you to keep these families in your prayers and your thoughts as we wear purple this month to support their journey. Beyond the recognition, we must advocate for policies and programs that directly address the unique challenges faced by children of military members. And I would like to take a moment to remember the children whose parents are currently deployed with the Pennsylvania National Guard. Enhancing educational opportunities, ensuring access to consistent mental health support, and fostering community connections are the utmost of importance. So let us commit to supporting these children, not just in April, but throughout the year.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Costa.

Senator COSTA. Mr. President, I rise on behalf of Senator Tartaglione, and offer her remarks and it will introduce for the records indicating that we are now at 6,483 days since our Commonwealth last increased the minimum wage. I ask that they be included in the record.

Thank you, Mr. President.

The PRESIDENT. Without objection, the remarks will be spread upon the record.

(The following prepared remarks were made part of the record at the request of the gentleman from Allegheny, Senator COSTA, on behalf of the gentlewoman from Philadelphia, Senator TARTAGLIONE:)

Mr. President, I rise because today marks 6,483 days since our Commonwealth's legislature last passed an increase in our minimum wage. Every time this Chamber returns to Session without addressing the moral failure of almost 17 years and 9 months of inaction on our minimum wage, we inch closer and closer to 18 years.

Mr. President, Governor Rendell signed Senate Bill No. 1090 in the summer of 2006, the last piece of legislation to be signed into law in Pennsylvania addressing the minimum wage and providing relief to our Commonwealth's lowest earners. That means, come the general election this November, Senate Bill No. 1090 will be 18 years old. Children in our schools across Pennsylvania have literally never seen our legislature make meaningful minimum wage reforms.

Let that sink in, Mr. President. There are graduating students of the class of '24 who have lived in a world with a minimum wage in the low \$7 range. I know I, and I assume my colleagues, are often asked to talk to students about the world, their lives ahead, and how we as elected officials are helping make the Commonwealth a better place than we found it. I am certain no one ever walks into a room full of students and touts how great of a life they can have working a job where they earn the minimum wage, or even a wage remotely close to it.

Just today, Mr. President, I welcomed students from the Liguori Academy and introduced them on the Senate floor. I have spent time getting to know these students and their teachers, and there is something that weighs heavy on my heart. These kids have never seen a Commonwealth where we appropriately value a human's work. Let us be clear, Mr. President. Our minimum wage is immoral. It is immoral to think a human being is worth just \$7.25 an hour for their work. We have a chance, Mr. President, to change that right now. We can, and we must, take time this budget season to appropriately address our minimum wage. Our workers deserve better, Mr. President. Our future workers deserve better, Mr. President. Pennsylvania deserves better.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Fayette, Senator Stefano.

Senator STEFANO. Mr. President, I rise today to recognize the week of April 6 through 12, 2024, as the Week of the Young Child in Pennsylvania. This week is about acknowledging the importance of early childhood care and education and celebrating the incredible potential that lies within every young child. The first few years of a child's life are crucial for their cognitive, emotional, and social development. Ensuring that an adequate support system surrounds young minds so they can learn their foundational skills they need to survive and succeed is vital, and we as legislators should keep this at the forefront of our minds.

In recognition of this week, we acknowledge the significant role that parents, caregivers, and educators play in supporting the growth and development of children. Investing in high-quality early childhood education and development is paramount to a continued investment in our Commonwealth's future. During this week, we honor the lively spirit and vibrant energy of every young child. As we recognize their newfound curiosity and creativity, we are reminded that we must empower their support system to ensure that each child has boundless opportunities available to them in the future. As we celebrate the Week of the Young Child, I ask that we recommit ourselves this week and every week to supporting young children and the parents, caregivers, and educators who work tirelessly to advocate for them, so that every child in Pennsylvania can grow to their full potential.

The PRESIDENT. The Chair recognizes the gentleman from Allegheny, Senator Robinson.

Senator ROBINSON. Mr. President, I rise along with Senator Mastriano and Senator Rothman, some of my fellow military service veterans, to recognize Senate Resolution No. 248, which proclaims April 2024 as the Month of the Military Child in Pennsylvania. The resolution honors and supports an estimated 37,000 Pennsylvania children who have at least one parent currently serving this great nation as a member of any branch of the U.S. armed services. These tens of thousands of children and their families, and many more before them, assist and sacrifice in their parents' service in securing and maintaining our freedoms. Additionally, more than 2 million children nationwide experienced the deployment of one or both parents during the Global War on Terrorism. These frequent moves, parental deployments, and reassignments often cause challenges and disruption in the education, living arrangements, and supportive networks of these children. With an estimated 80 percent of Pennsylvania children in military families being school-aged, it is imperative that we provide every resource they need to adjust to constantly evolving situations. Just 2 years ago, I was thrilled to have one of my first legislative initiatives get signed into law with my friend Senator Stefano, via Act 69, which provides Purple Star recognition to schools that go above and beyond to ensure military students are well acclimated into their new environments. This is just one example of how we can support all of those military children throughout the Commonwealth.

I also encourage my colleagues and constituents to "Purple Up!" on April 15, which is next Monday. This is a day to wear purple, which symbolizes sacrifice in all colors represented in each branch of our U.S. Armed Forces. Coming from a military family myself and having served with brave men and women who had young children at home as we served in Iraq and Afghanistan, I know firsthand the sacrifices a family makes. Thank you, Senator Rothman and Senator Mastriano, for your collaboration with me on Senate Resolution No. 248, and I thank my Senate colleagues for honoring April as the Month of the Military Child.

Thank you, Mr. President.

The PRESIDENT. The Chair recognizes the gentleman from Franklin, Senator Mastriano.

Senator MASTRIANO. Mr. President, just moments ago, we voted unanimously in support of Senate Bill No. 1101. It was birthed after a roundtable in Mercer County with Senator Michele Brooks, with fire chiefs in her district. The chiefs made it clear that the current process to become Firefighter 1 certified is just too difficult and unwieldy. Firefighter 1 is divided into 4 modules, which takes about 188 hours, 188 hours to complete. It is not an easy process to go through, particularly when the firefighter must travel great distances to take the training and the tests. What makes it difficult is after 188 hours of training, mostly volunteer fire individuals take a cumulative test, a comprehensive exam on all 188 hours of the 4 modules they traveled through. Our legislation, which passed unanimously just moments ago, will enable the firefighter to opt to take a test after each module rather than waiting for the complete 188 hours to be behind him or her. This change does not lessen the rigorous process or standards, it just makes the process more flexible and user-friendly. We are thankful for the support of the State Fire Commissioner's Office on this and thankful for our volunteer firemen and women out there who run into the jaws of danger and put their lives at risk to make our community safer.

The PRESIDENT. The Chair recognizes, for a second time, the gentleman from Franklin, Senator Mastriano.

Senator MASTRIANO. Mr. President, this morning, as chairman of the Committee on Veterans Affairs and Emergency Preparedness, we held a service in honor of our Vietnam Veterans Day in Pennsylvania. I have a lot to say about our Vietnam veterans and what they have been through. They faced circumstances abroad and at home that few veterans had to face. My message today can be summed up simply with: I am sorry and thank you. That is it. As to the I am sorry part, it is about how our heroes during the Vietnam era were treated when they came back home, when they came back to the United States from country, especially those landing in airports such as in San Francisco when they were greeted by being spat upon and called names. I cannot imagine after serving a year or more in theater, losing friends, slugging it through the Mekong Delta or the mountains with the Hmong warriors around the border area of Laos and Cambodia, to be treated in such a way after such intense combat. They were

yelled at often when they came home, heckled, and spat upon. Only a generation early, with their parents, the World War II veterans returned home to ticker-tape parades and thank you's, truly a hero's welcome. That is something our Vietnam-era veterans did not receive. They served our country with distinction and honor and answered the call when the country reached out to them, did their duties, sacrificed so much, and came home to rejection. They deserve our country's admiration, respect, appreciation, as well as gratitude.

For me, I remember, of course, the retreat from Saigon in 1975; the sadness and horror of the thousands of Vietnamese who had supported our mission for over a decade, trying to get out of the country, knowing that their lives would be ended once the communists took over; the disgrace of our helicopters being crashed on decks of carriers filled with the South Vietnamese family members and the tens of thousands of boat people that fled. My own dad, during that period, was in the Navy--he served over 20 years in the Navy--and I remember one day he stopped coming home from work in his Navy uniform in the States. And I asked him, I said: dad, why do you not wear your uniform anymore? I was always so proud to see my dad in his Navy uniform. And he said his base commander issued orders that when they leave work that they no longer wear their uniform because they may be attacked or assaulted or abused. And as a little kid, I remember thinking, I just cannot imagine that in our country that a veteran, a hero, will be treated that way. It just puzzled me. The Vietnam veterans did not deserve to be treated this way. It was heartbreaking to watch it and to see it or learn of it. They did not deserve to have their sacrifices scorned nor their service called into question. I still hope the apology has meaning to them so many years later. They did not deserve to be treated that way. And I recognize, as chair of the Committee on Veterans Affairs and Emergency Preparedness, I recognize and thank them for their service and recognize them for the heroes that they are.

As to the thank you: thank you, Vietnam-era veterans, for your service, your sacrifice, answering your nation's call, traveling across the globe to fight an enemy you did not choose. Thank you for being a Vietnam-era veteran. I want you to know that you have been vindicated by history, and I encourage you to be proud of the uniform you wear and the service that you have performed on behalf of a grateful nation. I say thank you on behalf of every man and woman who has served in our U.S. Armed Forces after you. You paved the way for us so that my generation did not have to experience the hate, the scorn, the derision. When I went off to war in 1990 to liberate Kuwait with about a million others, we came home and were treated like heroes. That is thanks to the Vietnam-era veterans. So, thank you. Thank you for paving the way with the Veterans Affairs Administration [U.S. Department of Veterans Affairs] and your struggles for justice with Agent Orange so that future generations would have a faster response other than being told we cannot help you; we do not know what your problem is. Thank you for answering the call and being steadfast so my generation did not have to endure that. In closing, it was recently brought to my attention that the General Assembly has placed into law a Persian Gulf War Day--that is fantastic, 1990-1991--as well as a Global War on Terror Day. But March 29, honoring our Vietnam-era veterans is not officially on our books in the Commonwealth. As such, we will be introducing legislation in short order to continue to honor our heroes from the Vietnam

War. I look forward to working with my colleagues in this Chamber to advance this proposal. Vietnam-era veterans, thank you for your service. We honor and respect you.

The PRESIDENT. The Chair recognizes the gentlewoman from Montgomery, Senator Cappelletti.

Senator CAPPELLETTI. Mr. President, I rise to recognize last week, April 1 through April 7, as National Public Health Week. I introduced Senate Resolution No. 262 to distinguish Public Health Week here in Pennsylvania. Our Commonwealth is home to nearly 13 million people. And as a result, we are also home to numerous public health organizations and advocates who work tirelessly to improve the health and well-being of our residents. I am sure you can think of many organizations that serve your district's health, whether it be the health departments, nonprofits, healthcare systems, and other community organizations. Public health seeps into every single facet within our daily lives. And the social determinants of health is the delicate well-being of our citizens, our loved ones, and our communities. Improving public health means that every community has access to the holistic range of needs that all human beings have.

Additionally, recognizing this week is even more important as recent legislative and judicial attacks on Americans' rights to receive and provide health care have threatened the well-being of our communities. Stripping people of their access and right to reproductive health care is detrimental to our society's well-being. We have heard countless stories of people who have been put in life-threatening situations because of their State's restrictions on abortion care. Politicians and judges do not belong in the doctor's offices. Here in Pennsylvania, we recognize that public health is a priority, and everyone deserves to have their health needs satisfied. This must include access to the full spectrum of reproductive health care.

In this legislative Session, I have cosponsored nearly a dozen health reform bills. One of them, Senate Bill No. 52, prohibits lifetime limits on health insurance policies that target individuals with chronic medical conditions. Another bill, Senate Bill No. 546, prohibits for-profit hospitals from taking advantage of hundreds of thousands of Pennsylvanians, eventually leaving them without health care. Additionally, Senator Schwank and I have introduced the Healthy Start Act, Senate Bill No. 573, legislation to accommodate pregnant individuals who are incarcerated to be placed in a community-based setting and ultimately ensure that birthing parents and newborns are kept together. These bills, along with so many other policy proposals we have introduced in the Senate, will make a meaningful difference in the health of our constituents' lives, setting Pennsylvania up for a healthier tomorrow. I hope this Chamber will join me in recognizing the importance of National Public Health Week and dedicate ourselves to ensuring all of our constituents have access to high-quality health care and services in our Commonwealth, as well as the

healthy and safe homes, schools, and community spaces that they deserve.
