I am joined today by over 130 students and their advisors from the Muhlenberg Junior High and High School aevidum club, who are visiting us today in support of student mental health awareness. Their slogan is, "I've got your back." This morning, the individual students eloquently spoke about the importance of, and their struggles with, mental health. They came to support legislation, which is sponsored by myself and Senator Kane, that would allow students to have three excused mental health days to regroup and refresh and come back to school energized as ever. I would like to extend my sincere admiration and gratitude for these young advocates. I know they have bright futures ahead of them. Their words were powerful this morning. I wish everybody could have heard them. So, if our guests will please rise, all those white shirts up there, Mr. President; stand up guys. I would ask my colleagues to join me in offering our students a traditional warm welcome and let them know we have your backs. Thank you.

I have also worked with them to secure funding to renovate and move into a new facility in East Liberty as their incredible work has far outgrown their old office. Mr. Runion is a recent addition to the East Liberty Family Health Care Center, having joined their team just 8 months ago, but I know that his passion for service and health equity make him an excellent addition to their team. I look forward to working with him and the center on future projects and continued efforts to ensure that the residents of Pittsburgh receive the services and healthcare that they deserve. I ask that the Senate give my guest, Mr. Arsenial Runion, our usual warm Senate welcome. Thank you.

In a spirited semifinal game, St. Theresa weathered an early storm and held off multiple runs by St. Clare/St. Paul from the Diocese of Scranton in the second half to advance to the fourth PA State championship game appearance in the school's 75-year history. In what will be remembered as the CYO game for the ages, a true contest of champions, St. Theresa battled Blessed Sacrament from the Diocese of Erie in a championship game rematch from 2023. It was a back-and-forth contest from start to finish. St. Theresa overcame a six-point deficit in the second half to win the school's second PA State CYO championship with a score of 47-41. The team finished the regular season and post-season with an impressive record of 26-1 overall. With this year's win, the St. Theresa's varsity boys' program has now won two PA State championships in three appearances over the last six seasons in 2018 and 2024. Senator COLLETT. Madam President, I rise to share my strong support for Senate Bill No. 973. My district in Montgomery County is home to one of the largest Korean American populations in the Commonwealth. Since entering office, I have had the privilege of meeting with many Korean Armed Forces veterans who fought valiantly alongside the United States during the Vietnam War. During these conversations, we spoke about the barriers these veterans, now naturalized citizens of the United States, are facing, specifically that they are ineligible for the benefits and rights American-born veterans are afforded. It is imperative that our Commonwealth finally recognize the significant efforts and sacrifice that our military allies have contributed to our safety and security through more than just our words, but with meaningful action. I would like to recognize and thank my constituent, Master Bong Pil Yang, a local business owner and community leader who has tirelessly advocated for Korean-born Vietnam veterans in Montgomery County. Thanks to his advocacy and thanks to the countless veterans who have shared their stories, we are one step closer to ensuring these brave citizens receive the benefits and accolades they so deserve. I urge my colleagues for an affirmative vote.

Thank you, Madam President.

The PRESIDENT pro tempore. The Chair recognizes the gentleman from Philadelphia, Senator Street.

Senator STREET. Madam President, I also rise to support this legislation. I want to thank the maker of the bill. This is an issue I have worked on in the past. There are many Pennsylvanians who do not realize that our Korean allied forces worked and fought side by side with Americans in the war. Many of them died, fought, bled with their American allies, and then after the war returned here. This acknowledgment of their service means so much to these folks who are now parts of our community, many of them now living as American citizens, but their service was as allied forces. The recognition will mean so much to them and to their families, their children, and certainly for people who have literally fought and been wounded and stood side by side and sometimes saved American lives. They deserve this honor. So, I thank the maker of the bill and urge an affirmative vote.

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Montgomery, Senator Pennycuick.

Senator PENNYCUICK. Madam President, the United States military is the greatest fighting force this planet has ever known. One of the most distinguishing factors that sets our military apart from our adversaries is our incredible network of worldwide alliances. These are allies who have and will continue to fight bravely alongside American forces. I was privileged to serve with many from different nations during my tours in Iraq and Afghanistan. But Madam President, I can think of no greater example of American allies serving an indispensable role alongside American forces as the Republic of Korea's Armed Forces during the Vietnam War. The South Koreans sent an estimated 350,000 soldiers to Vietnam and played vital combat and support roles in the American mission in Vietnam. After the war, many of these Korean Vietnam veterans immigrated to the United States. There are now over 3,000 naturalized Korean American citizens living in our country who served in the Vietnam War. Hundreds of those now call Pennsylvania home. They are American citizens who have made their lives and homes in this country and are entitled to the same level of respect as their U.S. military counterparts. I believe now is the time to recognize the sacrifices they readily made for our country. Senate Bill No. 973 is modeled after the recently enacted Federal Korean American Vietnam Allies Long Overdue for Relief Act, or VALOR Act. This measure will provide the same Pennsylvania rights and benefits as their American military veteran counterparts. According to the Pennsylvania Department of Military and Veterans Affairs, any costs will be minimal and absorbed in their current workload and budget. Through the passage of this measure, we can show support for our American allies who put their lives on the line and fought side by side with our soldiers in Vietnam and who now call our country home.

Thank you, Madam President, and I urge an affirmative vote.

This legislation is designed to help the surviving family members in the midst of their sadness and sorrow. It would ensure that family members of the deceased service members are notified of their veterans' burial benefits. The bill would require licensed funeral directors, funeral entities, and cemetery companies to provide notification to the counties of the deceased service person within 3 days to ensure that they receive the benefits deserved. It would also require the entities to provide the families of the deceased veteran with the contact information of their county veterans affairs director. Fostering this simple, commonsense communication between surviving family members, funeral directors, and county directors of veterans affairs will not only help ensure family

members get access to the veteran's records and benefits, but it ensures also that they will get the proper sendoff that they deserve. I thank Representative Craig Staats for his efforts on this issue in the House, and ultimately, look forward to getting this issue across the goal line for our veterans.

Thank you, Madam President. I ask for an affirmative vote.

And the question recurring, Shall the bill pass finally?

PETITIONS AND REMONSTRANCES

The PRESIDENT pro tempore. The Chair recognizes the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Madam President, today I rise in support of Senate Resolution No. 282, which recognizes May 2024 as Mental Health Awareness Month in Pennsylvania. Madam President, according to the CDC, more than 1 in 5 American adults live with mental illness. This includes an estimated 1.8 million Pennsylvanians with mental health conditions. The youth figures are just as striking. One out of every 5 teenagers in our country is currently dealing with a seriously debilitating mental illness or has suffered from one in the past. It is important to understand the scale of this issue, because study after study shows that mental health is equally important as physical health in our overall well-being. In fact, our collective mental health is one of the most pervasive and challenging issues we as lawmakers must grapple with. Mental health plays a massive role in other problems such as gun violence, childhood learning gaps, workforce shortages, you name it. And when we think about these ongoing dilemmas, improving mental health of our citizens needs to be at the top of the list for solutions.

As for myself, I would be lying if I told you that I have never felt anxious, overwhelmed, or depressed before. I felt those feelings in abundance through alcohol addiction, my accident, and the loss of friends and family. The truth is, I would not be here today without the support of my family and friends and dedicated professionals who helped me open up about my mental health and address it. That is a fact. From the bottom of my heart, I encourage my colleagues to extend support to those dealing with mental health--whether it is family, neighbors, or even yourself--this month and beyond. Accessing mental health services is not weak. It is the strongest thing you can do. I know there is a saying: it is okay to not be okay. And that is true. Just because you are not doing well mentally does not mean you need to mask your emotions and pretend everything is fine, so long as you accept that sometimes you need help and address the underlying challenges you are facing.

I urge my colleagues to promote mental health for all our Commonwealth residents by advancing policy that provides resources, education, treatment, and insurance coverage for mental health. And if anyone out there is struggling with thoughts of suicide or self-harm, please reach out to someone or call 988, the national Suicide and Crisis Lifeline.

Thank you, Madam President. Let us normalize mental health conversations. Let us expand access to mental health treatment, and let us support our neighbors who are experiencing mental health challenges.

The PRESIDENT pro tempore. The Chair recognizes, for a second time, the gentlewoman from Philadelphia, Senator Tartaglione.

Senator TARTAGLIONE. Madam President, I rise because today marks 6,511 days since our Commonwealth's legislature last passed an increase in our minimum wage. Our Commonwealth's low-wage and minimum-wage earners have been left behind by inflation and rising costs while our legislature has toiled and delayed and allowed our minimum wage to stagnate at \$7.25. Our minimum-wage earners deserve better, Madam President.

Madam President, it was July 9, 2006, the last time we took bold and meaningful action for our minimum-wage earners. I will never forget an encounter I had after we passed Senate Bill No. 1090. I was leaving the hotel in Harrisburg and going back home to my district, and I was stopped and thanked by countless workers as I left. It truly never hit me what we have done to raise the minimum wage until that moment, because the gentleman said to me: Senator, do you know what you did? You almost gave my family a 50 percent raise in my salary.

When we negotiated Senate Bill No. 1090, we had the data on what it would mean for the economy. We knew we would raise the minimum wage for 438,000 people across the Commonwealth, but what I lost in the process was the humanity. We made sure families would be able to earn a wage that helped put food on the table. We made sure workers could do their full-time job and not have to work two or three additional jobs to keep a roof over their head. We changed countless of Pennsylvanians' lives just with the stroke of a pen. It can be so easy in this building, Madam President, to lose the humanity of the situation. But right now, Madam President, Pennsylvanians are struggling. Pennsylvanians are living in State-sanctioned poverty. Pennsylvanians need help. That is why I will never give up our fight for our workers. I know how much this can and will mean for hardworking Pennsylvanians. I have seen the relief and excitement in workers who are finally going to have a little bit more in their paycheck every week. I know this fight is a fight worth being in. I will never

apologize for being pro-worker, and I will never stop advocating for our minimum-wage earners.

Senator COLLETT. As the two nurses currently serving in the Senate, Senator Judy Ward and I are proud to be able to speak on behalf of the more than 220,000 practicing nurses across the Commonwealth who give so much to protect the health and safety of their patients. I am thankful for Senator Judy Ward's partnership and collaboration on these resolutions. As you heard, Nurses Week, culminating on Florence Nightingale's birthday on May 12, is a time when we can all reflect on the significant contribution nurses make to us personally and within our communities, as well as their many contributions throughout history. The COVID-19 pandemic made it clearer than ever how deeply important nurses are to the healthcare profession and community health, and these professionals deserve our respect and gratitude for all they do each and every day. School Nurse Day celebrates the crucial and often overlooked work our school nurses do to

Senator REGAN. Madam President, today, May 6, 2024, is a somber day at the Capitol as we mark Police Officers' Memorial Day in Pennsylvania ahead of National Police Week beginning on Sunday, May 12. I have introduced a resolution recognizing these two significant designations in our Commonwealth, but more importantly, to honor six law enforcement officers who lost their lives in the line of duty. These brave souls, each with their own unique story and journey, made the ultimate sacrifice.

Oakdale Borough Police Patrolman Charles G. Stipetich made the ultimate sacrifice on July 3, 2022, when he was shot and killed by a road rage driver in Blawnox. Brackenridge Borough Police Chief Justin McIntire made the ultimate sacrifice on January 2, 2023, when he was shot and killed during a foot pursuit by a wanted subject. McKeesport Police Officer Sean Sluganski made the ultimate sacrifice on February 6, 2023, when he was shot and killed while responding to a domestic situation in McKeesport. Temple University Police Sergeant Christopher Fitzgerald made the ultimate sacrifice on February 18, 2023, when he was shot and killed while struggling with a subject in Philadelphia. Pennsylvania State Trooper Jacques Rougeau, Jr., made the ultimate sacrifice on June 17, 2023, when he was shot and killed by a wanted man in Walker Township. And Philadelphia Police Sergeant Richard Carrero Mendez made the ultimate sacrifice on October 12, 2023, when he was shot and killed at the Philadelphia International Airport while approaching a subject breaking into a vehicle.

These fine officers did not hesitate when called to serve their communities and our Commonwealth. These brave guardians of our safety did not hesitate in the face of danger. They did not hesitate to do what was necessary to protect those around them. Today, as we pause to honor their memory, I urge each of you to reflect on the profound impact of their sacrifice and the families they left behind. It takes a unique individual to put the needs and safety of others first, despite the dangers they face, which seem to increase daily. And I know firsthand the sacrifices that are made by each officer and their family every single day, but especially when a senseless act by a criminal means their end of watch. Tonight, the Fraternal Order of Police will hold their annual Fallen Heroes Memorial at the Capitol Rotunda to honor the loss of these six officers who are a reminder that the men and women of law enforcement bravely serve to protect us all, regardless of the potential consequences to themselves, and they deserve our unwavering admiration and respect. So, I express my sincerest gratitude to the officers we honor today, as well as their families, and I give thanks to all who have lost their lives in the line of duty and those who continue to serve and protect.

Pennsylvania is currently home to over 400,000 Jewish residents and a historically high number of 32 Jewish day schools.

These resolutions celebrate the continued vitality of the Jewish American community here in Pennsylvania and across the nation. As anti-Semitic activity continues seemingly unabated, these designations are an opportunity for Pennsylvanians of every faith to learn about and celebrate the inspiring history of Jewish people and Jewish culture. Learning more about the different types of communities that reside here in Pennsylvania helps to promote peaceful living, a shared respect, and an understanding that no matter who we are or what background we have, we all deserve a safe, healthy, and happy place to live and raise our families. I hope my colleagues will join me in this effort to promote awareness of and appreciation for the experience of Jewish Americans here in Pennsylvania. Thank you.
